Specialist Hall has demonstrated honor, a commitment to his duty, and a willingness to give his all for all of us. My hope is that his spirit and dedication lives on in all those he touched, and his selflessness and sacrifice are a constant reminder of the best America has to offer.

Mr. Speaker, I want to acknowledge those who have helped make the legislative process to honor Specialist Hall move so quickly. The research staff, the drafting and printing personnel, and the bipartisan floor staff have been working diligently to have a resolution to this chamber before we recess. I now ask my colleagues to pass HR 404, honoring Specialist Hall's selfless sacrifice and devotion to our country.

In addition, many thanks to fast-acting individuals, a citation has been drafted to be presented to Specialist Hall's family. Cosponsoring this citation are Representatives Pistella and Walko, who along with their staffs helped my staff quickly gather the relevant information.

Mr. JAMES. Mr. Speaker, I have been informed that there may be some constitutional issues with the amendment. However, I would just like to make a brief remark and then submit some statements for the record.

The SPEAKER pro tempore. The Chair thanks the gentleman and may submit his remarks to the clerk.

Mr. James, you would like to make a few comments?

Mr. JAMES. Yes. I just want to make a few comments, yes.

The SPEAKER pro tempore. You may proceed, sir.

Mr. JAMES. All right. Thank you.

Mr. Speaker, I had planned to introduce an amendment to establish greater accountability for our district attorneys. I think that they are elected and charged with a tremendous responsibility to the truth and justice. My amendment would have created a process in which to report cases where people think that a district attorney or a member of their staff has acted in an unethical manner.

Cases of prosecutorial misconduct have happened too frequently throughout our State and throughout our country, and people are silenced because they do not have a uniform way to express their dissatisfaction. There are avenues to take if a person wants to make a complaint against a police officer or against an attorney or against businesses but no real venue to place a complaint against a prosecutor or their staff.

The foundation for this amendment would have been a piece of Federal legislation passed in 1998 which requires the Department of Justice employees to act ethically and that they should be subject to State laws and rules, and it is not unreasonable to expect that district attorneys may or may not alter or mistake evidence or to release evidence that may exonerate a defendant or witness or not to disseminate information to be inappropriate.

And two Congressmen from Pennsylvania, Congressman Murtha and Congressman McDade, back in '98 had a bill passed in Congress because of prosecutorial misconduct, and I would like to submit information in regard to those issues and those remarks for the record, and I will withdraw my amendment.

Dear Sen. Specter:

Thank you for allowing me to speak with you recently concerning my request that the Senate Judiciary Committee conduct oversight hearings on the Department of Justice (D.O.J.) and F.B.I. regarding the harassment of Black elected officials. As I stated during our meeting, I believe that there is a deliberate, systematic attempt by some individuals within the D.O.J. to target Black elected officials at all levels – local, state and federal. Disturbing allegations concerning the F.B.I. crime laboratory, revelations concerning tainted evidence in the Judge Alcee Hastings case and the dismissal of the "Operation Lost Trust" indictments have all served to highlight a problem within the Department that has been allowed to continue unchecked for far too long.

There exists within the D.O.J. a permanent bureaucracy that has routinely engaged in reprehensible practices that include cover-up, corruption, fraud, judicial abuse, and prosecutorial misconduct. Several recent developments should be noted:

- No less the authority than F.B.I. Director Louis Freeh himself disclosed on February 25, 1997 that a D.O.J. investigation into questionable conduct in the handling of evidence at the bureau's crime lab in Quantico, Virginia, "seemed to indicate" that the F.B.I. intentionally mishandled evidence and gave false testimony to a judicial panel that later recommended the impeachment of Judge Hastings. Later, it was revealed that, even when the F.B.I. supervisors were in possession of evidence that this outrageous behavior had occurred, they covered up this information, and knowingly permitted the false evidence and testimony to be presented to the U.S. Senate during the actual impeachment proceedings!
- On February 28, 1997, U.S. District Judge Falcon Hawkins of South Carolina issued a stinging 86-page order in which he dismissed "with prejudice" the Operation Lost Trust cases. The landmark decision represented an unprecedented castigation of the Department of Justice and specifically identified the perpetrators of what Hawkins called "appalling and egregious prosecutorial misconduct," as ranging from the local U.S. attorney's office to the D.O.J.'s Office of Professional Responsibility, the D.O.J.'s Public Integrity Section and to F.B.I. Director Louis Freeh. In going after the heart of the Department's permanent bureaucracy by name, Justice Hawkins charged that the misconduct is not only serious, but, "repetitious, flagrant, and long-standing...amounting to a pattern of misconduct."

I share with you a belief in the fundamental goodness of government service. Like you, I believe that it is a noble endeavor; one that should be encouraged, not discouraged in any manner. I also once believed wholeheartedly in the essential fairness of government and those who served within, particularly at the D.O.J. In fact, there was a time in America's history when Blacks had only the D.O.J. to turn to when many bigoted upholders of "justice" ruled without regard to law or fairness, especially in the south. Based on recent events, my faith in the Department has been shaken.

Nevertheless, I still sincerely believe that there still exists within the government individuals who consistently maintain all public record beyond reproach and who will fight to maintain the integrity of the justice system. I consider you to be among those.

I am hopeful that you will look further into this matter and begin the process of conducting the oversight that you and your fellow Judiciary Committee members are uniquely qualified to do. Should you desire further information, please call.

On the question recurring, Will the House agree to the bill on third consideration? Bill was agreed to. The SPEAKER pro tempore. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the gentleman from Philadelphia County, Mr. O'Brien, is recognized. The gentleman waives off.

The gentleman from Washington County, Mr. Daley, is recognized.

Mr. DALEY. Thank you, Mr. Speaker.

I rise in support of SB 565. My colleague, Representative Denny O'Brien, and I have been working on this bill for the last 4 years. As a matter of fact, if you look at the bill, it is our full-time D.A. bill that we had sent to the Senate on two separate sessions and passed almost unanimously in this House. This bill passed this House twice before.

A full-time D.A. would provide greater strength to the criminal justice system. We need full-time prosecutors the same reason we need full-time judges. A locally elected prosecutor can reflect the community's values and attitudes, and this is something we have all agreed on over the last several years. The district attorney is more than just a chief prosecutor in the county. He or she is also the chief law enforcement officer in that county, and they also serve on numerous official and voluntary boards in the counties. We all know that.

Under this measure in the bill, the State would pay for the additional salary burden for each county's district, and this would help to reduce the financial burdens and limitations the counties face for employing a full-time D.A.

Working as a part-time prosecutor and as part of a private practice can present the appearance of a conflict of interest, and that is something we have been striving for, for several years. Current law prohibits full-time D.A.s from holding outside employment. Pennsylvania already has 27 full-time D.A.s, and of the remaining counties, 28 have part-time district attorneys who also have private law practices. However, counties treating the position as part time allow prosecutors to support themselves through private practices. This measure eliminates that specific conflict.

As the statutes, rules, and case law have become more complex, we need thoroughly trained prosecutors. Mr. Speaker, we cannot expect part-time district attorneys to keep up with the demand of the new laws and the new burdens that are placed upon them regarding DNA and other types of evidence that is used in court today.

I do not think anyone would disagree with the argument that Pennsylvania deserves to be represented by full-time attorneys whose entire attention is devoted to the administration of justice. This is just good public policy. This is something this House has recognized for 4 years, and now this bill comes to us from the Senate. We all understand the politics of the game. Unfortunately, now the ball has come on our court, which really was originally our ball.

The volume and complexity of cases continue to increase, making the job more and more demanding. Mr. Speaker, I have a D.A. back in Fayette County, and she has been practicing as D.A. for almost 3 years now. She has prosecuted 26 murder cases in the last year and a half. She has a case load of about 270 cases every trial term, with 8 part time.

Mr. Speaker, we ask that we pass this bill. We passed it before; we passed it before that. Let us get this bill and get it signed by the Governor.
