JUDGE SMITH. Congratulations. Mrs. BEYER. Thank you. Thank you.

#### **REMARKS BY SPEAKER**

The SPEAKER. Good afternoon. I would like to extend a warm welcome to all those gathered here this afternoon in this beautiful chamber. Welcome to the swearing-in of our newest member, Karen Beyer. Congratulations again, Karen.

On Tuesday, July 19, Karen was elected to represent Pennsylvania's 131st Legislative District of Lehigh County. For the first time as a member of this institution, welcome to the hall of the House, Karen. I encourage you to savor and remember this day and this moment for the rest of your life. And remember, when you are sworn in again, you only get four tickets. You do not get to bring everybody with you.

There will never be another day quite like it in this magnificent place, surrounded by family and your friends; your husband, Merrill; your children; and your other family members. You have accepted the tremendous responsibility which has been given to you by the people of your legislative district.

Becoming a member of this body is a special privilege, yet is one that you have truly earned. You worked very hard, first as Representative Doug Reichley's aide, then as a candidate in the special election, to gain the respect of the voters.

#### **REMARKS BY MAJORITY LEADER**

The SPEAKER. With that, I would like to ask the majority leader of the Pennsylvania House of Representatives, the Honorable Sam Smith, to say a few words.

Mr. S. SMITH. Thank you, Mr. Speaker.

The reverend clergy, our honorable members, our soon-to-be, sworn-in, newest member, Karen Beyer, and all your family and friends that are here, welcome to the hall of the House.

As Pete Wambach used to say, it is a beautiful day in Pennsylvania, and no matter what the issues of the day or the pluses and minuses that are out there, I think that for each of us we are blessed to live in this great Commonwealth and to enjoy the diversity and the wonders of this State, and as a State Representative, you will certainly find yourself both enjoying those and being perplexed by them at the same time sometimes.

Karen, there is no question that as the newest member of the House of Representatives and the newest member of the House Republican Caucus, we want to welcome you and we want to congratulate you on the hard work that you put into winning this election. It is certainly not something that is given to anyone. It is something where you have to go out and earn it, and you certainly did by making more than 7,000 personal contacts and conveying a message to the people that they understood and that I think put the challenge before the voters, and then now you will respond to that challenge.

It is a mandate that you get from your constituency, and it is a challenge in the respects that while they all may be telling you, you need to do this, when you go and do this, sometimes that is not exactly what they meant. It is a challenge in that each day you will try to do what is best for the people of your legislative district and for the Commonwealth of Pennsylvania, but we also know that we cannot please everybody at any given moment in time, and sometimes that is a little bit frustrating with this job.

But as a State Representative, you are in one of the most pivotal positions of any of the elected officials in the breadth of our nation. You are kind of far enough as a State Representative in a food chain of an order of elected officials to kind of tug on the strings of those that are seemingly far away in the Federal government, and yet, being in your district on a regular basis, you are also close enough to be personally involved in those local issues that are involved with your townships or your boroughs or your school boards, and I think that that is one of the great and exciting things also about this job as a State Representative, which I believe that you will come to relish most of the time and maybe scratch your head in bewilderment occasionally. But you are in a position, you are in such a pivotal position that you deal with the complaints and the problems, and they are not just State problems. You get into the locals and the Federal issues from time to time, and it just kind of puts you at the real crux, as a State legislator, at the real crux of where the action is in government, no matter what the issue.

All of us come here as a newly elected State Representative with some ideas and some form of an agenda in our mind, and most of us all come with the same things that we think are important: a positive and better jobs climate or strengthening our schools or the facilities that generate a good health-care system for all Pennsylvanians. Each of us comes here with a similar set of goals. What differentiates us is how we go about trying to achieve those goals, and that is part of the divide. Sometimes it is divided on a basis of Republican and Democrat, and sometimes it is divided on the basis of geography or whatever. But those are the kinds of things that I think will excite you and thrill you as you take off on this new adventure in your life.

I urge you to do one thing, and it is something that each of us when we come into this place and into this line of work, that you do not really see it, because it can be self-absorbing of your time, and that is to keep those people that are closest to you, your family, keep them, make sure they are a part of your life, that you make the time for them, because that is the greatest challenge. The demands for your time publicly will never end. There is always one more group or one more place that you could or should be, and if there is something that I found on a personal level that was a challenge for me, and I think it is a challenge for most of us, is to keep that in balance, and I would urge you that no matter what, no matter what your duties and responsibilities are here, that you always balance out that need of your, you know, your first constituency, in this case, your family, and I urge you to keep that in mind. As much as you will want to jump in and do everything possible, keep those things in balance, and I think in the long run, it will make you a stronger and better Representative for the people of your legislative district.

So with those words of welcome and cautionary advice, I hope you take them in the warm spirit in which they are intended. I welcome you again, congratulate you, and God bless you for many years of service to the people of Pennsylvania.

The SPEAKER. The Chair thanks the gentleman.

#### **REMARKS BY MR. COHEN**

The SPEAKER. At this time the Chair recognizes the Democratic caucus chairman, Representative Cohen.

Mr. COHEN. Thank you, Mr. Speaker.

Mr. Speaker, Representative Beyer, guests, members of the House, as you know, Karen Beyer was not the first choice of the Democratic Party, but nevertheless, we welcome you here to Harrisburg. We Pennsylvanians are Republicans, Democrats, third-party members, nonpartisan voters, but we are all Pennsylvanians.

The fact that you have a district that has been closely contested in the past and may likely be closely contested in the future gives you added leverage here. Your party wants you to win no less than you want to win. We hope you will use this added leverage to actively and aggressively seek a middle ground and create worthwhile opportunities for all Pennsylvanians.

If Bill DeWeese, the Democratic leader, was here, he would tell you great events and battles of military history and quotations from Shakespeare. He is not here, so you will miss that opportunity today.

What I would like to do is point out the mural that sits in front of us that Matt Ryan, the longtime Speaker of the House of Representatives, was very, very proud of because of the great panoply of Pennsylvanians; the different stages in history. And with modern sensibilities, we can note the absence of women from this mural, we can note the absence of minorities, but nevertheless, this is a mural of great Pennsylvanians.

You see William Penn in the center of the mural, the man who founded Pennsylvania. William Penn established Pennsylvania as a colony of religious freedom, one of only two such colonies in the British Empire; the other was Rhode Island. And William Penn was asked by one of his friends, why do we not just establish religious freedom for Quakers; why are we establishing religious freedom for everybody? And William Penn answered that the only way to ensure religious freedom for Quakers was to establish religious freedom for everybody. And more importantly, that set forth the notion, which was very unique for the time, that the way to ensure justice for any single group in society was to ensure justice for everybody in society.

And then also on the mural, in back of William Penn, is Benjamin Franklin, who was a man of great inventiveness. He was inventive in many ways. He invented the insurance industry. He invented what was then the modern printing industry in the Colonies. He was a man of science. He was one of the leading scientists of his time, although he not only did not have a college or graduate degree, he did not have a high school degree either. He was recognized around the world for his inventiveness, and it was inventiveness tied into practicality. He invented the insurance business. He invented volunteer fire companies. He invented the concept of libraries. And because of his inventiveness, he served as Chief Clerk of the House of Representatives, he served as a member of the House of Representatives, and he served as Speaker of the House of Representatives before going on to being Ambassador of France and president of the Constitutional Convention.

And in front of William Penn on the statue, on the left you see a guy with a frown and a cane who is pointing leftward, and that is Thaddeus Stevens, a great Congressman from the Lancaster area. And Thaddeus Stevens invented, wrote the 13th, 14th, and 15th Amendments to the Constitution, and these are the amendments that dealt with slavery and the integration of the former slaves into society. And probably the most important continuing legacy of that is the 14th Amendment to the Constitution, which guarantees all citizens equal protection of the laws. And that was a very, very radical and revolutionary concept that had no precedent in world's history, that each person should be protected equally by the laws, and we debate here from time to time as to what that means. As you serve in the legislature, you will see there is no shortage of issues that come before this body. Whenever we pass a budget, we deal with a lot of backlog of issues that have accumulated, but we never, ever complete all the tasks before us.

Three issues that we have to face in the upcoming sessions are: Medicaid funding. We were short of what we had spent the previous year because of Federal cutbacks, and there may be future Federal cutbacks, which will encourage us to make further cutbacks, and each time we make a cutback, people suffer, and we want to make as few cutbacks and ideally no cutbacks, if possible.

For many years we have tried to work on property taxes in Pennsylvania. And Jim Manderino, Speaker of the House and Democratic leader, shortly before he died in 1989 said when he first came here in 1966, everybody was talking about the property tax reform, and it was 1988 or 1987 when he said this, and people are still talking about it and nothing is happening, and probably 20 years from now people will still be talking about it and nothing is happening. Well, we made some efforts in the Pennsylvania legislature to address property tax reform. We passed a bill a year ago that should ultimately reduce property taxes, but there are all sorts of roadblocks in its way, and dealing with those roadblocks and seeing that property tax reform is actually achieved is going to be a major challenge.

And the third major challenge we have is the wage structure in Pennsylvania. When we voted to raise our salaries recently, we heard from Pennsylvanians who are unhappy with their wages, with their lack of opportunities. The average person in the private sector changes his or her job once every 4 years, and they change their jobs so frequently because there just are not enough opportunities on the job for advancement and the salaries are too low. People are stuck at starting salaries. And we have not raised— One thing we can do is raise the minimum wage, and we have not done that in Pennsylvania since 1988. It has not been done nationally since 1985.

These are challenges that you are going to have to face. We welcome you here to face these and other challenges. We believe the Democrats and Republicans working together can make this a better Commonwealth, and we welcome working with you as a key element in that.
