REMARKS BY MAJORITY LEADER

The SPEAKER. At this time the Chair recognizes the majority leader, the gentleman from Jefferson, Mr. Smith.

Mr. S. SMITH. Thank you, Mr. Speaker.

Representative Parker, it is my distinct honor to be one of the first to welcome you officially to the hall of the House of Representatives. Obviously, as it is with most of us that get here, you have worked hard. It is something that might be a fulfillment of a lifetime of work in a way that is culminated at this particular moment on your arriving here, and obviously, these are very exciting times.

But at some point as you, you know, kind of get the feel of this place, you will figure out where your role is, as each and every one of us has in terms of how we will effect change and how we will affect the direction of this Commonwealth.

So you know, we are here, as the Speaker said, we are here to help you learn and help you grow, and you will find out there are times that, you know, we agree in a healthy way and there are some times that we disagree in maybe an unhealthy way. But at the end of the day, I often remind this place that it really is the collective wisdom of the members of the House, ultimately the Senate and the Governor's Office; it is the collective wisdom that truly leads and guides us in where we go, whether it is you as a member of the Democratic Caucus in the House or the House as a whole versus what the Senate's direction might be or the legislature versus what the Governor's direction might be. All of us are here to advocate for some direction, and at the end of the day, our charge is to find the proper direction for the people of Pennsylvania, and that is a balancing act that is unique to our form of government and something that I think is a great experience in many, many ways.

To conclude my remarks, Mr. Speaker. Representative Parker, this is a new day in your life. I think that as most of us have, you will find it to be one of the most challenging and yet one of the most rewarding experiences, and I wish you the best of luck and all the skill that you can muster to do the best you can for the people you represent and to do the best you can for the people of Pennsylvania.

BILLS ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 1743**, **PN 2230**, entitled:

An Act amending the act of July 28, 1953 (P.L.723, No.230), known as the Second Class County Code, further providing for

assessment limits on counties of the second class; and providing for effect of appeal, escrow and payment under protest.

On the question,

Will the House agree to the bill on third consideration?

Mr. MUSTIO offered the following amendment No. A02560:

The majority having voted in the affirmative, the question was determined in the affirmative and the amendment was agreed to.

On the question,

Will the House agree to the bill on third consideration as amended?

Bill as amended was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

The Chair recognizes the gentleman from Allegheny, Mr. DeLuca.

The gentleman is entitled to be heard. Please keep the noise levels down.

Mr. DeLuca.

Mr. DeLUCA. Thank you, Mr. Speaker.

First of all, I want to commend Representative Mustio for taking my bill and making another bill here with a couple new twists. But anyhow, regardless of who introduces a piece of legislation, I think it merits us looking at it.

Mr. Speaker, would the gentleman stand for interrogation, brief interrogation, please?

The SPEAKER. The gentleman, Mr. Mustio, indicates he will stand for interrogation. The gentleman, Mr. DeLuca, is in order and may proceed.

Mr. DeLUCA. Mr. Speaker, on page 4, lines 18 through 29 here, can you explain that section to me? I do not know if you heard me or not. On page 4?

Mr. MUSTIO. It has to do with when a-

Mr. DeLUCA. It has to— Pardon me? Mr. Speaker, can we have a little order here?

The SPEAKER. The gentleman is entirely correct. We have asked for order. Please. If you have to have conversations, take them to the back of the hall of the House.

Mr. MUSTIO. The answer, Mr. Speaker, relates to the filing of a formal appeal, a formal protest of your property tax assessment, as opposed to a regular appeal.

Mr. DeLUCA. So what we are saying here, as I read it here, is that we are going to segregate 25 percent into a fund, and for that 25 percent to be utilized, we have to petition the court, the way I read this?

Mr. MUSTIO. No; no.

Mr. DeLUCA. Well, tell me how this works.

Mr. MUSTIO. When a formal protest of your appeal is made, a check accompanies that protest. It is different than when a homeowner, for example, files an appeal to their assessment. When you file your appeal under protest, you attach a check to that appeal. What this is requiring is that the taxing body holds back in a separate account 25 percent of that check amount so that the money is there as a guarantee to the entity that is filing the appeal. So if they win their appeal, they will get their money, their taxes back. So we want to make sure that the money is there for those that are filing the tax appeals under formal protest.

Mr. DeLUCA. What do you surmise it would take for that type of situation to lend itself through the system? How long would they be able to keep this money? I know you have in there they are going to pay interest, but how long would they be able to segregate this money, since a lot of these appeals take a lot of time—

Mr. MUSTIO. That is the way it is done right now.

Mr. DeLUCA. I understand, but is not our goal, what we are trying to do is close the loopholes in this process so that we can stop the backdoor tax increases by the reassessment process? Is that not what we are trying to do?

Mr. MUSTIO. Right, and this has nothing to do with that part of the process. What this has to do with is guaranteeing that the money is there; that the taxing body, the municipality, the school district, or the county does not spend the money and then not have the money available to return it to those that have won their tax appeal, filing it under formal protest. When you file under formal protest, you actually write the check for your taxes and make that appeal. So we want to make sure that the money is there and not spent by the taxing body. So they have to separate 25 percent of that out into a separate account.

Mr. DeLUCA. Okay. Now, let me also ask you about petitioning the court.

Mr. MUSTIO. Yes.

Mr. DeLUCA. Why are we putting that in here, the petition, that they have the opportunity to petition the court to go over 105 percent?

Mr. MUSTIO. Because I think that the taxing body needs to make its case if they feel they need to raise taxes higher than 5 percent. The way the bill is structured is, it is a revenue-neutral bill, as you know, and part of your bill is the base, but some of these provisions are different, and we wanted to hold the taxing bodies accountable.

So what the bill does, this has two steps. First, it has the zero-tolerance assessment provision, where if the assessed value goes up in a municipality, let us say in a school district, by 25 percent, then the millage in that district needs to also go down by 25 percent. So there is zero increase in revenues other than the items that are listed there for new construction or additions. So if they wanted then at that point to make a separate vote to raise taxes, they can do that.

But what is happening now in Allegheny County is, and if you have seen this, when the treasurer sends out the list of all the millage rates in the county by school district or municipality, that we have school districts where we have school directors running for reelection who say, we have not raised your taxes. Well, they technically are right. They have not raised the millage rate, but every time there is a reassessment, we as taxpayers are paying more. So what we are trying to do is clamp that, and by making it zero tolerance, we still are giving the school districts and the municipalities the

opportunity to raise taxes if they want to take that separate vote, and I think we know as elected officials, then it becomes a little bit tougher. So now they are going to start looking at perhaps the expense side of the equation. But we are capping it, what they can raise it, and this is the way it is in the counties of the fourth through the eighth class in the State already. We are capping the rate at 5 percent.

Mr. DeLUCA. I understand.

Mr. MUSTIO. If they want to go higher than 5 percent, if there is an emergency need in the district to do that, then I think they need to make that appeal to court to do it.

Mr. DeLUCA. So you believe that this will not incur a tremendous amount of legal expense on behalf of the taxpayers?

Mr. MUSTIO. No.

Mr. DeLUCA. And that we will make this revenue-neutral? That is the intent of the legislation. Am I correct?

Mr. MUSTIO. Absolutely. The intent is to make it revenue-neutral, but the intent is also to make the taxing body start to look at the expense side of the equation by forcing a separate vote to raise taxes. There are two ways to look at it. We can force the revenue side or, hey, we may have to force and make it work more efficiently and make some cuts, and that is the intent.

Mr. DeLUCA. Thank you, Mr. Speaker.

Mr. Speaker, I would like to make a statement.

The SPEAKER. The gentleman is in order and may proceed.

Mr. DeLUCA. Mr. Speaker, I support HB 1743, and it is about time that we hold local governments accountable and quit using the reassessment process as a backdoor tax increase, and this is one way that we can go about it. So I ask my colleagues to vote for HB 1743.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Kotik.

Mr. KOTIK. Thank you, Mr. Speaker.

I would like to interrogate the sponsor of the bill.

The SPEAKER. The gentleman is in order and may proceed.

Mr. KOTIK. Thank you, Mr. Speaker.

Mr. Speaker, my intention in rising today is to clarify for my own edification and for the clarification of the other members from Allegheny County. For instance, in one of the townships that is a growing township in Allegheny County, Robinson Township, if the total assessment value went up by \$1 million and 50 percent of that \$1 million was new construction, would the municipality have to decrease the tax rate by the half a million dollars?

Mr. MUSTIO. That is correct.

Mr. KOTIK. And if they wish to raise the revenues they needed for their budget, went above the 5 percent, then they would have to raise the revenues that way, by a tax increase.

Mr. MUSTIO. They would be able to raise taxes by an additional 5 percent by taking a separate vote to do that. If they want to go higher than that, then that is when, as we spoke with Representative DeLuca previously, they would have to go to court to do that.

Mr. KOTIK. So as long as they stayed within that 5-percent range, they would be okay.

Mr. MUSTIO. That is correct.

Mr. KOTIK. Okay. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Levdansky.

Mr. LEVDANSKY. Thank you, Mr. Speaker.

Mr. Speaker, HB 1743, essentially the ostensible goal seems to be to place a cap to make reassessments revenue-neutral. That is so that the revenue that a taxing body realizes from increases and reassessments will be used, dollar for dollar be used to reduce millage at the municipal county and school district level. Subsection (a) essentially establishes that as the goal of the legislation.

Subsection (b) then goes on to establish a rate that could be more than the budget-neutral reconciliation by the local taxing body doing a separate vote to essentially increase taxes beyond the reconciliation up to a 5-percent cap. Then subsection (c) notes that new construction is exempt from the process, which makes sense. Subsection (d) adds, I think, a very wide loophole whereby tax increases above and beyond 105 percent can be requested by the court of common pleas. So we have a judicial bypass loophole created in subsection (d).

My question to the sponsor is subsection (e) whereby a political subdivision can adjust its calculation by a 5-year average. Would the sponsor of the bill explain how that works and what the purpose of this 5-year averaging of tax revenues is proposed for?

Mr. MUSTIO. Yes, I would be happy to answer that question.

That relates to primarily municipalities or school districts that have a significant amount of commercial real estate in them. What we found over the years is the commercial property owners have a more sophisticated and also the financial resources to appeal their taxes. So when we went through the first countywide reassessment in Allegheny County, we found significant amounts of refunds, particularly to the commercial and business property owners.

So what this is doing is, again, to make sure that the proper amount of funds are set aside by a municipality to pay any returns to those that win their appeals. My concern would be for our taxpayers is if they won their appeal and the money was not there to refund them their taxes.

The reason we have the 5-year average in there is in the event there is an anomaly year. For example, the first year after the countywide reassessment, perhaps there is a significant adjustment, and you may have seen that in your district where you had a property assessed at \$1 million and a reassessment comes through and it is \$10 million. We all know that that is going to be taken back, so you make some adjustments for that. But rather than have a significant valuation for the one year, we thought a 5-year average was more credible.

Mr. LEVDANSKY. I mean, in theory that makes sense for circumstances where it would have a significant revenue impact on a taxing body's budget, but the reality is that nearly every taxing body in Allegheny County has a budget surplus, and is not the purpose of school districts and municipalities to carry a fund balance, to carry a reserve over from year to year, to deal with those kinds of revenue anomalies that could be caused by a reassessment, and why not just let their budget reserve be held to deal with these kinds of anomalies rather than essentially instituting carte blanche an ability for them through a 5-year average and to reap—

Mr. MUSTIO. They certainly have the opportunity to do that, and you see the word is "may" in there. They may utilize that. There may be a situation where these anomalies are there and they need the tool to do it, rather than have us come back years later and try and amend legislation. You have seen how

long it has taken this, over 2 years, to get this in process in working with the county executive and both sides of the aisle. So we thought we would try and get as many of the bugs worked out as we could up front talking with the various municipalities, the State association, you know, the township officials and that type, to make sure that the legislation is done in a good manner up front.

Mr. LEVDANSKY. Okay. Mr. Speaker, no more questions; just finally on the bill.

My concern is that subsections (e) and (f) do not just deal with the appeals, that they essentially institute in statute, in law, an ability for the calculation to be higher to start with, and I have concerns about that.

In short, what I would say is, look, the goal is to make it so that when we do reassessments, so that when a taxing body realizes an increase in revenue because of an increase in reassessments, that they be required dollar for dollar to allocate those additional revenues to lower millage. My concern is with this calculation process in place, with the provision that a taxing body can essentially vote to raise taxes up to 105 percent of the prior year's revenue, and with the judicial bypass, with language that I think is so weakly worded that practically any court of common pleas judge would nearly automatically grant a tax increase to a municipality if they could just prove for practically any reason that they need it, my concern is that the protection that we are trying to offer the taxpayers is largely an illusion, and it is an illusion because of these specific provisions that I think are going to be interpreted in such a way and applied in such a way that the cap on the reassessments to require revenue neutrality will be impractical. So my fear is that the taxpayer relief that we intend to deliver to the taxpayers in Allegheny County is largely an illusion given, I think, the provisions of the bill that really weaken it.

Nonetheless, nonetheless, despite those concerns that I have, I am going to vote for the bill and hope that we could revisit this issue perhaps at a later day, in another forum, to craft language that I think will not provide for the bypass mechanisms that this bill does.

So thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Belfanti.

Mr. BELFANTI. Thank you, Mr. Speaker.

Mr. Speaker, like the gentleman, Mr. Levdansky, I also have some reservations concerning several sections of this bill, but I do believe it is a step in the right direction, and I do believe that my colleagues should vote for it, and we can tweak some of the other problems at a later date, because the bill certainly is better than what we have on the books right now.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

Does the gentleman, Mr. Mustio, seek recognition? The gentleman is in order.

Mr. MUSTIO. On the bill; I guess I would like to address a couple of the comments that were made.

Obviously, we have a system in Allegheny County now where there have been abuses of the 5-percent windfall provision, and I know Representative DeLuca has been working for years to try and address that. There may be some amendments here that people may not understand fully, but to be quite honest with you, we wanted to make sure that we got a piece of legislation that works, and from the standpoint of being in local government previously, we want to make sure that we

do not put any burdens on them so that they then come back to us to make changes later.

I think what we have in here are very viable provisions. We make our locally elected officials accountable. No longer can they do the backdoor tax increases with the assessments. They are going to be held accountable by making separate votes for tax increases if they see those are fit. Who knows, they may even find ways to cut expenses and lower taxes beyond the revenue-neutral provision, which we would certainly encourage, and if they want to make their case to court, that certainly is a public way that they are going to have to justify raising taxes beyond that 5 percent.

I do not think at all that these are loopholes. I think these are mechanisms for control, and I think they are fiscally very responsible, and I think if you talk to your managers and your locally elected officials, you will find that to be the case.

I urge my colleagues for support of passage of HB 1743. Thank you.

The SPEAKER. The Chair thanks the gentleman.

On the question recurring, Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.
