YORK COUNTY RESIDENTS HONORED

The SPEAKER. The Chair at this time recognizes Representative Smith.

Mr. B. SMITH. Thank you, Mr. Speaker.

I am here today to recognize five heroes from York County. Think for a moment: What would you do if a plane crashed in your neighborhood? How would you react? What would you do? Five of my constituents reacted as heroes, and I have brought four of them here to be honored by you. What this citation does not mention is that three passengers in the airplane were killed.

These individuals, each performed different tasks to save not only the pilot of the airplane but to ascertain whether anybody else in the mobile home park, and you have to picture this, this airplane crashed, took off from the Capital City Airport, and at the end of the runway is the Old York Road, close to Pierre's, where some of you have been from time to time, and crashed into a mobile home park.

I was not able to get Marine Sgt. David Watson. He lives at the New Cumberland Army Depot; I could not make contact with him, so he is not here today. But I have a citation for each of the other four individuals and one for Sergeant Watson:

"WHEREAS, Sergeant David L. Watson, Ben Kirkpatrick, Danielle Parsons, George Turnbull and Chris Turnball" – over here in the corner – "are being honored for risking their lives to save that of another during the aftermath of an airplane crash; and

"WHEREAS, On June 25...a single-engine airplane took off from the Capital City Airport, almost immediately experienced mechanical problems and crashed headlong into a mobile home in a New Cumberland mobile home park. Sergeant Watson saw and heard the accident, stopped his car and ran to the scene to offer assistance. Ms. Parsons, Mr. Kirkpatrick and George and Chris Turnbull lived nearby and also ran to the crash site to help in any way possible. The pilot was able to exit the airplane, and as he was climbing out of the remains of the mobile home, which by that time was on fire, the home's propane tank exploded. Sergeant Watson and Mr. Kirkpatrick helped the pilot as soon as they could reach him; Ms. Parsons and Chris Turnbull, both of whom are Emergency Medical Technicians, attended to his injuries until an ambulance arrived; and George Turnbull, Manager of the mobile home park, checked adjacent mobile homes to see if any residents had been injured and cleared the scene to help establish a landing place for the Life Lion Critical Care Transport Service helicopter. Sergeant Watson's hands were treated for burns which he received while rescuing the pilot; and Mr. Kirkpatrick required medical treatment for his hands, which were injured during the propane tank explosion. True heroes all, the quick and unflinching response of Sergeant Watson, Mr. Kirkpatrick, Ms. Parsons and George and Chris Turnbull to that life-threatening situation was extremely courageous and reflects most highly on them."

Now therefore, I present from the House of Representatives a citation to each one of them for their heroic actions.

As you can tell by the citation, it was a harrowing situation, and picture in your minds a plane crashing in a mobile home park. These four and Sergeant Watson reacted spontaneously and heroically in the face of danger.

I do not know Webster's Dictionary definition of a "hero," but I do know my definition. These four and Sergeant Watson, without hesitation, put their lives in danger to save another and others if needed. The five of them showed us courage and concern for others. Let us honor them with a hero's welcome from the House of Representatives.
