He was riding at the time in a Bradley Fighting Vehicle.

Evans was a 2002 graduate of Blue Ridge High School, and he leaves behind his parents, Bill and Judy Evans; a brother, Joshua; a sister, Heather; and many other family members.

He was awarded the Bronze Star and the Purple Heart. He fought for what he believed in: God, his country, and freedom for all.

Bill's Bible verse when he was in Iraq with his fellow soldiers was Psalm 27:5. "For in the time of trouble he shall hide me in his pavilion: in the secret of his tabernacle shall he hide me; he shall set me up upon a rock."

Miss MAJOR. Thank you, Mr. Speaker.

And, Mr. Speaker, I sincerely appreciate your tolerance and your understanding in my rising to speak on behalf of these resolutions today, because once again I ask for your support on HR 482 honoring another fallen soldier, S. Sgt. Daniel L. Arnold, who also died on September 28, 2005, with four of his fellow soldiers while serving his country in Iraq.

Staff Sergeant Arnold was a passenger in that same M2A2 Bradley Fighting Vehicle while conducting combat operations in Ar Ramadi as part of a four-vehicle patrol to secure construction of a railroad bridge. The patrol came under indirect fire attack and the vehicle caught fire.

Staff Sergeant Arnold was a 1996 graduate of Montrose High School, where he played varsity football, and a 2000 graduate of the Johnson Technical Institute, where he earned a degree in diesel mechanics.

He is survived by his wife, Kimberly; two sons at home, Devin and Kody; along with his parents, his sisters, and a brother, and many family members.

Mr. Speaker, today I rise with a heavy heart to offer a condolence resolution honoring a very special young man, a young man from Bradford County who made the ultimate sacrifice for our country.

Spc. Oliver J. Brown was 19 years old. He was from Athens, Pennsylvania, and Specialist Brown was killed in action while defending his country on Wednesday, September 28, 2005. He was the first soldier from Bradford County to be killed during Operation Iraqi Freedom.

Specialist Brown was known to his family and his friends as "Bill" or "Olie." He was born on December 4, 1985, the son of Robert and Susan Brown-Orchard.

Oliver enjoyed playing baseball. He enjoyed hunting, traveling, computers, and photography. He also loved spending time with his family and his friends and making them smile.

He was a 2004 graduate of Athens Area High School and a member of the Pennsylvania National Guard, 109th Infantry Division.

Specialist Brown was one of five Pennsylvania Guardsmen killed near Ramadi while on a routine patrol to provide security for the construction of a railroad bridge. An explosive device struck the Bradley Fighting Vehicle Oliver was traveling in, and it was then attacked by small-arms fire and rocket-propelled grenades, setting it ablaze.

Oliver was a man of great character and heart. As a matter of fact, he was not even scheduled to go on this mission. He volunteered to go in place of a sick soldier, because Oliver was dedicated to helping to rebuild Iraq.

All five soldiers in the convoy will be awarded the Purple Heart and Combat Infantryman's Badge for the courage they displayed on this mission.

Words, of course, cannot adequately describe the deep sorrow those who knew him must feel at his loss. I wish his family and loved ones the comfort of knowing his sacrifices will not be forgotten. Oliver was a true hero and he will be forever in our debt.

I ask you today to join me in expressing our deepest sympathies to Oliver's family and loved ones. Please also join me in honoring this brave young man who fulfilled his duties with honor and dignity and laid his life upon the altar of freedom. May we never forget Oliver J. Brown.

The SPEAKER. For what purpose does the gentleman, Mr. Allen, rise?

Mr. ALLEN. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

## ANNOUNCEMENT BY DEMOCRATIC LEADER

The SPEAKER. The Chair again recognizes the gentleman, Mr. DeWeese.

Mr. DeWEESE. Thank you, Mr. Speaker.

I did have a couple of observations on property tax I wanted to share, but before I do that, as a result of our sidebar meeting at the Speaker's podium, I would like to announce to our members, Democratic members, especially on the spending limitation legislation that will be forthcoming next week, that we will have until 6 o'clock tonight to draft our amendments. So I did want to share that with the membership, and certificates can be garnered in the interim.

### INTERROGATION

Mr. DeWEESE. Is the gentleman, Mr. Leh, in the hall of the House? If he is not, the majority leader would be a perfect gentleman for me to query for a minute or two on some internal committee maneuvering that I wanted to have some enlightenment about.

Would the gentleman, Mr. Smith, submit to interrogation?

The SPEAKER. The gentleman will submit to interrogation, but I would like to point out that that extension applies to the spending-cap bill. The Chair recognizes the majority leader; only the spending-cap bill. Mr. Smith.

Mr. S. SMITH. Mr. Speaker, I am sorry. I presumed the minority leader wanted to ask me a question. I did not hear it if he did.

### PARLIAMENTARY INQUIRY

Mr. DeWEESE. I am sorry, Mr. Smith.

Before that, this inquiry would be another point of parliamentary inquiry to the Speaker. We might need time, because of the understandable commotion in the scheduling, with tomorrow being full freighted with committee meetings and not a regular voting day, we might need until 6 o'clock tonight for our rank-and-file Democrats to gather amendments to any bill that would be coming up, Mr. Speaker, on Monday, not just the cap-on-spending bill. I do not think that creates any dilemma.

The SPEAKER. For all bills listed on Monday's voting schedule, that would be correct.

Mr. DeWEESE. Thank you very much.

## **INTERROGATION CONTINUED**

Mr. DeWEESE. And then just a quick inquiry to the honorable gentleman from Jefferson County. The parlance of the floor here refers to a group of our esteemed colleagues. In fact, I think they have taken the nomenclature and affixed it to their own group. They call themselves the Commonwealth Caucus, and these delightful and talented colleagues have come at property tax from an innovative and different angle. They introduced, Mr. Speaker, a series of proposals, and those proposals initially were lodged in the Finance Committee, and then they wafted somehow over to the Rules Committee, and then they made their way to the Appropriations Committee, and they have had a very serpentine passage over the past many weeks.

Now, we sculpted a brand-new organism within our Finance Committee substructure. We got new members to participate outside of the committee echelon, and we appointed new subcommittee chairmen, and now I am led to believe that these measures of the Commonwealth Caucus – Mr. Rohrer being one of their brigadiers – have made their way to the Appropriations Committee, and I am stupefied as to why in a special session and a regular session the same bills have wafted hither, thither, and yon to three committees.

We have to get focused on property tax reform. Mr. Rendell, our Governor, gave us a proposal. The General Assembly and

the body politic have not embraced it. But the Republicans who run the House and run the Senate must show us some cohesion, some delineation, some precision, some consistency. Three committees in a matter of weeks for a handful of bills. I just would love to see these go to Finance, where Mr. Leh and Mr. Levdansky, the Republican and Democrat, these new committee substructures that have been architected, if there is such a verb – if not, I will take literary license – and engineered. That is where the action should be, and, Mr. Speaker, please explain to me why you gainsay the wonderful dynamics of your own Finance Committee.

Thank you, Mr. Speaker.

Mr. S. SMITH. Thank you, Mr. Speaker.

While that question was about as serpentine as what he was accusing the life of these bills, I will try to answer what I think is the gist of it.

Number one, that package of five bills that is commonly referred to as the Commonwealth Caucus plan had been referred in regular session to the Appropriations Committee, if I am not mistaken, prior to the creation of the special session. Secondly, the bills that have been referred or introduced in the special session, a few of them have been reported to Appropriations. So it is not like they received entirely special treatment, if that is what your concern is.

Mr. DeWEESE. Again, my Finance chairman, the esteemed Mr. Levdansky from Allegheny County, informs me once again that initially these Commonwealth Caucus bills went to Finance. They did not have enough steam to make their way out, but they could have been altered or modulated. We have a big, big problem with property tax reform in our State, and now they are in Appropriations, and it just did not make a whole lot of sense to me as to why they had made this migration from Finance to Appropriations, Mr. Speaker, when we specifically and with high hopes and substantial motivation within the past fortnight have made certain that we created four robust little subcommittees and we were going to have the whole world look at our property tax reform effort. We have a big challenge, and we are shackled and pinioned by what we perceive to be Republican nonchalance within the committee structure.

Mr. S. SMITH. I think you are confusing two courses of action here. The bills that were introduced earlier in this year in regular session, there are actually two sets at this juncture, I believe – one set that was referred to the Finance Committee, of which I believe they reported four out of five from the committee, if I am not mistaken. Subsequently, the bills were altered in a minor way, most likely, reintroduced, and referred to the Appropriations Committee. That was in regular session earlier this year. This fall, once the Governor called the special session, bills have been introduced in the special session. I mean, some, whatever, 70 or 80 bills, I guess, have been introduced that deal with property tax in a variety of ways. A handful of those bills have been reported to the Appropriations Committee, not the least of which is one that represents the Governor's own plan.

So I am not sure what the gentleman is trying to imply. I mean, it is what it is, is what it is. They were referred to a committee.

Mr. DeWEESE. Would the gentleman commit or not commit – it is very simple – to at some time in the near-term future – a week, 2, 3, 4; sometime between now and our national holiday of Thanksgiving – commit to putting these bills, these five bills, in the Finance Committee? That is where we have done taxes

for the three decades I have been in this process. The Appropriations Committee has a different kind of mission. I am not going to assert that it is inappropriate for them to be reposited there momentarily, but the gut-wrenching, tough analysis that has to come from these property tax proposals on all sides, the Commonwealth Caucus dynamic and many other amendments that would be forthcoming from both sides of the aisle, should go to Finance. That is the view of the Democratic minority.

Will you, sir, politely, respectfully, commit to at least at some time allowing them to have that passage through the screen, through the very enlightened, very, very talented staff teams on the Republican side and the Democratic side in the Finance Committee? We are going to have enough challenges within the Appropriations Committee on the big State budget that is impending in the next few months.

So the Finance Committee seems to be where we would like for these actions to take place. Would the honorable gentleman commit to sending them to the Finance Committee at some time in the next 2, 4, 6 weeks for a good, solid Finance Committee staff and member overview?

Mr. S. SMITH. Did you hear that thud? That was, I fell off the turnip truck.

This bill, this set of bills, the Commonwealth Caucus package, obviously has some special implications to it, special in the sense that it is outside of the box of what we historically have dealt with. One of the reasons that it went to the Appropriations Committee was because therein lies the great debate about it, and that is, you know, what is actually subject to tax and what would that generate? That is a direct function of the Appropriations Committee, and in fact, that fiscal note has been a point of significant debate between what the Department of Revenue, you know, suggests that that bill as written generates versus what other parties and individuals believe is encompassed in that package of bills.

So I think it is appropriate that seeing that that is one of the key, at least fiscally relative questions – what does this package, what does the key bill generate in the way of revenues or what is taxed, what is not taxed under that proposal, setting aside the political implications of taxing food and clothing and those issues which are, you know, appropriate here. That number that will ultimately be affixed to what that bill generates is a critical number in terms of its viability, you know, whether it actually does what it says it is going to do.

So that is why it is in Appropriations. Beyond that, I am not inclined to commit to reporting it to the Finance Committee. Obviously, at some point in time that a bill is on the floor of the House, my decision not to report it or refer it or suggest that the Speaker refer it to Finance Committee is ultimately, you know, open for floor debate and you or any other members at the time that that might appear on the floor are free to make a motion that the bill be referred to Finance and subject it to a vote of the full House.

So I do not look at it as though I am saying, no, not never. I am just saying I am not inclined to commit to that. However, if that is the will of the House one day, then it will be done.

Mr. DeWEESE. Thank you very much.

My interrogation is concluded. Just a couple of observations-

The SPEAKER. The gentleman is in order.

Mr. DeWEESE. —and then the House can be in recess.

# STATEMENT BY DEMOCRATIC LEADER

Mr. DeWEESE. I did not hear the thud, but I would never allege, to use my own Greene County metaphor, that the honorable gentleman fell off a load of pumpkins.

The Finance Committee will not get this proposal if my honorable colleague has anything to do about it, because he knows that it will receive a richly deserved burial within the Finance Committee. He is, of course, correct that it should make a momentary passage through the Appropriations Committee. That is one thing that he and I certainly agree on. I am sure other members on both sides of the aisle realize that the Commonwealth Caucus numbers historically, at least in many of our perspectives, have not added up, Mr. Speaker. There has been a chasm in the amount of revenue that would be needed versus the amount of money that would be generated. So it certainly should have a moment's respite in the Appropriations Committee, and our analysts there should tell us, if these bills were enacted, how much money would be raised, how much money would we need to raise if we did not raise enough, et cetera, et cetera. So I realize why it should be there for a short time.

But I saw the honorable gentleman, Mr. Smith, today at his news conference. It was published or at least video-screened for a statewide audience, and the honorable gentleman, Mr. Smith, indicated at that conference that there were at least thoughts in this room, in our setting, that property tax would be supplanted by a variety, a menu, a medley of different taxes, and if we are going to change the amount of focus on food and clothing, if we are going to talk about services, which many of us are very, very apprehensive about - legal, accounting, engineering, architectural, and so forth - we are very, very dubious about food and clothing also, but by virtue of the fact that the lion's share of the Commonwealth Caucus, this discrete entity of 18 or 20 - maybe more supporters are in the wings, I do not know but the lion's share, all but one of the formally recognized members are from the honorable gentleman's Republican Caucus, and if these taxing issues are going to be delineated, if these taxing issues are going to be explored, if we are going to have the passionate overview of Chairman Leh on the Republican side and Chairman Levdansky on the Democratic side and these subcommittees, subcommittees, special session the Republican Party, the Grand Old Party, went to our Governor and said, Governor Rendell, we want a special session on taxes. So then our reaction is, we put together a special subset of entities within the framework of the Finance Committee - subcommittees to explore this big, big picture, which is potentially a political albatross around all of our necks. We must do something on property tax reform or we shall suffer the consequences, and the only way to do it, in my view, is through the recognized structure of the Finance Committee.

The honorable gentleman will not commit. I accept that. He is honest. I hope that somewhere in his heart of heart he leans in that direction. But nevertheless, let it be asserted from this podium, from this side of the aisle, that most of the Democratic members want this property tax debate in the ensuing weeks between now and the yuletide to take place in the Finance Committee. If it does not, at least we made the argument here today.

The SPEAKER. The Chair thanks the gentleman.

## STATEMENT BY MAJORITY LEADER

The SPEAKER. The Chair recognizes the majority leader, the gentleman, Mr. Smith.

Mr. S. SMITH. Thank you, Mr. Speaker.

Just a short response, if I may.

One thing that is clear about the issue of property taxes is that through the course of last spring, the expectations of the general public were increased significantly because of the somewhat inflated proclamations that a billion dollars in gaming money was going to be driven out through Act 72, and I think the general public, when they hear a billion dollars, infers that that is going to be a huge amount of money in property tax relief, and surely that is enough to eliminate, you know, my property taxes, when in fact we all know that the property tax issue is tenfold of that billion dollars, and that is the high number. I do not think there are too many people that want to stake their reputation that a billion dollars will actually flow in the very near future. That is not the point of argument at this moment though.

The point of argument is that the expectations were increased significantly throughout the spring. As the school districts across the Commonwealth indicated four out of five that they did not want to participate in Act 72, there was a cry that came out that we should force that Act 72 down their throats, that we should just mandate it upon them, and that cry emerged at the end of May when the deadline was upon us and the first part of June. At that juncture we, at least through the leadership in the Republican Caucus, indicated that we did not think it was a good idea to overreact or respond quickly to that Act 72 issue simply because the gaming money was not sitting in a pot waiting to be distributed, so there was some time, if you will, to let the dust settle to where we could come back and take a more deliberative look and try to increase the level of success in terms of meeting the public's expectations relative to property tax reform issues. That was our decision to wait. We were not going to rush into something last June.

Consequently, with the Governor calling the special session, it clearly puts a special focus on this issue, and I am supportive of that. I do not know if the gentleman, Mr. DeWeese, is indicating he does not really think it is necessary, but the fact is, we have a focus on it. That is where we are here today, and regardless of what committee a bill is referred to or what track it takes to come to the floor, I think the challenge before us is to look at all of the various proposals that have been out there to try to determine, what is the problem we are trying to solve and who is it that we are trying to help when we solve this problem? That is a different answer to different people probably, but we need to come to some consensus, some uniformity, in terms of those types of questions.

The fact that the bill was referred to one committee or another does not impair its ability to be considered; does not reduce it in any way, shape, or form. At some point in the course of this special session, it is my expectation that we will either come to a consensus, as I am talking about, or we will deal with these issues individually.

Now, we can throw— We could take 10 different property tax plans that have been proffered within this House and we could bring them all up here, and arguably, they would all pass, and they could go over to the Senate, at which point in time the Senate would certainly be in the driver's seat to pick and choose and make the tough decision and send maybe one of those back

in some way, shape, or form. I do not think that is the desired route, nor is it the responsible route.

So while some members may be agitated over a particular plan that they really like or they really hate, my goal is not to put anybody on the spot relative to that particular legislation that may be egregious to someone. My goal is to work these bills over, to build the consensus, and it is clearly going to have to be a bipartisan consensus, I think, so that the product that we move from this House is something that truly fulfills and meets the expectations of the public, who have been promised property tax reform over and over by, you know, political leaders within this Commonwealth.

So I do not see that the committee into which the bill is referred is a signal of life or death. The fact is, we are looking at everything that has been introduced and we are going to try to boil that down and refine it into something that is workable and that solves this dilemma for Pennsylvania.

Thank you, Mr. Speaker.

Mr. DeWEESE. I cannot resist, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The gentleman, Mr. DeWeese.

Mr. DeWEESE. Again, politely and respectfully, one would hope that the amount of focus, the amount of time, the amount of TLC, the amount of tender loving care, that these tax reform bills receive from any committee of the majority leader's choosing will receive a whole lot more attention and focus than the razzle-dazzle, harum-scarum, slipshod, 99-mile-an-hour way that Bob Allen's bills on the spending cap just received in the Appropriations Committee. That came out of here with vertiginous dizziness, and nobody had hardly any idea of what was going on. So I hope that we will not be as cavalier and condescending and nonchalant as we do property tax reform.

We have got a great committee setup. It does not make any sense to me to reinforce, to bring in extra battalions in the Finance Committee just a couple of weeks ago to have special session on property tax reform and to have this entity called the Finance Committee given short shrift. It should be the epicenter, it should be the robust dynamic center of the debate, and the debate should ensue for the next several weeks, and the Republican Party should give us a property tax reform proposal sometime in November.

Mr. S. SMITH. Mr. Speaker, I am sorry that the minority leader has no respect for the members, the minority members at least, of the Appropriations Committee. I have all the faith in the world in the majority members.

Clearly, we are about trying to get this done. If you want to like tout this argument that where the bills are sent to and who gets their first crack at them, I look at that as a side show, if you will, Mr. Speaker. The bottom line is, we are going to be judged on what the ultimate product is and our goal is to produce something good.
