Mr. SANTONI called up HR 506, PN 3061, entitled:

A Resolution paying tribute to and honoring the memory of Sergeant William V. Fernandez, a member of the Pennsylvania Army National Guard's 2nd Brigade Combat Team, who tragically lost his life on September 19, 2005, while on active duty in Iraq.

On the question,

Will the House adopt the resolution?

The SPEAKER. On that question, the Chair recognizes the gentleman, Mr. Santoni.

Mr. SANTONI. Thank you, Mr. Speaker.

Mr. Speaker, it is with a heavy heart that I rise before you today. So many times resolutions on this House floor celebrate happy occasions. We all have applauded many athletes or teams who came here to celebrate a significant achievement or citizens

who achieved noteworthy milestones or goals. And while we will not overlook or disregard the tragedy that brings the family and friends of Army Sgt. William Fernandez here today, I would also like to think that we are here to celebrate a significant achievement.

We are here to celebrate a boy who overcame the struggles of his teenage years to become a man of honor and courage. His high school years were a difficult time for William Fernandez. A desire to hang out with his friends on the street kept him from attending classes regularly, and his grades showed it. But even at a young age, he realized he was in trouble and worked to find a way out.

William made the difficult decision to drop out of high school and followed in his brother Carlos's footsteps by joining the military. The Army, in a sense, saved him from an uncertain future and gave him the discipline, purpose, and direction he needed to turn his life around. He became a specialist in the Army and earned his GED (general educational development). He served for 8 years, including time in Panama, as part of Operation Just Cause and ended up living in California, where he graduated from a police academy and trained as a paramedic.

But William eventually returned to his roots in Reading, Berks County, and the military remained in his blood, because upon his return to Pennsylvania, he signed up to serve with his brother, Carlos, in the Pennsylvania Army National Guard. It was while serving in Iraq with the Pennsylvania Army National Guard's Troop B, 1st Squadron, 104th Calvary Regiment, 28th Infantry Division, that William's life would tragically come to an all too early end.

William and two other men were killed on September 19, 2005, when an improvised explosive device detonated near their vehicle while on patrol in Ar Ramadi, Iraq. He leaves behind a multitude of family and loved ones and the countless others whose lives he touched.

It would be impossible to calculate the value of the friendships he developed with fellow soldiers, of the bridges he built with Iraqi citizens he came into contact with, or to measure the void left behind in the wake of his death. President John F. Kennedy once said, "As we express our gratitude, we must never forget that the highest appreciation is not to utter words, but to live by them."

The life of William Fernandez is an example and a challenge – to make ourselves better citizens, to dedicate ourselves to a cause we believe in, and to leave the world a better place than we found it. William Fernandez did that, and for that, the residents of Berks County, our Commonwealth, and our nation share in extending to the family and friends of William Fernandez our deepest condolences and our immeasurable gratitude for his sacrifice.

The SPEAKER. For what purpose does the gentleman, Mr. McCall, rise?

Mr. McCALL. Thank you, Mr. Speaker.

Mr. Speaker, I would like to submit some remarks for the record.

I recently had a World War II ceremony in my district honoring World War II veterans, and I have the list of the names of those honorees. I would like to submit them for the record.

The SPEAKER. The gentleman is in order.

Mr. McCALL submitted the following remarks for the Legislative Journal:

Mr. Speaker, last week I had the privilege of honoring the World War II veterans in my legislative district. I was proud to present these members of "The Greatest Generation" with a commemorative medal and special citation on behalf of the Pennsylvania House of Representatives for their service to our nation. They fought for freedom. They answered the call to protect and defend. When they went to war, the hearts and hopes of the people they left behind went with them

After Pearl Harbor was attacked, many of these young people left high school and college to enlist in the military. Some of them had never even been out of Carbon County before, and now they were going halfway across the world to fight in places they had never heard of and help defend people they did not know.

These soldiers, sailors, marines, and airmen displayed their bravery of arms and their determination at Midway, at Guadalcanal, on the beaches of Normandy, in the snowy forests at Bastogne, in the skies over Bremen, at Monte Cassino, in Tunisia, and in 100 other places and battles. They helped to liberate citizens who had become prisoners in their own countries.

After the war they came home still holding the attitude that any obstacle could be overcome, and with that attitude, you helped to build the greatest nation the world has ever known.

We often think of a hero as someone who accomplishes incredible deeds or achieves some great feat. To me, a hero is simply someone who continues on despite fear, despite obstacles, despite any circumstance, to complete a task. That is why we can consider each of the veterans who fought in World War II a hero or heroine, because despite being young, despite being afraid, despite extreme weather or limited supplies, despite anything that came their way, they brought down the Third Reich and the Empire of Japan as their mighty arms of tyranny pulled the world closer in a suffocating embrace.

We can honor these citizens by remembering their achievements not just on Veterans Day or on special occasions but every day as we go about our daily lives by trying to make a difference in today's world the way they made a difference in theirs.

The medals and citations are only a small token of thanks from all the people in the Commonwealth to these veterans and their families, but they represent a deep well of gratitude for their service to our country. I want to let the World War II veterans of Carbon County and all of our veterans know how much we appreciate all they have done for us.

A Resolution honoring the life and extending condolences for the supreme sacrifice of Lance Corporal Patrick Brian Kenny, 2nd Battalion, 2nd Marine Regiment, 2nd Marine Division, who tragically lost his life on October 6, 2005, while in the service of his country when his vehicle hit a homemade roadside bomb in Karmah, Iraq.

Mr. PETRONE. Thank you, Mr. Speaker.

Mr. Speaker, we have in this hallowed House of Representatives from time to time paid tribute to many true heroes: Medal of Honor winners such as Mitchell Page from the Battle of Guadalcanal; Gino Merli from the Battle of the Bulge; members of the 506th Regiment Band of Brothers; and survivors of the sinking of the Yorktown and the Battle of Midway. They all had the same feeling that it is most appropriate that the Medal of Honor be given to those who did not come back, for they gave up all of their tomorrows for our todays; heroes like LCpl. Patrick Kenny.

It is with great sorrow that I honor LCpl. Brian Patrick Kenny, a member of the United States Marine Corps, from the Borough of Emsworth. Brian was a very well-respected and well-liked young man. He enlisted in the Marines immediately after graduating from Avonworth High School in 2003. Brian was the captain of his football team and served as an altar boy for his local church.

Lance Corporal Kenny was serving on his second tour of Iraq when he was killed. His first tour of Iraq brought him to Fallujah and his second brought him to the Al Anbar Province. Corporal Kenny was killed when the vehicle he was traveling in hit a roadside bomb in Karmah, Iraq. He served for 2 years in the 2d Battalion, 2d Marine Regiment, 2d Marine Division.

During his service to his country, Lance Corporal Kenny was honored by receiving many awards and medals. These include a Combat Action Ribbon for service in Iraq, Purple Heart, Operation Iraqi Freedom Medal, a National Defense Service Medal, and his Iraq Campaign Medal, a Global War on Terrorism Expeditionary Medal, a Global War on Terrorism Service Medal, and a Sea Service Deployment Ribbon.

His parents have noted that there were over 1,200 people at his funeral, indicating the great impact he had on all those who knew him. Many of his teachers, classmates, teammates, and friends were present at his funeral.

His father said, he was a wonderful human being, a caring person who always put others first. He always tried to make someone feel good.

In addition to his parents, Charles and Patricia, Patrick is survived by three sisters: Maggie, Molly, and Pvt. Katy Kenny, also a member of the U.S. Marine Corps, who was inspired to join her brother.

Heroes, yes, and do not forget he gave up all of his tomorrows for our today.

- § 1804. Commonwealth Court.
- (a) Judges.—Except as set forth in subsection (b), a judge of the Commonwealth Court shall receive as an annual salary the base salary of a judge of the United States District Court plus all adjustments under section 1810 (relating to cost of living).
- (b) President Judge.—In addition to the salary under subsection (a), the President Judge of the Commonwealth Court shall receive \$5,000.
- § 1805. Courts of common pleas.
- (a) Judges.—Except as set forth in subsection (b), a judge of a court of common pleas shall receive as an annual salary the base salary of a United States magistrate judge plus all adjustments under section 1810 (relating to cost of living).
- (b) President judges.—In addition to the salary under subsection (a), the president judge of a court of common pleas shall receive additional compensation in accordance with the following schedule:
 - (1) Allegheny County, \$2,500.
 - (2) Philadelphia County, \$3,000.
 - (3) Judicial districts having six or more judges, \$1,300.
 - (4) Judicial districts having one to five judges, \$650.
 - (5) Administrative judges of the divisions of the Court of Common Pleas of Philadelphia County with divisions of six or more judges, \$1,300.
 - (6) Administrative judges of the divisions of the Court of Common Pleas of Philadelphia County with divisions of five or fewer judges, \$650.
 - (7) Administrative judges of the divisions of the Court of Common Pleas of Allegheny County with divisions of six or more judges, \$1,300.
 - (8) Administrative judges of the divisions of the Court of Common Pleas of Allegheny County with divisions of five or fewer judges, \$650.
- § 1806. Philadelphia Municipal Court.
- (a) Judges.—Except as set forth in subsection (b), a judge of the Philadelphia Municipal Court shall receive as an annual salary the base salary of a United States magistrate judge minus \$3,450 plus all adjustments under section 1810 (relating to cost of living).

- (b) President judge.—In addition to the salary under subsection (a), the President Judge of the Philadelphia Municipal Court shall receive \$2,250.
- § 1807. Philadelphia Traffic Court.
- (a) Judges.—Except as set forth in subsection (b), a judge of the Philadelphia Traffic Court shall receive an annual salary equal to 50% of the annual salary determined under section 1805(a) (relating to courts of common pleas) plus \$3,800.
- (b) President judge.—In addition to the salary under subsection (a), the President Judge of the Philadelphia Traffic Court shall receive \$650.
- § 1808. Magisterial district judges.

A magisterial district judge shall receive an annual salary equal to 50% of the annual salary determined under section 1805(a) (relating to courts of common pleas).

§ 1809. Senior judges.

- (a) Amount.—The compensation payable to a senior judge of a court of common pleas, a senior Commonwealth Court judge, a senior Superior Court judge and a senior Supreme Court justice, assigned pursuant to section 4121 (relating to assignment of judges), and a senior Philadelphia Municipal Court judge assigned pursuant to section 4124 (relating to assignment of senior Philadelphia Municipal Court judges) shall be \$456 per day plus all adjustments under section 1810(a)(1)(ii) (relating to cost of living). In any calendar year the amount of compensation which a senior judge shall be permitted to earn as a senior judge shall not, when added to retirement income paid by the Commonwealth for the senior judge, exceed the annual salary payable by the Commonwealth to a judge then in regular active service on the court from which the senior judge retired.
- (b) Limitation.—In any calendar year, the amount of compensation which a senior judge assigned to serve on a court referred to in section 1806 (relating to Philadelphia Municipal Court), 1807 (relating to Philadelphia Traffic Court) or 1808 (relating to magisterial district judges) shall be permitted to earn as a senior judge shall not, when added to retirement income paid by the Commonwealth to that senior judge, exceed the compensation payable by the Commonwealth to a judge then in regular active service on the court from which that senior judge retired.

- (2) If the salary of the applicable designated Federal official has been increased in the previous 12-month period after not having been increased in one or more previous consecutive 12-month periods, the current annual salaries under this chapter shall be increased by the greater of:
 - (i) the percentage change in the Consumer Price Index for All Urban Consumers (CPI-U) for the Pennsylvania, New Jersey, Delaware and Maryland area for the most recent 12-month period for which figures have been officially reported by the United States Department of Labor, Bureau of Labor Statistics; or
 - (ii) the excess of the percentage of the increase in the salary of the applicable designated Federal official over the cumulative percentage increase of the change in the Consumer Price Index for All Urban Consumers (CPI-U) for the Pennsylvania, New Jersey, Delaware and Maryland area for the same period of time between the most current increase in the salary of the applicable designated Federal official and the immediate prior increase.
- (b) Administration.—The annual salaries as adjusted under subsection (a) shall be published in the Pennsylvania Bulletin by the Court Administrator of Pennsylvania by January 1, 2007, and by each January 1 thereafter.

- (a) Senate.—Annual salaries for legislative officers and leaders of the Senate are as follows:
 - (1) Except as set forth in paragraph (5)(i), a committee chairman shall receive 55% of the base salary of a member of the

United States House of Representatives plus all adjustments under section 1104 (relating to cost of living).

- (2) A committee vice chairman shall receive 52.5% of the base salary of a member of the United States House of Representatives plus all adjustments under section 1104.
- (3) The following shall receive the salary determined under paragraph (1) plus 20% of that salary:
 - (i) Caucus Administrator.
 - (ii) Caucus Secretary.
 - (iii) Caucus Policy Chairman.
 - (iv) Deputy Whip.
- (4) The Caucus Chairman shall receive the salary determined under paragraph (3) plus 8% of that salary.
- (5) The following shall receive the salary determined under paragraph (4) plus 8% of that salary:
 - (i) Appropriations Chairman.
 - (ii) Whip.
- (6) A Floor Leader shall receive the salary determined under paragraph (5) plus 8% of that salary.
- (7) The President pro tempore of the Senate shall receive the salary determined under paragraph (6) plus 8% of that salary.
- (b) House of Representatives.—Annual salaries for legislative officers and leaders of the House of Representatives are as follows:
 - (1) Except as set forth in paragraph (5)(i), a committee chairman shall receive 55% of the base salary of a member of the United States House of Representatives plus all adjustments under section 1104.
 - (2) A committee vice chairman and a subcommittee chairman shall receive 52.5% of the base salary of a member of the United States House of Representatives plus all adjustments under section 1104.
 - (3) The following shall receive the salary determined under paragraph (1) plus 20% of that salary:
 - (i) Caucus Administrator.
 - (ii) Caucus Secretary.
 - (iii) Caucus Policy Chairman.
 - (4) The Caucus Chairman shall receive the salary determined under paragraph (3) plus 8% of that salary.
 - (5) The following shall receive the salary determined under paragraph (4) plus 8% of that salary:
 - (i) Appropriations Chairman.
 - (ii) Whip.
 - (6) A Floor Leader shall receive the salary determined under paragraph (5) plus 8% of that salary.
 - (7) The Speaker of the House of Representatives shall receive the salary determined under paragraph (6) plus 8% of that salary.
 - (c) Limitations.-
 - (1) An individual entitled to receive an annual salary under this section shall be ineligible to concurrently receive an annual salary under section 1102 (relating to members of the General Assembly).
 - (2) An individual shall be ineligible to concurrently receive more than one annual salary under this section.
 - (3) An individual entitled to receive an annual salary under subsection (a)(3), (4), (5), (6) or (7) shall be ineligible to concurrently receive an annual salary under subsection (a)(1) or (2).
 - (4) An individual entitled to receive an annual salary under subsection (b)(3), (4), (5), (6) or (7) shall be ineligible to concurrently receive an annual salary under subsection (b)(1) or (2)

 - (i) the percentage change in the Consumer Price Index for All Urban Consumers (CPI-U) for the Pennsylvania, New Jersey, Delaware and Maryland area for the most recent 12-month period for which figures have been officially reported by the United States Department of Labor, Bureau of Labor Statistics; or

The following words and phrases when used in this chapter shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Base salary." The salary for the designated Federal official as of January 1,2007.

- (a) Governor.—The Governor shall receive an annual salary equal to 85% of the base salary of the Vice President of the United States plus all adjustments under section 1105 (relating to cost of living).
- (b) Lieutenant Governor.—The Lieutenant Governor shall receive an annual salary equal to:
 - (1) the salary under 46 Pa.C.S. § 1103(a)(7) (relating to legislative officers and leaders); plus
 - (2) \$15,000.
- (c) Cabinet.—Each of the following officers shall receive an annual salary equal to 85% of the base salary of the Attorney General of the United States plus all adjustments under section 1105:
 - (1) Adjutant General.
 - (2) Secretary of Aging.

 - (5) Secretary of the Commonwealth.
 - (6) Secretary of Community and Economic Development.

§ 1103. State Treasurer, Auditor General and Attorney General.

Each of the following officers shall receive an annual salary equal to 94% of the base salary of the Attorney General of the United States plus all adjustments under section 1105 (relating to cost of living):

- (1) State Treasurer.
- (2) Attorney General.
- (3) Auditor General.

§ 1104. Additional salary prohibited.

No officer listed in this chapter shall receive additional salary for services rendered to the Commonwealth in any capacity.

§ 1105. Cost of living.

- (a) Increase.—On January 1, 2008, and each January 1 thereafter, the current annual salaries under section 1102(a) and (c) (relating to Governor, Lieutenant Governor and Cabinet) and 1103 (relating to State Treasurer, Auditor General and Attorney General) shall be increased as follows:
 - (1) Except as set forth in paragraph (2), by the greater

of:

- (i) the percentage increase in the salary of the applicable designated Federal official during the immediately preceding period from December 1 through November 30; or
- (ii) the percentage increase in the Consumer Price Index for All Urban Consumers (CPI-U) for the Pennsylvania, New Jersey, Delaware and Maryland area, for the most recent 12-month period for which figures have been officially reported by the United States Department of Labor, Bureau of Labor Statistics.
- (2) If the salary of the applicable designated Federal official has been increased in the previous 12-month period after not having been increased in one or more previous consecutive 12-month periods, the current annual salaries under sections 1102(a) and (c) and 1103 shall be increased by the greater of:
 - (i) the percentage change in the Consumer Price Index for All Urban Consumers (CPI-U) for the Pennsylvania, New Jersey, Delaware and Maryland area for the most recent 12-month period for which figures have been officially reported by the United States Department of Labor, Bureau of Labor Statistics; or
 - (ii) the excess of the percentage of the increase in the salary of the applicable designated Federal official over the cumulative percentage increase of the change in the Consumer Price Index for All Urban Consumers (CPI-U) for the Pennsylvania, New Jersey, Delaware and Maryland area for the same period of time between the most current increase in the salary of the applicable designated Federal official and the immediate prior increase.
- (b) Administration.—The annual salaries as adjusted under subsection (a) shall be published by the Secretary of the Budget in the Pennsylvania Bulletin by January 1, 2008, and by each January 1 thereafter.
 - Section 4. This act shall apply as follows:
 - (1) Except for the application of 46 Pa.C.S. § 1107, the addition of 46 Pa.C.S. §§ 1101 through 1104 and 1106(a) shall apply to members of the General Assembly elected after the effective date of this act.
 - (2) The addition of 46 Pa.C.S. § 1107 shall apply to members of the General Assembly elected prior to the effective date of this act.

- (e) Philadelphia Municipal Court.—The President Judge of the Philadelphia Municipal Court shall receive an annual salary of \$103,000. The annual salary for the other judges of the Philadelphia Municipal Court shall be \$101,250.
- (f) Philadelphia Traffic Court.—The President Judge of the Philadelphia Traffic Court shall receive an annual salary of \$55,000. The annual salary for the other judges of the Philadelphia Traffic Court shall be \$54,500.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Chair recognizes the gentleman, Mr. Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

Would the gentleman, Mr. Smith— I would like to interrogate the maker of the amendment, Mr. Smith.

The SPEAKER. The gentleman, Mr. Smith, indicates that he will stand for interrogation. The gentleman is in order.

Mr. VITALI. Perhaps the interrogation might be best started off by just a brief explanation of the amendment.

Mr. S. SMITH. Mr. Speaker, I was prepared to give the members a little bit of a summary of this amendment, but by and large, it is an amendment that would repeal the pay raise for all three levels of State officials and it would take the compensation back to essentially what it was on the first of July, July 6.

Mr. VITALI. Thank you, Mr. Speaker.

Now, what I am trying to get at is what this will do. Does it change in any way what would have happened should we never have passed the initial pay raise bill? In other words, what differences remain, is what I am trying to get at.

Mr. S. SMITH. Mr. Speaker, to the best of our ability, and I am 99.9 percent confident that the language in this amendment returns the compensation plan back to what it was prior to July 7. So there are no differences in tomorrow, tomorrow being when this, not literally tomorrow but in the next few days when this bill presumably would be signed into law, and what the compensation would have been on July 6. To the best of my knowledge, to the best of my ability, that is what is embodied in this amendment.

There are some extra references in this amendment. It is a little bit lengthy, and that is due to some recent court rulings which basically suggest that when you repeal a bill that repealed something else, that does not automatically reinstate. It gets kind of double-talk sounding, but it is the court ruling that we

are trying to deal with, and that is why we had to make reference clear back to the 1995 compensation law.

Mr. VITALI. So when I look at section 7 of this bill, which starts on page 14, line 33, and goes to page 16, line 27, that is just to get things back to the way they were on July 6 and does not change anybody's compensation level. Is that correct?

Mr. S. SMITH. That is correct; yes, sir.

Excuse me, Mr. Speaker. It changes them in that it reduces the salaries back to what they were on July 6.

Mr. VITALI. In other words, no one at the end of the day is getting more in salary than they would have had this not—No officer of the Commonwealth, no member of the judiciary, executive branch, or legislature is getting more under this, would get more under this amendment than they would have, had we never enacted that piece of legislation on July 6?

Mr. S. SMITH. Mr. Speaker, that is my understanding and interpretation and intent with this amendment.

Mr. VITALI. Thank you, Mr. Speaker.

The SPEAKER. Does the gentleman, Mr. Metcalfe, wish to be recognized?

Mr. METCALFE. Thank you, Mr. Speaker.

Mr. Speaker, if I could ask a brief question of the prime sponsor of the amendment?

The SPEAKER. The gentleman indicates he will stand for interrogation. The gentleman is in order and may proceed.

Mr. METCALFE. Thank you, Mr. Speaker.

Mr. Speaker, the amendment that is before us has some legislative intent language that has been put into the bill. Would you be able to expand upon that a little bit for the membership as far as what the intent of that language is?

Mr. S. SMITH. Mr. Speaker, if you will recall, over the past 2 weeks one of the key areas of disagreement, if you will, between the House and the Senate was how to structure this bill as it relates to all three branches of State government.

The language in the front end of this amendment that deals with intent is our best effort to legitimately put forth what I believe is the absolute intent of this legislative body, both the House and the Senate, quite frankly, to state that as directly and as consistently as possible with the provisions of the State Constitution. So all of those parts that are enumerated in the intent section are there just to best lay forth for future interpretation, you know, what our actual intent is with the enactment of this legislation.

Mr. METCALFE. Thank you, Mr. Speaker.

If I could make a brief comment?

The SPEAKER. The gentleman is in order.

Mr. METCALFE. Thank you, Mr. Speaker.

Mr. Speaker, I appreciate the gentleman's answer on the amendment. I appreciate him putting forth this language in the legislative intent section, which I believe makes it clear that this bill applies to all three branches of State government and that this pay raise is a broadly applied pay raise repeal for all three branches. So thank you very much for this language, and I look forward to passing this amendment and passing this repeal bill that will repeal the legislative pay raises for all three branches of our State government.

Thank you, Mr. Speaker.

The SPEAKER. Does the gentleman, Mr. Tangretti, seek recognition? The gentleman is in order.

Mr. TANGRETTI. Thank you, Mr. Speaker.

I, too, would like to ask the majority leader a couple of questions.

The SPEAKER. The gentleman is in order.

Mr. TANGRETTI. Mr. Speaker, I wonder if the majority leader could enlighten us as to whether this is an agreement among all of the principals associated with this language and with this effort.

Mr. S. SMITH. Mr. Speaker, I cannot speak in absolute terms for anyone other than myself in reality, but obviously, we have worked this out within our body, and to the best of my understanding and it is my belief that the language in this amendment is and will be agreeable to the Senate. We have certainly discussed the key elements of this with them, and you know, if your concern is whether or not they are going to proceed over the next 3 days to run this bill and put it on the Governor's desk, it is my full expectation that that is in fact what will happen.

Mr. TANGRETTI. Thank you very much.

Thank you, Mr. Speaker.

The SPEAKER. For the information of the members, the Senate has been known to change its mind, Mr. Tangretti.

Mr. DeWeese, there are—

The House will be at ease.

The Chair recognizes the gentleman, Mr. DeWeese.

Mr. DeWEESE. Thank you very much, Mr. Speaker, for recognizing me. I see the gentleman, Mr. Bunt, on the far horizon. I always know that when I have the honorable gentleman's attention, that is a good sign for focus from the GOP.

These penultimate moments before the pay raise is rescinded merit a few observations, I believe, from the minority pulpit of a couple things to observe. One, retrospectively, Mr. Speaker, we made some mistakes, and I obviously was involved and complicit in that phenomenon.

The four things that we should have done differently, and this is a very, very momentous vote for the House to rescind its pay raise; there is no way around that issue, so from the microphone and from our district offices and in meetings, whether it is at one of Mr. Metcalfe's pancake breakfasts or one of Mr. Levdansky's town meetings, we all have to go back, Mr. Speaker, and discuss these matters with our constituency, but if we had done four things differently, I am confident we would not be here, and those were mistakes that we made. We should have probably asked for fewer dollars; two, we should have demolished the idea of unvouchered expenses that had been a part of our process, sanctioned by the Supreme Court in the 1980s and 1990s; number three, we should not have taken a dime until after the next election; and number four - and this is, I think, a specious number four, but nevertheless, the media has succeeded and we have failed in projecting this - we should have done it at 3 in the afternoon rather than in the wee hours.

Now, notwithstanding the fact that we have probably passed 30 or 35 percent of the important bills during my long tenure in this building in the wee hours, that is just a phenomenon. I have said it many, many times. That is something that the British Parliament has done for 300 years. It is something Mr. Samuelson reminds me that that does not make it a good thing, but we have passed so many things, the democracy that we experience in this chamber is sometimes cumbersome and sometimes elongated and sometimes, oftentimes for the past 30 years and way, way before I came here, Mr. Speaker,

we passed things at night, but it was a terrible perception and that was our fourth mistake.

Now, having realized that – moving to my second category, and I only have three – the whip and I on the minority side last time cast a symbolic vote, not a substantive vote. We knew that the proverbial Niagara Falls of "yes" votes was going to cascade and overwhelm us, but in that process I think the honorable gentleman from Beaver and I felt like we were union leaders at that point, metaphorically anyway. The gentleman from Beaver County has represented a hearty phalanx of steelworkers, Aliquippa, Beaver Falls, the Lehigh- Excuse me; the Lehigh Valley does have their steelworkers, but in the Beaver Valley, Mike is known as a, among other things, as a steelworker's representative, and I come from the coal fields south of Pittsburgh, and I am very, very well acquainted with UMWA (United Mine Workers of America) leadership, UMWA contracts, UMWA politics, and I thought and still believe that a symbolic protest vote was appropriate.

Bringing us to the third and final observation, Mr. Speaker, the inexorable momentum of the moment is tangible. This is going to pass overwhelmingly, and we will have to go back and try to do something else another day, another year, another session, but it is not totally inappropriate for this General Assembly to consider its compensation from time to time. Whether the mechanism will be a commission as was founded three or four decades ago, whether it will be another rough-and-tumble vote, I am certain it will be debated much more aggressively, much more openly in the broad light of day.

The Governor said that he was against the pay raise most recently, that was his pronouncement, but he was for it for judges. The Governor obviously knows that somewhere approaching 80 percent of this money is going to go to judges, so when we cast this vote in a little while, the record will be, as was entertained in the brief debate by the gentleman from Butler, the gentleman from Westmoreland, the gentleman from Delaware, approaching the majority leader, the record will be unequivocal in the General Assembly's House chamber that this rescission is for House and Senate and executive and judicial officers. It cannot be made more unequivocal on the record. My speculation is that the Supreme Court will vouchsafe the authenticity of their pay raise somewhere down the line and this will go to Federal court, but tonight's vote is a rescission of a pay raise for the judiciary also. If we were to just rescind a House vote, as I said a week ago, and a Senate and legislative vote, Mr. Speaker, we are only talking about 20, 25 percent of the pie. That has to be realized.

We are the General Assembly. We have taken the grief and many people would aver that we deserved the grief, but the bottom line is, the amount of dollars going into this putative pay raise, the lion's share, was going to the judiciary. Tonight's vote, notwithstanding what I would opine will be a reversal at the Supreme Court level, says that this vote rescinds General Assembly, judicial, and executive pay raises.

Those were the three points I wanted to make. Thank you very much, Mr. Speaker, for the microphone.

The SPEAKER. The Chair thanks the gentleman.

Does the gentleman, Mr. Smith, wish to be recognized? The gentleman is in order.

Mr. S. SMITH. Very briefly, Mr. Speaker.

Mr. Speaker, just let me kind of supplement a couple of the comments that I made in response to the interrogations.

Obviously, the clear intent of this bill is to deal with all salaried officers of this Commonwealth. I believe the amendment and ultimately the bill that we have before us should pass constitutional muster. It is something that we have put a lot of time and effort into trying to meet all the various elements of such challenges.

Probably the most key thing in reflecting on this exercise over the last few weeks is that clearly it has put a cloud over the legislature in terms of our ability to get things done. It concerns me in that regard, and as we hope to move forward in the coming weeks, to move forward with a positive agenda to put Pennsylvania back on track, hopefully dispensing with this would at least allow us, I do not know what will happen in the editorial pages and in the newsrooms, but at least in this room, that we will be able to return our focus to the business of the people, to focus on the issues that are most important relative to tax reform, health-care issues, jobs, and economy, some of the basic issues that we know are important, and that is really what we are about today, is to clear the slate so that we can get to that agenda, and I would ask the members, Mr. Speaker, for an affirmative vote on the amendment and the bill.

The SPEAKER. The Chair thanks the gentleman.

The SPEAKER. The Chair recognizes the gentleman, Mr. George. Mr. George.

Mr. GEORGE. Mr. Speaker, I have an amendment. Would my amendment be in order, Mr. Speaker?

The SPEAKER. No, Mr. George.

Mr. GEORGE. Well, Mr. Speaker, if I may-

The SPEAKER. Mr. George, your amendment clearly goes to a fiscal code. The amendment, the bill that is before us amends Titles 42, 71, and 46. Yours is clearly out of order, Mr. George.

Mr. GEORGE. With the Speaker's permission, would you allow me 2 minutes to elaborate on this, just 2 minutes?

The SPEAKER. Mr. George, if it were up to me by myself, I would listen to you all evening, but it is up to the membership. Under that, the gentleman, Mr. George, is in order until someone objects.

Mr. GEORGE. Well, if somebody objects, then I will just make a move that we suspend the rules, but it is not my position or my hope to embarrass my colleagues. We have been in this slugfest for too long now. We have been doing nothing for nobody, including ourselves, and we owe it to these people in Pennsylvania to do the people's business, and so what I am saying, Mr. Speaker, because I believe in the Republicans on that side and the Democrats on this side and we as rank and file, I have been here 31 years, and I have never seen what I am

seeing today, but I am willing to believe that things will get much better for the people in Pennsylvania.

I was going to introduce a LIHEAP (Low-Income Home Energy Assistance Program) amendment. You can laugh or you can jangle, but you will not be cold this year. A lot of other people will be. So my apology to you, Mr. Speaker, my apology to my friends, Mr. Smith and to Mr. DeWeese, but I am not apologizing for the fact that I believe when we come back, we better start attending to those things that the people sent us down here to attend to.

CONSIDERATION OF HB 1956 CONTINUED

The SPEAKER. Would the gentleman, Mr. McGeehan, please come to the rostrum.

(Conference held at Speaker's podium.)

The SPEAKER. The Chair recognizes the gentleman from Philadelphia, Mr. McGeehan.

Mr. McGEEHAN. Thank you, Mr. Speaker.

And thank you and the House for their indulgence in meeting with me and discussing what I think is just as important when we deal with reforms in this House. I must say that I am in full agreement with many of the members here who believe a change, a radical change, is needed. I do not come to that decision lightly, and I know many people in this chamber and outside of this chamber will look at this movement and this amendment as somehow disingenuous and somehow, as it was termed, a poison pill for this bill.

I want to assure you, Mr. Speaker, and the members of this House that I was not playing a game with the integrity of these collective members both here in the House and in the Senate. I truly believe that the election process for members of the House and Senate has gotten beyond the means of ordinary people, has gotten beyond the means of steelworkers and electricians and plumbers and truck drivers, the majority that used to make up this body and the Pennsylvania Senate, but they are being locked out of this process. They are being replaced by lawyers and businesspeople and doctors and people who can self-finance campaigns, and I have a real problem with that and I think the majority of Pennsylvanians do as well.

I believe, in listening to the debate in this House and in the Senate on the repeal of the pay raise provisions, that those advocates were right. Those advocates were right in that our attention as legislators should be based full time on the interests of the people we are elected to represent, not on your outside interests, not on your bond work, not on your other income-making revenue sources, but on the attention of the people in Pennsylvania.

Mr. Speaker, I know that many people have worked long and hard on this pay raise issue, many of my friends on both sides of the aisle, and in their interest and in the interest of a speedy resolution to what has become a very ugly situation, I will withdraw this amendment.

The SPEAKER. The Chair thanks the gentleman.

On the question recurring,

Will the House agree to the bill on third consideration as amended?

Bill as amended was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

The question is, shall the bill pass finally?

On that question, the Chair recognizes the gentleman, Mr. DeWeese.

Mr. DeWEESE. Just to echo some of the sentiment of the previous speaker, I was chatting with one of my colleagues from Westmoreland County earlier today, and he reminded me that in the late 1960s and early 1970s under the aegis of Herbert Fineman, Matthew Ryan, and others, the Pennsylvania General Assembly became pretty much a full-time legislative operation. In recent debates we have neglected to project that phenomenon. Most of us are full time, and that needs to be stated once again for the record.

When the executive branch ran Pennsylvania almost unilaterally in the 1960s and back into history, there were calls for reform among many media outlets to give the legislature more power, more muscle, more central involvement. So a full-time legislature with full-time salaries, as discussed by the honorable gentleman, Mr. McGeehan, is certainly worthy of subsequent debate. I realize his reluctance to enmesh this particular amendment into the final bill to rescind and into this evening's endeavor, but nevertheless, as the future goes forward, I am confident that this issue will be addressed once again here on the floor.

Thank you, Mr. Speaker.

On the question recurring, Shall the bill pass finally?
