Section 2. Bernard (Benny) J. Dombrowski Memorial Highway.

- (a) Designation.—The section of the Bay Front Parkway in Erie County from State Street east to Wayne Street south to [the intersection of Bird Drive and East Grandview Boulevard] <u>Station Road</u> is hereby designated and shall be known as the Bernard (Benny) J. Dombrowski Memorial Highway.
- (b) Service in the House of Representatives.—Bernard (Benny) J. Dombrowski was a committed community servant who served with distinction as a State Representative from the First Legislative District from 1970 to 1990. Also, during his tenure in the House of Representatives he was elected to the position of Majority Caucus Administrator.
- (c) Signs.—The Department of Transportation shall erect and maintain road signs which shall display the name of Bernard (Benny) J. Dombrowski at the beginning and the end of the section of the highway designated in subsection (a).

Section 2. The act is amended by adding sections to read: Section 8.1. Armed Forces and Veterans Memorial Highway.

- (a) Designation.—State Route 132, known as Street Road, from its beginning point at State Road, Bensalem Township, Bucks County, to its terminal point at Lower State, Warrington Township, Bucks County, is hereby designated the Armed Forces and Veterans Memorial Highway.
- (b) Signs.—The Department of Transportation shall erect and maintain appropriate signs displaying the name of the highway at each end of the highway and along the highway at an appropriate location within each municipality through which the highway passes.

Section 8.2. Beech Creek Veterans Memorial Bridge.

- (a) Designation.—The bridge on State Route 150 crossing the Beech Creek in Clinton and Centre Counties is designated and shall be known as the Beech Creek Veterans Memorial Bridge in honor of all the citizens of Clinton and Centre Counties who have served in the armed forces of the United States.
- (b) Signs.—The Department of Transportation shall erect and maintain appropriate signs which shall display the name of the bridge designated in subsection (a) at each end of the bridge.

Section 8.3. Willie Mae James Leake Memorial Highway.

- (a) Declaration of policy.—The General Assembly finds and declares that:
 - (1) Mayor Willie Mae James Leake had the distinction of being the first African-American mayor for the City of Chester, Delaware County, and served in that capacity from 1986 to 1991.
 - (2) Mayor Leake's pride for the City of Chester led her to a career in city politics. Mayor Leake's political career began in 1972. Subsequently, she began this career appointed to the Chester-Upland School Board. In 1977 Mayor Leake received the highest number of votes among Republican candidates for a six-year term on the school board. In 1982 Mayor Leake was appointed City Treasurer. In January 1983 Mayor Leake was appointed to the City Council of Chester, Pennsylvania, and at this time she made history as the first woman to serve on City Council.
 - (3) Mayor Leake was also on the executive board of the Chester branch of the NAACP.
 - (4) The distinguished achievements and contributions of Mayor Willie Mae James Leake reflect the spirit of not only a distinguished servant to the City of Chester, Delaware County, and the Commonwealth, but also a great Pennsylvanian.
- (b) Designation.—The highway in Delaware County carrying State Route 291 from Ridley Creek to the Trainer Borough line is hereby designated and shall be known as the Willie Mae James Leake Memorial Highway.
- (c) Signs.—The Department of Transportation shall erect appropriate signs at each end of the highway displaying the designation made by this section.

Mr. Speaker, HB 1834 will allow PENNDOT to grant electronic access to specific driver's license information necessary to confirm an individual's organ donor status.

Since passage of Act 102 of 1994, organ procurement organizations verify an individual's donor status by calling the State Police to check their driver's record. New technology and safeguards are now in place to allow this information to be accessed electronically by Pennsylvania's two organ procurement organizations, which will result in less time to verify a person's organ donor status and more time for family members to discuss their loved one's wishes about donation.

We need to make every effort possible to help grieving families when they are faced with the loss of a loved one. Organ donors and tissue donors are heroes. They are ordinary people with extraordinary power.

Nationally, as of today, 90,363 individuals are on the United Network for Organ Sharing's transplant list. Today in Pennsylvania 14,276 individuals are waiting for the gift of life. Many others are in need of a life-changing eye, tissue, or bone donation. We must make every effort possible to give life and hope to those individuals waiting for the precious gift of life

I want to thank Chairman Geist and Chairman McCall for their efforts on this bill in the Transportation Committee. I want to thank Representative Fleagle and Representative Metcalfe for their cooperation on the amendments to this. I want to thank Representative Taylor for very kind words, and I ask for a "yes" vote on HB 1834.

Mr. LEVDANSKY. Thank you, Mr. Speaker.

Mr. Speaker, just for the information of the members, especially the members on this side, I just want to make sure everybody understands what this legislation does. This affects school districts and municipalities and counties of the fourth through eighth classes.

A couple weeks ago we voted on legislation to affect second-class counties, Allegheny County, and in that, we made sure that we established a 5-percent revenue maximum increase after a reassessment in second-class counties. This legislation would permit school districts and municipalities in fourth- through eighth-class counties, it would permit a school district to receive up to a 10-percent boost in revenues following a reassessment and would enable a municipality in a county of fourth through eighth to receive a 5-percent increase in revenues after a reassessment.

I do not understand the rationale for treating school districts in fourth- through eighth-class counties, you know, differently than school districts and counties of the second class, but I do not represent a fourth- through eighth-class county, but I just wanted to point out that inconsistency or at least lack of uniformity from my perspective. So I do not quite understand why we are treating school districts in fourth- through eighth-class counties much more generous than other counties in the Commonwealth by enabling them to receive up to a 10-percent increase in revenue following a reassessment without the school board having to make a vote. But with that caveat and with that particular concern, I just wanted to make the members on this side of the aisle, at least, who represent fourth- through eighth-class counties aware of that lack of uniformity before they vote on this.

Lightner, Jr., of the Pennsylvania National Guard's 28th Division Military Police Company based in Johnstown, who tragically lost his life while in the service of his country, in the Ramadi Province of Iraq on October 27, 2005.

The SPEAKER. On that question, the Chair recognizes Mr. Stern.

Mr. STERN. Thank you, Mr. Speaker.

We are here this evening to honor the life and extend condolences for the supreme sacrifice of S. Sgt. Daniel R. Lightner, Jr., of the Pennsylvania National Guard's 28th Division Military Police Company based in Johnstown, who tragically lost his life while in the service of his country in the Ramadi Province of Iraq on October 27, 2005, during combat operations with the Guard's 2d Brigade Stryker Combat Team.

S. Sgt. Daniel R. Lightner, Jr., was a native of Hollidaysburg. He attended Lock Haven University and received an associate's degree from Kansas City Community College. He served in the United States Army from 1995 to 1998, and upon completing his active duty, he enlisted in the National Guard while working as a corrections officer at the Federal prison in Lewisburg.

Sergeant Lightner joined the Pennsylvania State Police in 2003, and he was assigned to Troop J in Embreeville, Chester County, where he served until his Guard unit was activated in January 2005 for deployment to Iraq.

An avid runner, as a cadet he received an award as the cadet with the highest physical fitness rating. In the military he received the Order of the Purple Heart, the Army Achievement Medal, among many other medals that were bestowed upon him. He was the 20th National Guardsman and the first State trooper killed in Iraq.

Sergeant Lightner wrote a letter to his best friend in the whole world, Tom Hatch, on June 20 of this year, saying, "If you are reading this letter it means I have died for my family, God and country. Please try not to be sad because I volunteered for this mission and I would not hesitate to do it again if I could. These are the principles I stand for no matter the cost."

Sergeant Lightner, Trooper Lightner, Danny, as his friends and his family knew him, went on to say that "I am smiling down from heaven right now because I am most thankful that God gave me the greatest sisters, and I had the greatest mom in the whole world and I died with honor serving the greatest God and country in the world. I lived the ultimate life of joy and happiness and I was ready, no regrets."

Sergeant Lightner loved cars, old Mustangs especially. He loved to hunt. He was a fisherman. He loved to read his Bible, and he loved to talk about God. He preached at his church, the Field of Harvest Fellowship Church in Altoona, the last time that he was home on leave.

Our heartfelt sympathy goes out to his mother, Judy, and his three sisters – Shannon, Shilo, and Shonda – and to his many friends

May we remember one of Pennsylvania's finest in passing this resolution, and I would respectfully ask for everyone's support here this evening.

BILL ON CONCURRENCE IN SENATE AMENDMENTS AS AMENDED

The House proceeded to consideration of concurrence in Senate amendments to the following **HB 515**, **PN 3173**, as further amended by the House Rules Committee:

An Act amending the act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, further providing, in sales and use tax, for the definition of "manufacture"; and further providing, in personal income tax, for imposition and, in corporate net income, for definitions

On the question,

Will the House concur in Senate amendments as amended by the Rules Committee?

The SPEAKER. It is moved by the gentleman, Mr. Reed, that the House do concur in the amendments.

On that question, Mr. Levdansky.

Mr. LEVDANSKY. Mr. Speaker, I just want to point out, this legislation comes nowhere near addressing the recommendations in the Governor's Business Tax Reform Commission report, a bipartisan task force that was appointed by the Governor and by the four legislative caucuses. The business tax cuts that will be engendered by this are nowhere near what was recommended in that report.

I also just want to point out that one particular critical piece of this, the net operating loss, the cap is going to be raised over the next 3 years but that the cap will also consider 75 percent of a company's prior losses to be applied in a given year. This has the potential, the potential to generate huge tax savings for literally a handful or two of Pennsylvania corporations.

I do not think, you know, I do not think it is fair to everybody else in the business community. I do not think it achieves, I know that it does not achieve anywhere near the level of business tax reductions that those Republicans and Democrats and business people on the Business Tax Reform Commission recommended, and so I am going to be voting against concurrence in HB 515.

Thank you.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Turzai.

Mr. TURZAI. Thank you very much, Mr. Speaker.

I rise in support of HB 515. This is a bill that incorporates two of the most important component parts of the Keystone Manufacturing Initiative, and I would like to applaud my colleague, Representative Dave Reed, for his persistence and diligence in getting this bill through. It includes both a change

to the net operating loss carry-forward, which was part of HB 650, and 100 percent changing the corporate net income tax to a single sales factor.

Mr. Speaker, without employers, there are no jobs in Pennsylvania. Good jobs promote strong schools and strong communities. This tax relief bill is the real economic stimulus package Pennsylvania needs. This progrowth legislation recognizes that we need to lower overhead costs, including taxes for our manufacturers and other employees so that they can stay here, expand here, and provide family-sustaining jobs.

While we would have liked to have seen a full elimination of the cap on net operating loss carry-forwards, the cap in this bill would be increased to \$5 million in 2007, \$7.5 million in 2008, \$10 million in 2009, and \$10 million or 75 percent of available losses, whichever is greater, after that. Forty-five other States allow for an unlimited carry-forward. We are getting close. By raising the cap, we have leveled the playing field for Pennsylvania job creators, and they can now engage in fair competition with businesses in the other 45 States.

I ask the support of all the members and once again congratulate Representative Reed and also want to thank all the persons who were involved in the Keystone Manufacturing Initiative in getting these two component parts moving forward to the Senate today.

Thank you very much.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Indiana, Mr. Reed. Mr. REED. Thank you, Mr. Speaker.

I would just like to first off thank my colleague from Allegheny County, Representative Turzai, for all of his hard work on the Keystone Manufacturing Initiative as well as a number of members on the Republican side of the aisle who have put forth pieces of legislation over the last 3 years to help our workers across the Commonwealth by putting them back to work and securing their jobs for the future.

As we look forward to this proposal, which will look to reform our business tax structure, it is important to also note that these are bipartisan proposals. The single-sales-factor component to this particular proposal has been talked about by Representative Mann from the Lehigh Valley for a number of years now. It actually passed the House unanimously just a few months ago.

It is also important to note how far we have come as we have negotiated this bill throughout the process. The bill that the Senate actually sent over to us had a price tag in fiscal year '06-'07 of over \$150 million a year, and we have actually tried to bring it down a little bit more within our means so that the price tag of this particular proposal over fiscal year '06-'07 will be a mere \$48 million a year. Now, when you look at the way we can compensate that, as we look, and I would encourage the Governor to sign this bill into law, we can easily come up with that \$48 million, because just a couple of weeks ago we passed the repeal of the pay raise, which actually saves the Commonwealth \$17 million a year, and according to the Department of Revenue, we are actually running a \$100 million surplus in the first 4 months of this fiscal year. So if you add those two numbers together, we have already got \$117 million we can use to afford this program in year 1 alone with \$50 million in change to spend elsewhere.

Mr. Speaker, the important thing to note, as we have looked at many different forms of tax reform over the last several days, as we continue to look at the property tax issue that has plagued our Commonwealth for over 30 years now, today we are giving Pennsylvanians an option. We are giving them an option to go back to work. We are doing so by decreasing the personal income tax, which each and every individual across the Commonwealth who is paying income taxes is going to benefit from, and at the same time, we are going to lower the cost of doing business across the Commonwealth of Pennsylvania, and in essence, we will then allow more Pennsylvanians to go to work instead of living off of our government.

The important thing to also note within this bill is the single-sales-factor provision. It was an honor to represent the House Republican Caucus at the Governor's Manufacturing Summit just a couple years ago as a freshman legislator, and one of his priorities at that conference was to deal with the outsourcing issue. Bringing the single sales factor to the State of Pennsylvania encourages our businesses, our manufacturers, to not only sell their products within the Commonwealth but to locate their assembly facilities, their factories, their manufacturing facilities, within our borders as well. This is one of the single largest things a State can do to curb outsourcing in the State of Pennsylvania. This will make our manufacturers more competitive with other States and other nations. This is one of the single largest things – I would repeat – if you want to curb outsourcing, this bill is one of the single largest things we can do as a State to help keep our manufacturing jobs within the State of Pennsylvania.

Again, Mr. Speaker, I appreciate the support that these measures have seen on both sides of the aisle throughout the entire process, and I look forward to the Governor signing this bill within the next couple weeks.

Thank you.

The SPEAKER. The Chair thanks the gentleman.

Mr. DeWeese.

Mr. DeWEESE. Will the gentleman submit to brief interrogation? Mr. Reed.

The SPEAKER. The gentleman indicates he will stand for interrogation. The gentleman, Mr. DeWeese, is in order and may proceed.

Mr. DeWEESE. If there is a substantial downturn in the economy in the next 6 months, what is the result relative to what we are doing tonight?

Mr. REED. There is actually no result, because none of these business tax structure changes would take effect until fiscal year '06-'07.

Mr. DeWEESE. Okay. What if there is a substantial downturn over the next year and a half to 2 years?

Mr. REED. Well, I am actually very encouraged, because according to the Governor's Office, there are actually more people working today in Pennsylvania than there ever has been. So I am actually looking forward to seeing less of a need for social services and Department of Welfare programs in the next budget year, because we have got so many people going back to work. So I am actually kind of looking at it in a very optimistic perspective based upon the information that the Governor has provided us with through his press office.

Mr. DeWEESE. Let the record state that the honorable gentleman, in my view, did not squarely answer the question.

I have no other comment for the gentleman. I just have some observations—

The SPEAKER. The gentleman is in order.

Mr. DeWEESE. —on the proposal.

I do not know why we are attempting to lower taxes in November when the normal process is to lower taxes during the budget cycle. The whole panoply of issues that we discuss each year as we formulate a budget package is inherently rested and nurtured by a discussion of taxes, rested upon and nurtured by a discussion of taxes, or a reduction in taxes or an increase in taxes.

The gentleman from Pittsburgh, Mr. Levdansky, indicated a little while ago that the Governor's bipartisan tax reform commission had produced a certain result and that HB 515, as amended in the Senate, was a far cry from that. I cannot fathom why we are doing this if we do not have a real solid idea of what is going to be in the treasury in February and March and April and May. The reason we have a yearly budget process that comes to fruition in May and June is because, Mr. Speaker, we have some solid identification of the revenue numbers. To reduce taxes substantially in November without knowing what the revenue yields will be in January and February and March and April and May seems to be a very, very dubious fiscal policy for the General Assembly to embrace. I just do not understand why it is being done now. It just does not make what I would call good fiduciary common sense.

Now, I would agree with the gentleman, one of the two gentlemen, I think it was the gentleman from Indiana who indicated that it had been a bipartisan effort in some degree. He is correct. The Secretary of Revenue, Greg Fajt, was leading the charge for net operating loss carry-forward a long, long time ago, and many people on this side of the aisle will, I am sure, vote in favor of concurrence tonight. The Democratic leadership is not asking for a favorable or an unfavorable vote. We, at least some of us who are privileged to be at this podium from time to time, will urge the Governor to veto this measure, because we do not think it is responsible – yet. It might be responsible in the springtime. The whole idea of net loss carry-forward is a good idea. The Governor is right and the former speaker is right. I sat with him and we both addressed that manufacturers' summit in Lancaster with Governor Rendell a few years ago. So conceptually what we are doing in many cases is something that we would approve of. The timing, I think, is an abomination. I just do not think you can be budgeteering all year long, especially when you do not know what the revenue yields will

My last observation is that it does not seem like it was very long ago, a week or so, when so much energy and enthusiasm emanated from this side of the aisle relative to capping spending. You want to cap spending on all of these different programs. I assume you want to cap spending for volunteer firemen and you want to cap spending for libraries and so forth. I am confident that you want to cap spending as we debated in the TABOR (Taxpayer's Bill of Rights) legislation not so long ago. So you are wanting to cap spending, but at the same time, you are also wanting to reduce taxes, and that is okay if you can tell me specifically, specifically what programs you want to reduce.

Now, I do not buy it that you can try to reduce a couple hundred million dollars in revenues to the State Treasury by this business tax reduction program tonight, unless you tell me where you are going to cut a couple hundred million dollars out of State fiscal policy. If you can do that, then naturally this vote makes more sense.

So, Mr. Speaker, to review, we are not going to ask our members at this juncture, to use a phrase that I have used a couple times too many already, to fall on the sword. But notwithstanding the fact that we believe net operating loss carry-forward legislation is appropriate at some juncture, we do not think it is appropriate tonight. We do not think that the Republican Party is being responsible trying to cut taxes in the middle of a fiscal year. If this tax cut is appropriate, and it may be, we should be doing it in the springtime with the whole budget.

So I am going to vote in the negative, and I am going to ask the Governor to veto this proposal. I think it is superficial. I think it is campaign politics. I think it is one of the first volleys in the next gubernatorial race, so we should just call it for what it is. Nevertheless, I look forward to the ongoing debate.

The SPEAKER. The Chair recognizes the gentleman from Allegheny, Mr. Frankel.

Mr. FRANKEL. Thank you, Mr. Speaker.

There are many of us on this side of the aisle who are very supportive in creating a more competitive business climate in Pennsylvania. I have authored a version of lifting the cap on net operating losses. However, here we are this evening and we have been considering property tax reform, reducing property taxes. We have not gotten to that decision yet today, but it seems to me that in terms of the priorities that we ought to be dealing with today, we ought to be dealing with property taxes this evening, not with the business taxes. That seems to be the order of business today, and to supersede that by talking about the business tax cut package without dealing with the homeowners of Pennsylvania today seems to me to be not the responsible action.

So, Mr. Speaker, I would move that we table this HB 515 until we have dealt with the issue of property taxes.

The SPEAKER. It is moved by the gentleman, Mr. Frankel, to table HB 515, PN 3173.

On the question,

Will the House agree to the motion?

The SPEAKER. On that motion, it is only debatable by the floor leaders.

The majority leader, the gentleman from Jefferson, Mr. Smith.

Mr. S. SMITH. Thank you, Mr. Speaker.

Mr. Speaker, obviously I oppose the motion to table. It is also obvious, Mr. Speaker, that the order of the day or the last few days and of the next few days that we are in session will be

to primarily focus on property taxes. We spent a great deal of time on that this week, and while we were not successful in passing a bill to the Senate, I think that there was a lot of success achieved within this, at least within this body of the legislature in terms of ferreting out what is workable and what is not workable.

So, Mr. Speaker, I would argue that to suggest that we should table this bill because we have not succeeded in putting a bill on the Governor's desk relative to property taxes is nothing but just a smoke screen and a reason to sidestep the other issue of the day. Clearly, when we came back into this fall session, we set forth several agenda items that we wanted to move forward on. This is not a bill that just, you know, sprang out of dust over the last few days. It is a bill that has moved through the process over the last many months.

Quite frankly, I was going to save this until closing remarks, but when the minority leader questioned the timing of this bill in suggesting that we should only consider what the tax policy for Pennsylvania is at the same time that we do the budget, normally in June, I would argue that this is a better time for us to pass a change in the tax structure. There is no impact on this through the remainder of this fiscal year. In the next fiscal year, in the '06-'07 fiscal year, the impact is around \$46, \$47 million, and clearly when the Governor in his current stage would be putting together his budget, assuming that he were to sign 515 into law, as he is putting together his budget proposal that he presents to us at the first of February, clearly this being in law today gives everyone at the budget table, starting with the Governor in February, a better opportunity to fashion a budget along concrete lines as opposed to the susceptible lines of the whims of the day come next June.

So, Mr. Speaker, I would oppose the motion to table and ask the members to proceed with the vote on HB 515.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the minority leader, the gentleman from Greene, Mr. DeWeese.

Mr. DeWEESE. I accept the honorable gentleman's comments from Jefferson County as being his perspective. I respectfully take another tack on the issue, but I can see where reasonable people can disagree on this.

I think that we should be doing the tax policy of the Commonwealth most all of the time in the spring when we do the budget. I do not feel that tonight is a moment for that dire exception. I feel that my position is buttressed by the fact that a nonpartisan tax commission that Representative Levdansky referred to earlier in the evening came up with a significantly different work product. If Republicans and Democrats and people that the Governor had appointed were able to give us a work product that we could deal with tonight, I would step back from the position and say that tonight was an exception.

I am certain that we do not have the votes to sustain – well, I am rather certain that we do not have the votes to sustain Mr. Frankel's motion, but I am going to vote in support of it. I would vote in the affirmative to table. Thank you.

On the question recurring, Will the House agree to the motion?

Mr. S. SMITH. Excuse me, Mr. Speaker. Are we on final passage?

The SPEAKER. Yes.

Mr. S. SMITH. Thank you, Mr. Speaker.

If I could just make two quick comments on it?

The SPEAKER. The gentleman is in order.

Mr. S. SMITH. Thank you, Mr. Speaker.

Mr. Speaker, I would urge the members to support HB 515 in concurrence. I wanted to point out for the record that there was a lot of talk about some of the elements of this bill as we were doing last year's budget, and when you get into the budget pressures, obviously it is a tough time to make certain decisions. I think it is important that we do do this at this time of year, as I mentioned a few minutes ago, in order that the budget process can be built around these important tax cuts, and these cuts were not something that were just pulled out of air. These were something that when the business community was lobbying over the last year or so, they were all over the board. They were on different issues, different issues that were important to each of them, and there were some of us that challenged them outside of the hall of the House and challenged them to identify which cuts would make Pennsylvania more competitive and which ones would do the most for helping to create and retain jobs in Pennsylvania.

If you look at what is in this bill, Mr. Speaker, it is not the wish list of the business community; that is for sure. This is their boiled-down kind of, I would almost say this is a bare minimum of what they said is most necessary to make Pennsylvania more competitive, to help Pennsylvania employers create more jobs, and I think that is something that all of us stand for. This is a significant movement towards economic development as anything else this House has done over the last couple of years, and I would urge the members to vote in favor of HB 515.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Reed.

Mr. REED. Thank you, Mr. Speaker.

I just want to point out a few things very quickly in response to the gentleman from Greene County. He had mentioned that we needed a proposal to find out where this money was going to come from. Well, I offered \$117 million to pay for \$49 million next year, so that would be out there.

Secondly, his revenue projections are from actually the Governor's Department of Revenue. Secretary Greg Fajt puts us \$104 million ahead of estimates. So I guess perhaps I have a little bit more faith in the Department of Revenue than my colleague from Greene County.

Thirdly, when we talk about evaluating tax policy in mid-November, mid-December, I really just wanted to point out that we actually, and this was supported by the gentleman from Greene County, we supported a very large tax increase in December of 2003, so I certainly do not think it is inappropriate to talk about tax decreases for the people of Pennsylvania in November of 2005.

And lastly, I guess I would just say, I would encourage the Governor not to veto this bill but to sign this bill into law, because quite frankly, it is about whether you are probusiness and whether you want to decrease outsourcing in the State of Pennsylvania, and I really do believe those are ideals that both

the Governor and I share and both Republicans and Democrats alike share, at keeping more people working in Pennsylvania and more of our jobs within our borders.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The gentleman, Mr. DeWeese.

Mr. DeWEESE. Just a couple remarks on final passage of HB 515 in concurrence in Senate amendments.

I just think that we as a General Assembly with very, very scarce dollars for LIHEAP (Low-Income Home Energy Assistance Program) and for Medicaid reimbursements, and when we have not dealt with minimum wage, when we have been dealing with property tax unsuccessfully for a long, long time, and within the last day and a half, one of the 900-pound gorillas in the middle of the proverbial bed has been how do we pay for property tax reductions. Well, I do not know that it is all that circumspect for us to be strangling the revenue yields of the Commonwealth at the same time we are trying to find ways to put money towards reduction of property taxes. I just think that it is not a good idea. Again, I can count. I know the momentum is in favor of this bill going to the Governor, but I will ask the Governor to veto it. I think we will come back right after Thanksgiving. I would like to importune, very politely, the majority leader to put a minimum-wage bill on the calendar and get down to some serious property tax debates upon our return.

Relative to that statement, I have met this evening with the Speaker and the floor leader on the Republican side along with Representative Evans, Representative Veon, and we feel that we will be able to make some mutual progress in the early weeks of December, and I would like to think, notwithstanding our disagreement here on 515, we can work for some mutuality next month and make certain that before we leave here before Christmas vacation, that we send a property tax bill, one that is very, very solid and mutually embraced by House Republicans and House Democrats, to the Senate.

So I will be voting in the negative on this, but the world will not come to an end, and I would anticipate that the Governor would veto this bill. I think it does reflect a great deal of fiscal irresponsibility, notwithstanding the wonderful observations of my young colleague from Indiana County.
