Mr. TAYLOR. Thank you, Mr. Speaker, and I appreciate the attention of the members of the House, because this is not our run-of-the-mill resolution.

Unfortunately, Mr. Speaker, it is much too common for members of this House to offer remarks in support of a condolence resolution regarding a Pennsylvanian who makes the ultimate sacrifice, but it is necessary today to do that again. I ask all the members to join me in paying tribute to Gennaro Pellegrini, Jr., and extend condolences to his family.

Gennaro Pellegrini was a member of the Pennsylvania National Guard since 1998 and was assigned to the 1st Battalion, 111th Infantry Regiment. Gennaro, known to his friends and family as Jerry, worked some of the most dangerous assignments in Iraq, including checkpoints and capturing armed enemy insurgents.

We all know the dedication and commitment required in the Pennsylvania National Guard, but Jerry Pellegrini also served double duty. He served the citizens of Philadelphia as a police officer in a very important way. Like his father, he actually took the badge number of his father, 3722. He was a police officer since 2001 and was assigned to the 26th Police District, not only protecting my constituents but those of Representatives Lederer and Cruz.

He received numerous citations and commendations for his courage, hard work, and commitment. Jerry was also known to be a frequent visitor to our elementary schools, talking to the kids about police work and dedication to the National Guard.

But Jerry was very famous in the neighborhood as a boxer. In 1997 he was a Golden Gloves welterweight champion and earned a reputation as a seasoned, hard-punching fighter. Jerry went on to win his first professional bout in May of 2004 at the historic Blue Horizon on North Broad Street in front of his family, friends, and fellow officers.

His skills as a boxer came in handy one day as Jerry and his partner were chasing a suspect for some time. His partner had fallen behind, and Jerry finally caught the suspect. He did not need help from fellow officers, he did not need a gun, he did not even need handcuffs, as Jerry proceeded to knock out the suspect with one punch, to the amazement of his fellow officers. This earned Jerry the name "One Punch Jerry," and for many years people thought he earned that name in the ring, but in fact, he earned that protecting the citizens of Philadelphia on those very streets.

Sadly, Jerry's training as a National Guardsman, his years as a police officer, and his talent in the boxing ring could not protect him from the ultimate tragedy, as Corporal Pellegrini died from injuries received while on a routine patrol in Bayji, Iraq, on August 9, 2005. The Humvee in which he was riding hit a roadside bomb and his unit came under small-arms fire and rocket-propelled grenade attack from insurgents.

Corporal Pellegrini was one of five servicepersons killed in the incident, four of whom were from southeastern Pennsylvania. All four of those had condolence resolutions on this floor. Corporal Pellegrini is survived by his parents, Edith and Gennaro Pellegrini, Sr., and sisters, Dana Marie and Kimberly Ann. He was courageously serving his country and Operation Iraqi Freedom at the time of his death.

A great example of Jerry's dedication and his character was how Jerry, while in Iraq, constantly provided information to the children of Port Richmond in the city of Philadelphia from these very children. Jerry's way of trying to make the best of a bad situation, he organized a drive where kids from the city tried to provide something that these kids in Iraq needed, which turned out to be, of all things, flip-flops, to negotiate the desert in Iraq. Jerry did that and tried to keep the information flowing back and forth between kids in Iraq and the kids in Philadelphia.

I would like to introduce, with us today are Jerry's sister, Dana Shearon; her husband, Timothy; and their children, Caitlin and Timothy, Jr.; and we are also joined by Robert Ballantine, financial secretary of Lodge 5, Fraternal Order of Police in Philadelphia. I would like the entire House to give our guests a warm welcome and extend our condolences.

A Resolution honoring the life and extending condolences for the supreme sacrifice of Lieutenant Colonel Michael E. McLaughlin of Mercer, Mercer County, who became the first field grade officer of the Pennsylvania Army National Guard to die in action since World War II when he was killed on Thursday, January 5, 2006, by a suicide bomber at an Iraqi police recruiting station in Ramadi, Iraq.

On the question,

The SPEAKER. Please, this is a condolence resolution.

The Chair recognizes the gentleman, Mr. Wilt.

Mr. WILT. Thank you very much, Mr. Speaker, and I applogize for the delay earlier, and I appreciate the attention of the members.

Each and every one of us that have taken this mike over the last several months to recognize one of our fallen heroes knows that it is certainly not something that we take lightly. I appreciate the members' support of HR 572, and if I could just take a quick moment and tell you a little bit about Lieutenant Colonel McLaughlin.

He was a 1980 graduate of West Forest High School in Tionesta. In fact, his parents still live in Representative Rapp's district. He held degrees in industrial management and industrial engineering and a master's degree, all from the University of Pittsburgh.

Lieutenant Colonel McLaughlin directly planned and supervised the mobilization of the unit for deployment of the M109A6 Howitzer, the most advanced field artillery delivery system in the world. Lieutenant Colonel McLaughlin was deployed to Iraq with the 2d Brigade, 28th Infantry Division, as brigade effects coordinator, and his duties included the coordination of all lethal and nonlethal fires.

Lieutenant Colonel McLaughlin, his work directly improved the quality of life for the Iraqi people, and on the day of his death, he was actually greeting Iraqi men who had signed up to serve both as police officers and in the military, and in the process of going through the line, a suicide bomber detonated himself, killing Lieutenant Colonel McLaughlin and several other Iraqis.

Lieutenant Colonel McLaughlin's military awards include the Silver Star, which he was given posthumously; the Army Commendation Medal with three oak leaf clusters; the National Defense Service Medal; the Army Service Ribbon; the Overseas Service Ribbon; and the Field Artillery Honorable Order of St. Barbara.

Lieutenant Colonel McLaughlin was married in August of 1982 to Tamera Fedele, who survives along with two daughters, Ericha and Erin.

And I wanted to let the members know that a few months ago we passed on this floor and the Senate sent it to the Governor's Office and he signed into law a scholarship program for children of our fallen heroes who are killed in Operation Iraqi Freedom. In fact, Lieutenant Colonel McLaughlin's daughter will be the first Pennsylvanian to receive that scholarship. So I want to thank the members for their foresight, because this young woman will now have an opportunity to complete her degree from one of our State System schools, and I think we should all be proud of that.

Lieutenant Colonel McLaughlin was killed at 10:55 in the morning, and as I mentioned, there were other Iraqis that were killed along with him, and the total killed that day were 80.

So I just wanted to let you folks know what we are doing here in this chamber sometimes seems a little mundane and we take it for granted, but here is a story of hope that we have created in a young woman so that her father's passing will not be for naught.

I thank the members for their attention, and I urge your passing of HR 572.

And, Mr. Speaker, if I could say one more thing. It just hit me. Senator Robbins and I were going through the receiving line at the funeral home for Lieutenant Colonel, and when we got to his wife, she wanted us to reiterate to all of the members here what Mike felt about his duty in Iraq, and he wanted us to hear the true story of what was going on over there and the desire of the Iraqi people to have control of their own government, to protect their own citizens, to take control of their own military, and Lieutenant Colonel McLaughlin was helping make that a reality for the Iraqi people.

Thank you very much, Mr. Speaker, and I thank the members for their attention.

ROSA PARKS REMEMBRANCE DAY

STATEMENT BY MS. BISHOP

The SPEAKER. The gentlelady, Ms. Bishop, requests unanimous consent. For remarks under unanimous consent, the gentlelady is granted the time.

Ms. BISHOP. Thank you, Mr. Speaker.

My fellow colleagues, this is a very special day and it is also a very telling time. It seems that we face challenges almost on every front. Globally, socially, economically, morally, yes, this is a very telling time, but it is also a telling time – a time to remember, a time to tell the facts about great victories that we have seen; a telling time to remind us all that struggle may be hard but we have the strength and the courage to prevail.

Rosa Parks reminds me of this every time I think of her. I am so deeply grateful that we had the opportunity and were able to honor her during her lifetime with Pennsylvania's Rosa Parks Day. My heart is glad to know that the hands that worked so hard for equality, those same hands held her proclamation from this House and brought a smile to the woman who brought Montgomery's racism to its knees.

We are starting to lose more and more of the 20th century's greatest leaders. Today, as we speak, they are laying Coretta Scott King to rest. Now we have not only lost the mother of the movement, we have lost the first lady of the movement. Coretta Scott King was thrust into a lifetime of social vigilance and responsibility. She not only led the world in coping with her husband's murder, but as the years went on, she became a famous champion of women's rights and human rights of the underprivileged across this vast world of ours. Ambassador Andrew Young said Coretta Scott King was as "strong or stronger than her husband."

Will you please join me in a moment of prayer and silence reflecting on this gracious lady's contributions to the movement for nonviolent change.

President Bill Clinton spoke of her at her funeral in November, and he puts it this way: "The world knows of Rosa Parks because of a single simple act of dignity and courage that struck a lethal blow to the foundations of legal bigotry.... Rosa Parks ignited the most significant social movement in modern American history – to finish the work that spawned the Civil War and redeem the promise of the 13th, 14th, and 15th Amendments."

Clinton continued, "For 50 more years, she moved beyond the bus, continuing her work on that promise....

"Rosa Parks...was small in stature with delicate features. But the passing years did nothing to dim the light that danced in her eyes, the kindness and strength you saw in her smile, or the dignity of her voice.

"To the end, she radiated that kind of grace and serenity that God specially gives to those who stand in the line of fire for freedom and touch even the hardest hearts."

That is right, special fortitude and vision are given, too, and so Rosa Parks was chosen to help in the business of cleaning up the mess of inequity or inequality.

A standup woman was needed, one with special abilities to stay in her seat, someone willing to sacrifice, someone unafraid to go to jail and be handled by some of the wrongest headed people in Alabama, someone of supreme courage and integrity, and that someone was Rosa Parks.

And so on that late winter day in 1955, in a racially hostile Montgomery, Alabama, she simply refused to get up and move to the back of the bus, and for that she was arrested.

She was arrested for sitting where she pleased. The struggle she sparked brought a young Dr. Martin Luther King to national prominence as he spearheaded the Montgomery, Alabama, Bus Boycott.

Later Dr. King marked this historic connection, declaring the Montgomery Bus Boycott led to the Voting Rights Act of 1965. And, ladies and gentlemen, I am here today to remind you as I stand that had it not been for Rosa Parks taking a stand and sitting anywhere she pleased, I would not be able to stand in the Pennsylvania legislature. All of the great men and women who stood up before us have had us standing on their shoulders, and remember, for years Rosa Parks was the lone female image in a sea of male leadership. That transcends race.

All the women who serve in the Pennsylvania State House and Senate, both Federal Houses of Congress, regardless of color, all the women serving in the Cabinets across this country, all the female judges in the land, all of us, we are all linked to these great freedom fighters. Without them, where would any of us be today?

Rosa Parks, in her quiet defiance and unswerving courage, launched a thousand careers for women in public service. Her message does not stop there either. Hispanics who are now U.S. Attorneys General or Asian members of the President's Cabinet, Supreme Court Justices of any gender who were the first of their ethnicity, White males in nontraditional jobs, anyone who has sacrificed and successfully challenged the status quo – we are all brothers and sisters. We are all linked and joined together at the hips, and we must never forget.

All of us must remember the great impact these great leaders have had on our lives. We must remember how we got here. We must continue to tell the stories of struggle and share our strength with others. That is what was done for us and that is what we owe, and if we do our duty to those who did so much for us, this country, in fact the world would be better for it, and may we never forget, to whom much has been given, much shall be required.

Thank you, Rosa Parks, for not standing up, because for you not standing up, you have allowed me to be able to say, thank you, Mr. Speaker, for allowing me to stand up.

I would oppose the motion to remove HB 2021 from the table. There has obviously been a lot of activity and discussion relative to this issue in this body and in the Senate, and I would simply ask the members to hold this bill on the table for the time being.

Vote "yes" on the motion, remove this bill from the table, put this bill on the active calendar so the House of Representatives can vote to increase the minimum wage in the State of Pennsylvania.

Mr. Speaker, again, this is the second day in session that I wanted to rise and make sure that the record is clear. Mr. Speaker, when we passed the Pennsylvania uniform firearms law, we had 700 permits in Philadelphia County. Following the Pennsylvania uniform firearms law, there are over 3500 permits in Philadelphia County.

Mr. Speaker, it is time for the legislature, both the House and Senate, to reexamine the Pennsylvania uniform firearms law and to decide whether or not there are circumstances where a county should be allowed to take steps to address an existing emergency. There is an emergency in Philadelphia County today with the proliferation of weapons, weapons of all kinds, weapons that have our Philadelphia police officers having to look over their shoulders every day and every night because there are people out there on the street who have access to weapons that are much more prolific than the weapons that they have.

So, Mr. Speaker, I am rising today to put that information on the record. It is time to revisit the Pennsylvania uniform firearms law and provide Philadelphia County with the kind of support that it needs to deal with the proliferation of guns and the taking of innocent lives in Philadelphia County.
