And in choosing the queen, he met so many other women that were available to him, and she did everything she could to discourage him from picking her. As the story of Purim tells us, she did not put on makeup, did not put on perfume, did everything, and yet he chose her, and when he did, she questioned the Almighty. Later on, when Haman was about to destroy the Jewish people of Persia, she was in a position as queen to be able to intervene on behalf of the Jewish people of Persia, and because of her intervention, with God's help, she was able to save the Jewish

Many of us have been put into this position because, most of us, all of you have been put in this position because you were elected to this position, and now all of you have opportunities to do the best you can, not literally to necessarily save the lives of your constituents but to do the best for them.

I hope and pray that the Almighty will guide your wisdom and your hearts and your minds to always make the right decisions as was taking place during the holiday of Purim.

The applicant shall comply with all laws and regulations pertaining to registration including the payment of any additional fees. The department is authorized to reissue a combination of numbers or letters for a personal plate if the department records reveal that no activity, such as renewal or transfer of the personal registration plate, has occurred for a period of five or more consecutive years and provided that the personal registration plate was never reported as lost or stolen. Whenever the department reissues an inactive personal plate, the department may purge its records of all references to the previous owners of that personal plate. The department shall, however, note upon its records the reissuance of the personal plate and to whom the plate was issued. If the vehicle is licensed to a business that is not a member of the special group, the department shall issue the plate as long as the business owner or officer making application is a member of that group.

Mr. GEIST. Thank you, Mr. Speaker.

As much as I hate to rise and urge a "no" vote on this, because of past agreements that have been worked out with the administration and the courts, I am going to reluctantly ask for a "no" vote.

Thank you.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Casorio.

Mr. CASORIO. Thank you, Mr. Speaker.

Mr. Speaker, just for the members' information, this, again, is another attempt by those of us in the west and now some of my fellow colleagues in the central part of the State to place, this amendment would place a 5-year moratorium on the auto emissions testing plan.

Mr. Speaker, just for the general information of the body, again, this would place a moratorium on the unfair and unnecessary auto emissions testing plan for a period of 5 years.

Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman.

I ask that the members please take their seats. Members, please take your seats. Let us tone down the conversations. Some of these amendments are not agreed to, are going to require you to listen to debate, and there are going to be some points of debate that you are going to want to hear. We cannot do that as long as we are making so much noise. Members, please take your seats. Quiet down, please.

The gentleman, Mr. McCall, is recognized.

Mr. McCALL. Thank you, Mr. Speaker.

Mr. Speaker, I rise to oppose the Casorio amendment, and I certainly understand where the gentleman is coming from and the concern that he has on placing a moratorium on emission inspections. But I am sure all the members of this legislature understand the position we are in as policymakers, and we are in a position that we cannot make a decision to put this Commonwealth or place this Commonwealth in a moratorium on emission inspections. We are under court order – Federal court order.

First and foremost, let us go back to 1991 when the Clean Air Act amendments were passed that mandated to the States, by virtue of Federal law, that we will implement an emissions control program in the Commonwealth of Pennsylvania. We did not meet the requirements of that 1991 Federal act and were taken to court by PennFuture and the Delaware Valley Clean Air Council. Those two groups fought the Commonwealth in court and told the Commonwealth that you did not meet your State implementation plan under the Clean Air Act amendments. The Commonwealth lost that court case. Therefore, we are not only under Federal law but we are under court order to comply with the Clean Air Act amendments and the State implementation plan that this Commonwealth ordered. So it would be completely irresponsible for us as policymakers to pass this moratorium until, if the gentleman so desires, he takes this case to Federal court and fights the case in Federal court and has that requirement taken off of us.

So I would ask that we would defeat the Casorio amendment.

LEAVE OF ABSENCE

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Eachus.

Mr. EACHUS. Thank you, Mr. Speaker.

I would like to put two members on leave: Mr. BLAUM from Luzerne County on Capitol leave, and Mr. STURLA from Lancaster on leave for the day.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Pallone.

Mr. PALLONE. Thank you, Mr. Speaker.

And while we recognize the Federal requirements with the emission testing, the issue is universal testing throughout the Commonwealth, not just in select counties and select ZIP Codes

(Zone Improvement Plan Codes). This is an issue of equity and fairness throughout the Commonwealth of Pennsylvania. Those of us in the west who are subject to the emission testing today certainly do not oppose the emission testing if every county in every community and every automobile and truck owner in Pennsylvania had to do it. It is not happening today. There are only a few select counties and a few select ZIP Codes that are responsible for this particular burden that is out there on the taxpayers and the vehicle owners in Pennsylvania.

This particular issue today is a matter of equity for vehicle owners. It is not an issue of complying with a Federal mandate. We certainly would agree that if all communities, if all counties, if all ZIP Codes would certainly comply like they are supposed to, then we certainly would participate in that. The issue is equity and fairness. It is unfair, it is not equitable, and we have just a select number of people in Pennsylvania that have to deal with this onerous burden and there are others who are exempt.

I support the Casorio amendment and ask all of you to support it as well. Thank you.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Fairchild.

Mr. FAIRCHILD. Thank you, Mr. Speaker.

I rise to oppose the Casorio amendment. I think that issue does deserve debate, but I am not sure an amendment on a bill to help 100,000 young kids that want to be sports men and women in this Commonwealth is the place to do it.

I also would like to reference the fiscal note whereby the Pennsylvania Department of Transportation gives an opinion that if we would do this, we would stand the chance of losing \$1,600,000,000 annually in our highway program. I think that is a lot of zeroes to take a gamble on, and I do not think we should do that

This issue has been around here for a long time, which the maker of the amendment is trying to correct. I think the proper place to do this is in the proper committee and, again, not on an amendment to a bill that is intended to help our young people in the Commonwealth.

Please oppose the amendment. Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman and calls on the gentleman, Mr. Stairs, from Westmoreland County.

Mr. STAIRS. Thank you, Mr. Speaker.

Certainly listening to the debate, we hear the dilemma that this Commonwealth is in. We are under a Federal court order, but when one looks at it quite closely and then tries to use a commonsense approach, there is a great deal of frustration there and inequity to the matter.

I know that we have a Federal court order, and I think we have to start negotiating our way out of this in some way. I think this is a good start, by voting "yes" on this particular amendment.

I just cannot come to feel comfortable with the fact that so many cars driving on our roads in Westmoreland County or Allegheny County or the counties affected by this – they are people from all over the United States let alone all over Pennsylvania – some of these cars have inspections, some do not have inspections, and many people live a mile or less from a county boundary and that county has no inspections. So it is really a mess to say it quite mildly. And I think what really upsets me most, if anything, is that all the cars that have been manufactured since 1996, they are computerized. Do not ask me to explain how they operate, because you cannot fix them like

you used to be able to fix a car because of the different technology in the cars, but, you know, the failure rate is so minor that we are penalizing everybody for a few problems out there, very few problems.

And I do not know if this amendment is going to pass or not; I am going to support it and I would hope that other members could support it also, but we have to get moving on a way that is fair, that makes sense, and not penalize people because you live in a certain part of the State when everybody is driving through that certain part of the State. And this may not be the place to do it, but certainly we have to do it soon to pass a meaningful, commonsense approach to this emission testing and not make our constituents be burdened with an, I think, unnecessary expense.

The SPEAKER pro tempore. Strike the vote, please.

The Chair recognizes the gentleman, Mr. McCall.

Mr. McCALL. Mr. Speaker, I am not sure if this question will go to the maker of the legislation or the Appropriations chairman. I will ask the question and either could respond.

The SPEAKER pro tempore. Mr. McCall, no. Proper procedure would be to direct your question to a particular individual. Would you like to talk to the Transportation chairman? I do not see the Appropriations chairman here at the moment.

Mr. McCALL. I will direct my question to the maker of the legislation, Mr. Speaker.

The SPEAKER pro tempore. The gentleman, Mr. Fairchild, is the prime sponsor of that legislation, and he agrees to your interrogation. You may begin.

Mr. McCALL. Thank you, Mr. Speaker.

Mr. Speaker, the fiscal note that I read that was attached to this legislation said there would be no fiscal impact to the Commonwealth, and when I checked with the department, I was told that there would be a \$177,000 initial impact just to get the computer systems in place to provide this information, the forms and the publications and so on and so forth, but in addition, there would be at least a \$1 million hit to the General Fund recurring every year because of the number of people they would have to hire, and I am just wondering, your fiscal note says there is no impact, the department's fiscal note

is saying \$1 million recurring to the General Fund and \$177,000 initially. I am just wondering if you could explain that.

The SPEAKER pro tempore. The gentleman, Mr. Fairchild, will suspend for a moment, please.

Mr. FAIRCHILD. Thank you, Mr. Speaker.

I am not sure—

The SPEAKER pro tempore. Just a minute, Mr. Fairchild.

Please, members, you are being very rude, making it very difficult for the interrogation to take place. I notice many of the members are standing talking with each other, obviously not about the issue at hand. Please take your conversations elsewhere. Please take your seats. Members, please take your seats. It would be helpful if you took your seats. Quiet down, please.

The gentleman, Mr. Fairchild, may proceed.

Mr. FAIRCHILD. Mr. Speaker, the problem is, because of the noise in the chamber, I did not get the whole question. Could he rephrase the question, please?

The SPEAKER pro tempore. The Chair recognizes that problem and would ask the members again to please quiet down.

For the information of the members, there are four more bills after this one. One of them has almost all of the same amendments to it that you have just gone through on this bill. So if we wish to proceed as expeditiously as possible, I think it would be helpful to all if you would carry your conversations outside of the hall. Otherwise, we have to keep interrupting, we have to keep stalling, to get you to be quiet in order to have the debate. Please cooperate.

Mr. McCall, I think Mr. Fairchild has asked you to restate your question, if you would, please.

Mr. McCALL. Thank you, Mr. Speaker.

Mr. Speaker, in reviewing the fiscal note to the legislation, there is no fiscal impact to the Commonwealth, yet in checking with the department, they are telling us that there would be a \$177,000 initial cost to the Commonwealth basically just to implement the computerization, the computer program, and then forms and publications just introducing the program. But then there would be a \$1 million recurring cost to the General Fund every year, \$1.1 million every year annually. That would be a hit, probably not to the Motor License Fund but to the General Fund, yet our fiscal note is saying that there is no impact, and I am just wondering if you could, if somebody could explain what the difference is.

Mr. FAIRCHILD. Thank you, Mr. Speaker.

Obviously I cannot speak for the Appropriations Committee, but it is my understanding that they did contact PENNDOT and PENNDOT gave them the fiscal note. Now, with that said, I can understand that there may be some initial costs to set it up, simply because it is new to the bureaucrats here that we are now taking a look at those under 16. So between meetings and everything else, there are certainly going to be costs involved. The million dollars, I assume that we have about 100,000 of these, so it is \$10 a crack. I assume that a photo ID processing is about the same, and I am going to read the fiscal note, the fiscal impact: "As applicants are required to pay the required fee and cost of the photograph for an identification card, there is no adverse fiscal impact to the Motor License Fund." So in other words, the intent is purely that they will be treated just like everyone else that gets a nondriver photo ID. They still have to pay for it, whether you do it now.

Mr. McCALL. Thank you, Mr. Speaker.

Just a statement on final passage.

The SPEAKER pro tempore. The gentleman is in order.

Mr. McCALL. I thank the gentleman for the explanation.

I just think it is important that we understand that there will be a fiscal impact on this legislation, that this really is not a core function of PENNDOT. However, I do applaud the gentleman. I think in this time with all the security concerns that we face in this country, that it is a good piece of legislation, but I think we should all be aware that there will be a fiscal impact to the Department of Transportation to the tune of about \$1 million a year.

Thank you, Mr. Speaker.

Mr. GEORGE. Mr. Speaker, we are going to attempt to offer A4379.

The SPEAKER pro tempore. The Chair thanks the gentleman.

Mr. **GEORGE** offered the following amendment No. **A04379:**

Amend Sec. 1, page 1, line 8, by striking out "by adding subsections"

Amend Sec. 1 (Sec. 4973), page 1, line 11, by striking out all of said line and inserting $\,$

(a) General rule.—A permit may be issued under this section for movement of a mobile home or a modular housing unit that exceeds 14 feet in body width but which does not exceed 16 feet in width.

- (b) Conditions.—A vehicle, combination or load permitted under this section shall be operated under such conditions as specified by the department pursuant to section 4962 (relating to conditions of permits and security for damages). A mobile home or modular housing unit which exceeds 14 feet in body width may not exceed 80 feet, including hitch, in home unit length or 14 feet 6 inches in height. The use of standard running lights shall at all times be required. The department shall promulgate all necessary regulations for the use and operation of standard running lights. These regulations shall include language requiring standard running lights attached to the rear of the modular undercarriage in a manner to promote the utmost visibility.
- (c) Equipment.—In addition to the requirements of this title and departmental regulations, a mobile home that is wider than 14 feet in body width or a modular housing undercarriage which is carrying a modular housing unit that is wider than 14 feet in body width shall be equipped as follows:
 - (1) the mobile home or modular housing undercarriage shall have at least four axles;
 - (2) each wheel on a mobile home or modular housing undercarriage shall be equipped with operable brakes; and
 - (3) the tires on a mobile home or modular housing undercarriage may not carry a weight in excess of the tire manufacturer's rating as marked on the sidewall of the tire.
- (d) Pilot cars.—In addition to the conditions of this title and departmental regulations, a vehicle, combination or load permitted under this section that is wider than 14 feet in body width shall be accompanied by two pilot cars on all highways, with one pilot car leading the permitted motor vehicle and one pilot car following the permitted vehicle or combination.
- (e) Restricted travel periods.—A vehicle, combination or load permitted under this section that is wider than 14 feet in body width shall be moved only from 9:00 a.m. to sunset on Monday, Tuesday, Wednesday and Thursday and from 9:00 a.m. to 12 noon on Friday. Movement under this section is not authorized at any time on Saturday or Sunday or during any holiday period specified in departmental regulations or the permit.

On the question,

The SPEAKER pro tempore. On that question, the Chair recognizes the gentleman, Mr. George.

Mr. GEORGE. Mr. Speaker, this amendment allows for the transportation of empty modular undercarriages 24 hours a day, but these undercarriages are the oversized trailers used to transport modular homes. I am concerned that without proper rear lights, these low-standing units will be difficult for other drivers to see. So this amendment requires that standard running lights shall be attached to the rear of the transportation vehicle and used at all times during and after transportation of home modular units. Mr. Speaker, we are required to turn on our lights during the rain. We certainly ought to be able to protect the motoring public by putting lights on a vehicle that cannot be distinguished without them.

I would ask that we adopt it.

The SPEAKER pro tempore. The Chair recognizes the gentleman, Mr. Siptroth. Mr. Siptroth, in a few minutes we will get to that.

The Chair recognizes the gentleman, Mr. Harris.
