It was a long time ago, back in 1939, July 4, when Lou Gehrig decided to give it up because his muscles were not working properly, and I think most of us associate ALS with Lou Gehrig's disease. And unfortunately, unfortunately since 1939 we have no cure. We do not know the reason. So the

people that are here in the back of the House today are asking you to take a few minutes out of your day today and listen to their story.

They are not a big group. You know, there are only 30,000 nationally that have ALS. It is a death sentence, Mr. Speaker. The average life expectancy once diagnosed is only 2 to 5 years, only 2 to 5 years, so that we do not see a lot of research and development big dollars being spent on this disease, because quite frankly, the pool is not big enough, but these are real people. These are people who have come out here today just to be recognized, to spend a few minutes with you, and to ask you to support their cause.

I would ask you to please support HR 616. I would ask you also to acknowledge the people that came a long way today for their work, their help, their concern, and the fact that they continue to move forward to try and get recognition on such a devastating disease.

If we could have the attention of all the members, this bill recognizes a fallen soldier.

Thank you, Mr. Speaker.

Each and every day soldiers from Pennsylvania and across this country put their lives on the line in Iraq, Afghanistan, and points around the world. They do it to protect our rights and freedoms, they do it to advance democracy, and they do it so future generations can live in a safe and free world.

Many soldiers have made the ultimate sacrifice for this noble cause. They are our true heroes. One of those such heroes is Spc. Michael Franklin. Specialist Franklin joined the Army just 4 months after he finished high school, following in the footsteps of his uncles. Less than 2 years later and 1 year ago today, he lost his life in a roadside bomb attack while patrolling in Ramadi, Iraq.

Today on the 1-year anniversary of his death, we humbly pay tribute to Specialist Franklin and to the sacrifices he made for us by naming a bridge in his honor. This bill will designate a bridge in Coudersport Borough, Potter County, as the Specialist Mike Franklin Memorial Bridge. The bridge carrying Route 6 over the Allegheny River will serve as a reminder of Mike's sacrifices to his country.

In August 2004 Mike volunteered to leave his brigade in South Korea to fight in Iraq. Mike, who was single, regularly volunteered for hazardous duties to allow the married soldiers in his group to avoid them. The last time his parents, Bill and Tina Franklin, saw Mike was at a family picnic before he left for Iraq. Mike spoke with his parents the night before the explosion that took his life. Mike very courageously gave his life so that other soldiers could go home to their wives and children.

Mike died at the age of 22. His brigade was patrolling Ramadi, one of Iraq's most dangerous cities. Mike was working at a checkpoint at one of the entrances to the city when a bomb detonated near the checkpoint. That day Mike gave his life in order to protect America and to ensure the freedom of Iraqi citizens.

Mike joined the Army because he wanted to follow in the footsteps of his two uncles who had served in the military and because his parents said that he truly believed in America's mission in Iraq. A beloved family member, a dedicated soldier, a noble citizen, Mike deserves the eternal gratitude of all those who have benefited from his selfless devotion to duty and democracy.

We are very honored today to have Specialist Franklin's father here with us, Mr. Bill Franklin. So will you please join me in recognizing and honoring Mr. Franklin.

I want to thank all the members for your support with HB 2026, and please join me in honoring Spc. Mike Franklin by supporting HB 2026. Thank you.

He was elected to serve as a member of the House of Representatives of Pennsylvania in the 1949-1950 and 1953-1954 legislative sessions, representing the 13th Legislative District; and in the 1955-1956, 1957-1958 and 1959-1960 legislative sessions, representing the 8th Legislative District. While a member of the House, he served on the Aeronautics, Corporations, Education, Law and Order, Municipal Corporations, Public Health and Sanitation, Public Utilities, Railroads and Railways and Ways and Means Committees. Additionally, he was a member of and served Vice Chairmanships on both the Insurance and Military Affairs Committees. Also a dedicated community servant, Mr. Floyd was a member of the 20th Ward Executive Committee for six years; Senior Vice Commander of Post 8400 of the Veterans of Foreign Wars; and a member and Chairman of the 20th Ward Good Government Club. He also was a member of Mt. Sinia Lodge No. 4, Free and Accepted Ancient York Masons, Prince Hall; and the Charles Memorial Baptist Church, where he served as a member of the Pastor's Aid Committee; now therefore be it
