PRAYER

RABBI SOLOMON ISAACSON, Guest Chaplain of the House of Representatives, offered the following prayer:

Good morning, ladies and gentlemen.

So I do not forget, later on today we will be distributing wine and matzo for everyone in honor of the holiday of Passover, which begins next Wednesday evening. If anybody is in Philadelphia and would like to attend a Seder, you are more than welcome to give us a call, and we would be honored to have any of you gentlemen or ladies join us for a Seder. If you have never seen one, to be at an Orthodox Seder is a very pleasant and enjoyable experience, and please let us know if you would like to attend.

We stand here before the holiday of Passover, and it reminds us to the fact that we should appreciate what the Almighty gives us. We take sometimes our lives for granted. We do not appreciate the wonderful country that we live in, a country where we are allowed to demonstrate and express ourselves without being afraid that we will be persecuted, without being afraid to say what our opinions are, and afterwards be prosecuted for it.

This is a country based upon liberty and justice, but this is based upon the fact of an incident that took place 3500 years ago when the Jewish people were freed from slavery after being in slavery for 210 years. It was only after they were freed that they began to really appreciate what freedom is. I do not think we need to, all of us, go into slavery for 210 years to appreciate our democratic country – even though I believe I am in a majority of a Republican House here, but the word "democrat," I did not mean in that sense – in the democracy that we live in.

So I think that we should maybe reflect upon and think about and really appreciate the wonderful country that we live in and all the attributes that this country comes with. We all have deficiencies, and I believe our country has those also, but let us look at the positive, let us look at the glass half full rather than half empty and take advantage of this wonderful country that we live in and to try to make our lives better lives, and we should work together to bring peace on the entire world. Amen.

That being said, I would like to at this moment say a prayer for the soldiers who are now working to maintain that freedom in other parts of the world.

May He who blessed our forefathers, Abraham Isaac, and Jacob, may He bless the fighters of the United States Army, Marines, Air Force, and Navy, who stand guard over our land and the cities of our God from the borders all over the world. May Hashem cause the enemies who rise up against us to be struck down before them. May the Holy One, blessed is He, preserve and rescue our fighting men from every trouble and distress and from every plague and illness; may He send blessing and success in their every endeavor. May He lead our enemies under their sway, and may He adorn them with the crown of salvation and with the diadem of triumph. And may there be fulfilled for them the verse, for it is Hashem, your God, who goes with you to battle your enemies for you to save you, and let us say amen.

(Prayer in Hebrew.)

He who grants salvation to the kings and dominion to rulers, whose kingdom is a kingdom spanning all eternities; who releases David, His servant, from the evil sword; who places a road in the sea and a path in the mighty waters, may He bless, safeguard, preserve, help, exalt, make great, extol, and raise high our beloved President, Vice President, Governor, Speaker of the House, and all the members of the House of Representatives.

The King who reigns over kings, in His mercy, may He sustain them and protect them from every trouble, woe, and injury; may He rescue them; may He gather peoples under their sway and cause their enemies to fall before them wherever they turn. May they succeed.

The King who reigns over kings, in His mercy, may He put into their heart and into the heart of all of their counselors and officials compassion to do good with us and with all the people of the great State of Pennsylvania.

In their days and in ours, may we be saved, and may the redeemer come quickly. So may it be His will. Now let us all say amen.

Thank you very much. God bless all of you again, and I wish all of you a happy Passover, and I believe Easter is also arriving at the same time. I do not know why it always works out that way. Does it not? But anyway, God bless all of you, take good care, and may He watch over you and protect you and give you much health and happiness.

Thank you, and enjoy the wine and matzo. It is delicious.

An Act authorizing and directing the Department of General Services, with the approval of the Department of Military and Veterans' Affairs and the Governor, to grant and convey, at a price determined through competitive bidding, certain lands situate in Columbia Borough, Lancaster County.

Mr. SIPTROTH. Thank you, Mr. Speaker.

Mr. Speaker, being a musician myself, I rise today to ask my fellow members of this House to join me in honoring an influential jazz musician. Admired for his strong attack and flawless execution, jazz trumpeter Clifford Brown left his mark on American music.

Born in 1930 in Wilmington and educated in Maryland, Clifford Brown was drawn to music at a young age. Trumpet was his first love. He made his short but vibrant career performing in Philadelphia and Europe. He played and recorded with greats like Dixie Dizzy Gillespie, Dinah Washington, and Charlie Parker.

In 1954 he formed the Brown-Roach Quintet with drummer Max Roach.

Sadly, on his way to Chicago with pianist Richie Powell and his wife, Clifford Brown was killed at the age of 26 in an accident on the Pennsylvania Turnpike in 1956.

I ask you, Mr. Speaker, to join me in honoring this man by passing this resolution to respect and pay tribute to a talented musician, who was dedicated to his craft but his life was drawn short.

We have walked this through the House and the Senate, and it is a good bill, and I ask for a concurrence vote.

An Act amending the act of January 17, 1968 (P.L.11, No.5), known as The Minimum Wage Act of 1968, further providing for minimum wage.

On the question,

Will the House agree to the bill on third consideration?

Mr. **TAYLOR** offered the following amendment No. **A07238:**

Amend Title, page 1, lines 1 through 8, by striking out all of said lines and inserting

Amending the act of January 17, 1968 (P.L.11, No.5), entitled "An act establishing a fixed minimum wage and overtime rates for employes, with certain exceptions; providing for minimum rates for learners and apprentices; creating a Minimum Wage Advisory Board and defining its powers and duties; conferring powers and imposing duties upon the Department of Labor and Industry; imposing duties on employers; and providing penalties," further providing for minimum wage; and providing for preemption.

Amend Bill, page 1, lines 11 through 15; page 2, lines 1 through 30; page 3, lines 1 through 23, by striking out all of said lines on said pages and inserting

Section 1. Section 4(a) and (a.1) of the act of January 17, 1968 (P.L.11, No.5), known as The Minimum Wage Act of 1968, amended or added December 15, 1988 (P.L.1232, No.150), are amended and the section is amended by adding a subsection to read:

Section 4. Minimum Wages.-Except as may otherwise be provided under this act:

- (a) Every employer shall pay to each of his employes wages for all hours worked at a rate of not less than:
- (1) Two dollars sixty-five cents (\$2.65) an hour upon the effective date of this amendment.
- (2) Two dollars ninety cents (\$2.90) an hour during the year beginning January 1, 1979.
- (3) Three dollars ten cents (\$3.10) an hour during the year beginning January 1, 1980.
- (4) Three dollars thirty-five cents (\$3.35) an hour after December 31, 1980.
- (5) Three dollars seventy cents (\$3.70) an hour beginning February 1, 1989[, and thereafter].
- (6) Six dollars fifteen cents (\$6.25) an hour beginning July 1, 2006.
- (7) Seven dollars fifteen cents (\$7.15) an hour beginning July 1, 2007.
- (a.1) If the minimum wage set forth in the Fair Labor Standards Act of 1938 (52 Stat. 1060, 29 U.S.C. § 201 et seq.) is increased above [three dollars thirty-five cents (\$3.35) an hour] the minimum wage required under this section, the minimum wage required under this section shall be increased by the same amounts and effective the same date as the increases under the Fair Labor Standards Act, and the provisions of subsection (a) are suspended to the extent they differ from those set forth under the Fair Labor Standards Act.

* * *

(e) In lieu of the minimum wage prescribed in subsection (a) and notwithstanding subsections (b) and (d), an employer may, during the first sixty calendar days when an employe under the age of twenty

years is initially employed, pay the employe training wages at a rate of not less than the minimum wage set forth in section 6(a) of the Fair Labor Standards Act (29 U.S.C. § 206(a)). A person employed at the training wage under this subsection shall be informed of the amount of the training wage and the right to receive the full minimum wage, or a higher wage, upon completion of the training period. No employer may take any action to displace existing employes, including partial displacements such as reduction in the hours, wages or employment benefits of existing employes, for purposes of hiring individuals at the training wage authorized by this subsection.

Section 2. The act is amended by adding a section to read:

Section 13.1. Preemption.—The regulation of minimum wages under this act is a matter of exclusive State control. Minimum wages may not be regulated by any ordinance, home rule charter provision, resolution, contract, rule or regulation of a political subdivision.

Section 3. All acts and parts of acts are repealed insofar as they are inconsistent with the addition of section 13.1 of the act.

Section 4. This act shall apply as follows:

- (1) The addition of section 13.1 of the act shall not invalidate any ordinance, charter provision, resolution, rule or regulation in effect on the effective date of this section.
- (2) The following provisions shall apply to contracts entered into or renewed on or after the effective date of this section:
 - (i) The addition of section 13.1 of the act.
 - (ii) Section 3 of this act.

Section 5. This act shall take effect immediately.

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Chair recognizes the gentleman, Mr. Taylor.

Mr. TAYLOR. Thank you, Mr. Speaker.

This amendment is really a gut-and-replace of HB 257. It increases the minimum wage immediately on July 1, 2006, to \$6.25 and then to \$7.15 an hour effective July 1, 2007.

Also embodied in this amendment is a training-wage provision which will allow employers to pay less than the minimum wage at \$5.15 an hour for those employees who are 20 and under and work for the first 60 days.

It also includes a preemption provision which prevents municipalities across this Commonwealth from devising their own minimum wage, grandfathering in Philadelphia, which has a minimum-wage standard that is different on employees who have worked under contract with the city of Philadelphia.

Mr. Speaker, we have not increased the minimum wage in Pennsylvania over and above the Federal standard since 1988. Nineteen other States have done this. Hopefully it is time today to do this and put this issue to rest, and I would ask for your support.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Veon.

Mr. VEON. Thank you, Mr. Speaker.

Mr. Speaker, I rise to strongly support the amendment being offered by the gentleman, Mr. Taylor.

First let me thank and commend the gentleman, Mr. Taylor, for his willingness to work together to find language that I am confident can be supported by the vast majority of the members here on the House floor.

I also want to take a moment to thank the gentlemen, Mr. Cohen and Mr. Belfanti, on the Democratic side for the leadership they have provided for many months now. Mr. Speaker, I think we certainly understand that this is a very

big, important step in the right direction to get a minimum-wage increase, get a bill signed into law by the Governor so we can in fact increase the minimum wage for over 400,000 Pennsylvanians.

I strongly support the gentleman's amendment and ask for an affirmative vote.

Thank you, Mr. Speaker.

Mr. Speaker?

The SPEAKER. Mr. Veon.

Mr. VEON. One other point I wanted to make, if it is in order.

The SPEAKER. The gentleman is in order.

Mr. VEON. Thank you.

Mr. Speaker, just a very brief interrogation with the gentleman, Mr. Taylor, just to clarify one point in the amendment.

The SPEAKER. The gentleman indicates he will stand for interrogation. The gentleman is in order and may proceed.

Mr. VEON. Thank you, Mr. Speaker.

Mr. Speaker, on the front page of the amendment on line 34, there is what we understand to be a technical mistake in the language, and the written words on line 34 say "Six dollars fifteen cents," and of course in parentheses the numerical change is "\$6.25." I just wanted to point that out and ask the gentleman to confirm my understanding that we are talking about \$6.25 and that this would be considered a mistake by the Reference Bureau for the purposes of passing this bill here today.

Mr. TAYLOR. Mr. Speaker, as everyone here knows, this was a lately arrived at agreement. My understanding is this is a typographical error that will be corrected by the Reference Bureau. The number should be in both the written and the numerical, it would be \$6.25 as of July 1, 2006.

Mr. VEON. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Cohen.

Mr. COHEN. Thank you, Mr. Speaker.

Mr. Speaker, new poverty guidelines released by the U.S. Department of Health and Human Services show the value of the minimum wage for low-income families has dropped again. A family of three with a full-time minimum-wage worker has experienced a \$500 drop in real wages over the last year or the equivalent loss of about 24 cents an hour.

Five dollars and fifteen cents an hour now represents only 64 percent of the poverty level for a family of three. This is the lowest minimum wage in terms of buying power in my lifetime. The minimum-wage worker today would have to work 62 hours a week, 52 weeks a year at two jobs just to meet the family-of-three poverty guideline of \$16,600.

Throughout the 1960s and 1970s, a minimum-wage worker was able to keep a small family of three out of poverty on a 40-hour-a-week job. Today even two full-time minimum-wage workers can barely keep up with what one minimum-wage worker could provide in 1968.

Today the smallest family of two, usually a mother and her child, earns barely 80 percent of the poverty guideline for a family of two.

And what about teenagers and young adults working to help support themselves and their families or to pay for education or seniors trying to supplement minimum pensions and pay for prescription coverage? Do they not deserve a raise? When we introduced HB 257 and HB 2021 early last year, we made a conscious decision to piggyback our efforts on the successful efforts in neighboring New York and then neighboring New Jersey. But with the release of these new poverty guidelines, it is apparent that delay has terrible costs to the low-wage worker we are trying to help. Even our own increase still leaves people working at the minimum wage in poverty. Today it takes a full-time wage of \$7.98 to keep a small family at the poverty line.

Five States have already passed legislation over the \$7.15 level that we are facing today. Washington is at \$7.63; Oregon is at \$7.50; Connecticut is at \$7.40; Rhode Island is at \$7.40; Vermont is at \$7.25. In California they are haggling over different plans to raise the minimum wage to \$7.75, and in New Mexico they are haggling over different plans to raise the minimum wage to \$7.50.

Today this represents a step in the right direction. It is a step in which labor can claim victories; it is a step in which business can claim victories; it is a step in which the people of Pennsylvania generally can claim victories. We are taking a good, solid first step towards raising the minimum wage to a level that keeps people out of poverty. Never again should people suffer because of political indifference. Pennsylvanians desperately need a minimum wage that provides dignity instead of poverty, and they deserve nothing less.

I urge the support of the Taylor amendment as a significant first step in the right direction.

The SPEAKER. The Chair recognizes the gentleman, Mr. Belfanti.

Mr. BELFANTI. Thank you, Mr. Speaker.

Mr. Speaker, I will be brief with my remarks.

I first would like to thank Chairman Cohen, the members of the House Labor Relations Committee, a few from the other side of the aisle, but all of them from my side of the aisle for finally bringing this to a head here today.

It is imperative. It is 4 years too late. It has been 4 years we have been trying to raise this wage to \$7.15, and as Chairman Cohen said, the real wage ought to have an escalator, a cost-of-living index, or a third tier raising this wage in the year 2008 to \$8 an hour. But today we are here in the spirit of compromise.

The training wage that was opposed by myself and members of my committee is a 60-day training wage. I appreciate Republican Chairman Bob Allen and his staff for negotiating that with us. We believe that is fair. What we believed was unfair would be a training wage for any child or any young person under the age of 18 or 19, because it would encourage certain employers from when that individual was about to reach that age of 18 or 19, to figure a way to lay that person off and bring on a new 16-year-old and pay them a training wage for 2 years. But a 60-day training wage is fair. A 60-day training wage will allow that person to learn how to make popcorn and sell it at the movie theater or ring a cash register at the Dollar General store, and we can agree to that compromise.

What we are still going to fight for over the coming years, just so everyone is on notice, is a cost-of-living adjustment. We believe that that is absolutely critical and necessary so that it is not another 8, 9, or 10 years before this issue resonates here before the members of the State House and the State Senate.

I am asking members from both sides of the aisle to support the Taylor amendment. I realize this issue has been driven by the House Democratic Caucus, but the gentleman, Mr. Taylor, has always shown himself to be a friend of the working man, and if the legislation was to be hijacked, as you would, by a member of the Grand Old Party, he is the individual that I feel proudest to stand here and support.

Finally, Mr. Speaker, for those individuals who talked about family values yesterday in a debate on family planning and Planned Parenthood, I would like to point out that there are instances and there is an individual in my district, a single mother, who works a full-time job at a Dollar General store at slightly over minimum wage, 20 hours a week in a convenience store in the evening at slightly over minimum wage, and her son worked for PENNDOT last year holding a flag and brought home more in his 40-hour-week paycheck than his single mother did working 60 hours a week. If we are going to promote family values, Mr. Speaker, that means these mothers have to be home, spend some time with their kids, spend some time with their husbands, if they are fortunate enough to have them, and that is what this wage will allow some of them, not all of them, to do. It is a compromise. It is not what we want; it is not completely what we want, but as Chairman Cohen said, it is a step in the right direction.

I strongly urge support of the Taylor amendment.

The SPEAKER. The Chair recognizes the gentleman, Mr. Thomas.

Mr. THOMAS. Thank you, Mr. Speaker.

Mr. Speaker, I rise to extend my sincere thanks and appreciation to Representative Cohen. I was an early cosponsor on HB 257. I welcomed that opportunity, and I want to also extend my sincere thanks and appreciation to Representative Taylor.

You know, one writer said that leadership is not measured by what men or women do in times of comfort and convenience but really what they do in times of chaos and conflict. Mr. Speaker, I know this was not easy for Representative Taylor and I know it is not easy for many members of this House, but, Mr. Speaker, it is the right thing to do at the right time with the right conditions.

Another writer said that leadership is measured by whether a man or woman can stand tall when forces are pulling against them and whether they can choose to do what is in their selfless interest versus their selfish interests. Mr. Speaker, Representative Taylor, Representative Cohen, and others are doing what is in their selfless interest, in the interest of humanity, and not in the interest of themselves.

And so on behalf of the people of the 181st Legislative District, I say thank you, thank you, thank you to Representative Taylor, Representative Cohen, and others.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Fleagle.

Mr. FLEAGLE. Thank you, Mr. Speaker.

Mr. Speaker, I heard a lot of differing views in my caucus, and I am sure the Democrats heard from different parts of their State, but I guess my position is not real unique, having a district in one of the areas that is contiguous with another area of the Commonwealth that has a State that has a much lower minimum wage than ours. Actually, Maryland – and I wake up every morning and look out my window and can see Maryland as can most of my district – has a minimum wage of \$6.15 an hour.

And frankly, Mr. Speaker, when I was asked throughout the last couple years, should we increase the minimum wage, my answer was yes, and I do think we should. I am kind of

disappointed that I was cut out of any kind of choice of how much that would be by the amendment process we are looking at here. This is a take-it-or-leave-it type of thing. And frankly, my response to people, whether it is businesses or my constituents, is, yes, I think we should increase the minimum wage, but we cannot raise it too much that we stop being competitive, and that is exactly what we are doing. We in Franklin County have a hard enough time competing with Maryland, with Washington County, that has a \$6.15 minimum wage, and ours is even lower than that and we still cannot compete with them.

But I think that this just goes too far, and I would certainly be willing to vote for something that is in the \$6.15 range, but I do not have that choice, Mr. Speaker. So I will be voting against this amendment, and hopefully as this goes along, the Senate will be a little bit wiser than us, hopefully, and send something back to us that will keep us competitive with Maryland yet allow my constituents to have a pretty solid increase. I think a \$6.15 increase is, what, 20 percent and \$7.15 is 40 percent. Forty percent would be devastating to my area, Mr. Speaker, and I certainly do not think a 20-percent increase is out of line, but we did not have that choice.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman, Mr. Maitland.

Mr. MAITLAND. Thank you, Mr. Speaker.

I rise to second the remarks made by the gentleman from Waynesboro.

I think a majority of people in my district would like to see a more modest increase in the minimum wage than that contained in this amendment. I think a 20-percent increase is reasonable, but given my 30-mile border with the State of Maryland and the agricultural base in my community that would be devastated by a 40-percent increase in the minimum wage, I have to be against this amendment and hope that it is defeated and that we can vote in a more moderate and reasonable increase in the minimum wage.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The gentlelady, Ms. Josephs.

Ms. JOSEPHS. Thank you, Mr. Speaker.

I stand to talk about the women a little bit who are making minimum wage, who are about two-thirds of the workers, and many, many of them have families and cannot make ends meet. I am hoping that those people on both sides of the aisle who are advocates for women, who worry about women's health, who worry about women's opportunities, women's educational and professional opportunities, will raise this minimum wage so that women can take care of themselves better and their families.

And I also want to say that several talk show hosts have made the claim that no businesses in the Commonwealth actually hire workers at the minimum wage in Pennsylvania. I want to tell you about one central Pennsylvania business called Movie Gallery, who hires their employees at \$5.15 or \$5.40 per hour based on their experience. Movie Gallery has many locations in central Pennsylvania. I am assuming that most of these locations are represented by the ladies and gentlemen of the Grand Old Party. They are Etters, New Cumberland, West York, Spring Grove, New Oxford, Palmyra, Elizabethtown, Ephrata, and Womelsdorf. So I am hoping if you heard a name of a community, regardless of what side of the aisle you are on, but I think you might be a Republican, where

people are being paid this kind of shameful wage, that you will vote with us and help your constituents out.

Thank you. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentlelady.

The Chair recognizes the gentleman, Mr. Eachus.

Mr. EACHUS. Thank you, Mr. Speaker.

I rise to support the Taylor amendment, and I say to those potential critics of an increase in this minimum wage that Pennsylvania at the wage rate of \$5.15 an hour has become essentially a Third World country on the east coast, surrounded by States like New York, New Jersey, Ohio, Delaware, Connecticut, Massachusetts, and the like who have increased their minimum wage to equal or greater amounts than the Taylor amendment. This move forward really is a way to say to our working families at the bottom of this economy, as Ms. Josephs said, two-thirds of the 500,000 people working for minimum wage in the Commonwealth of Pennsylvania are single women with children trying to find their way up to the next opportunity in this economy, and it is the right thing to do. It sends the message that we will not undervalue our people, and I think that is essential as a beacon. If we are all going to float the boat, we all have to float together, and what the Taylor amendment does for all of us is set this correctly.

Many of the businesses in our communities say that they cannot even attract people for \$5.15 an hour. So many of them have already made the decision to pay more. This base line of a minimum wage at \$6.25 and \$7.15 moves the bar forward for those families who are struggling at the bottom of our economy, and I do support the Taylor amendment.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The gentleman, Mr. DeLuca.

Mr. DeLUCA. Thank you, Mr. Speaker.

Mr. Speaker, I would like to just, I support the Taylor amendment, but I would like to read into the record from an individual who was watching PCN (Pennsylvania Cable Network) around February 1 when I made a comment on the floor of this House, and I hope you would just be a little patient. It is only a small couple of paragraphs, and I would like to read it to you. It is from a business called Rizzo's. It is a restaurant, a small restaurant, and I guess it is in Crabtree. I do not know where Crabtree is, and certainly I do not know the restaurant.

They said, "Dear Rep. DeLuca," I want to thank you for your comments you made on the floor of the House. "My family has owned and operated our family restaurant for the last 70 years. Being that we are in a rural, 'off-the-highway' location, we already are paying our employees at rates above minimum wage. It is the only way, along with our reputation, to entice folks to apply for work with us. Unfortunately, the combination of larger companies paying the current minimum wage and the fact that people can make more income by collecting assistance, we are finding it hard to get applicants for available positions. We have job openings – no one wants to fill them!! You asked a question we've been asking for years: Who is going to wash dishes and clean the restrooms? At our place, it is usually one of our family members!! Leveling the playing field by raising the minimum wage might just help us attract more applicants by encouraging non-working..." individuals "in general to seek employment."

I think this says it all from a small businessperson. He is in favor of raising the minimum wage, and certainly that is the right thing that we should be doing here today.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

PARLIAMENTARY INQUIRY

The SPEAKER. For what purpose does the gentleman, Mr. Cohen, rise?

Mr. COHEN. Mr. Speaker, I would like to thank the members for their support of the minimum-wage legislation.

I would like to raise a point of parliamentary inquiry.

The SPEAKER. The gentleman will state his point.

Mr. COHEN. Thank you.

Mr. Speaker, on March 6, 2006, the Appropriations Committee reported out HB 2021 on the House minimum wage. However, the committee chairman held the bill on his own reconsideration motion after the meeting had been adjourned. The Parliamentarian said it was his opinion that the committee had 5 days to consider the reconsideration motion. This has not happened. The bill has still not been read across the desk. I would like to know what the status is of HB 2021?

The SPEAKER. There will be no further votes cast on the floor of the House.

Mr. DeWEESE. Mr. Speaker?

The SPEAKER. Mr. DeWeese.

Mr. DeWEESE. At the appropriate time, I just wanted to share a few observations on the week, the month, the future.

The SPEAKER. The gentleman, Mr. DeWeese, is entitled to be heard. Just please keep the noise levels down. The gentleman, Mr. DeWeese.

Would the gentleman, Mr. Cohen, suspend to allow the gentleman, Mr. DeWeese, to speak?

Mr. DeWEESE. Would it be more appropriate for me to suspend and ask the gentleman, Mr. Cohen, to finalize the House business?

The SPEAKER. Mr. Cohen did have the floor, and we are looking up the answer for Mr. Cohen.

Mr. DeWEESE. I am sorry. I will-

The SPEAKER. So Mr. Cohen is deferring to you.

Mr. DeWEESE. Thank you, Mr. Speaker.

STATEMENT BY DEMOCRATIC LEADER

Mr. DeWEESE. Just 30 seconds.

The SPEAKER. The gentleman is in order.

Mr. DeWEESE. Mr. Speaker, Mr. Levdansky, Mr. Levdansky, the chairman of the Finance Committee, and I have talked recently as well as some other members of our rank and file, and we wanted to at least share one more time with our Republican brethren and sisters the inclination that some of us have to increase sales taxes in Pennsylvania very modestly, by half a percent or a percent. I know this mantra seems to be almost a tautology, day after day after day, but nevertheless, in this kind of setting it is appropriate.

We could reduce property taxes in Pennsylvania fundamentally, substantially, even overwhelmingly if we would embrace a very small sales tax. Because of dynamics that we are all very familiar with, many of us have been knocking on doors in rural townships and boroughs and school districts in our home counties. In Greene and Fayette and Washington Counties, and according to my good friend, Mr. Levdansky, even in his district in Elizabeth and the Allegheny section where he represents, we are hearing many, many people say, Mr. Speaker, that they would rather have a very small sales tax increase, a half a percent, a percent. I would even go higher if we could eliminate property taxes in Pennsylvania.

I know we have some Republican members that agree with us. We do not have a whole lot of support right now in the State Senate, but we have to take the bully pulpit, like I am doing right now, from time to time and repeat again and again and again that many of us are willing to increase the sales tax rate by half a percent or a percent and reduce property taxes overwhelmingly.
