The dogs have to be trained, whether your handicap is blind or another disability, and these people get these dogs, work with the dogs, and get them in a position that the dogs can actually be given to one of our Pennsylvania people who need those dogs.

There was legislation that was introduced to allow the training of those dogs to go into various locations. Currently our laws only allow a dog with a valid person to go into a restaurant, as an example, to eat, but you have to train the dogs in order to behave in those restaurants and how to act in those restaurants, and we are trying to get the bill passed that will allow that to happen.

Service dogs help spinal cord injuries, polio, cerebral palsy, muscular dystrophy, arthritis, stroke, and many other diseases that go unrecognized by many of us.

It is my pleasure today to recognize the Susquehanna Service Dogs. If you would please give them another round of applause, I would appreciate it.

Mr. STABACK. Thank you, Mr. Speaker.

Mr. Speaker, amendment 8055 allows hunters who are tracking a wounded animal with a blood-tracking dog to carry an authorized weapon during regular hunting hours. As the bill now reads, no one searching for their wounded animal can carry any weapon during regular hunting hours. With this amendment, when hunters find a wounded animal, they will be able to dispatch it legally and humanely.

Mr. Speaker, this is an agreed-to amendment, and I would ask for an affirmative vote.

Mr. WILT called up **HR 801, PN 4251,** entitled:

A Resolution honoring the life and extending condolences for the supreme sacrifice of Army Staff Sergeant David Michael Veverka, Maine National Guard company B, 3rd Battalion, 172nd Infantry Regiment, who tragically lost his life while saving his fellow serviceman, Private Chris Frasier, in service to our country in Iraq on May 6, 2006.

On the question, Will the House adopt the resolution?

The SPEAKER. On that question, the Chair recognizes the gentleman, Mr. Wilt.

Mr. WILT. Thank you very much, Mr. Speaker, and I do appreciate the attention of the members to recognize the life and service of S. Sgt. David Michael Veverka, the third Mercer Countian killed in Operation Iraqi Freedom.

When David Veverka attended Jamestown High School in rural Mercer County, he wrote an essay for the Veterans of Foreign Wars Voices of Democracy Scholarship Contest. In his essay, he wrote about his father, Ron, and his service in Vietnam. The theme of the essay was how much David admired his father's and others' service and what it meant to have the freedoms that we enjoy as Americans. His high school English teacher, Doug Hunter, remembered how serious David took the writing of the essay, and in news accounts of David's death, Mr. Hunter was quoted as saying, "I remember thinking that this was the best" high school "speech I ever read."

S. Sgt. David Veverka followed his hero's footsteps in 1999 by enlisting with the U.S. Army's 3d Battalion, 172d Infantry Division, where he served until 2002. Not wanting to burden his family with the cost of higher education, he volunteered with the Maine National Guard while studying marine ecology at the University of Maine. Upon being deployed to Kuwait and eventually to Iraq, he told his family, "The Army has given me so much, it's time for me to give something back"; do not worry about me.

On May 6, 2006, he was killed when a grenade thrown by a man walking the road with two young children was tossed into

his convoy vehicle. An instant before the explosion, he and Sgt. Dale James Kelly, Jr., pulled 19-year-old Pvt. Chris Frasier of Windsor, Maine, into the vehicle and shielded him from the shrapnel. Both Sergeant Veverka and Sergeant Kelly succumbed to their injuries a short time later. Mr. Frasier is alive today thanks to the heroism of Sergeant Veverka and Sergeant Kelly.

David Veverka was born September 15, 1980, in Greenville to Ronald Veverka and Carol Skakalski-Polley. He graduated from Jamestown High School in 1999 and was awarded a posthumous degree, summa cum laude, in wildlife ecology from the University of Maine. He was only eight credits shy from graduating when he was deployed to Iraq.

While a student, David especially enjoyed teaching middle school students about marine ecology, and in his spare time he enjoyed fishing, playing basketball, and outdoor adventure sports such as kayaking and mountain biking.

David Veverka was buried in Arlington National Cemetery, where ironically, during his period of enlistment from 1999 to 2002, he served there as a member of the elite Old Guard, which stands watch over the Tomb of the Unknowns.

Unfortunately, David's family is unable to be here with us today, but he is survived by his father, Ron Veverka, husband of Jodi Fey; mother Carol, wife of Jeff Polley; two brothers, Keith Veverka, husband of Tricia, and Doug Veverka, husband of Tammy; sister Sandra Soliday, wife of Scott; and three stepsisters, Natasha, Brianna, and Kylee Polley.

Please join me in remembering and honoring the life and service of Sgt. David Veverka by unanimously supporting HR 801.
