STATEMENT BY SPEAKER

The SPEAKER. As some of you may be aware, Joseph M. Murphy, who served as Sergeant at Arms since January 1990, passed away unexpectedly last Wednesday, February 7.

At this time we would like to observe a moment of silence in Joe's memory. Members and guests will please rise.

(Whereupon, the members of the House and all visitors stood in a moment of silence in solemn respect to the memory of Joseph M. Murphy.)

PRAYER

RABBI SOLOMON ISAACSON, Guest Chaplain of the House of Representatives, offered the following prayer:

I would just like to say something in memory of Mr. Murphy. We are taught that in the creation of a human being, there are three partners – Father and the Mother and the Almighty – and what the Almighty gives is the soul, the neshamma. When a person dies, the body dies but the soul continues to live on. And having met Joseph many times, I am sure that now he is the Sergeant at Arms by God's throne up in heaven. So I am sure he will do just as good a job there as he did for us here in the House. May God rest his soul. Amen.

In the Jewish calendar, which begins with the holiday of Rosh Hashanah, every week we read a different portion of the Bible. Saturday, on the Sabbath, we read the portion in Exodus that deals with the giving of the Ten Commandments, and many people know many of them, but one of the ones that are looked at a little bit and forgotten is the last one, "Thou shall not covet...." A person has to realize that God gives each of us what we are entitled to. There is always going to be somebody who has more, but there is always somebody who has less. Our rabbis teach us, who is rich? He who is happy with what he has.

I hope and pray that God will convey those types of feelings to all of us here in this room, to appreciate everything that the Almighty gives us. (Prayer in Hebrew.)

May He who blessed our forefathers, Abraham, Isaac, and Jacob, may He bless the Armed Forces of the United States – the Army, Navy, Air Force, and Marines – who stand guard over our land and the cities of our God. May Hashem, the Almighty, cause the enemies who rise up against us to be struck down before them. May the Holy One, blessed is He, preserve and rescue our fighting men from every trouble and distress and from every plague and illness, and may He send blessing and success in their every endeavor. May He lead our enemies under their sway, and may He adorn them with the crown of salvation and with the diadem of triumph, and may there also be fulfilled for them the verse, for it is the Almighty, Hashem, who goes with you to battle your enemies for you to save you, and let us say amen.

(Prayer in Hebrew.)

May He who grants salvation to kings and dominion to rulers, whose kingdom is a kingdom spanning all eternities; who releases David, His servant, from the evil sword; who places a road in the sea and a path in the mighty waters, may He bless, safeguard, preserve, help, exalt, make great, extol, and raise high our beloved President, Vice President, Governor, Speaker of the House, and all the employees of the House of Representatives and all the officials of this land.

The King who reigns over kings, in His mercy, may He sustain them and protect them from every trouble, woe, and injury. May He rescue them. May He gather peoples under their sway and cause their enemies to fall further before them. Wherever they turn, may they succeed.

The King who reigns over kings, in His mercy, may He put into their heart and into the heart of all their counselors and officials compassion to do good for us and wherever the entire country is, wherever the people are.

In their days and in ours, so may it be His will, and let us say amen.

HB 112, PN 413 (Amended)

A Resolution expressing profound sorrow for the death of Police Detective David M. Petzold of the Upper Saucon Township Police Department, who was killed in the line of duty on November 9, 2006

Mr. DeWEESE. Just would entreat with the Chair to make certain that we have order in the chamber, that all members be seated, and that the gentlelady be given the respect that this moment deserves.

The SPEAKER. The Chair thanks the gentleman.

All members will please take their seats, and the aisles will be cleared.

The lady may proceed.

Mrs. BEYER. Mr. Speaker, honorable colleagues, today I rise to report to you that we had a painful loss in the

131st District. Upper Saucon Township police officer David Petzold lost his life in the line of duty.

The details of his death are tragic to be sure. However, what is important for all of you to know is that in the predawn darkness on November 9, in the final moments of his treasured life, David was acting to ensure the safety of those he was sworn to protect and serve. David was an honorable, noble, kind, and generous man. Moreover, his loss was a tremendous blow to the community he served so well, and today we bestow upon his family the House of Representatives' highest posthumous honor recognizing Officer Petzold for his impressive service to the people he labored to protect.

David was a model officer. He was a hero. He served the residents of Upper Saucon Township for nearly a decade. For a brief time Dave left Upper Saucon to become an FBI agent, one of the most prestigious and highly selective law enforcement organizations in the world, but Dave longed to return to the community he loved so well, the place where his career started, to be there for his young and growing family and his beautiful wife, Jessica.

Dave believed he could make a bigger difference in people's lives by coming home. He was very active in the Upper Saucon community. Because of his expertise, Dave was the first investigator hired in the 18-man police force. Additionally, he worked as a D.A.R.E. (Drug Abuse Resistance Education) officer in the Southern Lehigh School District.

Officer Petzold was well known and well liked by the students he counseled. The impact of the time he spent with them must have been significant, because it is through their generous acts upon learning of his death, the children at the school district rallied to demonstrate how much they cared for him. Here are just a few examples of how these kids showed their appreciation and support to this grieving family: One child sold lollipop bouquets so that she might give something to the Petzold family, a group of middle school boys got together and held a football game in Dave's honor, and finally, a teenager celebrated her 16th birthday by urging her friends to bring a donation for the Petzold children in lieu of a birthday gift for her. It is in their acts of big-heartedness and respect for their fallen friend and his family do you genuinely witness the legacy of this selfless man.

To his colleagues, he was a man of integrity. They will tell you that you could find no one more dependable, trustworthy, or easygoing. He gave tirelessly of himself. He was the first officer to help and the last to leave when times were tough. He took the job of police officer to the next level. His professionalism and ethics were above reproach. No assignment was too large or too small. In the words of one fellow officer, "He was the cool head in the crowd." He was the one who always kept things under control.

The spirit of this 32-year-old man was filled with warmth and kindness. He was one of seven children from a very close-knit family.

(Fraternal Order of Police) president Mark Koch. Please join me in recognizing Dave's family and colleagues.

If I could just take a moment and say to my colleagues that we are commencing a new legislative session and we have many great responsibilities ahead of us, but in my mind, there is no greater responsibility of government than public safety, and it is these folks – our law enforcement officers, our emergency responders – that work daily and give so much of themselves and too often their lives to protect and serve all of us.

More than 20,000 uniformed police officers work in our streets daily, and in the past 10 decades, we have lost 703 officers. In my mind, our number one responsibility in this legislature is to make sure that we deliver to our law enforcement officers and our emergency responders and we afford them every possible opportunity to improve the safety for them as they do for us every day.

Mr. Speaker, it has indeed been an honor for me to stand in the well of the House chamber and to honor one of our Commonwealth's fallen heroes.

On HR 76 I humbly ask for an affirmative vote.

A Resolution honoring the life and extending condolences for the supreme sacrifice of United States Army Major Michael Lewis Mundell of the 1st Marine Expeditionary Force, who tragically lost his life in service to our country in Iraq on January 5, 2007.

Mr. SOLOBAY. Thank you, Mr. Speaker.

I stand before you today to offer condolence resolution 45 celebrating the life and honoring the sacrifice of U.S. Army Maj. Michael Lewis Mundell.

Michael was born and raised in the Canonsburg area, my hometown, and graduated in 1977 from Canon-McMillan Senior High School, where as a high school student got hooked on golf and forged a lot of lifelong memories and friendships with friends, oftentimes bringing them back to the Canonsburg area to reunite with those friends and play a little bit of golf on the links and perhaps play some cards. It is even rumored occasionally he had a few beers – I am not quite sure if that is true or not, but maybe Deanna could tell us about that – and shared a lot of laughs with his friends.

Mike's true calling, though, was the military. He studied history at Washington and Jefferson College and conducted ROTC (Reserve Officers' Training Corps) classes at Wright State University in Dayton, Ohio. As a hobby, he was a Civil War buff and loved painting miniature soldiers. Above all, he was an apolitical student of battle. He understood war's role in history and was proud to serve his country, and he served it well

Mike spent 10 years in the Army as a tank officer in Germany and Kentucky, where he met his wife, Audrey. He later worked as a civilian contractor for the Army, training officers for combat. When the Iraqi war broke out, Mike volunteered to return to active duty. He served his country well, receiving many honors. The list is long and impressive: the Bronze Star, the Purple Heart, Iraqi Campaign Medal, Global War on Terrorism Service Medal, Meritorious Service Medal, Army Commendation Medal, the Army Achievement Medal, the National Defense Service Medal, Armed Forces Reserve Medal, Army Service Ribbon, Overseas Service Ribbon, and the Combat Action Badge.

Ever since he was a kid, Mike wanted to be a soldier, but his priorities changed on him a while back when his children, Erica, Ryan, Zach, and Dale, came along. He was a devoted father – coached their baseball, soccer, and football teams – loving every minute he could spend with his family. Mike was a great dad to have around.

He shipped out for Iraq last Father's Day, promising his 17-year-old daughter, Erica, that he would be home in time for her high school graduation in April, a promise that fate is not going to let him keep. Mike died in Fallujah on January 5, killed by a bomb attack while en route to the scene of an American tank that had been hit by a large IED (improvised explosive device).

A few weeks before he died, Mike gave an interview to a reporter, telling him that the insurgents here "hate us all, American and Iraqi Army alike." I ask today that we pass this resolution as a way to express that although Mike may have felt the bitter sting of hatred in Iraq, here at home he is loved. I ask that we pass this resolution as a way to tell Mike's wife, Audrey, sons Ryan, Zach, and Dale, and daughter Erica as well as the family members that are here today with us that his life had value, his contributions were meaningful, and he will never be forgotten. And Erica, boy, I want you to know that your dad will be with you at graduation. Just look for him where he lives now, deep in your heart.

GUESTS INTRODUCED

Mr. SOLOBAY. I would like to now take a moment to acknowledge the members of Mike's family who are here with us today: Mike's cousin, Donna, and her husband, Ken Brophy, if they would stand; Mike's Aunt JoAnne and

Uncle Walter Gray; and Mike's sister, Deanna, and her husband, Ken Sofranko. If you could give them a round of applause, please.

As I mentioned, Mike was passionate about the Civil War. He read everything he could on the subject. It is fitting that we remember Mike the way many fallen Civil War soldiers were remembered. I would like to share a few lines from a song of that period, "The Vacant Chair." It tells the story of John Willie Grout, a young Union soldier who was killed in the fall of 1861. Willie's absence at the Thanksgiving table that year inspired these words:

We shall meet, but we shall miss him, There will be one vacant chair. We shall linger to caress him While we breathe our evening prayer.

At our fireside, sad and lonely,
Often will the bosom swell
At remembrance of the story
Of how our Willie fell.
How he strove to bear the banner
Thro' the thickest of the fight
And uphold our country's honor
In the strength of manhood's might.

Mike, may God bless you and your family during this most difficult time, and I ask now if you would all join me in the unanimous passage of HR 45.
