A Resolution honoring the life and extending condolences for the supreme sacrifice of Second Lieutenant Christopher Loudon, a member of 4th Infantry Division, 2nd Platoon, C Company, who tragically lost his life in service to our country in Baghdad, Iraq, on October 17, 2006.

Mr. SURRA. Thank you, Mr. Speaker.

Mr. Speaker, I will be honest with the members that I prayed that I would never have to stand before you and honor a fallen member of our military from my legislative district, but unfortunately, I guess my turn at the microphone has arrived.

Second Lt. Christopher Loudon, a member of the 4th Infantry Division, 2d Platoon, C Company, lost his life on October 17, 2006, in Baghdad.

I know the Loudon family very, very well. His father is a schoolteacher in the local school district; he had my sons. Chris's brother, Nick, went to school with my son, Andy, were very close, wrestled together. His mother also works in the schools back home, and these are good people. They have three fine sons, and you always hear the term it is always our brightest and finest. This is certainly the case with Christopher.

Christopher has a daughter. He is married to Jacey Laidacker Loudon. He is survived by his two brothers, 1st Lt. Nicholas Loudon, who is currently in Iraq and rode home on the plane with his brother's body in October, and young Jonathan Loudon, who is a senior at Brockway Area High School, and I had the honor of giving him an Eagle Scout award on Friday evening. And I gave an Eagle Scout award to his brother, Nicholas, and to Christopher. And it was announced that Jonathan is going to be attending West Point. So this is a family that has really given its all to protect our country.

Christopher enjoyed mountain biking, kayaking, backpacking, hunting, cooking, photography, much like his father. He was very athletic, very energetic, a very intense individual. He was a graduate of Officer Basic School, Airborne School, and Ranger School, and he died from injuries

resulting from a roadside explosion on routine patrol in Baghdad.

I would appreciate all the members remembering this family and this fine American today.
