NATHAN EACHUS PRESENTED

The SPEAKER. At this time we would like to ask Representative Todd Eachus to come to the rostrum to recognize his son for a very special achievement.

Mr. EACHUS. Thank you, members of the House.

I stand before you as a member of the 116th Legislative District, and today I also stand before you as a proud father.

I am joined today by our athletic director, Mr. Chris Perry; our head wrestling coach, Mr. David Shafer; my wife, Ellen, who is in the Speaker's well; and my son, Ben, who is with her as well. I am also joined with the gold medal in the 189-pound AAA weight class, my son, Nathan Eachus.

The Speaker has graced me with the Speaker's rostrum, so I will take a moment. I do not need a proclamation for this one.

I have been honored to be part of Nathan's wrestling life since he has been 6 years old, and it culminated last week at the Giant Center with the championship in the AAA 189-pound weight class against a very tough opponent from the Nazareth School District, and I wanted to really just take a moment to thank Coach Crowell and David from Nazareth for being just really good sports. It has been a tough season for them, but they were able to succeed; both of them were successful.

Nathan is a member of the Hazleton Area High School Wrestling Team and represents our first State champion in wrestling in the history of the Hazleton School District as well as the first State champion in any sport in our school district's history. So it is a proud moment for our community and our school district today to have Nate here.

His season record was 40 and 6. He is a junior in high school, so he will have another shot at a gold medal next year, God willing, and his career record is 97 and 23. He not only achieved the State championship, he was the runner-up in the Northeast Regional and he lost to Mr. Crowell, whom he beat in the final. He was the Keystone Games Champion, which took place at State College, as well as the Bethlehem Holiday Classic Champion, which is one of the toughest tournaments in the country.

Just one more moment, if I might. Nathan was quoted this week. He has realized what it means to be a public citizen this week, and I am not sure he has enjoyed it, but he was quoted in the newspaper and asked what his inspiration was, and he said that it was his brother, Benjamin, who is in the well, who was also a State qualifier. He did not make it through, but he said Ben was the reason why he was there and their work meant something.

So I wanted to thank Coach Shafer for everything he does for our boys in the Hazleton Area School District; Mr. Perry for his fine service. This is his last year. He will be retiring after 36 years as athletic director. This is his first State championship. Chris, we are proud that we could provide you with one, proud for me to be able to say that Nate Eachus is the State champion at 189 pounds.

Mr. KIRKLAND. Thank you, Mr. Speaker.

First of all, to the members and to Speaker O'Brien, I want to say thank you.

As we prepare to celebrate Black history, last month, as many of you know, we were unable to do it in February because of the inclement weather, and I appreciate having this opportunity today. I appreciate the Speaker affording us this opportunity today to celebrate it in a very, very small but yet major way.

The song "Lift Every Voice and Sing" is the national anthem to African-Americans. The author of this historic piece, James Weldon Johnson, was born June 17, 1871, in Jacksonville, Florida, and in 1900 he wrote the famous poem "Lift Every Voice and Sing," and then his brother, John Rosamond Johnson, transformed the poem into a beautiful song. In 1916 James Weldon Johnson joined the National Association for the Advancement of Colored People, where he dedicated over 15 years of service. On June 26, 1938, Mr. James W. Johnson was laid to rest. A car that Johnson was riding in was struck by a train during a heavy rainstorm in Wiscasset, Maine.

Today we will continue to carry on the amazing spirit of Mr. Johnson, and every time we go to lift our voices and sing, we can remember the legacy that he left behind.

Today a 12-year-old student from Swatara Junior High School, Master Marqil Chandler, will perform the Negro national anthem, "Lift Every Voice and Sing."

Please join me in standing as this young man comes before us today.

This is one of our former employees – and maybe she is coming back – Jeannie Porter's grandson, and it is one thing to be able to sing with music; it is an even greater task to sing without, a cappella. So we thank this young man.
