Mr. REICHLEY. Thank you, Mr. Speaker.

As some of you may know, in my former occupation as a prosecutor, I addressed several juries on death penalty cases, but as you can tell, I am having a hard time on this today.

The tragedy of the loss of one such as Sgt. Ashly Moyer is slightly tempered by the fact that she offered her life in the service of this country, and she believed in helping the people of Iraq.

Sergeant Moyer resided in Macungie, Lehigh County, Pennsylvania, and was a 2003 graduate of Emmaus High School, where she joined the delayed enlistment program. She comes from a family proud of its military service. Her grandfather was a World War II Marine who served at Iwo Jima and subsequently in Korea and Vietnam. Her grandmother also served in the Marines, and her father served in the Marines honorably for this country and continues to serve this Commonwealth, formerly as a liquor control enforcement agent,

now with the Board of Probation and Parole, and as a part-time police officer in Kutztown in Berks County.

In speaking with her father last night and his fiancée today, they recalled how Ashly was moved by the loss on 9/11. She enjoyed stories of the military life – excuse me – that she heard from her father and grandfather, but at the same time admitted that in her service in Baghdad, she cringed every time she passed a sand mound.

As I said, Ashly enlisted directly into the military, serving at Guantanamo Bay before being deployed to Iraq as a military police officer. On March 3, 2007, 1 month before her 22d birthday, while driving the second vehicle in a patrol in which she was carrying her lead officer, an IED (improvised explosive device) was detonated underneath the vehicle. Her fiancé was two vehicles back and attempted to rescue her but was repelled by ambush gunfire. She was honorably buried in Arlington.

She is survived by her parents, Michael Moyer and Jane Drumheller; stepparents; her younger sister, Teagan, who is celebrating her 10th birthday here with us today.

An Act amending the act of June 13, 1907 (P.L.560, No.373), entitled "An act designating the official flag of the Commonwealth of Pennsylvania, and describing the same; providing for the carrying of such flag by the regiments of the National Guard of Pennsylvania; authorizing the Secretary of the Commonwealth to provide, and have deposited in the office of Secretary of the Commonwealth, a model of said flag, and making an appropriation therefor," further providing for specifications for the official flag of the Commonwealth.

As well, this State flag design change in the law will not take effect until July 1, 2009. This will allow manufacturers, retail stores, suppliers, consumers, et cetera, ample time to phase this new flag into existence.

I thank the prime sponsor and several of my colleagues for working with me on this language, and I would ask for an affirmative vote on this amendment.

Mr. SOLOBAY. Thank you, Mr. Speaker.

Realizing this is only second consideration on this bill and it will not get to final passage until we come back in on the 21st, I just wanted to display a couple images, if I could, to those folks.

Presently our State flag is celebrating, I believe, its 100th anniversary or its 100th birthday this year, and viewing that flag, as many other flags at the Constitution Center in Philadelphia, I observed one distinct, unique scenario with the Pennsylvania flag, and that is, unless you truly know that that is the flag of Pennsylvania, by viewing it you cannot appreciate that it is from this Commonwealth.

The present design, as many have seen and many know, and of course the blue is not as vivid as it is on the regular flag, but this is the present concept of our State flag. What my bill would do would be to put recognition to the flag so that whenever other folks, other States, or even our own children and residents of this Commonwealth view the flag, they would know where it came from, and the flag that we would change to would be from this to this flag having the Commonwealth on it.

Again, those folks have that at their desks. I would ask that as time goes on, that we get the opportunity to vote this on May 21.

Thank you, Mr. Speaker.

The SPEAKER. Representative Samuelson.

Mr. SAMUELSON. I rise to interrogate the maker of the bill. The SPEAKER. The gentleman indicates he will stand for interrogation. The gentleman is in order, and he may proceed.

Mr. SAMUELSON. The question is about funding or fiscal costs. Is this only when flags are replaced, or is there a requirement in this bill that flags be replaced sooner?

Mr. SOLOBAY. The amendment that is in place on the bill right now gives an implementation date, I believe of – and, Russ, help me out on the date – I think it is a 5-year implementation on this? So, you know, obviously, outdoor flags will be replaced long before this. It is giving the opportunity for both replacement and for manufacturers to come up to speed on their manufacturing process.

So in the place of, you know, State buildings, whatever, obviously there are going to be flags that may still be out there, as there are right now. I mean, you look in some places, the U.S. flag still has 48 stars on it. So there will be no penalty against anyone if they do not, but any new flags that are being purchased or manufactured will have it.

Mr. SAMUELSON. And the top of this bill says "making an appropriation." Is there any funding associated with this bill? In the first paragraph of the bill, it says "making an appropriation," but I cannot find the appropriation.

Mr. SOLOBAY. There is a fiscal note, I believe, around \$90,000 for the Commonwealth usage right now, the changeover during that timeline. So it could be spread out over a period of time, and there is a fiscal note that has been requested and received, and that is the figure that we were given.

Mr. SAMUELSON. Okay. And I just ask that that fiscal note be provided to the members before the vote. It is not available as of today, but I appreciate your summary.

Mr. SOLOBAY. It has to go back to Appropriations after second consideration, so they may relook at that also.

The SPEAKER. Representative Beyer.

Mrs. BEYER. Thank you, Mr. Speaker.

Will the member stand for a brief interrogation?

The SPEAKER. The gentleman indicates that he will. The lady is in order. She may proceed.

Mrs. BEYER. Can you tell me how many States currently designate their State name on their State flag?

Mr. SOLOBAY. I believe, Mr. Speaker, that there were 17 or 18, if I remember correctly. I forget. I do not have my notes with me on that; I was going to have that ready for final passage. But I believe 17 or 18 that it is presently on -26. I am sorry, 26. I just got the information.

Mrs. BEYER. Can you tell me then how many Commonwealths indicate "Commonwealth" of their respective State on the flag? I believe there are five Commonwealths? Four?

Mr. SOLOBAY. Presently there are four Commonwealths, and I am not sure if it is listed on the other three or not. I could find that out.

Mrs. BEYER. Okay. Thank you, Mr. Speaker.

# STATEMENT BY MR. BELFANTI

The SPEAKER. The Chair recognizes Representative Belfanti under unanimous consent. The gentleman may proceed. Mr. BELFANTI. Thank you, Mr. Speaker. I will be brief. I have no prepared remarks.

I would just like to bring to the attention of the House that many members, both Republican and Democrat, who represent counties in the northern half of the State are very disgusted and beguiled by the actions last week of the Pennsylvania Game Commission whereby four members who are in favor of eliminating and eviscerating the doe herd, and they have been doing a very good job at that for the past 15 years through a series of game commissioners, that Chairman Boop, Tom Boop,

spoke out on behalf of sportsmen and said that the policy is not working and it must change, and because he spoke out, four of his members are now threatening to put him on some type of trial and remove him from office. I find that very disheartening.

We as a General Assembly have been hearing for 10 years from our sportsmen groups and others that apart from the hot spots down in southeastern, southwestern Pennsylvania where we believe two or three or four additional doe licenses may be warranted, the mountain regions of Tioga, Clinton, Potter, Northumberland, the doe herd is one-tenth the size of what it was when I was a 12-year-old. We are hurting our young people. We are keeping them from wanting to hunt, when they hunt year after year after year and do not see any deer.

The only part of the Game Commission policy that we all agree with is the 3-point rule, and I know many members here are not hunters so they may not understand that. But the doe management program ought to be called the doe massacre program in this State, and I think that Chairman or President Boop ought to be given a medal and not be threatened to be removed from office, and I do not know if the House has any power or ability to do anything about this issue, but if we are able to, I would like members who are hunters and represent northern tier counties to please contact me and Representative Phillips so we can see if we can do something about this.

# STATEMENT BY MR. PHILLIPS

The SPEAKER. Representative Phillips. Mr. PHILLIPS. Thank you, Mr. Speaker.

I rise to support my colleague from Northumberland County and the statement he has made. I cannot believe the action that was taken by four commissioners of the Pennsylvania Game Commission in removing a certain commissioner, a colleague, from being president of that commission. I think it is unbelievable. It is irrational that if somebody in any commission does not agree with somebody, that they would take action to have him removed.

He is an outstanding individual. He has done his job, and like I mentioned, you cannot condemn an individual if they do not agree. That is not how things should work. I think what it has done, it gave the Game Commission a black eye, and I know I got a tremendous amount of inquiries and e-mails and telephone calls from hunters throughout the State who cannot believe that an action like this would be taken, and like I mentioned before, I agree with the gentleman from Northumberland County, and I do not think action like this should be taken, and although we do not have control in the legislature over the Game Commission, we can still give our opinions as to what happened in this action that was taken a couple of weeks ago.

We will probably end up adding an extra voting day May the 24th so that the bill can be voted on final passage that week and sent to the Senate for consideration. We are trying to make sure that your month of May is organized. We would expect a short voting day, Mr. Speaker, on the Monday preceding that Tuesday and Wednesday, on May 21, and spend the balance of that day in caucus. The Republicans and the Democrats would meet separately and discuss at length our views on the budget.

This is very, very specific, and also equally important: Pursuant to rule 19(b), all amendments to the budget will need to be filed by 2 p.m. on Monday the 14th. We are going to ask the Reference Bureau to have attorneys here during the weekend to aid all of us in the preparation of amendments. As we have indicated again and again from a series of microphones and different settings within our committee structure and our

caucuses and here on the floor, the budget numbers are tight in the Keystone State and your amendments to add any new programs will have to be accompanied by amendments to delete other dollars from the budget. They will have to be revenue-neutral numbers. We have better revenue yields than we had anticipated, but we still have very, very serious deliberations on whether we will need additional revenue to carry on the State's business.

But I hope that this scheduling – it is not a portrait, but it is a sketch of the month of May – will be helpful, and I stand here to answer any other logistical questions that might be forthcoming, Mr. Speaker.
