BISHOP GUILFOYLE HIGH SCHOOL GIRLS BASKETBALL TEAM PRESENTED

The SPEAKER pro tempore. The Chair requests that Representative Geist come to the podium for a presentation, please.

Representative Geist.

Mr. GEIST. Thank you very much, Mr. Speaker.

It is certainly a pleasure for me today to be able to introduce to the House the Class A girls basketball champion, Bishop Guilfoyle High School. I have had the pleasure of watching these kids for the last 3 years, actually for many, many years, and what a year they had; what an absolutely phenomenal year. To be a State champion is absolutely an amazing thing.

At this time I would like to introduce the team members, who are in the back, and coaches, and when I call your name—No; I will just introduce the team, have the team stand up in the back; give a round of applause.

During the playoff run Mark Moschella executed some great coaching moves, and I know that, I sat with Representative Walko, whose North Catholic team was an excellent team, and watched the State championship game, and Mark always has something that he pulls out of his pocket, great coaching moves that you never expect; neither does the other team expect it. During the State championship game when things were really tough and, you know, we needed a big shot, we needed a

3-pointer desperately, he put the secret sign in, and Dani Williams shot that 3 from the corner. Being the ace shooter that she was, it was all net, and I think that was just probably one of the most exciting plays, to know that you have an official 3-point shooter like that.

The game was great. The team was great. The coaches are absolutely wonderful. Behind me I have Coach Moschella and coach Bill Adams, and I always call Bill the biggest kid in Altoona. They have done an absolutely fantastic job, along with the other coaches in the back, and we just think that this is a very, very great day to honor Bishop Guilfoyle.

Also behind me are Mary Forr and Courtney Carroll. Mary has scored 1,000 points in her career, or more, and they were true leaders of this team as captains – Mary with her great hook shot in the championship game, and Courtney controlling the point, and they went to that stall game early on and did not score for the first 6 minutes, to add a little drama. And we are just pleased to be able to honor them today, and I would ask you to give Bishop Guilfoyle High School a really warm welcome to the General Assembly. And, Mark, I would like to present this citation to you.

YORK SUBURBAN HIGH SCHOOL BOYS SWIM TEAM PRESENTED

The SPEAKER pro tempore. The Chair would like Representative DePasquale to come to the podium, please.

Mr. DePASQUALE. Good morning, everyone.

I stand with Representative Keith Gillespie today as we both represent the Suburban School District and their head coach, Dick Guyer, who also is an elected official and serves a dual role of being a public school swim teacher and also an elected official in local government. So I want to congratulate him and the rest of his team on back-to-back State championships in swimming. As you can see, there are only nine members of the swim team up here, but yet six of the nine are first team United States all-Americans.

So this is a back-to-back State championship for the Suburban Swim Team, and I thought that was an honor worthy of having them up here on the dais, and I want to congratulate them. Last year they won it with only six members. This year they are doing it with nine, and this is the first swimming back-to-back State championship in the history of York County, and we only found two other instances of it happening in the entire history of Pennsylvania. So I want to congratulate the Suburban Swim Team and stand with Representative Gillespie as we do that.

SCHENLEY HIGH SCHOOL BASKETBALL TEAM PRESENTED

The SPEAKER pro tempore. If Representative Wheatley could please come to the rostrum.

Representative Wheatley.

Mr. WHEATLEY. Thank you, Mr. Speaker.

If I could, it is not often that I have had the opportunity to stand in front of all of you and to be honored in presenting such a wonderful, wonderful set of things that I think we have always talked about as some of the reasons why we do what we do,

is for the youth and young people, and so before you this morning, I have the very distinct pleasure and honor to present to you some wonderful young men, some young men who since 4 years ago, I think two of them at least behind me, came into high school on a mission, on a mission to make history, and to represent a city, a school, and a neighborhood in a way that we have not seen since the late seventies. Now, they started out as freshmen; then as sophomores, got a little closer to that dream in the quarterfinals; then as juniors, had the distinct pleasure of coming to the State and by 2 points and a flimsy call, missed that opportunity, but they promised last year that if they got back to the State championship, they would finish the deal.

Behind me, ladies and gentlemen, you are looking at members and representatives of what many have deemed and called the greatest basketball team, or one of the greatest basketball teams to come out of western Pennsylvania in the last 25 years. They were the first basketball team from the City League, the city champions, to win the highest classifications in our State since 1978. You are looking at gentlemen who epitomize, I think, the examples of hard work, perseverance, dedication to a cause. You are looking at the Schenley High School Basketball Team, who just recently captured, who just recently captured the championship, the State championship, Class AAAA State championship, and they did this under the guidance and leadership of Coach Skrocki, and they did this under some talented players, two of whom are standing behind me: DeJuan Blair, whom they used to call "Baby Shaq," but he likes to be referred to as "Big Fella." Am I correct? And then the driver of the ship, the small man next to him, Jamaal Bryant, whom they refer to as "Onion." Am I correct?

These gentlemen, ladies and gentlemen, these men have made me proud, they have made a city proud, and they have definitely brought energy and honor to a neighborhood. I want you to join with me in recognizing the 2007 PIAA Class AAAA State Boys Champions, Schenley High School Spartans.

And just as a caveat, just as a caveat, just as a caveat, as I may, because I want to recognize something – and I am going to let the mike go, Mr. Speaker, in a minute - I want to recognize that they did this, they did this by beating one of our most well-known and recognized programs from the east. Now, last year we did this, I had a member here put a challenge before me, and I had to bow down because my team was stolen, the championship was stolen from my team, but that is all right, but this year another member from the east thought that they had a chance against our great Schenley basketball program, and that member is Representative Kirkland. Now, Representative Kirkland – he is right there; he is standing up, but he is short – Representative Kirkland promised my team that if we were to beat his Chester team, that he would have our colors on. We also brought him a shirt. He is not wearing it, but he needs to put his shirt on. And he has made a commitment to feed our team, so we have some hoagies from Furillos – is that right? – in Chester. We have that in the Irvis Office Building, and we would love for members to stop by and further fellowship with us as we celebrate this championship. So thank you.

Pennsylvania hosted 138 million guests in 2005 alone, placing our Commonwealth neck and neck with New York as the fourth most visited State in the country. Those tourists pumped \$25.7 billion into the State's economy. That money is spent to enhance the bottom line of a variety of Pennsylvania's industries, including transportation, food service, retail sales, lodging, and entertainment. As a result of that spending, our State and local governments get a shot of \$2.6 billion in tax revenues, a lot of it coming from those who visit outside of Pennsylvania.

All of this business supports, directly or indirectly, the jobs of almost a half a million Pennsylvanians, and that is to say nothing of the societal importance of tourism in Pennsylvania – the bonds that we form by taking family vacations and the links that we create with our past, with nature, and with the world.

One dedicated group of people, right in the heartland of Pennsylvania, does its part to make tourism work in Pennsylvania. By combining history and entertainment, the men and women behind the Pennsylvania Renaissance Faire provide an experience that everyone should have the opportunity to enjoy. They join us today to proclaim in their own grand style what an important day it is in our beautiful Pennsylvania.

Please join me in welcoming from the Pennsylvania Renaissance Faire Her Majesty, Queen Elizabeth, and the Lord High Sheriff Governor Marshall Law, the Earl of Kent.

PROCLAMATION BY EARL OF KENT

EARL OF KENT. Hear ye, hear ye.

Let it be known on this day in the year of our Lord 2007 that Her Majesty, Queen Elizabeth I, has traveled forth through time and has chosen the great Commonwealth of Pennsylvania to visit, just as over 130 million visitors have chosen Pennsylvania annually. Representing all the tourist concerns in this great Commonwealth, she comes today to laud the Tourism and Recreational Development Committee of the Pennsylvania House of Representatives for its many accomplishments in its short 14-year history.

At the time of its founding in 1997, this was the first statewide program of its kind in the United States, and it since has grown from 200 volunteers to 2900 today. This program has given seniors a meaningful opportunity to help monitor and protect water supplies and to share their concern for and knowledge of the environment with others, especially younger generations.

In addition, volunteers have located abandoned oil and gas wells, cleared invasive species from waterbeds, and photographed the progress of the projects. The program has contributed the equivalent of \$8 million worth of volunteer time during its 10-year history.

Furthermore, this successful program has been recognized by the United Nations Environment Programme, the President's Council on Sustainable Development, RenewAmerica, county governments, and watershed groups all across the nation.

Join with me, if you will, by not only endorsing but congratulating those who do the most ombudsman work. Let us support HR 260.
