They were the two blockbuster movies, but the best picture of the year was about an underdog from Philadelphia, Pennsylvania, by the name of Rocky Balboa. I was a senior in high school, 17 years old, and I think the one piece of history that George can relate to the most and all of us on our side of the aisle that talked with George about one of his favorite pastimes was Seattle Slew won the Kentucky Derby, Triple Crown as well, and certainly I am sure George may have had a little bet on that race.

But George was hired in 1977. Some of the members may remember the gentleman that he came to Harrisburg with, and his name was Bernie O'Brien. He was chairman of the Mines and Energy Management Committee. Kevin Blaum served in that seat for a number of years, and now Eddie Day Pashinski serves in that seat. But he cut his teeth with Bernie O'Brien and then moved on to work with Fred Taylor, where I think he honed his golf skills. Right, George? Fred Taylor was an avid golfer. George was a 36 handicap; now he is a 10.

But the reality is that George has been an outstanding, dedicated, hardworking employee of this House of Representatives. I have known George for almost the entire 30 years because my father served before me. Bernie O'Brien and my dad were great friends, and I got to know George before I was elected, but then when I was elected, he was one of those staff persons that, you know, kind of takes you under their wing and makes sure that you do the right things as you represent the people that elect you here in Harrisburg.

But George has been involved in many pieces of legislation, but I think when property taxes finally get reduced, when gaming money finally gets to the table, the one crowning moment was the work that George Bedwick did on the gaming legislation. He was truly a leader, truly a hard, diligent worker in making sure that all of the t's were crossed and all of the i's were dotted in formulating that piece of legislation.

He will certainly be a tough gentleman to replace, and I know we all say that it is easy to replace people in this chamber and, really, in any walk of life, but I can honestly say one thing about George that will be sorely missed and I do not think can ever be replaced. The institutional knowledge that this man has, his knowledge of the rules, but the institutional

knowledge and history that he has of this House of Representatives is certainly something that will be very, very difficult to replace. He has an encyclopedic memory, and it is something that will be sorely missed I know by me. I have only had him on my staff for 6 months. He really worked on the leadership team of Ivan Itkin and then certainly with Mike Veon and then me for the last 6, 7, 8 months. But we will certainly miss his institutional knowledge and that encyclopedic memory that he does in fact have.

So I certainly want to wish George Godspeed in his travels, and I know that the next time the Kentucky Derby comes up, I know there will be a lot of e-mails over to George to find out who the winner – and by the way, he did pick last year's winner – we will be asking George who we should be betting on with the Kentucky Derby. But Godspeed to you, George, in your retirement. I hope you enjoy it. Get your golf clubs and get that bag and travel.

Thank you, Mr. Speaker.

The SPEAKER. As Representative McCall reflected back so many years when he was 17, I was 23 when I first came to this chamber. George and I were fondly exchanging stories, because our first meaningful participation in the legislative process we began together in February of 1977, and if you thought this budget was tough, you should have been here in '77, and out of respect for Representative John Taylor, I am not going to tell any of those '77 budget battle stories.

But in passing, one thing that Representative McCall did not mention was George's distinguished military service while attending Dickinson Law School. He participated in the Dickinson College ROTC (Reserve Officers' Training Corps) program, and he spent 6 weeks in training in his first year of law school at Fort Knox, Kentucky – so maybe that is where he got his helpful hints on how to predict the Kentucky Derby – and the second year at Fort Indiantown Gap, and upon graduating law school, he entered the Army Reserves and continued his Reserve service for 20 distinguished years.

And, ladies and gentlemen, as I talked to George downstairs in my office, we reflected on some personal stories that we had, and I remember in 1980 I left the halls of this House. I had bigger and grander designs, which did not work out, and I came back in '82, but I remember everybody wishing me well as I walked out, and then I remember being alone with myself as I left this chamber. Please join me in sharing your personal stories with George so this last day is truly a memorable day.

Ladies and gentlemen, I present George Bedwick.

Section 1. The definitions of "police department" and "police officer" in section 2162 of Title 53 of the Pennsylvania Consolidated Statutes are amended to read:

§ 2162. Definitions.

The following words and phrases when used in this subchapter shall have the meanings given to them in this section unless the context clearly indicates otherwise:

* * *

"Police department." Any of the following:

- (1) A public agency of a political subdivision having general police powers and charged with making arrests in connection with the enforcement of the criminal or traffic laws. This paragraph includes the sheriff's office in a county of the second class.
- (2) A campus police or university police department, as used in section 2416 of the act of April 9, 1929 (P.L.177, No.175), known as The Administrative Code of 1929, certified by the Office of Attorney General as a criminal justice agency under the definition of "criminal justice agency" in 18 Pa.C.S.

§ 9102 (relating to definitions). This paragraph does not include a campus police or university police department of the State System of Higher Education and its member institutions.

- (3) A railroad or street railway police department formed with officers commissioned under 22 Pa.C.S. Ch. 33 (relating to railroad and street railway police) or any prior statute providing for such commissioning.
 - (4) The Capitol Police.
 - (5) The Harrisburg International Airport Police.
 - (6) An airport authority police department.
 - (7) A county park police department.

"Police officer." Any of the following:

- (1) A full-time or part-time employee assigned to criminal or traffic law enforcement duties of any of the following:
 - (i) A police department of a county, city, borough, town or township.
 - (ii) Any railroad or street railway police.
 - (iii) Any campus or university police department.
 - (iv) The Capitol Police.
 - (v) The Harrisburg International Airport Police.
 - (vi) An airport authority police department.
 - (2) A deputy sheriff of a county of the second class.
- (3) A security officer of a first class city housing authority or a police officer of a second class city housing authority.

(4) A county park police officer.

The term excludes persons employed to check parking meters or to perform only administrative duties and auxiliary and fire police.

Amend Bill, page 2, by inserting after line 30

Section 4. Section 2168 of Title 53 is amended by adding a subsection to read:

(e) County park police.—Any county park police officer who has successfully completed the basic training course under this subchapter prior to the effective date of this subsection shall be assigned a certification number under this subchapter but shall be required to complete the in-service training as set forth in section 2164(7) (relating to powers and duties of commission).

Amend Sec. 3, page 3, line 1, by striking out "3" and inserting

On the question.

Will the House agree to the amendment?

The SPEAKER. On the amendment, the Chair recognizes Representative Pallone.

Mr. PALLONE. Thank you, Mr. Speaker.

This amendment does nothing more than improve an already standing law that we passed back in November of 2004, which gave the county park police in a third-class county the ability to have law enforcement powers and authority. We basically gave them their badge, their gun, their uniform, and their jurisdictional limitations, but there is a component missing which requires them to have the MPOETC (Municipal Police Officers' Education and Training Commission) number, which gives them the ability to be able to actually issue citations.

Currently there is only one county park police department in Pennsylvania. It is in Westmoreland County. Anytime that they enforce any of the laws on county property, they have to call either the local police department, Greensburg police because of the courthouse, or the local county detectives to make the actual arrest and issue the citation.

This particular component of two bills that otherwise passed and were signed into law back in 2004 will actually give the county park police the ability to be able to issue their own citations and appear in court and so forth for proper enforcement.

Mr. REICHLEY. Thank you, Mr. Speaker.

This amendment was prompted by a request from the Lehigh County Solicitor's Office representing the sheriffs. It specifically is limited to the, I believe, five home-rule-charter counties within Pennsylvania.

Under current law, in order for sheriff's fees to be either increased or decreased, it would require State legislation, and this would empower merely the five home-rule counties to have the ability, by ordinance of the county commissioners, to set the sheriff's fees within those particular counties. This does not mandate any kind of sheriff's fee increase or decrease. It specifically does not affect the county of the first class, Philadelphia, because I think Philadelphia already has this ability. So this does not affect any non-home-rule-charter counties and is really limited to just empowering the five

home-rule-charter counties to be able to have greater flexibility setting their own sheriff's fees.

BILL ON THIRD CONSIDERATION

The House proceeded to third consideration of HB 487, PN 1411, entitled:

An Act providing for notice of motor vehicle event data recorders and for information retrieval; imposing penalties; and providing for evidentiary rules.

The SPEAKER. The question is, shall the bill pass finally?

Representative Harhai.

Mr. HARHAI. Thank you, Mr. Speaker.

HB 487 creates the Event Data Recorder Act to provide for information retrieval from an event data recorder in a motor vehicle.

An EDR is similar to black boxes used in commercial airliners. EDRs record what a car is doing. EDRs record information such as steering wheel movement, whether brakes were applied and the level of brake pressure, the speed of the vehicle, whether a seat belt was buckled, and the actual movement of the car itself. If there is a crash, the EDR stops and records that last several seconds of the operations of the vehicle leading up to the event.

EDRs were developed because the National Transportation Safety Board, NTSB, advocates the use of EDRs to improve transportation safety. By providing comprehensive data, EDRs assist safety researchers, accident investigators, and automotive designers in developing ways to reduce severity of vehicle accidents in the future.

However, most consumers do not know what an EDR is, let alone the fact that they probably have one in their vehicle and they record braking, speed, seat belt use, et cetera. According to the National Highway Traffic Safety Administration, 65 percent of model year 2005 vehicles were equipped with EDRs.

Unfortunately, like with all new technology, there are now incidents when the EDR data is being used for purposes beyond the original intent – namely, in court proceedings and in insurance matters.

My legislation requires that a vehicle manufacturer disclose that an event data recorder, EDR, exists in the vehicle. Additionally, EDR data would only be retrievable if the owner of the vehicle provides consent, a lawfully issued subpoena is produced, it is used for purposes of increasing vehicle safety, and the device is retrieved for the purpose of diagnosing or servicing the vehicle, or even the National Transportation Safety Board should make a request for the data as part of an accident investigation. It also provides the downloaded EDR data should not be used unless supported by other evidence in determining the cause of an accident.

Mr. Speaker, while technology brings advancements and benefits, evidence has shown that EDR data is not always reliable and as a result should not be used unless supported by other evidence in determining the cause of an accident. Let me give you an example.

In 2004 Maine Gov. John Baldacci was involved in an accident in his State-owned SUV (sport-utility vehicle) when the car, driven by a State Police detective, hit an ice patch while passing a slower car and caused both vehicles to spin off the highway. Although the EDR indicated the SUV was traveling 71 miles per hour before the air bag deployed, the detective driving the car claimed the speedometer showed 55 miles

per hour, a number that was closer to the 55-65 miles per hour that police investigators estimated based on physical evidence at the scene. The EDR also indicated that the Governor was not buckled in, although Baldacci and his driver disputed this. Medical personnel who treated the Governor also said his injuries, which included a broken rib, were consistent with someone wearing a seat belt.

A similar case recently happened in Westmoreland County, in my district, Mr. Speaker. A gentleman was charged with vehicular homicide in a crash caused by a freak snow squall that killed his pregnant wife and another driver. With no skid marks or air bag deployment, the Commonwealth of Pennsylvania proceeded to prosecute this man for two felony counts of homicide by vehicle with information obtained from the EDR. The EDR said the man was traveling at a speed of 58 miles per hour 5 seconds before the accident and 51 miles per hour 1 second before the accident. The Pennsylvania State Police accident reconstruction expert— Mr. Speaker? Mr. Speaker? May I have a little—

The SPEAKER. The gentleman is entitled to order. Caucuses in the side aisles will break up; caucuses in the center aisles. Members will take their seats.

The gentleman is in order and may proceed.

Mr. HARHAI. Thank you, Mr. Speaker.

The PA State Police accident reconstruction expert, using crunch factor calculations, determined the speed at the time of impact to be between 30 and 40 miles per hour. Again, the air bags did not deploy, but State and local police were convinced that the EDR was accurate and used it as the sole piece of evidence claiming reckless driving caused the accident. After being released from the hospital and attending to the funerals of his wife and unborn son, the gentleman was arrested. Thankfully, Mr. Speaker, the gentleman's attorney learned that the EDR in the vehicle was subject to a recall. He also learned that there are no Federal or Pennsylvania guidelines regulating the use, disclosure, calibration, installation, or removal of EDRs. Thankfully, the gentleman was acquitted, but only after a very expensive trial defending himself against faulty technology that he most likely had no idea was even in his vehicle in the first place.

Finally, Mr. Speaker, limited tests of EDRs have indicated that if power to an EDR is lost during the crash, the device may not record all data or could falsely record seat belt data. The vehicle's speed can also be recorded inaccurately if the car is airborne during an accident, rolls over, or loses a wheel from the drive axle.

Mr. Speaker, HB 487, long overdue, is a good consumer protection bill that alerts and protects consumers from having well-intentioned technology used against them without their consent and requires additional evidence to prove that the technology is in fact accurate.

I ask for an affirmative vote on my legislation, Mr. Speaker, and I thank you very much.

The SPEAKER. Representative Reichley.

Mr. REICHLEY. Would the prime sponsor of the bill stand for brief interrogation, Mr. Speaker?

The SPEAKER. The gentleman indicates that he will. The gentleman is in order and may proceed.

Mr. REICHLEY. Thank you, Mr. Speaker.

Let me just preface my questions by saying I fully understand and sympathize with the intentions of the prime sponsor.

Mr. Speaker, would you be able to describe for the members of the House if similar legal provisions are in place in the States surrounding Pennsylvania with regard to the EDRs?

Mr. HARHAI. There are roughly between 11 to 13 States that do have it. Surrounding Pennsylvania, I do not believe anyone, to my knowledge, has that at this point.

Mr. REICHLEY. Okay. So if this legislation was to become law as it stands today, there is not a concurrent obligation upon New Jersey drivers, for instance, to have an EDR in place and to have driving activity which could be downloaded from such a device?

Mr. HARHAI. Currently the Federal government is establishing the regulations, but all we want to do is to let people know that the data is within the vehicle. I do not think any State has anything presently, but I know that multiple States, in the neighborhood of 20 to 30 States, are working on similar legislation, but the Federal government really rules the roost on this issue.

Mr. REICHLEY. Okay. And, Mr. Speaker, I believe that – and I cannot see my computer screen from here – but I think you have certain requirements specified where the information is downloadable; for instance, with a subpoena. Is that correct?

Mr. HARHAI. I am sorry. Could you repeat that, please.

Mr. REICHLEY. The bill prohibits the downloading or the retrieval of data unless one of the following conditions applies, and you have six different elements built into that. Is that correct?

Mr. HARHAI. Yes, sir.

Mr. REICHLEY. And one of those is that a subpoena is lawfully issued; number two, I think. Is that correct?

Mr. HARHAI. Yes.

Mr. REICHLEY. When you are referring to a subpoena, are you including a subpoena duces tecum, which is provided for under the Rules of Civil Procedure?

Mr. HARHAI. Yes.

Mr. REICHLEY. Mr. Speaker, would the scenario then be in a motor vehicle accident where a civil suit is initiated, the plaintiff's attorney or the defendant's attorney could serve a subpoena duces tecum upon the opposing party to get the downloadable information or the retrieved information from the EDR?

Mr. HARHAI. What we are looking at is all parties being given equal footing on being able to get the information – insurance, law enforcement, the owner of the vehicle – and that was the biggest point. The owner of the vehicle at one point did not have the ability to get that information, but they paid for the vehicle in the beginning.

Mr. REICHLEY. I understand the response, Mr. Speaker, but I think my question was, in a civil lawsuit, would the information from one party to another be obtained merely upon the service of a subpoena duces tecum, which is more or less a subpoena for production of records and documents?

Mr. HARHAI. Yes, it would.

Mr. REICHLEY. Would you agree, Mr. Speaker, that such a subpoena under the Rules of Civil Procedure does not in fact require a judicial signature or any review of the merits of the request by an independent party?

Mr. HARHAI. The court itself could rule that it is inadmissible. That would be a ruling on their part.

Mr. REICHLEY. And I notice you were speaking with the gentleman, Mr. Longietti, who I know has experience as a lawyer, particularly in civil matters. Mr. Speaker, I take it,

though, that the courts ruling on any question of admissibility would be after the fact that the information has actually been obtained by the lawyers in the civil suit merely by means of a subpoena duces tecum.

Mr. HARHAI. I do not know if this is answering your question or not, Mr. Speaker, but we had help from the trial lawyers to get the verbiage correct in order to avoid any conflict, and that is what we based this upon. I do not know if that helps you or it does not.

Mr. REICHLEY. No. I think it is helpful, Mr. Speaker. I appreciate that.

My final question, Mr. Speaker, would be, does your legislation enable a private vehicle purchaser to go to the dealership to say, I want you to disconnect this device?

Mr. HARHAI. At no time can you disconnect the EDR. As a matter of fact, if you did disconnect it, nothing would operate because it is so entwined and entrenched with the actual operation of the vehicle. It is not just a mere unplugging. It is tied into the computer and everything else that goes with it.

Mr. REICHLEY. Mr. Speaker, what would happen in the situation, as with many members in the General Assembly, where a vehicle which is from the Commonwealth pool of vehicles is operated by a member of the House? Who is the possessor of the EDR information?

Mr. HARHAI. That information is owned by the Commonwealth.

Mr. REICHLEY. So not the driver?

Mr. HARHAI. Not the driver himself or herself.

Mr. REICHLEY. All right. Thank you, Mr. Speaker.

That is the extent of the questions I have. May I speak briefly on the bill, Mr. Speaker?

The SPEAKER. The gentleman is in order and may proceed. Mr. REICHLEY. Thank you, Mr. Speaker.

As I mentioned before, I completely understand the sentiments of the prime sponsor of the legislation and understand that in consultation with the Trial Lawyers Association, they sought to draft language which creates an equal-footing situation for each party in the civil litigation.

Let me just bring to the attention of the members that under the answers provided and under the language of the legislation, under rule 4009.26 of the Civil Rules of Procedure, all that is merely necessary to obtain this information in a civil lawsuit is for the service of subpoena duces tecum, a subpoena for records and documents. That in and of itself does not require an evaluation by a judge to determine if there is a legitimacy to this request or to overcome any privacy interests that the operator of the vehicle would have within this lawsuit. It is different than a search warrant in a criminal procedure where a judge or district judge is making an evaluation if there is a reasonable set of facts described to overcome the privacy interests of an individual. It is different than a service of a witness subpoena, which in criminal situations also would enter documents that would have to undergo an examination by a judge. So what you have is a situation where the interests of each party in a civil suit have sort of fallen to the interests of the trial lawyers in obtaining as much information as possible.

The last point I would raise is that the gentleman I think was very honest in admitting that this is a matter being reviewed at the Federal level and that many States are considering legislation like this. Let me just throw out a scenario there. Sometime during the course of the year Pennsylvania drivers would be going to the Jersey shore. They get into a car accident,

and this legislation is in effect which would allow the New Jersey plaintiff's attorney to request the EDR information from the Pennsylvania driver but no concurrent obligation exists on the New Jersey driver. So you are placing the Pennsylvania resident at a disadvantage in going out of State and potentially being involved in a motor vehicle situation. The same thing would apply to Maryland; the same thing would apply to the District of Columbia, Ohio, New York.

So these are some factors which the members of the General Assembly may want to consider when voting on the legislation. Thank you.

Mr. HARHAI. Mr. Speaker?

The SPEAKER. Are there any other members seeking recognition on final passage before the Chair recognizes the prime sponsor?

Seeing none, the Chair recognizes Representative Harhai.

Mr. HARHAI. Thank you, Mr. Speaker.

I just had one final message. I wanted to thank Chairman Joe Preston of the Consumer Affairs Committee and his staff for their help with this bill; also Chairman Joe Markosek of the Transportation Committee and his staff. AAA (American Automobile Association) and Mr. Ted Leonard were very instrumental in helping me through.

This bill has gone on or been through the works for about 2 to 3 to possibly even 4 years, and I want to thank former Representative Kevin Blaum, who kind of got me turned on to this bill and thought it was a good cause for consumer knowledge, and I am just happy to be able to kind of push it through. So I want to thank you again.

Shall the bill pass finally?
