BILL ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to HB 17, PN 2982, entitled:

An Act amending Title 75 (Vehicles) of the Pennsylvania "automated red light Consolidated Statutes, further defining enforcement system" and "serious traffic violation"; and further providing for period of registration, for person with disability plate and placard, for weight restriction relating to special registration plates, for use and display of illuminated signs, for automated red light enforcement systems in first class cities, for employer responsibilities and for unlawful activities related to equipment standards.

On the question,

Will the House concur in Senate amendments?

The SPEAKER pro tempore. On the question, the Chair recognizes the gentleman, Representative Vitali.

Mr. VITALI. Thank you, Madam Speaker.

Will the maker of the bill stand for brief interrogation?

The SPEAKER pro tempore. The gentleman indicates he will stand for interrogation. You may proceed.

Mr. VITALI. Could we have a brief explanation of this bill? Mr. MARKOSEK. Thank you, Madam Speaker.

HB 17, in its original form, was passed out of the Transportation Committee earlier this year and passed the House and was sent over to the Senate, and it contained some language that was suggested by the Federal government, Federal Highway Administration, to keep us in tune with their Federal commercial driver's license laws, and it cleaned up some of our laws pertaining to commercial driver's licenses.

Over in the Senate, the Senate recently amended the bill to include several things: One is to reenact, for a 4-year period, the red light camera program in Philadelphia, and it also dealt with changing the weight limit on some vehicles that are eligible for veterans license plates. Currently those vehicles up to 9,000 pounds may have these license plates, but we have some folks out there that have bigger vehicles, some pickup trucks, et cetera, that go as high as 10,000 pounds, and so the bill does say that it can go to 10,000 pounds as well. That language was part of a bill that we passed out of our Transportation Committee, sponsored by Representative Todd Rock.

And I think, just off the top of my head, Madam Speaker, that is pretty much the bill and the changes that were made by the Senate.

Mr. VITALI. In quickly reviewing, I see language with regard to food delivery vehicles. Did you talk about the food delivery vehicle section? There is a spot in here about food delivery vehicles. Did you discuss that? I was reading and listening, half-and-half, at the same time.

Mr. MARKOSEK. Yes, Madam Speaker, the gentleman is correct, or the question regarding the allowing of additional signage on vehicles, again, was part of Representative Rock's bill that will allow for some illuminated signs on pizza delivery vehicles and, I believe, ice cream vehicles as well.

Mr. VITALI. Thank you.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes Representative Payton.

Mr. PAYTON. Thank you, Madam Speaker.

As many of you know, HB 17 contains the language from HB 1690, which was the extension of the red light camera program, and I could not let this opportunity pass without expressing my extreme disappointment with my colleagues over in the Senate for taking out the accountability measures for the Philadelphia Parking Authority and also taking away the revenue from the School District of Philadelphia.

I find it unconscionable that we redirected the revenue to PENNDOT instead of the SMART (Saturday Morning Alternative Reach and Teach) program at the school district, which has a proven track record of reducing bullying and intimidation within our schools. And considering the recent events of violence within our schools, it is an atrocity that the Senate can so easily disregard such an essential program. And I want to question my colleagues' commitment to education, and I think it is wrong to take the revenue away from the School District of Philadelphia.

So I urge a "no" vote on this legislation.

The SPEAKER pro tempore. The Chair recognizes Representative Dwight Evans.

Mr. D. EVANS. Thank you, Madam Speaker.

Madam Speaker, I rise to ask that we support concurrence on HB 17, and the reason I ask that we support concurrence on HB 17 is that there is an awful lot of work that has gone into this particular issue.

Madam Speaker, the House Appropriations Committee held a hearing of the Philadelphia Parking Authority, and in that process we asked a lot of the tough questions on both sides of the aisle. I can say to you, Madam Speaker, in the questions that we asked, those questions went a long way around the question of accountability.

Now, when this bill came out of the Appropriations Committee, we tried to make an attempt, offered by one of my colleagues, Representative McGeehan, on this bill, to redirect the money. We were not successful. But, Madam Speaker, I would say to you that basically, at this particular point, we have made some changes, some changes because this is a good program. This program saves lives. It also makes money for the Commonwealth of Pennsylvania. And as a result, Madam Speaker, I was able to get a letter written to the chairman of the Transportation Committee and myself that outlines, specifically, the reform measures that we wanted to have in the law. I will not read all of the measures that have been laid out in this letter, but this letter was cc'd to the Republican leader, Sam Smith, Bill DeWeese, Richard Geist, Jewell Williams, George Kenney, and Representative McGeehan. This is a letter that basically outlines, in a specific way, the kinds of reforms that we need to have regarding the Parking Authority.

LETTER SUBMITTED FOR THE RECORD

Mr. D. EVANS. I will submit this for the record and put this on the record so that we know that we are committed to accountability, openness, and transparency regarding the Philadelphia Parking Authority.

So I would encourage both sides of the aisle to support HB 17.

Thank you, Madam Speaker.

Mr. D. EVANS submitted a letter for the Legislative Journal.

The SPEAKER pro tempore. The Chair recognizes Representative McGeehan.

Mr. McGEEHAN. Thank you very much, Madam Speaker.

Madam Speaker, I reluctantly rise to oppose the Senate amendments inserted in HB 17. I do that with a caveat that I praise the work of Representative Dwight Evans and Representative Payton for bringing more accountability to the Philadelphia Parking Authority.

As a member of the Appropriations Committee, it is the first time in my memory that an organization was brought before the Appropriations Committee to answer the substantial newspaper, negative newspaper coverage that the Parking Authority had been subjected to, and Representative Evans, Chairman Evans, was correct that much good came out of that meeting, and he should be praised along with the other members of the Appropriations Committee.

However, I think the changes that were made to HB 1690, that we sent to the Senate and came back in the form of the amendments inserted into Representative Markosek's bill, HB 17, pale in comparison to the tough standards that the Appropriations Committee imposed on the Parking Authority.

And I just have a few observations but was wondering if the sponsor of the bill, Representative Markosek, would stand for a brief period of interrogation?

The SPEAKER pro tempore. The gentleman indicates he will stand for interrogation. You may proceed.

Mr. McGEEHAN. Thank you very much, Madam Speaker.

In the Senate amendments – and let me draw a distinction between HB 1690 as it left Appropriations and your bill, HB 17, which was amended by the Senate. My understanding is that the bill that we passed in the House Appropriations Committee, all the revenues from the red light camera program that currently exists in Philadelphia go to the Motor License Fund. Is that correct? One hundred percent of those?

Mr. MARKOSEK. Yes, ma'am. That is correct.

Mr. McGEEHAN. Under HB 1690, all of the revenues would go to the School District of Philadelphia and the two programs that were enunciated by Representative Payton. Is that correct?

Mr. MARKOSEK. I believe there was an amendment that would do that. The original bill, I believe it was designated to go to the school district, and we changed that in committee, and then it went on the floor, and there were some other amendments that would have driven some of the money to the school district, but of course, that bill is still in the Appropriations Committee in the House.

Mr. McGEEHAN. Your vast experience – and obviously you are well known as the go-to guy on transportation issues in the House and across Pennsylvania – in your experience when we deal with traffic violations, in any other municipality or locality, how is that money divvied up?

Mr. MARKOSEK. Currently traffic violation fines are generally shared by the municipality and PENNDOT, and I believe fines of red light infractions in Philadelphia, that are given out by Philadelphia police, are divvied up the same way. But the fines with the red light cameras, the money totally goes to the Bureau of Motor Vehicles, the highway fund, transportation fund, in Harrisburg.

Mr. McGEEHAN. Not putting words in your mouth, but would you characterize that as something beyond the norm in your experience as the Transportation chairman?

Mr. MARKOSEK. Well, in the Philadelphia situation, I think the cameras have been in place for 3 years now. As far as I know, that has been the only situation whereby that is correct. There were some other compromises, as I understand it, when the bill was originally passed a few years ago, because with the red light cameras, there are no points generated, and I think part and parcel of the compromise there was the money would go to PENNDOT. So notwithstanding whatever the compromise may have been, I would suggest that the red light camera program in Philadelphia, as far as I know, is the only program where the money goes fully to the Department of Transportation.

Mr. McGEEHAN. Thank you, Madam Speaker.

That ends my interrogation.

Madam Speaker, may I speak on the bill?

The SPEAKER pro tempore. The gentleman is in order and may proceed.

Mr. McGEEHAN. Thank you very much, Madam Speaker.

Therein lies the problem that the chairman had indicated, that the revenue funding source from the red light cameras is outside the norm of the practice and the history of what we do in this House and in the Senate as far as the distribution of the funds generated by these traffic violations, and you have to ask yourself why.

In every other locality, in every other borough and city that has traffic violations, the locality keeps 50 percent of that money; the other 50 percent goes to the Motor License Fund. Yet in this program, that only exists in Philadelphia, where the vast majority of people who are being fined are Philadelphians, Philadelphia sees none of that revenue. It goes back to the Motor License Fund. That was a mistake we made when we originally crafted this bill. That is a mistake that is being perpetrated today by the amendments inserted into HB 17, and that is just dead wrong. Philadelphia sees no benefit, direct benefit, to the locality from this source of revenue. That is the main program, and obviously the program that was being funded was the children of the School District of Philadelphia. Now that money can be spent in Altoona or Erie or anywhere else, despite the fact that this program only exists in Philadelphia, and Philadelphians are bearing the disproportionate amount of the fines and costs incurred in this program.

There are other changes – and again, let me praise Representative Evans for having the foresight to really open up this process, open up the authority to greater scrutiny. Yet the amendment that Representative Evans inserted into the House bill that we sent does not reflect in the amendments inserted into HB 17. Not only does this ignore openness and transparency, it extends a program not by 3 years but by 4 years. So we have a limited, limited scope of transparency not for 3 but for 4 years under the Senate version. It totally disallows the Attorney General and the Auditor General to have oversight on the Parking Authority operations and practices.

Madam Speaker, I know I do not have to remind the members that for 2 months the Parking Authority has been subjected to story after story in the local media and statewide media about some of the abuses, whether they are real or perceived, in the Parking Authority. And yet in the amendments inserted into HB 17, we tell the Auditor General and the Attorney General they do not have any authority to look at the practices, expenditures, and operations of the Philadelphia Parking Authority. That is dead wrong.

It also removes the provisions in the Right-to-Know Law that we inserted in the House and yet were stripped out in the Senate version, the amendments to HB 17.

Madam Speaker, this places an undue burden on the city of Philadelphia. This is unfair to the city of Philadelphia and to the schoolchildren of Philadelphia. This is a pale, this is a pale substitute for the tough measures we inserted in the House into HB 1690. This is coming back as a ghost, as a ghost. It answers none of the problems that were enunciated in the tremendous media coverage that was subjected to the Parking Authority.

Let me add one thing: I have been a frequent critic, Madam Speaker, of the authority, and I must say with the help of the leadership of Representative Evans on this issue, I believe they have made some progress, and I believe they are making progress still, and the letter that Chairman Evans had read into the record I think reflects some of that progress, but it does not go far enough. By voluntarily subjecting yourself to some of these measures, it does not have the effect of law, does not have the effect of statute, does not provide penalties of law for not keeping your promises, and, Madam Speaker, there were many promises made when we initially began this program that we now know were not kept.

Are you signaling me, Madam Speaker?

We know that many of the promises that were made here on this floor and elsewhere have not been kept relative to the Philadelphia Parking Authority. Madam Speaker, by voluntarily subjecting yourself to oversight and to scrutiny does not have the same effect, and we all know that. By making a statute that requires the Parking Authority to live up to the agreements that we institute by law carries a much greater relevancy authority and subjects those individuals and that organization to the power of law.

These voluntary measures do nothing to satisfy that concern of mine, I think the concern of the people of Philadelphia, and I hope the concerns of the members of the House.

For those reasons and others, I would ask that we nonconcur in the amendments to HB 17.

Thank you, Madam Speaker.

The SPEAKER pro tempore. Representative Roebuck.

Mr. ROEBUCK. Thank you, Madam Speaker.

I stand here today and I wonder why we are engaged in this debate, a debate that focuses largely upon the Philadelphia Parking Authority.

If we go back to the record and we look at the legislation that this House adopted in the year 2001, which was designed to reform that authority, then, indeed, we should not be engaged in this debate, because that legislation was based upon very clear problems and it was designed to resolve those problems. If we quote the record, quoting the then majority leader who said, in offering his support to this legislation, "The Philadelphia Parking Authority is a State agency created...by this General Assembly. For years and years, it has..." been using "...hundreds of millions of dollars willy-nilly,...by scandal after scandal..." and that there are no "...normal checks and balances and to accountability."

And so, indeed, we tried to put that in place, but then the gentleman went on to note that the purpose of the revenues going to the authority were designed to help the schools in Philadelphia and that we ought to, in the language, "squeeze" the authority to ensure that the amount of money going to Philadelphia schools was, indeed, greater.

What are we doing then today by, in fact, adopting legislation that chooses not to squeeze but to divert money that should be going to the schools in Philadelphia? What are we doing today when we are saying, although there are continued problems, somehow maybe that is all right? We accept a Senate bill which does not provide any real means of accountability, which does not address the continuing problems of the authority, and which puts us in a position of negating our responsibility as legislators to do something about a problem that directly affects a State agency – not a city agency, not a national agency – a State agency for which we are responsible.

Madam Speaker, we ought to reject this bill as amended by the Senate. If we believe in open government, if we believe in transparency, if we believe in reform, then we ought to be about ensuring that reform applies everywhere. This bill is fundamentally wrong. It is not open; it is not transparent. It diverts money from my schools, and it helps to make the problems we face in my constituency far worse.

I would urge those of you who believe that we are in a new day in Harrisburg, that we are, in fact, in a new atmosphere of change, a new atmosphere of responsibility, to reject concurring in the Senate amendments and send this bill to wherever it needs to go to get the problems inherent in it changed and remedied. We owe that to the school kids of Philadelphia. We owe that to the schoolchildren of Philadelphia. We owe it to our young people.

Thank you, Madam Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman and would remind members that the question before the House is concurrence in Senate amendments and asks that remarks be kept to that subject.

On the subject, is the gentleman, Representative Geist, seeking recognition?

Mr. GEIST. Thank you very much, Madam Speaker.

I did not really think that we were going to have to speak at all on this bill, but I would like to remind the House that when Representative McCall and I worked on this piece of legislation, we did so with the idea that it was for safety and public safety in Philadelphia as an experimental program, not as a revenue generator for anything. In no way was this ever designed to be a rolling tollbooth so that Philadelphians would pay at the light for some function or some program in the city, which would put additional pressure to create more tickets.

It is an experimental program. The time to grade it has not run out. The Senate amendments that were put in here are very good and they work. The city of Philadelphia, with all the other things that they have and all the other programs, can certainly find other ways to raise money for projects rather than going after a new revenue source.

The bill is a very good piece of legislation, it is a good compromise, and I would urge a "yes" on concurrence.

The SPEAKER pro tempore. The Chair recognizes the gentleman from Philadelphia, Representative Taylor.

Mr. J. TAYLOR. Thank you, Madam Speaker, and I will be very brief to let these young folks sing here.

Before everybody gets all excited about this, this is very simple. We are extending an existing program in the city of Philadelphia that has been very successful. It is due to sunset at the end of this year if we do not pass this bill. There was never any money from red light cameras going to the schools in the city of Philadelphia. So they did not get cut because they never had it. We made many references to a House bill that is still in the House; it never got to the Senate.

So a lot of the debate may need to happen at some point in this chamber, that was brought up. It has nothing to do with the concurrence vote on HB 17, and I would urge all the members to support this, to support and continue a very important project in Philadelphia.

The SPEAKER pro tempore. Representative Benninghoff. Mr. BENNINGHOFF. Thank you, Madam Speaker.

I just wanted to make a quick reflection on an initiative that is probably just as dear to the hearts of those of us who live in central Pennsylvania and across the northern tier. While I think it is important that we are cognizant of what goes on in the city of Philadelphia and the fact that some of our food vendors need lights on the top of their cars, the people in central Pennsylvania are very, very concerned about the tolling of I-80, and this bill would have provided a tremendous opportunity for many of us who have amendments to try to address a bill that was moved very quickly through the process, with no public hearings, no public conversations, and very little input.

My good friend, Representative McIlhattan, has a proposal that would allow you, the members, to have the right to vote by two-thirds majority on whether or not we should toll I-80—

The SPEAKER pro tempore. Will the gentleman suspend.

Once again the Chair reminds him and all members that what is before us is concurrence on Senate amendments.

Mr. BENNINGHOFF. I appreciate that, Madam Speaker, and I will keep that in close proximity in my mind, which could be a very long distance.

I will be brief, but I think it is important because these initiatives, when first rendered, are told to us that they will be a pilot program – pilot programs which are then expanded for several years later, and then, as other sad events, they progress throughout the Commonwealth. And who knows? Maybe we might even see red lights on I-80. It would be kind of scary, but we have done sillier things.

I would just ask that the members keep in mind that there are other parts of this State, and the Interstate 80 project of tolling is very, very concerning for those of us who live in rural Pennsylvania. I think we should have just as long dialogue, maybe even today, on that issue, as well as instituting expansion of the red light cameras.

Madam Speaker, I thank you.

The SPEAKER pro tempore. Representative Schroder.

Mr. SCHRODER. Thank you.

Would the maker of the bill stand for brief interrogation?

The SPEAKER pro tempore. The gentleman indicates he will stand for interrogation. You may proceed.

Mr. SCHRODER. Thank you, Madam Speaker.

Madam Speaker, there is just a matter that I want to get on the record with regards to a section of the bill that reduces fines for violations of the number of hours of operation of truck drivers, I believe. There has been a substantial reduction in the fine for those violations, and I am told that it is in connection with the requirement of Federal law. Could you explain to me and to the House what the requirement is?

Mr. MARKOSEK. Thank you, Madam Speaker.

The gentleman has a very good question, albeit a very technical one. Yes, this is a requirement of the Federal government. It reduces the fine in section 4107(d)(3) from \$2,750 to \$500 for drivers, or employers, who receive a citation for driving, or who allow vehicles to be driven, beyond the hours-of-service criteria established by the U.S. Department of Transportation. So the bill, essentially by mandate of the Federal government, will be identical to what they have asked us to do.

Mr. SCHRODER. Thank you, Madam Speaker.

Madam Speaker, just for a point of further clarification.

Madam Speaker, I am having trouble hearing the answers given by the gentleman, Mr. Markosek.

The SPEAKER pro tempore. Will the gentleman just suspend for one moment. There is, once again, entirely too much noise, and the gentlemen are having difficulty hearing each other back and forth. If we could just ask members to hold conversations to a minimum.

While the gentleman suspends, I am going to ask you to embellish one extra moment.

CENTRAL DAUPHIN HIGH SCHOOL SINGERS INTRODUCED

The SPEAKER pro tempore. You may have noticed in the back of the House patiently waiting are the singers from Central Dauphin High School. They were here this morning as part of our Capitol tree-lighting ceremony and have been patiently waiting. The Central Dauphin Singers are here today as part of our Capitol tree- lighting ceremony and would like to wish us holiday greetings. They are here today as the guests of Representative Ron Marsico. Mr. Masters is their instructor. We welcome you to the hall of the House.

Ladies and gentlemen, please recognize the Central Dauphin Singers.

The SPEAKER pro tempore. Representative DeWeese.

Mr. DeWEESE. I would like to thank Representative Marsico for inviting these youngsters. We have it on great authority from Dan Surra, who was a preeminent voice in his high school chorus, that you performed in excellent fashion.

The SPEAKER pro tempore. The Chair thanks the Central Dauphin Singers and wishes you a merry Christmas as well, and we will let you go catch that bus.

CONSIDERATION OF HB 17 CONTINUED

The SPEAKER pro tempore. The Chair thanks Representative Schroder for suspending momentarily for the holiday greeting. The gentleman is in order to proceed.

Mr. SCHRODER. Thank you, Madam Speaker.

I was glad to suspend for that cheerful interlude there, and good job.

Back to the question, Madam Speaker. So are you saying then that Federal law only allows us to impose a \$500 fine for that particular violation and that we have no leeway?

Mr. MARKOSEK. That is correct, if we do not want to violate the Federal law.

Mr. SCHRODER. And what is the penalty for that violation? Would we lose funds? What would happen?

Mr. MARKOSEK. It could be a decertification of the program, the CDL (commercial driver's license) program, which I do not think any of us would want. It would also, perhaps – an option of losing highway funds up to 384,000, and what we are doing here is correcting language in our original bill that we passed, Act 37 of 2005, which you and I more than likely voted for, where we had some information and some of the language in here that was drafted improperly. We imposed fines in one section and not another. What this does is changes that around. There is actually no loss of fine money relative to this new language. So it is just a matter of changing the language on paper, essentially, so we comply with the Federal regulation relative to this, so we do not have a program that is decertified.

Mr. SCHRODER. All right.

Thank you, Madam Speaker, for the interrogation.

The SPEAKER pro tempore. Representative Metcalfe.

Mr. METCALFE. Thank you, Madam Speaker.

Madam Speaker, one of the prior speakers had mentioned that this legislation is not about a moving tollbooth. And I think there are many of us who will be voting in the negative, Madam Speaker, because this legislation is not about those tollbooths that are moving toward I-80. Many of us would have liked to have seen this legislation give us a chance to repeal the I-80 tolling, and I will be voting in the negative because this legislation does not address a very important issue to this Commonwealth, and that is tollbooths that are moving toward I-80.

Thank you, Madam Speaker.

The SPEAKER pro tempore. Representative McGeehan.

Mr. McGEEHAN. Thank you, Madam Speaker.

I am not a disinterested party in this debate. Part of my district is included in the red light camera program along the Roosevelt Boulevard. I touch a small portion of it, and many other members have much larger swaths of Roosevelt Boulevard than I do, and I am sensitive to the public safety concerns of those who have spoken before and the possibility of a danger to the public if this program is not renewed.

I have had conversations with the Philadelphia Police Department. They have been freed up on I-95 and the Schuylkill Expressway by the increased presence of the State Police on those roadways, and I am informed by the Philadelphia Police Department that they intend to dedicate portions of their highway patrol to traffic enforcement along the Roosevelt Boulevard.

Madam Speaker, if we do not concur in these amendments today, this program does not die. It shuts down, yes, but it will be made up by a contingent of the Philadelphia

I urge a negative vote. Thank you, Madam Speaker.

Mr. KENNEY. Thank you, Madam Speaker.

I rise as a Philadelphia legislator to support concurrence in HB 17.

The previous speaker just spoke about the Philadelphia Police Department, who supports the continuation of this program, and they want the assistance. They need the help on Roosevelt Boulevard, a 12-lane highway. They know they do not have the resources; they do not have the police manpower. They know the bottom line is these red light cameras are saving lives, and if we have the opportunity today to save lives and continue this program, we should continue it, and I ask my colleagues to support us.
