Mr. Kessler.

Mr. KESSLER. Thank you, Mr. Speaker.

Yesterday at 8 p.m., 100 years ago, one of the most fatal fires in the history of our country happened at the Rhodes Opera House in Boyertown, Pennsylvania. This fire led to legislation that was passed right in this House in 1909 that had a major effect on fire exits, and other States followed suit throughout the country. I would like to take a minute and read this story to you.

On January 13, 1908, the people of Boyertown gathered on a cold night to be entertained by a church play at the second-floor auditorium of the Rhodes Opera House. The performance began at 8 p.m. with a packed house of 310 people. "The Scottish Reformation," a play, was presented by members of St. John's Lutheran Church.

During the interlude, before the fourth act, a tube from the projection slide show came loose, emitting a hissing noise, which alarmed the crowd as well as the cast. The cast members parted the curtains and accidentally knocked over a kerosene lantern on the stage, setting off a small fire.

The crowd quickly panicked and pushed toward the unmarked exits and fire escapes. The auditorium doors allowed for a very narrow passage and opened inward, causing the weight of the crowd to press against them, preventing them from opening the doors. Many people were crushed to death before the fire came close. Fire raged for more than 7 hours, until the building was reduced to rubble.

The fire killed 170 of the 310 people in the building that tragic evening, with entire families perishing, and despite best efforts, 25 victims remained unidentified. Boyertown lost nearly 10 percent of its population that night, and nearly every family in the borough lost a member. The Rhodes Opera House fire is among the 10 most fatal fires in United States history.

In the aftermath of this devastation, in 1909 Pennsylvania legislators enacted legislation to set standards for doors, landings, fire extinguishers, and most importantly, marked exits and doors, which must open outward and remain unlocked. After Pennsylvania passed this legislation, New York followed suit and several other States throughout the country. The opera house in Boyertown will always be remembered for the lives lost and the protective legislation and regulations which were the foundation for the current safety regulations.

"...Therefore be it RESOLVED, That the House of Representatives recognize the 100th anniversary of the

Rhodes Opera House fire of January 13, 1908, in Boyertown, Pennsylvania; and be it further

"RESOLVED, That copies of this resolution be transmitted to the Boyertown Historical Society and Boyertown Borough Council."
