Mrs. HARHART. I rise today to introduce HR 550, which designates January 2008 as "Cervical Cancer Awareness Month" in Pennsylvania.

With regular and accurate screening, cervical cancer is highly preventable, and when found early, cervical cancer is highly curable. While widespread screening has reduced death rates from cervical cancer, women are still dying, despite advanced medical techniques and evaluative procedures.

The American Cancer Society estimates that in 2007, 11,150 women were diagnosed with cervical cancer and more than 3,670 died of the disease in the United States. Cervical cancer rates in the United States are affected by education, access to regular cervical cancer screening, and screening accuracy. Experience shows that increasing cervical cancer awareness among women, especially underserved women, significantly reduces the probability of mortality from this disease.

Through education and screening, women can decrease their likelihood of developing cervical cancer and that, with early detection, cervical cancer can be successfully treated.

I ask for your support on this important health issue to promote good health for Pennsylvania women. Thank you, Mr. Speaker.

BILL ON SECOND CONSIDERATION

The House proceeded to second consideration of **HB 1742**, **PN 3008**, entitled:

An Act requiring scrap processors and recycling facility operators to collect certain information relating to the purchase of scrap material; requiring commercial accounts; and restricting scrap processors and recycling facility operators from purchasing certain materials.

On the question,

Will the House agree to the bill on second consideration?

Mr. \mathbf{ARGALL} offered the following amendment No. $\mathbf{A05226}$:

Amend Preamble, page 1, by inserting between lines 11 and 12

(3) Individuals have found it to be more financially advantageous to sell used beer kegs to a scrap processor or recycling facility operator as opposed to returning the kegs to the distributor from where they were rented.

Amend Preamble, page 1, line 12, by striking out "(3)" and inserting $% \left(1\right) =\left(1\right) \left(1\right$

(4)

Amend Sec. 2, page 2, by inserting between lines 9 and 10 "Beer keg." A vessel designed to contain at least 128 fluid ounces of malt or brewed beverage.

Amend Sec. 2, page 3, line 2, by striking out "beer kegs,"
Amend Sec. 5, page 7, by inserting between lines 19 and 20
(5) Beer kegs.

Mr. Speaker, my amendment would clarify some of the language in the existing legislation which would make it very clear that people cannot steal beer kegs and then expect a recycler to take them, and so it makes it very clear that the kegs belong to the owner and should be returned.

Thank you, Mr. Speaker.

The SPEAKER. Representative Pashinski, on the amendment.

Mr. PASHINSKI. Thank you, Mr. Speaker.

That is an agreed-to amendment. Thank you.

The SPEAKER. The Chair thanks the gentleman.

down by a scrap processor, that they are to be returned to the rightful owner.

It's a sickness that has infected the mind, destroyed our vision, made us blind, removed the traits that once made us kind to our neighbor.

Though society as a whole is dysfunctional,

we turn our frustrations into something personal

and direct our anger toward others without being rational.

The ties that once bound us to one another are considered nominal.

Our elders – their fear of what the future may bring us is exceptional.

So many leaders urge the observance of a Day of Atonement.

We've ignored the lessons of the past; have not tapped into our endowment.

A prolonged drought withered all hope that current conditions are not permanent.

We bathe in the waters of despair and disillusionment

and fail to pursue life, liberty, and the betterment of our lives.

Generational poverty breeds drugs and crime that have become an institution.

Some lobby the government for money in the form of restitution.

The nation needs to be reminded of the provisions in its own constitution.

The deprivation of my people's rights has created this destitution.

The end of the long night of racial injustice is the cure; there is no substitution.

Yes, debilitating poverty chains...people to the lowest rung on the ladder

but their self-destructive patterns – ugh! Nothing makes me madder.

Dealing and wheeling, looting and shooting; trying to see who can be badder –

these are the devil's tools and are as venomous as an adder.

Strive for education, economic empowerment, racial unity. Nothing would make me gladder.

With my life I paved the way on the non-violent trail.

There are kings and queens from which you hail.

To enjoy the riches of freedom and the security of justice one cannot be in jail.

If you choose to drink from the cup of bitterness and hatred, you're doomed to fail.

Continue to work with the faith that unearned suffering can balance the justice scale.

I say to you today my friends let us not wallow in the valley of despair.

Freedom will ring from the slums of the inner city to the mansions of Bel Air.

Faith in our heavenly father and love for one another must be in our crosshair.

Even though we'll face difficulties, we must not stray from this bill of fare.

Pledge to always march forward without turning back – change is in the air.

I have returned to remind you of the fierce urgency of now.

Now is the time to make justice a reality for all of God's children; every knee must bow.

When times get rough and ends don't meet and you begin to wonder how,

do not let the enemy defeat you; this you cannot allow.

My country 'tis of thee, sweet land of liberty – these words to my face bring a smile.

As I leave again ponder this: the battle has already been won.

Your charge is to protect those gains. Do not continue to allow the victories to be undone.

Education is still the key. Now forward to financial understanding run

and don't forget to extend a helping hand to a daughter or a son.

ANNOUNCEMENT BY SPEAKER

The SPEAKER. As the House considers this resolution, the Chair sends best wishes for a speedy recovery to its prime sponsor, Representative John Siptroth, who is watching on PCN (Pennsylvania Cable Network) and is here with us in spirit. Hello, John.

Mr. SCAVELLO. Thank you, Mr. Speaker.

I want to commend Representative Siptroth and Representative Bev Mackereth for putting this resolution together. I just hope that we are able to find dollars in this formula down the road to address this big concern of not funding our schools properly, especially the faster growing school districts. We are still funding schools at 1990 levels. Schools that have been growing for the last 17 years are still being funded at 1990 census numbers, and I hope that this resolution goes a long way in addressing those needs.

REMARKS BY MR. SIPTROTH READ FOR THE RECORD

The SPEAKER. Representative Roebuck.

Mr. ROEBUCK. Thank you, Mr. Speaker.

I want to begin the debate by reading a statement from Representative John Siptroth, and I do it in recognition that he is not with us today. The statement reads as follows:

Mr. ROEBUCK (for Mr. SIPTROTH) read the following remarks for the Legislative Journal:

For too long many of the Commonwealth's school districts have been unduly challenged in meeting the needs of their students with adequate funding because of inequities in the State's public education funding formula.

Changes in demography, population growth and decline, and aging infrastructure all have had devastating impacts on schools' budgets in areas across the State. Often the funding burden is passed on to the taxpayer.

Costs for new school construction, equipping our students with the technological advancements needed to succeed in the current economy, and offering innovative programming can all be overwhelming. We need to reevaluate Pennsylvania's formula that drives our public education funding to ensure that State funds allocated for basic education are distributed adequately and equitably. Now is the time to approach and tackle this challenge as we have an important tool at our disposal.

In 2006 the General Assembly requested a costing-out study be performed by the State Board of Education. Now that the study is complete, it is time to evaluate the data. To do this fairly and equitably, my resolution would establish the Joint Legislative Commission on Public School Finance.

The 41-member commission would be tasked with analyzing the data from the study and developing at least two formulae on how to adjust our current system for funding public education in the Commonwealth. The goals of the diverse commission are direct and well-defined and focused on the goal of educating our children. The commission would need to act quickly. Members would have to meet within 60 days of being appointed, and the commission would have to report its findings to the Governor, the President pro tempore of the Senate, and the Speaker of the House within 1 year from its first meeting date.

Education is a public good that truly serves the entire community and State. When we offer less than the best to any child, we are doing ourselves, our community, and our future a disservice.

Mr. ROEBUCK. Given these words by Representative Siptroth, I would urge that all the members of the legislature adopt this resolution and move us towards the goal of reaching what will be adequately funded education across the Commonwealth.

Thank you, Mr. Speaker.

The Chair recognizes Representative Stairs on the resolution. Mr. STAIRS. Thank you, Mr. Speaker. I appreciate your recognizing me. I changed positions from one end to the other here.

This is very important legislation, and we have been talking about equity in this chamber for many, many years. A number of years ago, in the early eighties, when we adopted the formula that was going to, the ESBE (equalized subsidy for basic education) formula, that was going to drive education, we thought we had a pretty good thing, but over the years things change and it is maybe a little out of whack right now. So I applaud the makers of this resolution to sit down and go back and look at it again and make some significant changes. With the costing-out survey that was done, the Governor is getting involved in his own methods of doing this, so I think we are onto something very important here, and I would hope that the members could support this.

There are a few changes that need to be made, but we can address those. This is a good concept and certainly will bring the equity problem that is really devastating education into the forefront and hopefully resolve many of our problems that we have in many of our schools.

So I would ask my colleagues to join me in supporting this resolution and we can get going here and make a difference in correcting a very serious problem.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes Representative Mackereth.

Mrs. MACKERETH. Thank you, Mr. Speaker.

Act 114 of 2006 mandated the State Board of Education to contract out and study the cost of educating all 1.8 million Pennsylvania students to Pennsylvania State standards. At the time many of us were unaware that Pennsylvania State standards meant 100 percent of our students would be proficient in 12 subject areas by 2014. Pennsylvania State standards far exceed the No Child Left Behind standards.

The cost: \$21.9 billion, \$4.8 billion that we do not have. This would mean a near doubling of the State sales or personal income tax. This is not going to happen. However, the costing-out study does provide a detailed statistical foundation that quantifies some of Pennsylvania's long-known educational funding problems.

This resolution would establish a joint legislative commission on public school finance. The commission would be chaired by an expert on public school funding, and its members would hopefully be Pennsylvania's best and brightest.

The commission would be charged with creating a new, rational, realistic funding formula that is fair and equitable to all of our 501 school districts. Some of my colleagues, on both sides of the aisle, have expressed concerns regarding the unrealistic State standards as well as the inconsistencies and concerns for the makeup of the commission. I agree with these concerns. Both sides of the aisle have agreed to work with the Senate to fix these problems on a similar bill that they will be bringing up.

I would like to urge all of my colleagues to support this bill. I think it is critical that we move forward to get this done, to take the information that we have from the costing-out study and to come back with a funding formula that works for Pennsylvania.

CONSIDERATION OF HR 460 CONTINUED

The SPEAKER. The Chair recognizes Representative Harper on the resolution.

Ms. HARPER. Thank you, Mr. Speaker.

When I reviewed this resolution for this week's voting, I thought that the study commission is lacking in one group that is very important in any school funding formula. Those would be people who are paying the property tax in Pennsylvania and particularly senior citizens. I had proposed an amendment to correct this situation because we have a 41-member study commission composed mainly of people who will be spending the funds that are raised for education in Pennsylvania,

and I did think that this body is concerned about how those funds are raised.

I do think a study is very, very important. The formula has not been changed in many years, while the population has shifted across this State. So I have talked to my colleagues on the other side of the aisle, and I have received their assurances that when this resolution goes to the Senate, we will ask the Senate to add taxpayers to the group that is studying the funding formula for Pennsylvania's schools. These are the community's schools; they belong to the whole community – the parents, the children, the teachers, the school boards, and also those who are paying for the schools.

So with the assurances of my colleagues on the other side of the aisle that they will work to make sure that the taxpayers are adequately represented on this study commission, Mr. Speaker, I will be voting "yes" today.

Thank you very much.

The SPEAKER. Representative Micozzie.

Mr. MICOZZIE. Thank you, Mr. Speaker.

Mr. Speaker, for the last 5 or 6 years, or the last three sessions, at least, I have introduced what was known as a successful school budget proposal. My proposal always advocated equitable distribution, accountability, and a new formula to make sure that every child in Pennsylvania receives an adequate education – has an opportunity to receive an adequate education.

I think the costing-out study is the right direction. If anyone attended the meetings of the Board of Education when they displayed their findings, the provisions in that report talk about a successful school proposal. Many of the provisions that I have in my bill, HB 1544, are included in that report.

I think it is time that we, the General Assembly, have the courage to do what is right, to make sure that the school districts in our Commonwealth and the children that go to those schools do not continue to fall through the cracks and make sure they have every opportunity to obtain a good education and not depend on the ZIP Code (Zone Improvement Plan Code) that they live in.

Thank you, Mr. Speaker.

The SPEAKER. Representative Thomas.

Mr. THOMAS. Thank you, Mr. Speaker.

Mr. Speaker, I have some initial concerns about HR 460, but the majority chairman has just assured me that HR 460, in fact, implements one of the costing-out study recommendations. Mr. Speaker, I think it was a giant step that this legislature took in directing such a study. I think that the people who have taken a look at this issue have done the right thing. And, Mr. Speaker, I am now elated that it is clear that you cannot expect a Cadillac performance from children when you are only spending Volkswagen dollars.

Mr. Speaker, there are many schools in my district and throughout the Commonwealth of Pennsylvania that just cannot satisfy the No Child Left Behind basic requirements, and one of the reasons that they cannot satisfy it is because they just do not have the resources. No matter how much money we have spent, money has been used, and I think in an appropriate manner, but when you have to now start to try to reverse long years of benign neglect, you have to make the investment. So I support HR 460, and I hope that if we do nothing else, that we take the necessary steps in 2008 to make sure that our children have the resources that they need to have access to a quality education,

regardless of where they live or the circumstances under which they live.

Mr. Speaker, education is the bridge to the future. Education is the sine qua non of whether or not you will see success or see failure. And so, Mr. Speaker, it is imperative that we move HR 460 and all other resolutions and/or bills that will address the recommendations outlined in the costing-out study.

Thank you.

The SPEAKER. Representative Wheatley.

Mr. WHEATLEY. Thank you, Mr. Speaker.

Mr. Speaker, I rise in support of HR 460 with this caveat: I hope that in our next presentation from the Governor's budget address in February, I am hoping that he, in his wisdom, will quicken the pace for us to have significant investment into our educational system and takes a critical look at the way our funding system is currently. And although HR 460 puts into place the commission to study some of these questions, I am hoping that we move at a faster pace, if necessary.

I do want to support this resolution moving forward, but I do not want this resolution to become an impediment to us addressing this educational question in a quicker, faster capacity. So, Mr. Speaker, I want to continue to support this moving forward, but I hope that the Governor and our colleagues, both in the Senate and the House, will take faster action to address this in the here and now and not wait for a year for this to come back to us.

Mr. FAIRCHILD. Thank you, Mr. Speaker.

HBs 775, 776, and 777 are a package of bills which amend the three county codes by requiring counties to place a veteran's marker and flag on the graves of all honorably discharged veterans rather than just wartime veterans, as required in current law.

A veteran, whether active duty, retired, National Guard, or Reserve, is someone who, at one point in their life, wrote a blank check made payable to "The United States of America," for an amount, "up to and including their life." That is honor, and this legislation recognizes that fact and the sacrifices our men and women have made and continue to make on our behalf. Many counties already do provide this honor to all veterans. These bills make this practice uniform across the State.

These bills also allow the counties to purchase and use veterans' markers that are made of aluminum, like the one I have in my hand, and members are encouraged to take a look at it. You will see it is very hard to tell the difference between the aluminum and the brass or the bronze, but the price differential is very substantive, and many counties have gone to this system, and it is probably the way most will go.

I will add that there are a couple more bills coming shortly that address the funding for the counties in this endeavor. So with the encouragement of the veterans in your district and the encouragement of the State Veterans' Commission and the County Commissioners Association, the staff on both sides of the aisle here worked very, very hard and together to bring this legislation to you today.

So with that said, I would ask for an affirmative vote on these three bills that are now before this body.

I find it highly unfair to our veterans and distasteful that they would have to wait for processing to that degree.

I would like to also note for the members, Mr. Speaker, that when asked why that circumstance exists, I was told they do not have enough employees. Mr. Speaker, this is an area where the State needs to employ enough people to get caught up on these applications, and it is something I urge my House members to support in addressing right away with the administration.
