Mr. Speaker, this resolution is in recognition of Catholic Schools Month in the Commonwealth of Pennsylvania. Just for some background information, Catholic elementary and secondary schools in the Commonwealth educate 183,000 students annually. In addition, they save our Commonwealth and local taxpayers more than \$1 billion each year.

In addition, Mr. Speaker, our Catholic schools have a strong reputation and record of instilling in our young people a strong foundation of values, self-esteem, self-confidence, and leadership skills. Furthermore, Mr. Speaker, our Catholic schools throughout the Commonwealth provide our young people with solid values and academic skills needed in becoming responsible citizens of this Commonwealth and of our nation.

Finally, Mr. Speaker, I add that the dropout rate from the Catholic schools is less than 3 percent. In addition, they have a postgraduate higher education enrollment rate of 80 percent.
