Mr. Speaker, this is an amendment which clarifies some technical language in the bill, and it is an agreed-to amendment.

The SPEAKER. The Chair recognizes Representative Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

Will the maker of the amendment stand for brief interrogation?

The SPEAKER. The gentleman, Representative Sturla, indicates he will stand for interrogation. Representative Vitali is in order and may proceed.

Mr. VITALI. Thank you.

I was just quickly scanning the language related to I think a physician being on the premises 50 percent of the time. Could you just sort of explain what this does? I understand it is technical in one sense, but just sort of explain what it does just for the benefit of the members.

Mr. STURLA. Mr. Speaker, this is just a clarification of the language to show that physical therapists are actually on the premises for a physical therapy assistant for at least 50 percent of the time for billing purposes. There are multiple offices, in many cases, where there are multiple people, and since we are now allowing the physical therapy assistants to work unsupervised, we want at least a presence of a physical therapist 50 percent of the time in those offices.

Mr. VITALI. If I may continue, have any groups weighed in on this amendment one way or the other – physical therapists, doctors, physical therapist assistants? Have there been any letters one way or the other in support or opposition to this?

Mr. STURLA. Mr. Speaker, on this amendment and the next amendment that I will offer and the bill, it has the support of PANPHA (Pennsylvania Association of Non-Profit Homes for the Aging), the PA Health Care Association, the PA Physical Therapy Association, the Department of State, and the Physical Therapy Board.

Mr. VITALI. Okay. Is there any opposition you are aware of?

Mr. STURLA. Not that I know of. There are a couple groups that remain neutral on it, but we had stakeholders in meetings for what sometimes seemed days on end, and we finally came to an agreement on this, along with Republican staff and Democratic staff.
