Mr. GODSHALL. Thank you, Mr. Speaker.

Before we vote on this resolution, I have the distinct honor of introducing to you today and saying thank you and recognizing three young people from Penn State University who have a mission in life – an early mission in life – and their mission is helping young people with cancer.

I have some comments I just would briefly like to read. There is an event that is held every year at Penn State University. It is called the THON, T-H-O-N. THON is the Penn State IFC/Panhellenic Dance Marathon, the largest student-run philanthropy in the world.

THON is a year-long fundraising effort that culminates in a 2-day, no-sitting, no-sleeping dance marathon, where dancers stay on their feet for 46 hours.

The annual dance marathon, combined with high school mini-THONs statewide, raffles, canister collections, fundraisers by Greek organizations and service clubs, and donations from alumni and corporations, raises money for the Four Diamonds Fund, which aims to conquer childhood cancer at the Penn State Children's Hospital in Hershey, Pennsylvania.

In its 36-year history, THON has raised more than \$52 million to fight childhood cancer – \$52 million. This year I am pleased to report that THON raised a record \$6.6 million for the fund, shattering last year's fundraising total by more than \$1.4 million.

GUESTS INTRODUCED

Mr. GODSHALL. Today I am honored to welcome the student organizers of this important event and to sponsor a resolution recognizing them for their hard work and dedication to the research, treatment, and eventual eradication of childhood cancer. Dustin Kinney is here, overall rules and regulations chairperson, and I understand Dustin is the one who regulates the kids standing out in all kinds of weather – in all kinds of weather – on the sidewalks and in the street with canisters, collecting money for kids with cancer.

Ian Rickenbach is here. He is the overall entertainment chairperson, and I understand his duty— I asked him if that involved the Eagles cheerleaders, and he said, I wish, but he is the overall entertainment chairperson; and Sara Firestone, Pennsylvania State University Development Office.

Would you please rise and give these fine young people a real House welcome.

Thank you very much, Mr. Speaker.

I would also be remiss if I did not remark at this time that one of the members just recently asked me what I was doing up here, and I said to recognize the Penn State young people on this effort, and he said he wants to let me know that the Four Diamonds Fund really helped a member of his family fight leukemia a number of years ago and is a fine person today. So that just happened a few minutes ago, and I just want to say thank you for your welcome.
