The SPEAKER. The Chair recognizes Representative Gibbons for the purpose of an introduction.

Mr. GIBBONS. Thank you, Mr. Speaker.

I come before the House today, along with Representative Cappelli, so that the two of us can come here to celebrate the 100th-year anniversary of the United States Army Reserve, as well as honor the Army Reserve's commitment, dedication, and service by its warrior soldiers to the United States of America.

As you may know, the Army Reserve celebrates its centennial on April 23, 2008. The celebration commemorates the historic contributions of the United States Army Reserve veterans as well as the continuing assistance of its soldiers to the protection of national security interests and homeland defense of the United States.

Since its conception, the citizen soldiers of the United States Army Reserve have assisted our enlisted soldiers on several battlefronts, including both World Wars, Korea, Vietnam, Bosnia, and the Persian Gulf, and currently, Reservists are supporting the efforts of Operation Enduring Freedom and Operation Iraqi Freedom.

With us today to celebrate the centennial, we have a group of Army Reservists from the Harrisburg Armed Forces Reserve Center. They are seated with us today in the back of the House. As I announce them, I would ask that they please rise and be recognized by the House.

We have Lt. Col. Robert Baumgardner, S. Sgt. Kevin Davis, M. Sgt. Andrew Dinunizio, Sfc. James Fearn, Spc. Crystal Fernandez, Sgt. Maj. Rosa Harmon, Sgt. Teresa Kauffman, Sfc. Elizabeth Limon, Army Reserve Ambassador Phil Petter, Spc. Lisa Swann, and S. Sgt. Gary P. Wright. Will you please honor these soldiers for their commitment to our country.

I also think it appropriate that we honor the members of our chamber here with us who have also served as members of the Army Reserve. I hope, and I do not know that this list is complete, but I know that at least three of our members have served – Representative Bob Mensch, Representative Ron Marsico, and Representative Bryan Lentz – and I would also like to thank them for their service along with any other members whom I may have missed who have served in the past in our Army Reserves serving our nation.

I will turn it over to Representative Cappelli for any remarks he might have.

Mr. CAPPELLI. Thank you, Representative Gibbons.

Members of the House, I am very appreciative to Representative Gibbons for allowing me to jointly sponsor this important resolution commemorating the centennial anniversary of the Army Reserve.

I am told that there are approximately 175,000 Army Reservists in the United States, and 90,000 of them are currently on active duty in either Afghanistan or Iraq and that an additional 30,000 are on active duty somewhere else in the world in support of freedom, hope, and putting an end to global terrorism. These are not only heroes, they are unsung heroes, and we should all be very appreciative of their sacrifices and commitments to our national defense.

He is now an ambassador with the Army Reserve, soon to be approaching 50 years of continuous service to the United States Army Reserve. Colonel Petter, thank you and God bless you, sir.

Whenever under this act, discretion is vested in the department or any board thereof as to whether, or the manner in which, to exercise a power or fulfill a duty, the department shall, after such examination or investigation as it shall deem appropriate under the circumstances, exercise such discretion in such a manner as it shall deem necessary to ensure the safe and sound conduct of the business of any institution subject to its supervision, conserve its assets, maintain public confidence in the business of such institutions and protect the public interest and the interest of depositors, other creditors and shareholders thereof.
- C. The department may promulgate such rules and regulations necessary and appropriate to administer this act.
- D. The department may issue statements of policy and interpretive letters necessary and appropriate to administer this act or any other statute within the department's jurisdiction to administer or enforce.
- E. Notwithstanding any other law or provision of this act to the contrary, the department may require licensees to use a national electronic licensing system in order to apply for or renew licenses issued pursuant to any statute within the department's jurisdiction to enforce. The department may require licensees to pay a processing fee for the use of a national electronic licensing system. Notwithstanding any other law, the department may modify, by regulation, license renewal and reporting dates for any licensees subject to this subsection that are inconsistent with the use of a national electronic licensing system. The department is not authorized to require a person or corporation which would otherwise be totally exempt from licensure pursuant to any statute under the department's jurisdiction to submit information to or participate in any national electronic system.

On the question,

The SPEAKER. The question is, shall the bill pass finally?

Representative Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

Will the prime sponsor stand for brief interrogation?

The SPEAKER. The gentleman, Representative Belfanti, indicates he will stand for interrogation. Representative Vitali is in order and may proceed.

Mr. VITALI. I am basically just looking for a brief explanation of the bill.

Mr. BELFANTI. Yes, I will stand for interrogation.

Mr. VITALI. I would like to begin my interrogation by asking the prime sponsor to give a brief explanation of his legislation.

Mr. BELFANTI. Okay. The legislation corrects a deficiency as a result of certain laws taking effect prior to the institutions of the Bureau of Probation and Parole and the Attorney General's narcotics task force being established.

All other law enforcement agencies – is the gentleman listening? – all other law enforcement agencies where individuals are required to wear Kevlar vests and arrest people in the middle of the night are covered by what is called binding arbitration legislation. These officers who were designated after the laws that created the normal police departments and State Police were designated initially as officers of limited jurisdiction. They purportedly have a right to strike, but they are in a catch-22 because they are not allowed to strike as they are considered essential personnel.

If you would consider the fact that if the entire State parole officer detachment were to go on strike or all of the narcotics officers who work for the Attorney General were to go on strike, what a field day it would be for narcotics dealers and for convicted felons that are not yet done serving their parole. They are out on parole because they have not served their maximum time in jail. And if it is not for probation officers at the county level and parole agents at the State level, and again, in the case of the Attorney General, half the Attorney General's Office, which was created prior to 1950, is covered by binding arbitration, and the other half, what we consider the narcotics agents, are not covered. So this is just a loophole that needs correcting, and I am here to hopefully correct it.

Mr. VITALI. Thank you.

Are you aware of any groups who have expressed their opposition to this legislation?

Mr. BELFANTI. I must say that the F.O.P. (Fraternal Order of Police) is for it. The Office of Administration and the Attorney General, who would probably prefer to collectively bargain and allow these agencies to be considered strikable employees, would prefer to maintain the status quo so that they can keep their thumb, if you will, on these particular agents.

Once again, these agents are people that perform some of the most dangerous tasks in the Commonwealth. In fact—

Mr. VITALI. I do not mean to cut you short, but—

Mr. BELFANTI. —State parole agents—

Mr. VITALI. Excuse me. I do not mean to cut you short. My question was, do you know of any groups who have expressed opposition to the bill?

Mr. BELFANTI. No, no. Other than what you would expect, the executives of the branches that now have it both ways, they can state these officers are eligible to collectively bargain, and by that, they are allowed to strike. On the other hand, they are considered essential State employees so they are not allowed to strike.

Mr. VITALI. So again, could you just list the groups that have expressed opposition to this?

Mr. BELFANTI. No. Every group that I know of, the State Police officers, the Chiefs of Police, other officers of limited jurisdiction that are not included, including the sheriff's agency and departments, the employees, of course, of both the Attorney General's narcotics division, all of the parole agents, and all of the probation officers at the county level are very much in favor of this.

Mr. VITALI. So are you saying there is no group who has expressed opposition to this?

Mr. BELFANTI. No group whatsoever, other than administrative agencies, again, bureaucrats who like to have it both ways.

Mr. VITALI. Okay. Thank you.

REMARKS SUBMITTED FOR THE RECORD

Mr. D. O'BRIEN submitted the following remarks for the Legislative Journal:

Prison Reform Package/Speaker Dennis M. O'Brien HBs 4, 5, 6, and 7

Today we vote on a legislative package to reform how we manage and incarcerate those convicted of crimes. HBs 4, 5, 6 and 7 together provide much-needed reforms to make the public safer, ensure that offenders receive treatment services essential to break the cycle of crime, reduce duplication of efforts that waste taxpayer dollars, add essential safeguards to outdated laws, and ensure that crime victims are treated fairly.

If you join me in support of this package, we will bring historic change to Pennsylvania's sentencing practices, State and county correctional systems, offender treatment services, and parole supervision. This comprehensive, bipartisan package is the product of long and hard work by criminal justice stakeholders and members of the House.

Please allow me to review the goals that this package of bills will accomplish.

First and foremost, they address a long-standing imbalance between our county and State correctional systems. As the recent Pew study demonstrated, our correctional systems (Pennsylvania Department of Corrections and county jails) have resulted in Pennsylvania having an overall incarceration rate that is roughly average for the nation. However, a much greater proportion of inmates are housed in the county jail system.

This is the result of Pennsylvania's unique sentencing laws that grant sentencing judges the power to place long-term inmates in the county prison system. Most States require offenders serving sentences of 1 or more years to be placed in the State correctional system. Pennsylvania, however, allows judges to place any inmate with a sentence of less than 5 years in the county prison system. Even longer sentences can be served in the county jails through the stacking of shorter sentences.

This sentencing scheme has resulted in county jails – that are designed to be short-term detention facilities – being required to house and treat very serious offenders serving long-term sentences. Specifically, county prisons must house prisoners serving these long sentences. They are also required to house offenders who are paroled from these long sentences but then violate the terms of their parole.

This is bad public policy for a number of reasons. First, county jails are funded by local property taxes. These large prison budgets place an inordinate strain on the county budgets and result in a lack of funding for other essential criminal justice needs, such as police officers and prevention programs.

In addition, the county prisons lack the financial and staff resources to provide essential drug treatment and other services for these serious offenders that will be returning to our communities. Without proper treatment, these offenders will commit more crimes and endanger the public.

Finally, county jails often cannot house so many prisoners. A number of our county jails have faced Federal lawsuits seeking the release of a prisoner to reduce the jail population. These lawsuits lead to pressure of local officials to release dangerous inmates or Federal court orders mandating mass prisoner releases. In Philadelphia, for example, prisoners ordered released by the Federal court prison cap resulted in the rearrest of these offenders for almost 10,000 new crimes, including 79 murders. One of these included the murder of rookie police officer Daniel Boyle, who was killed after stopping a car stolen by a defendant repeatedly released by the Federal court.

To address this pressing problem for the counties, we have developed this bipartisan prison reform package to reduce county jail overcrowding and pressure to release jail inmates. Specifically, this package will shift the burden for incarceration and treatment of serious offenders from the county to the State system. As a result, we will improve offender treatment through centralized programs, administrative support, and specialized expertise. This improved treatment and additional county resources for other essential criminal justice services will significantly reduce the risk of crime in our communities.

In addition to this shift of responsibility for serious offenders, this package also serves many important public policy goals. It ensures truth in sentencing for the victim, the public, and the offender. It provides incentives for nonviolent offenders to participate in evidence-based rehabilitative programs proven to reduce the recidivism risk. It reduces the risk of harm to inmates and correctional officers through the improved exchange of information between the county and State system. It revamps old and outdated Pennsylvania law governing the release of inmates for medical treatment to add appropriate safeguards. It will improve county and State parole practices through parole guidelines that ensure consistency and fairness. It will encourage parole resources to focus on higher risk offenders. It will also reduce taxpayer costs through the centralization of prisoner transportation and use of video-conferencing technology to reduce the number of prisoner transports required.

This is, of course, an ambitious package. But it has been carefully crafted with the support of the bills' sponsors who include ranking Judiciary member Ron Marsico, Representative Kathy Manderino, and

Judiciary Chairman Tom Caltagirone. As a result of this work, this package enjoys the unprecedented support of stakeholders throughout the Pennsylvania criminal justice system. This package is supported by the County Commissioners Association of Pennsylvania, the Pennsylvania District Attorneys Association, the Pennsylvania Prison Society, the Sheriffs Association, the Association of Wardens, the Pennsylvania Sentencing Commission, the Department of Corrections, the Pennsylvania Board of Probation and Parole, and the Governor.

These aforementioned groups support the following specifics of this package:

I. Place-of-Confinement Amendments.

HB 4 would do the following:

- require the State to house prisoners serving sentences of 2 or more years;
- allow prisoners, under limited circumstances, to serve 2- to 5-year sentences in the county (with agreement of the district attorney, the judge, and the county jail administrator if the jail population is less than 110 percent of the rated capacity);
- require the lumping ("aggregation") of consecutive terms of confinement for purposes of determining place of confinement:
- allow judges to send previously sentenced prisoners to the State system if they violate the county Restrictive Intermediate Punishment (RIP) sentence; and
- require the State to reimburse counties for long-term work release (but with a statewide cap of \$2.5 million).

These amendments contained in HB 4 are essential to put Pennsylvania more in line with accepted correctional practice as most States require prisoners serving sentences of 2 or more years to serve those sentences in the State system.

II. Temporary Transfer of Prisoners for Judicial Proceedings.

HB 5 would address current problems encountered with the transportation of State prisoners needed for court hearings. Under current practice, each county is responsible for the transportation. The separate county transportation systems need to be centralized to reduce the overall cost to the taxpayer.

HB 5 would require the Department of Corrections transport State prisoners to State prisons near the courthouse. Counties electing to use this transportation system would reimburse the Department of Corrections for the cost of the transportation, but not the cost of confinement. In addition, HB 5 encourages the use of video-conferencing technology to reduce the overall number of prisoner transports. HB 5 is designed to reduce overall taxpayer costs through consolidation of transportation services and to reduce the risk of prisoner escapes.

III. Parole Guidelines.

HB 4 and HB 6 together provide important changes relating to parole. In summary, the Sentencing Commission would promulgate parole guidelines. The proposed Sentencing Commission guidelines would apply to initial paroles, recommitments, back-time, reparoles, and resentencing. County judges, like the Pennsylvania Board of Probation and Parole (PBPP), would be covered by the statutory requirements and parole guidelines. Thus, like sentencing guidelines, there would be new constraints on judicial discretion. PBPP would have statutory authorization for nonreporting parole (termed "administrative parole") for certain classes of offenders who have been successfully managed for a period of time on parole.

There would also be significant changes in parole jurisdiction. Judges would be responsible for paroles of inmates serving 2- to 5-year sentences in the county prison, under the new place of confinement provisions that will take effect in 3 years. Importantly, no inmate would be subject to this parole jurisdiction change unless the district attorney, county jail administrator, and judge previously agreed to the county prison placement. When the final provisions take effect, the PBPP would no longer be in the business of paroling prisoners from county prisons unless they have agreed to accept a "special parole."

HB 4 and HB 6 also address the issue of early parole for county sentences. There have been concerns about current county sentences where sentenced prisoners are paroled prior to the expiration of the minimum sentence without notice to prosecutors and crime victims. After much constructive negotiation on this issue, we have crafted provisions that ensure truth in sentencing, prevent the undercutting of sentencing guidelines, and still permit counties to operate existing earned time or good time programs that conform to these statutory requirements.

Under these new early parole provisions, a judge imposing a county sentence (of less than 2 years) would have the option of making that offender eligible for an early parole to a county reentry plan. The eligibility date would be announced at the time of sentencing, thus ensuring that the victim, public, and offender all know at what point that offender would be eligible for release from that prison. The offender could not be released at a point earlier than the date announced at sentencing and the date reported to the Sentencing Commission. This also makes clear that county jails cannot simply implement early release programs that release prisoners early for good behavior. Rather, such releases would be a part of the sentencing and parole orders. This open and transparent process is essential to ensure fairness to victims and public confidence in our criminal justice system.

IV. Medical Release.

The current statute governing prisoner releases is outdated and fails to account for the need to place terminally ill prisoners in hospice care. At the same time, the current statute lacks public safety protections and does not take into account victim notification. HB 7 adds essential safeguards to this process by ensuring appropriate notice and an opportunity to be heard for prosecutors, victims, and correctional officials. HB 7 also requires judges to consider public safety issues and the impact on victims in making these decisions and establishes a mechanism for reincarcerating inmates for changed circumstances. Finally, the new law establishes criminal penalties for those who illegally leave medical facilities. Importantly, HB 7 changes the current system that authorized judges to "modify" existing sentences to accomplish a medical release. Under HB 7, prior sentences could not be "modified." Rather, judges could simply "defer" the service of a prison sentence. Thus, these provisions would not apply to capital cases nor permit reduction of fines or restitution orders. In addition, inmates would not be entitled to sentencing credit for placements in medical facilities. At the same time, HB 7 would allow Pennsylvania to receive matching Federal funds for medical treatment.

V. "Rebuttable" Parole at the Minimum.

HB 6 would allow for the presumptive parole of prisoners who meet the State Intermediate Punishment (SIP) eligibility standards but were not referred or accepted to the program. These prisoners would be eligible for automatic release at their minimum sentences if they have maintained a good conduct record in prison, they do not pose a public safety risk, and there is an adequate parole plan. The proposed language also adds substantial checks and balances. It also encourages PBPP to devote supervision resources to higher risk offenders.

VI. Department of Corrections Requests for SIP Referral.

HB 4 would allow the Department of Corrections to request that an eligible prisoner be considered for SIP. These amendments retain the requirement of the prosecutors consent before entry into the program. However, the new amendments will authorize resentencing in appropriate cases where inmates are identified for this program after entry into the State system. Current law precludes such resentencing.

VII. Recidivism Risk Reduction Incentives.

HB 4 amends 42 Pa.C.S.A. § 9756 and adds a new chapter in Title 44. This comprehensive proposal (known as the "Recidivism Risk Reduction Incentive Program" or "RRRI," pronounced as "Triple-R Eye") is designed to ensure that nonviolent prisoners participate in evidence-based programs proven to reduce recidivism. In addition to revisions to 42 Pa.C.S.A. § 9756 (sentencing provisions), there are definitional provisions, limits on eligibility, limits on the types of programs that can be approved, additional public safety protections, requirements for published guidelines and regulations, reports, evaluation, and an educational plan (targeted for prosecutors, the defense bar, and judges). This limited program is modeled on a successful recidivism reduction program in New York State. Research also demonstrates that this targeted approach can reduce recidivism rates for program participants.

In addition, HB 4 has carefully crafted limits to this program to preclude inappropriate releases of prisoners who pose a risk to the public, are high-level drug dealers, or who are unlikely to be rehabilitated by such programs. For example, offenders who have twice been sent to the Department of Corrections and received the benefits of the RRRI programs from the department would not be automatically entitled to an RRRI for a third time. Rather, judges in this case would retain the discretion to deny this program to these offenders.

VIII. Prisoner Information Provisions.

HB 4 amends 42 Pa.C.S.A. § 9764 to address the information accompanying prisoners admitted to the State system. These proposed amendments are designed to ensure that the Department of Corrections has medical information, escape history, prison infraction records, sentencing credit information, and other information necessary for the safe management of prisoners. The bill includes language that would minimize the burden on the county system and encourage the use of electronic records. This information is essential to prevent improper prisoner releases, protect staff and inmates from violent prisoners, and prevent harm to inmates from incomplete information relating to medical conditions or prescribed medications.

This summary does not list every important change that will come to benefit our State and its citizens as a result of this prison reform package. You can be assured that changes resulting from your action today to send this package to the Senate – and eventually to the Governor – will:

- 1) make the public safer;
- 2) protect the rights of victims;
- 3) give offenders every possibility to turn their lives around and reduce recidivism;
- 4) and ensure that we spend tax dollars wisely.

I ask for your support in enacting this landmark package, and I thank my colleagues on both sides of the aisle who have stood with me in the difficult but necessary work of crafting this legislation.

Mr. SABATINA. Thank you, Mr. Speaker.

Mr. Speaker, this bill upgrades current law. What it does is it finds that people that are in possession of a firearm with an altered serial number, right now they are charged as a misdemeanor of the first degree. This bill upgrades it to a felony of the second degree.

The SPEAKER. Representative Manderino.

Ms. MANDERINO. Thank you, Mr. Speaker.

I rise to support HB 1845 on final passage, but I also want to put some remarks on the record with regard to some of the content that went into the bill when it was amended on second

consideration. One of the amendments that went into the bill was identical language to HB 1160, which is an emergency, the petition to allow for the carrying of a concealed license, carrying of guns, getting a concealed license permit, and I just want to put on the record that the Pennsylvania Coalition Against Domestic Violence has had a long-stated position in opposition to this notion. Contrary to what has been purported in a view that these emergency licenses will aid in the protection of domestic violence victims, it has long been considered the position of the domestic violence community that this will not give added protections and, if anything, will give added risk of harm to domestic violence victims.

There are a number of stated reasons for opposition, but I just want to put one on record that is the one that concerns me the most, and that is that this can become an avenue for abuse of the protection-from-abuse process. The protection-from-abuse process and petition is always a very sensitive subject. When those issues come before the judiciary, they often are weighing the credibility, the pluses and minuses, the fears, and the realities of two very vulnerable people. And the domestic violence coalition believes, and I agree with them, that to make an emergency petition to allow the circumventing of the regular process to apply for a concealed weapon, to be able to be shortcut just by going into court and alleging that you need it because of your fear through a protection-from-abuse order, I think, is going to exacerbate the concerns folks have about how that process is abused.

So I just want to put that on the record. I think most of what is in the bill is good, but I know that there are concerns about this provision. Thank you, Mr. Speaker.

RESOLUTION

Mr. LEVDANSKY called up HR 642, PN 3420, entitled:

A Resolution directing the Legislative Budget and Finance Committee to conduct an evaluation and study of the Pennsylvania Game Commission's current deer management program and practices.

On the question,

Will the House adopt the resolution?

The SPEAKER. The Chair recognizes Representative Levdansky.

Mr. LEVDANSKY. Thank you, Mr. Speaker.

Mr. Speaker, this resolution directs the House Budget and Finance Committee to do a study on the Pennsylvania Game Commission's deer management program.

About 5 years ago, the Game Commission adopted some significant changes relative to deer management, roughly including such things as antler restriction and concurrent buck and doe seasons. We finished 5 years of this new program on deer management with the Game Commission. These changes were designed to improve the overall, to address the overall health of the deer herd in Pennsylvania, the health of our forest habitat, and to address deer and human conflicts.

Over the years there has been some controversy, where some might even be underestimating, amongst the ranks of deer hunters in the Commonwealth. There are a lot of sentiments, pro and con, relative to the existing deer management program. It seems to me, in listening to the debate, that the advocates of the new program and the critics of it often do not have the necessary data so that we could maybe reach some compromises and some understandings on where we need to go relative to our deer management in Pennsylvania.

And a lot of times we are talking past each other on the issue, simply because we do not have good data and good information and good science-based information to evaluate where we are. So under this resolution, the Budget and Finance Committee would oversee an audit of the Game Commission's deer management program, most likely retain some out-of-State expertise because we want to make sure that this study is both comprehensive and professional, but we also want to ensure that it is objective as well. So under this resolution, the Budget and Finance Committee, and our staff has expertise relative to the Game Commission's programs and finances, it would oversee this project and, finally, would result in the issuance of a report with findings and conclusions.

And no matter where you stand on our deer management program, I think all sides to the debate on this critical issue recognize the benefit of having an independent, objective audit done on the Pennsylvania Game Commission's deer management program, and I would urge an affirmative vote.

Mr. STERN. Thank you, Mr. Speaker.

Mr. Speaker, the resolution before us is presented to honor the memory of those brave officers who gave their lives in the line of duty in this Commonwealth and to recognize the annual police memorial ceremony to be held in their honor across from Solders' Grove at noon on May 5, sponsored by the State Fraternal Order of Police.

Philadelphia Police Officer Walter Barclay lost his life due to complications of a gunshot wound on August 19, 2007, that he had received 40 years earlier when he was shot by a burglary suspect. He had served as a policeman for 1 1/2 years at the time of the shooting.

Officer Charles Cassidy lost his life on November 1, 2007, after being shot the previous day when he walked into a robbery in progress. He had served with the Philadelphia Police Department for 25 years.

Pennsylvania State Police Officer Scott Ball was serving as a Pennsylvania National Guard soldier in Afghanistan when he was among five people killed in an ambush by suspected Taliban militants on August 27, 2007. He was an 8-year State Police veteran and a former active-duty soldier who joined the National Guard in 1992.

The deaths of these law enforcement officers make a total of 702 officers who, through the year 2007, have made the ultimate sacrifice since organized law enforcement was established in Pennsylvania.

I ask for your support for HR 690, as you have in years past, as a symbol of our gratitude and appreciation for the hundreds and thousands of brave men and women who have given their lives in the line of duty in order to protect Pennsylvania and her people. Thank you, and I appreciate your support for this resolution.
