The SPEAKER. The Chair would like to take this opportunity to recognize a former member who has joined us for a visit today, former legislator Francis Gleeson from Philadelphia.

GUESTS INTRODUCED

The SPEAKER. The gentleman from Clearfield County, Representative Camille "Bud" George, has several guests in the gallery today deserving recognition. The House extends its welcome to Aerial Fullington Weisman, the president and CEO (chief executive officer) of the Fullington Bus Company of Clearfield, and Jack Custaney, the chief financial officer. The Fullington Bus Company has been transporting people, first by horse – were you on that horse, Bud? I believe you were – and surrey, and now with state-of-the-art luxury motor coaches since 1908. Also in attendance is Jason Barnett, the business administrator for the Clearfield Area School District, home of the Bisons. Would you please stand and be recognized.

We have two guest pages from Representative Sue Helm's district with us today on the House floor. Richard is chaperoned by his mother, Pam Barnes. She is located at the back of the House. Would you please stand and be recognized.

MUSCLE CAR AND DRAG RACING DRIVERS PRESENTED

The SPEAKER. The Chair requests that Representative Haluska, Representative Gillespie, and Representative Payne come to the podium for the presentation.

Mr. HALUSKA. Good morning, everybody.

The Pennsylvania Motorsports Caucus; it is motorsports day in Harrisburg, and we are basically here, the five gentlemen behind me – behind Representative Payne and Representative Gillespie and myself – are basically people that have been with drag racing and muscle cars for many years.

Absent today due to health reasons is Bill Jenkins, better known as Grumpy Jenkins, from Malvern, Pennsylvania. Bill is a legend in drag racing and is still practicing his craft in his seventies today by building race motors for a top 10 Pro Stock team.

As you will see on your desks, there is a fan guide, courtesy of the national hot rod racing association. NHRA (National Hot Rod Association) hosts 24 races across the country each year, featuring 4 professional categories along with 8 sportsman categories. Maple Grove Raceway in Reading, Pennsylvania, annually hosts one of these races. This year it will be held on August 14 through 17.

Across the State, we have a number of drag racing facilities which hold weekly events which are attended by many sportsman racers who hone their skills, and eventually, some may get to the professional ranks. The era of muscle cars would have never happened if it had not been for the men like the ones that are here behind us today that we honor for their dedication to the sport of drag racing and to muscle cars. Many of the innovations that brought muscle cars from the sixties and seventies out of Detroit, that we will see today over in Soldier's Grove, came from some of the ideas that these gentlemen have fostered over the years.

If you look at your guide that is laying on your desks, your NHRA fan guide, if you have never been to the races and you do not know what a drag race is, you can refer to page 25 and it tells you a little bit about Maple Grove Raceway up in Reading. If you go to page 89, it tells you what drag racing is all about; and if you go down to page 96, it describes the drag strip. And if you are not inclined, I am sure you have a friend or you have a relative that is a muscle car enthusiast or a car enthusiast; I am sure they would appreciate you sharing that guide with them.

Today drag racing has really changed, and today the Top Fuel car covers the 1320 feet of a drag strip in a little bit more than 4 1/2 seconds, at 330 miles an hour. So it has come a long way, and I am going to introduce Representative Payne,

who has a little bit to say about our five recipients here standing behind me today.

Mr. PAYNE. Thank you, Gary.

The Motorsports Caucus is truly that - a team effort. I encourage my colleagues, at the break, to go out to Soldier's Grove and see some of the cars that are out there. It brought back great memories for me.

I have the privilege of introducing four people. The introductions will be brief.

Bud Faubel is a Korean war vet. Bud, put your hand up. He holds the record for the fastest qualifying speed of 156 miles an hour at the Daytona Speedway – on the sand; holds the record for the fastest in Daytona on the sand. In 1956 he was named the national champion, Stock Car Eliminator champion in drag racing, and he earned the title of "Mr. Stock Car Eliminator." Bud.

Next is Jere Stahl. Jere holds the NHRA records – and get this – in '64, '65, '66 in a Plymouth Hemi, '66 in another Plymouth Hemi, and '67. Jere also won the class G/S (ground speed) at the Indy Speedway in 1964, and he broke the record by .68 seconds and the BFX record by .8 seconds. Jere Stahl.

Next is Ken Montgomery. Ken began racing at 13 years of age at the Hatfield Speedway and competed at the York U.S. 30 Dragway. He captured three national drag race titles and the 1998 Keystone Nationals, held right here in Pennsylvania at Maple Grove. Ken.

Next is Bruce Larson. Bruce began his drag racing career at 16 in Linden, New Jersey. He drove a chopped '32 Ford coupe. He began driving a '64 Ford Cobra and set the AA sports record. In 1969 he won the Super Stock Nationals in York, and in 1989 he won the NHRA Winternationals, Spring Nationals, Mile-High Nationals, Seafair Nationals, Fall Nationals, and the Winston Nationals. Bruce Larson.

It is my pleasure now to introduce Representative Gillespie.

Mr. GILLESPIE. Thank you, Representatives Payne and Haluska.

Ladies and gentlemen and fellow colleagues, it is my honor and pleasure to introduce and present a House citation to Darwin Doll. Darwin resides in Springettsbury Township in York County and has a long and extensive history with muscle cars and the United States Hot Rod Association drag racing, not only as a racer but as a coordinator and an administrator in various capacities.

Many of the exhibits on display here today out in the grove are a direct result of Darwin's efforts. Please join me in a warm House of Representatives greeting, and thank you to Darwin Doll for all his efforts.

Mr. HALUSKA. Thank you, Mr. Speaker.

JIM KELLY PRESENTED

The SPEAKER. The Chair requests that Representative Kenney come to the podium for a presentation of a very special friend of Representative Matt Baker.

Mr. KENNEY. Good morning.

Today it is my distinct pleasure to welcome home someone whom many of you may recognize as one of the best quarterbacks who has ever played professional football. Jim Kelly got his start playing football for the East Brady Bulldogs in Clarion County, where he passed for more than

3900 yards and threw 44 touchdowns. His performance earned him a spot in the Big 33.

From his success in western Pennsylvania, Jim continued his career at the University of Miami. While there, he led the Hurricanes to a 1980 Peach Bowl appearance. Coupled with his high school and college accolades, Jim Kelly is most notably recognized for his time as the quarterback of the Buffalo Bills. Jim led the Bills to four consecutive Super Bowl appearances and five divisional championships in the early nineties.

In August of 2002, Jim Kelly was inducted into the Pro Football Hall of Fame. But beyond his many sports accomplishments, it is Jim Kelly's work after football that we are here to honor today.

In 1997, Jim and his wife, Jill, founded the Hunter's Hope Foundation after their infant son, Hunter, was diagnosed with Krabbe disease, an inherited, fatal, nervous system disease. The Hunter's Hope Foundation has increased the awareness of Krabbe disease and other leukodystrophies and helped fund research efforts to identify new treatments and therapies.

The Hunter's Hope Foundation has also been championing universal newborn screening so every child, every time, everywhere, is screened at birth for treatable metabolic disorders.

Jim Kelly is here at the State Capitol today along with James Dennis, the State director of the Pennsylvania March of Dimes – Mr. Dennis – and Jacque Waggoner, who is the CEO (chief executive officer) of the Hunter's Hope Foundation but, more importantly, Hunter's grandmom and Jim's mother-in-law. Jacque.

They are joined by many other representatives of the Pennsylvania March of Dimes and Hunter's Hope Foundation to urge members of the House and Senate to support the Newborn Child Testing Act, which I have sponsored for the past two legislative sessions, and I do want to take the time to thank the members of this House who have unanimously supported this legislation, HB 883, which is awaiting consideration in the State Senate Appropriations Committee.

But it is my honor to present Jim Kelly with a House citation, recognizing his tireless efforts to support the health and welfare of America's newborns by ensuring that every child in every State receives the proper medical screening at birth.

Please welcome Jim Kelly to the Pennsylvania House of Representatives. Jim, congratulations.

The SPEAKER. The Chair is going to take some literary license with an old cliché and say, if you do not know your past, you will not know your future, and I believe that is every bit as true in the NFL (National Football League) as it is with every historical facet of our life experience.

As Representative Kenney has articulated, Jim Kelly has been a champion in the sports world, championing his fellow Buffalo Bills to numerous Super Bowls, and he demonstrated extraordinary courage on the football field, but what he is doing also is taking a very intimate issue in his life experience and championing that on a much broader stage, and we applaud him for that.

The reference to that cliché comes to mind because as Jim Kelly has historically pioneered the history of the NFL and documented it in numerous Super Bowls, our own Donovan McNabb came to this podium and he represents the future of the NFL.

So it is my pleasure to bring the courageous Jim Kelly to the podium for a few words. Please welcome Jim Kelly.

Mr. KELLY. Thank you, Mr. Speaker. Thanks, Representative Kenney.

I know everybody has a lot of things on their agendas, but I want to personally thank you and tell you what an honor it is for me to be here, not only to represent my son, Hunter, who passed away just 3 years ago from a fatal disease; the bottom line, and I will not take a lot of time, but this, to me, is very important.

My son, after I retired from the Buffalo Bills, my son was born on Valentine's Day, which is my birthday also, and I was one of those daddies that dreamt about going out in the backyard, just like most fathers do, and playing catch and throwing the football around and going fishing and all those great things that fathers and sons do.

But my son was diagnosed with that illness 4 months into his life. By that time, it was too late, and my son just passed away 3 years ago at the age of 8 years old – way too early for a young man to go. And the bottom line is, I was one of those little boys who was able to dream as a young kid what I wanted to do with my life, and my life was to play football. That is what I wanted to do.

By doing our research through our foundation, we found out that every State in the United States tests for a different amount of diseases – some States 4, some States 8, some States 44, like Mississippi and Hawaii. In our great State of New York, where I live now, they tested for 11 diseases. If my son was diagnosed at birth, he would have been able to have a quality of life. It did not take our government very long in the State of New York to go from 11 to 44 and then test for my son's disease, at 45. And I know this great State of Pennsylvania, where I was born and raised, will do what they can to make sure that every kid out there gets a chance to dream like I was able to do.

I know that each and every person that is sitting in this room either has a relative, a friend, or a family member that has a disability. The bottom line is, let us give these kids a chance to dream like I was able to do, because if I do not do it and if the people from the March of Dimes do not do it, it might take a long time from now, and the bottom line is, let us give these kids a chance to dream like I was able to do.

BRADEN GOURLEY INTRODUCED

RICHARD BRANT PRESENTED

The SPEAKER. The Chair requests that Representative Bastian come to the podium for an introduction.

Mr. BASTIAN. Thank you very much, Mr. Speaker.

I have behind me this morning a young man from Meyersdale, Pennsylvania, a senior in high school, Richie Brant, and behind him is Trooper Jeff Brock and Trooper Jim Reavel. They are both involved with Camp Cadet in Somerset County. Jeff is the president and Jim Reavel is the vice president, and both are on the staff of summer camp.

Many of you are familiar with Camp Cadet in your own counties. Our county has had an organization for about 8 years now. We put on a camp each year for young men and women between the ages of 13 and 15 years of age. These individuals go through an intense week of military-style training, a lot of physical training, a lot of running and marching. The FBI (Federal Bureau of Investigation) comes in to talk to them, the Game Commission, the Fish Commission. They visit a local prison. They are trained to be somewhere involved, in the future, in police work.

This young man, Richie Brant – we had, just a minute ago, another hero – Richie Brant is also a hero. Richie Brant was in the right place at the right time and he did the right thing, because he had the right training. Richie was a member of the Camp Cadet camps group about a year and a half ago, 2 years ago, in '06. He learned CPR (cardiopulmonary resuscitation), and on the day before Christmas, this last year, he heard a thud from upstairs. He went up, and his dad had had a heart attack. He had stopped breathing. From the training Richie had as a member of that Camp Cadet camp, he learned CPR and performed the CPR. He had other members in the family do the right thing, call 911. He stayed with his dad until he was on the helicopter to a tertiary hospital. This young man is a hero.

With us today, too, is his mom, Christine Brant, on the side – if she would stand up – his sister and grandparents and uncle, the Faidleys – Celeste, David, Ruth, and Robert. Let us give all

these people a warm, hearty welcome from the House of Representatives.

Mr. McCALL. Thank you, Mr. Speaker.

Mr. Speaker, this is an agreed-to amendment. The agreement is between the Department of Community and Economic Development industry leaders, the House Tourism and Recreational Development Committee, both sides.

But I would like to just briefly go over some of the changes, some of which are very technical and others may be substantive, but basically, the amendment expands the list of eligible costs that the grants can be used for. Now the only expenses that would be ineligible are rent, utilities, equipment, insurance, financing, and capital expenditures.

A technical amendment clarifying that tourism and tourist definitions are synonymous in the legislation. It secures exact funding percentages for both grant programs throughout the bill. It expands the list of eligible applicants for regional marketing partnerships, the grants themselves, and provides for a limitation on the grant amounts to a single regional marketing partnership.

Mr. Speaker, again, I want to thank all the participants who worked diligently to bring this compromise language to the table, and I would ask for an affirmative vote.

Mr. TANGRETTI. Thank you, Mr. Speaker.

Mr. Speaker, the McCall amendment has fine-tuned the bill that has been long in coming. We are, in effect, putting together, putting in place, a tourism promotion act that has been needed for a long time.

This repeals Act 50 of 1961, and we have been kind of flying by the seat of our pants since then with respect to these tourism promotion dollars. In 1991 and thereafter, we adopted a hotel tax that allowed, for the first time, additional dollars to be raised locally for this purpose. What that had done though, as a result of that enactment, had created a system that was out of whack with respect to how the money is distributed throughout the Commonwealth, with respect to the tourist promotion agencies and the regional marketing initiatives that, by the way, are not even in statute.

So what we have done is codified, for the first time, how these dollars are going to be spent and the process by which they are to be distributed and how they are to be used. I think it is something that we all, in this House, should support. All of the TPAs (tourist promotion agencies), all 49 of them, all 49 of them have endorsed and supported this legislation, the administration, the Department of Community and Economic Development, Deputy Secretary Rowley, his staff, the industry.

The minority chairman and myself and other members of the committee all have worked very hard on this, and I would be remiss if I did not mention the executive director, Mrs. Stalnecker, of our side of the aisle and our committee and Al Taylor on the minority side who worked diligently to get this done as well as a number of industry experts, their executive committee who worked along with Deputy Secretary Rowley.

So I want to thank all of them and all of you, and I would hope that going forward, we are going to see a huge increase in our promotional dollars, how they are used as we support the second largest industry in this Commonwealth, the tourism industry.

I would ask for an affirmative vote on HB 2302.

Thank you, Mr. Speaker.

The SPEAKER. Representative Nailor.

Mr. NAILOR. Thank you, Mr. Speaker.

Mr. Speaker, I rise and ask for an affirmative vote as well. It has been a pleasure working with the majority chairman, Chairman Tangretti and his staff. This has been a bipartisan piece of legislation. There has been a lot of work done with the State's 49 visitor's bureaus working with DCED (Department of Community and Economic Development). As was mentioned, it has taken over 20 years to get this far.

What DCED has done over the years is pretty much hold harmless the various TPAs, and by doing that it became very inequitable at their funding levels. This bill does three major things, and they are very detailed, but I will make them basic. It consolidates two grant programs for the ease of understanding an equitable distribution of the funds. It gives tourist agencies a seat at the table with DCED and developing grant guidelines that affect them. And it provides greater accountability for the regional grant program that is currently governed by the department guidelines and not in statute. This puts it in statute, Mr. Speaker.

It is a good piece of legislation. It has been a long time coming. A lot of work was put into it, and I ask for an affirmative vote. Thank you.

Mr. Speaker, this amendment changes the effective date of HB 2295 from 60 days to immediately. The intent of HB 2295 is to restore language to the Uniform Condominium Act relative to the payment of unpaid assessments for common expenses that are owed to a condominium association through a judicial sale of a unit.

The language was inadvertently removed in 2004 when the omnibus amendments were made to the act. The removal of this critical language has caused, and will likely cause in the future, condominium associations to lose their statutory entitlement to this significant source of revenue. Therefore, I believe the change in the effective date of the bill is warranted, and I respectfully request the support of the House for this amendment.
