2007 CALIFORNIA UNIVERSITY OF PENNSYLVANIA FOOTBALL TEAM PRESENTED

Mr. DALEY. Thank you, Mr. Speaker.

Ladies and gentlemen, on behalf of the Washington and Fayette County delegations and all of us in southwestern Pennsylvania that are privileged to have children who have attended or attend California University of Pennsylvania, it is my absolute pleasure to introduce to you some of the members of the 2007 Cal U Football Team.

Ladies and gentlemen, this past year we witnessed the most prolific football season in California University's history. The Vulcans dominated the PSAC (Pennsylvania State Athletic Conference) opponents on their way to their first 11-0 undefeated regular season since 1958. The feat marked Cal's third consecutive PSAC West Championship and earned the Vulcans their first NCAA (National Collegiate Athletic Association) Division II National Playoff in the school's

156-year history. In the playoff, the Vulcans rattled Southern Connecticut State 43-7 in the first round and then pounded Shepherd University 58-38 to claim its first Northeast Regional Championship in Vulcan history.

The Vulcans entered the NCAA Division II National Semifinal game undefeated, but suffered its first loss and only loss of the season to the eventual national champions, Valdosta State. The 2007 Vulcans finished the season 13-1, won the Lambert Cup Trophy, which crowned the Vulcans "The Beast of the East" in Division II and were crowned the most improved football team in all of Division II.

The Vulcan offense really found its stride during the playoff stretch, scoring 125 points and amassing 1400 yards. The Vulcan defense finished number one in the nation in rushing defense, scoring defense, and total defense. With me at the dais, ladies and gentlemen, are Coach Luckhardt; D'monn Baker, assistant coach; player, Matt Humbert; and Cha'Mar Jones, player. Ladies and gentlemen, PSAC State Champions and the Beast of the East, California University Football Team, and I ask for your applause and appreciation for their attendance today.

REMARKS SUBMITTED FOR THE RECORD

Mr. PETRONE. Thank you, Mr. Speaker.

I just would like to submit remarks on HB 2295 and thank my colleagues for the unanimous vote.

Thank you. I want to submit these remarks.

The SPEAKER pro tempore. The Chair thanks the gentleman, and he may submit his remarks to the clerk.

Mr. PETRONE submitted the following remarks for the Legislative Journal:

HB 2295 amends the Uniform Condominium Act to restore language which provides that 6 months of unpaid assessments for common expenses, which a condominium association is entitled to when a condominium unit is sold through a judicial sale, shall be paid out of the proceeds from the judicial sale of the unit.

The language was inadvertently removed in 2004 when omnibus amendments were made to the act.

The removal of this provision for payment of unpaid assessments from the proceeds of the judicial sale of a unit has caused, and will likely cause in the future, condominium associations to lose their statutory entitlement to this important lien and significant source of revenue when a unit is sold at a judicial sale.

Revenue from assessments for common expenses provide a condominium association with the funding mechanism necessary to perform its maintenance and other services in accordance with the association's contractual and statutory obligations.

The intent of this legislation is to rectify the previous error, restore the original language to the act, and eliminate the discrepancy with the provisions of the two other statutes that govern common-interest ownership communities, the Real Estate Cooperative Act and the Uniform Planned Community Act.

Therefore, I appreciate the support of the House for this critical legislation.

STATEMENT BY MR. D. EVANS

The SPEAKER pro tempore. The Chair at this time recognizes the gentleman, Mr. Evans, for remarks.

Mr. D. EVANS. Mr. Speaker?

The SPEAKER pro tempore. The House will come to order.

Mr. D. EVANS. Mr. Speaker?

The SPEAKER pro tempore. The gentleman, Mr. Evans, is recognized.

Mr. D. EVANS. Thank you.

I would like to make an announcement to the members of the House relating to the budget. First, Mr. Speaker, I want to thank all of you for your patience and endurance relating to trying to manage this budget process. I have said consistently from the beginning that we would work together and try to meet the needs of the people of Pennsylvania as well as the workers of Pennsylvania.

I know that there have been times when some of you have not agreed with me, and I recognize that and I respect that. But at the end, we all have to work together to try to do what is best for the people of Pennsylvania. HB 2330, which is the budget bill, we dealt with it – HB 2380; I apologize – HB 2380, which we dealt with in the Appropriations Committee today. We offered an amendment to that particular bill with some of the priorities that I have heard from all of the members, Democrats and Republicans, and people across the Commonwealth of Pennsylvania.

That bill is now in position for this House to entertain during the week of the 23d of June. The new printer's number, as a result of the amendment, will be posted today. I want to explain to you why we chose that strategy. Ideally, we have to try to work things out with the Senate. We have had two meetings at the Governor's Mansion. We had a couple meetings in my office, and the staffs have been meeting. They met yesterday; they will meet again tomorrow.

So what we are attempting to do is to work with the Senate and the Governor's Office to try to come up with something that we all can generally agree on so that we can finish by June 30, is what we are attempting to do. If we should not be successful, then, obviously, that week of June we will vote on the budget bill – if we are not successful in working out the things we need to work with the Senate.

Your leaders, who have been involved in all the different meetings and their staffs have been involved, we all have been trying to figure out ways to meet the needs of the people of this State. So I express to you that we are really trying to work this out and meet the deadline of June 30. I am very optimistic that

we can do it. It is going to take a lot of work, and no pointing fingers at anyone, we are just going to have to really work at it.

So we are asking you – I know I am, at least, asking you – to continue to work with us. The budget bill will be in position. Based on our rules, that is the week that it will get to come up, based on rule 19(b). So I share with you that we wanted to let you know that it will be posted and ready for amendments, but obviously, I hope we can work out things with your side, with the Senate, and with the Governor's Office and come up with something.

What I think I have heard from all of you on both sides of the aisle is you would like for us to work this out. I know there are some people who may have some difference of opinion in what they would like to see, but at the end of the day, we have to work with the Senate, and we have to work with the Governor's Office in order to make this happen. You all have been through this, and you know for a fact, you can kind of go through the process we have gone through in the past and ultimately end up where we are going to have to work together anyway.

So I am stressing to all of you – and I have spoken to your chairman, and I know my staff has spoken to your staff – we are trying to work this out with input from everybody; it is not just some small group sitting in some closed room trying to work it out. A lot of people sit in that room, your staff sits in that room, and your leadership is there, so we do have these discussions. So I wanted just to announce about HB 2380, the budget bill.

Thank you, Mr. Speaker.

The SPEAKER pro tempore. The Chair thanks the gentleman and recognizes the gentleman, Mr. Civera.

Mr. CIVERA. Thank you, Mr. Speaker.

Mr. Speaker, would the chairman just answer a few questions that I have, because I want to put this on the record? I think he has already addressed it, but I came into the room a little bit late.

Mr. Speaker, today at the committee meeting—

At the end of that process, the questions were raised as far as if the members still wish, because now it has a new printer's number, to amend that bill when it does come out and however the negotiations go, they will still be allowed, if they redraw their amendments, to amend that bill, Mr. Speaker?

Mr. D. EVANS. The answer is correct, Monday by 2 o'clock.

Mr. Speaker, I would just like to say a few words.

The SPEAKER pro tempore. The Chair thanks the gentleman. If he has concluded his interrogation, he may proceed.

Mr. CIVERA. Mr. Speaker, Appropriations did have a meeting today, like the chairman described. It was a meeting that the Republicans were on record as voting "no" and the Democrats were voting "yes." It was not about an issue of whether to release the general appropriations bill; it was an issue of our spending, which we will get into as this progress moves on.

I am hoping, I would have liked to have seen that the budget process would have moved a little bit sooner rather than to wait on June the 23d, that this process and the amendment process could have taken place to bring the members of this General Assembly together and have a – especially to the new members – to have a real general idea of how this process works.

Let me just keep in mind that we must be cautious in how we address this bill. Our revenues are slightly down from last year – not slightly, but they dropped, like, \$140 million in May – and we need to be conscious of that. But the process has begun. I thank the chairman today for being open as far as the amendment was concerned. And for the members on the Republican side, I will circulate the amendment that was put forward to us in the Appropriations Committee to our Republican members so they have a true understanding of exactly what is going on. Thank you very much.

The SPEAKER pro tempore. The Chair thanks the gentleman.

Any other announcements or any other business? The Chair recognizes the majority leader, Mr. DeWeese.

Mr. DeWEESE. Just 60 seconds; I would like to condense this.

The exchange I just heard between our two friends and budgeteering luminaries tells me that this chamber has at least two options as the ensuing weeks unfold. One option would be to have somewhere between 250 and 300 amendments to debate, or the other option would be to work aggressively with our Appropriations Committees and their leaders and try to arrange a compromise proposal that could be done with a more simple exercise. So that is just something I wanted to share. Those two options are preeminent in my thinking as to what will be unveiled over the next 2 weeks.
