I am here today to announce a few visitors. They are in the back of the hall of the House, Judge Henry McCool and his wife, Connie, retired schoolteacher from Monroe County. Mr. Danker has given every dollar of proceeds from the book to the veterans. So I recommend, I hope each and every one of us here in this room will buy this book. It is a great book. STATEMENT BY MRS. BEYER

The SPEAKER pro tempore. The Chair recognizes Representative Beyer for the purpose of remarks and an introduction.

Mrs. BEYER. Thank you, Madam Speaker.

I am so delighted to have my Lehigh Valley colleague up there, Madam Speaker. It is the first time you have introduced me when you have been up there, and it is a real honor and a pleasure.

The SPEAKER pro tempore. Thank you; my pleasure.

Mrs. BEYER. A little later on today, we are going to vote on a resolution that I would like to talk a little bit about now. In the Lehigh Valley, we are blessed with a rich historical heritage in many, many ways, and today we are paying tribute to our national pastime, baseball, and to one of the greatest stadiums ever built.

As you may recall in the wonderful baseball movie, "Field of Dreams," in that movie a farm owner is told by a spirit to build a baseball field, and the specific phrase was used, "If you build it, they will come."

In 1933 a businessman and great baseball fan named Howard "Lefty" Fegley had a dream and a vision, which resulted in the construction of Limeport Stadium. Madam Speaker, may I just have a little order, please?

The SPEAKER pro tempore. The lady is correct. There is certainly too much noise, and she deserves to be heard.

Thank you. The lady is in order and may proceed.

Mrs. BEYER. Thank you, Madam Speaker.

That grand ballpark will turn 75-years-old next month, and for these many years, it has been a haven for the great game of baseball, entertaining fans, young and old, and resulting in Limeport, Pennsylvania being aptly named "The biggest little baseball town in America."

In short, he built it and they came. Limeport Stadium has been the home of East Penn League baseball, specifically Howard's own team, the Limeport Milkmen, and it is said that Howard's two baseball-playing sons, Homer and Russel, were the inspiration for building this beautiful stadium. In its rich history, the stadium has undergone some modifications, but never has the integrity of the original construction been compromised.

There are many stories about this grand ballpark, and we could tell those stories for hours on end. One of the legends has it that Howard Fegley, the builder, his favorite beagle is buried under third base. Over the years, Limeport Stadium has played host to the Limeport Bulls, Dodgers, Southern Lehigh High School, Connie Mack baseball, American Legion baseball, and Allentown College.

Today this ballpark is managed by Limeport Stadium Incorporated, a nonprofit organization of 50 men and women, all dedicated volunteers. They have made \$100,000 worth of renovations and improvements, all through fundraisers and donations.

GUESTS INTRODUCED

First of all, the Limeport Stadium Incorporated 75th Anniversary committee chairman, Mr. Tom Fulton. Also with us today is the community relations director, Mr. Frank Koeller, and finally, the owner of the big, booming voice that fills Limeport Stadium from the public address system, the voice of Limeport Stadium, Mr. Chris Barebo. They are at the rear of the House. Will you please rise and be recognized.

On Saturday, July 19, the anniversary will be celebrated with a series of daylong events. I am very, very proud – very proud – to represent this beautiful community and this beautiful stadium. Thank you very much, Madam Speaker.

The SPEAKER pro tempore. The Chair thanks the lady and certainly agrees that Limeport Stadium is a real jewel of the Lehigh Valley. We thank the gentlemen for joining us today.

Mr. CASORIO. Thank you, Madam Speaker.

Madam Speaker, I rise today to honor a fallen hero, S. Sgt. David Wieger. Sergeant Wieger was killed in Iraq on November 1, 2007, when the convoy he was riding in struck an improvised explosive device near Balad Air Base, north of Baghdad. Sergeant Wieger was returning from a meeting with intelligence sources when he and two of his fellow officers were killed.

Sergeant Wieger, who was on his first tour of duty in Iraq, was on an important Federal law enforcement assignment for the U.S. Air Force Office of Special Investigations when he gave his life for his nation.

I am proud to honor Sergeant Wieger today, not only because of his service and sacrifice to the nation as a member of the United States Air Force, but also because Sergeant Wieger was a member of the law enforcement community for which I have such deep respect and gratitude. Sergeant Wieger's dream had always been to protect and serve. Madam Speaker, he was a 1997 graduate of Norwin High School in North Huntingdon Township, in my district, and studied criminal justice at Westmoreland County Community College.

When his initial 6-year commitment to the U.S. Air Force had been fulfilled, he reenlisted. He reenlisted in order to continue serving his nation and protecting the country, family members, and friends that he loved.

FAMILY INTRODUCED

Mr. CASORIO. I am honored, Madam Speaker, to be able to host Sergeant Wieger's parents today, Michael and Lori Wieger, and his brother Michael, and Michael's wife, Brenda. Would you please be recognized before the House.

On behalf of the entire Pennsylvania House of Representatives and the people of Pennsylvania, I want to offer my condolences to the family and my appreciation for the values that they instilled in their son – honor, commitment, courage, and duty – values that were constantly and consistently on display as Sergeant Wieger served, and ultimately sacrificed his life for his country.

Madam Speaker, I would ask that the members, later today, join me in honoring the life of S. Sgt. David Wieger and expressing our condolences to his family by voting "yes" on HR 782.

CONDOLENCE RESOLUTION

The SPEAKER pro tempore. The Chair recognizes Representative Everett for the purpose of a condolence.

Mr. EVERETT. I would ask that Representative Hanna and Representative Seip join me.

Today I also rise in front of my colleagues here in the House to honor another of our fallen Pennsylvania heroes, M. Sgt. Sean Michael Thomas. I do this not only as the State Representative from Sean's hometown but also as a retired military officer in honor of a fallen comrade, and also as a friend of the Thomas family, whom I have grown to know quite well over the last year or so.

M. Sgt. Sean Michael Thomas was a native of Hughesville, Lycoming County, but at the time of his death he also was living and his unit was located in Representative Hanna's district in Clinton County. And he served in Iraq with Representative Seip's wife while they were deployed, so that is why they are joining me today.

Master Sergeant Thomas was a 1992 graduate of Hughesville High School, where he was actively involved in tennis, wrestling, soccer, and football. At his memorial ceremony, which overflowed the gymnasium at the Hughesville High School gym, Sean's family, friends, teachers, pastors, teammates, and fellow soldiers consistently painted the picture of a young man who brought energy and joy to everything he did.

As one of his college friends from Penn State said, if you did not know Sean when you got to the party, you knew him by the time you left. All of us remember Sean as the big guy with red hair and a big heart, a guy who lit up a room when he entered, a guy who would do anything for his family, his friends, and his comrades. During his senior year, Master Sergeant Thomas joined the Army Reserves and remained with the Reserves until 1998.

He then joined and served with the Pennsylvania Army National Guard's 728th out of Lock Haven, Pennsylvania, which is in Representative Hanna's district. He had an 8-month tour in Afghanistan, for which he was awarded the Bronze Star Medal, and Master Sergeant Thomas was serving in Baghdad with the 28th Division Support Command from Harrisburg when he gave up his life for our country in Iraq in an attack.

Throughout his military career, Master Sergeant Thomas received various awards and was posthumously awarded the Purple Heart, the Combat Action Badge, and his second Bronze Star. Master Sergeant Thomas is survived by his parents, Diana and Daniel Thomas; his two brothers, Daniel Jr. and David; and his two sisters, Melinda and Kelly, all of whom are with us today.

In addition to everything else he was in life, Sean was also the favorite uncle to Sean, Mitchell, Dylan, Andrew, and Rachel, all of whom are also with us here today, and all of them idolized their big Uncle Sean, and they still do.

However, first and foremost, Sean was dedicated to his lovely wife, Carrie, and their daughter, Alexa. Sadly, Sean will not get to spend the time he would have wanted to with either his wife or his daughter, as Alexa was just 6-months-old when Sean was taken from us, and he and Carrie would have celebrated their 1-year anniversary the day after Sean's memorial ceremony.

There are other relatives that are with us today and members of Sean's unit and folks who served with him in the back of the House, and I would like all of them to rise, along with the family, and have them recognized here today.

At this point, I would like to turn the podium over to Representative Seip, who would like to make some remarks.

Mr. SEIP. Thank you. I rise to support this resolution.

Madam Speaker, I actually had the honor of meeting Master Sergeant Thomas. Master Sergeant Thomas, as Representative Everett alluded to earlier, served in Baghdad, Iraq with my wife, Lt. Col. Starr Seip. Master Sergeant Thomas did a tremendous job for our Commonwealth and our nation in helping my wife maintain millions of dollars of assets in the desert and keep track of all of those assets and keep them safe.

I first learned of the tragic death of Master Sergeant Thomas from my wife. She called me at home and told me what had happened, and she said to me, the funeral arrangements will be on Good Friday. And she said, you know, I had been in that very spot about 20 minutes before this had happened to Master Sergeant Thomas. Instantly, I knew I had to go to Hughesville.

When I got to the high school, there were mourners outside, there were mourners in the vestibule, there were mourners inside the hallway, winding down into the gym, outlining the gym, outside of the gym, back down the corridors, crisscrossing their way back to the auditorium, and it took some time for me to get to where Master Sergeant Thomas was lying. And the whole time, I could only think to myself, what am I going to say to Carrie when I see her and the family? I finally got up into a position where I could overhear some of the comments that were being made to the family by other soldiers who had served with Master Sergeant Thomas. The comments that I heard were that we worked with Sean, he was a great soldier. He was a good coworker, and he made other soldiers better.

I want to thank Carrie and the family for coming to events. I have seen the family over at the 28th Division for all different types of events like the Freedom Salute. And these are difficult times, and it is difficult to talk at events like this, but it is very important to remember the service of our fallen heroes.

I have been at promotion ceremonies and retirement ceremonies with my wife, and those are easy times and enjoyable times to attend. They are necessary events, just like this is necessary, so that we have an opportunity to pay our gratitude to heroes like Master Sergeant Thomas for all that he has done for our Commonwealth and our nation.

I thank the family, and I urge my colleagues to give an affirmative vote on the resolution.

Mr. EVERETT. I want to thank Representative Seip for those comments.

I will just wrap up by saying that those of us back in Hughesville, in Lycoming County, will never forget Sean. We have already renamed the post office in Hughesville in his honor. There have been numerous concerts and charity motorcycle rides in his honor, and as long as any of us are around who knew Sean and as long as his family and his nephews and nieces are around, Sean will always be remembered. I would ask you to join me in voting later today to have the House of Representatives honor the memory of M. Sgt. Sean Michael Thomas.

Mr. HARKINS. Thank you, Mr. Speaker.

Mr. Speaker, on Friday afternoon I, like so many other Americans, was shocked and saddened to learn of the passing of Tim Russert of the famed NBC (National Broadcasting Company) "Meet the Press."

At the age of 58, Mr. Russert accomplished much more than most realized until the network began sharing the stories of religious people, political folks, and network personalities, just to name a few. They expressed their fond memories of Tim Russert, and many would reflect on many a Sunday morning that was reorganized because of who was going to be on "Meet the Press" any particular Sunday. Often after the first segment, you would feel that Russert was either too soft or too tough on the guest, depending on your leaning, but at the end of the show, you came away admiring how well the interview went and the things you learned about the particular guest or guests, and they showed the human side of all those involved.

Many remember the phrase "Blue State/Red State" coined by Russert or the white dry erase board that screamed "Florida, Florida, Florida" from the 2000 election. Or you cannot forget Chris Matthews, Tim Russert, and Pat Buchanan debating who really won the Presidential election of 2000. That was television education at its finest.

Russert was born and raised 90 miles from my district, in Buffalo, New York. An Irish Catholic, he graduated with honors from Cleveland-Marshall College of Law. He worked on Senator Daniel Patrick Moynihan's successful 1976 senatorial campaign. He also went on to work with Mario Cuomo's successful 1982 gubernatorial campaign, and he worked for a time in the Governor's Office in Albany, New York. In 1984 he left politics and went with NBC. In 1985 he arranged for Pope John Paul II's first American television interview. He then took over "Meet the Press" in 1991 and became the longest-serving host of the program.

An avid sports fan, Tim Russert would often pull for the Buffalo Bills so much so that the Bills' organization released a statement saying that the team would listen to Russert's exhortations of "Go Bills, Go Bills," and they actually made it part of their Sunday pregame preparations.

Perhaps Tim Russert's proudest accomplishments, though, were his family ties. In 1983 he was wed to Maureen Orth, and they have one son, Luke. His unwavering love, respect, and admiration for his dad, "Big Russ," as he was affectionately referred to in his book "Big Russ and Me," shows the example Timothy John Russert taught to all of us in his down-to-earth, simple way that we should all strive to emulate. We should carry on and share in his simple, do-unto-others lifestyle to try and attempt to make this a better world.

Thank you. I would ask that you would join with me in this resolution.

Mr. BENNINGHOFF. Thank you, Mr. Speaker.

Mr. Speaker, at this moment, if I could, I would ask Representative Hanna to just join me in a couple moments of discussion. We have had a lot of dialogue on this proposal back and forth and trying to work out—

The SPEAKER. If the gentleman will suspend.

The noise level is entirely too loud. The Chair requests that all members take their seats and hold their conversations to a minimum.

Representative Benninghoff.

Mr. BENNINGHOFF. Thank you, Mr. Speaker.

And briefly, for the members' sake, I will be pulling this, but Representative Hanna and I thought there were some important reasons why we ought to discuss a couple comments on this.

Specifically, this amendment would have prohibited the construction of any permanent building and/or type of structure on this proposed land transfer, and through our dialogue and discussion, there were concerns that there may be some need for some agricultural-related structures to be housing either farm equipment and/or necessary items for agricultural research and development by the Penn State University. So I have agreed to pull that.

My wish would be two things: As we do that, that Representative Hanna and the rest of the committee that will be doing the master plan would keep in mind that these structures be minimal, obviously, in size and amount of acreage they take up, but I think because of the sportsmen's access, we should also try to keep them consolidated throughout this 1100-acre parcel. At this point I will turn it over to Representative Hanna, who I think wanted to make a comment also.

Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes Representative Hanna. Mr. HANNA. Thank you, Mr. Speaker.

Representative Benninghoff has correctly reviewed what we have agreed to. In fact, his amendment calls for a blanket prohibition of building on the property. Instead, we have agreed that there will be no building outside of the needs for agricultural uses. Currently there are barns and storage sheds and the like on the property. It is anticipated that those are the types of buildings that would be necessary for agricultural use. Our agreement is that he would withdraw the amendment, and Penn State will agree with the steering committee and those involved in the master planning process to incorporate in the master plan for this property that there will be no buildings other than those buildings necessary for the agricultural uses.

AMENDMENT WITHDRAWN

J (relating to beneficial use of sewage sludge by land application). The condition shall be covenant on running with the land and shall be binding upon the grantee, its successors and assigns. Should the grantee, its successors or assigns, permit any portion of the property authorized to be conveyed in this section to be used in violation of this subsection, the title shall immediately revert to and revest in the grantor.

Mr. BENNINGHOFF. Again, thank you, Mr. Speaker.

Briefly, for the members' sake, I believe this is an agreed-upon amendment for this land transfer. I had requested

that we have an amendment drafted to prohibit the application of any sludge or agricultural waste-type materials on this land. For those who are not aware, we are talking about a large parcel, currently owned by Rockview prison, that contains a very pristine waterway, and there was concern of runoff, should we not have this language specifically written out in this legislation.

So therefore, I would ask the members' support. The SPEAKER. Representative Hanna.

Mr. HANNA. Thank you, Mr. Speaker.

I would agree with Representative Benninghoff and urge everyone to support the amendment. We have an agreement with Penn State University that they will accept the amendment and that there will be no spreading of sewage sludge on the property. So I would encourage your favorable vote for the amendment.

BILL ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 676**, **PN 3949**, entitled:

An Act authorizing and directing the Department of General Services, with the approval of the Governor, to grant and convey to the Philadelphia Regional Port Authority certain lands situate in the 39th Ward of the City of Philadelphia; and providing for Commonwealth ownership of submerged lands.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

(Bill analysis was read.)

The SPEAKER. The question is, shall the bill pass finally?

The Chair recognizes Representative Keller.

Mr. W. KELLER. Thank you, Mr. Speaker.

I believe Representative Clymer wishes to interrogate.

The SPEAKER. The Chair recognizes Representative Clymer.

Does the gentleman wish to interrogate Representative Keller?

Mr. CLYMER. That is correct, Mr. Speaker.

The SPEAKER. The gentleman indicates he will stand for interrogation. Representative Clymer is in order and may proceed.

Mr. CLYMER. Thank you, Mr. Speaker.

Mr. Speaker, in section (1), subsection (D), paragraph 1 of the bill, your language clarifies that the deed limits the use of the land to maritime purposes. Your definition of "maritime purposes" specifically excludes activities related to gambling or gaming. While I certainly agree with your definition and appreciate the exclusion of gaming, would I be correct in my understanding that this exclusion is just to guarantee that this land is not used for a casino? In other words, would you agree that any reasonable definition of "maritime purposes," by nature, excludes casinos, and you are really just adding this specific language to dot your i's and cross your t's?

Mr. W. KELLER. Yes, Mr. Speaker; you are correct. We put that in the amendment, which is now part of the bill, for 16 acres between parcels 122 and 124, and we also did it for the

main parcel down at the naval shipyard, but there is also a reverter clause. If any time that land is not used for maritime use – for the movement of cargo or passengers off of ships – it will revert back to the DGS (Department of General Services). And also, the Philadelphia Regional Port Authority and its authorizing legislation is not allowed to do any development except port industrial. So there are many safeguards in this legislation.

Mr. CLYMER. Mr. Speaker, that ends my interrogation. May I speak on the bill?

The SPEAKER. The gentleman is in order and may proceed. The Chair will again ask members to take their seats and

he Chair will again ask members to take their seats and hold their conversations to a minimum.

Representative Clymer.

Mr. CLYMER. Thank you, Mr. Speaker.

Mr. Speaker, this bill, without doubt, is going to create thousands of jobs as it provides new land for maritime activities and purposes along the Delaware River, and I commend the gentleman and the other members of the Philadelphia delegation for supporting this legislation. I, too, support this bill and would ask members to do likewise.

REMARKS SUBMITTED FOR THE RECORD

The SPEAKER. Representative Keller.

Mr. W. KELLER. Thank you, Mr. Speaker.

I would like to thank the gentleman from Bucks. I know he has the best interest of the Commonwealth at heart, but this is solely for port industrial use.

I have some comments I would like to spread upon the record.

The SPEAKER. The Chair thanks the gentleman. He will submit his remarks. They will be spread upon the record.

Mr. W. KELLER. Thank you, Mr. Speaker.

Mr. W. KELLER submitted the following remarks for the Legislative Journal:

Mr. Speaker, as the third riparian land transfer of this session, we continue to establish best practices to protect the Commonwealth's interest in these lands. We look to templates created by the administration, as well as case law, environmental concerns, and long-neglected property ownership of these submerged lands. Simply put, Mr. Speaker, this legislation reaffirms the Commonwealth lands and commits it to the common good and protects the public trust.

In providing for the Commonwealth's ownership of submerged lands, it is the intent of the General Assembly to affirm the findings of the Supreme Court of the United States of America and the Supreme Court of the Commonwealth of Pennsylvania, which assert title to the riverbeds of navigable waterways below the ordinary low-water mark rests solely with the Commonwealth of Pennsylvania. The ordinary low-water mark is that of which the river flowed when the Commonwealth was established, *Shively* v. *Bowlby*, 152 U.S. 1, 1894 and *Black* v. *American International Corp.*, 264 Pa. 267, 1919.

In addition, changes to the adjacent land due to natural accretions along navigable waterways become the real property of the adjacent land holder. However, fastland created by intentional, manmade fill or deposits upon the riparian lands of the Commonwealth remain real property of the Commonwealth and any interests in these lands must be conveyed by an act of the General Assembly, *Black v. American International Corp.*, 264, Pa. 267, 1919.

Acts of the United States of America intentionally filling riverbeds of navigable waterways within the boundaries of the Commonwealth, absent an act of the General Assembly or by eminent domain of the United States of America do not abdicate the Commonwealth's title or interest in the riparian lands or real property filled or deposited upon.

Acts by the United States of America and the Commonwealth of Pennsylvania to adopt pierhead and bulkhead lines were established as a means to regulate obstructions in navigable waters and did not alter riparian ownership in lands.

Absent an act of the General Assembly, ownership or title or the riverbed cannot be conveyed to a private individual or private use, as these lands are held in public trust pursuant to Article I, section 27, of the Pennsylvania Constitution.

On the question recurring,

Shall the bill pass finally?
