MOMENT OF SILENCE FOR OFFICER PATRICK McDONALD

The SPEAKER. If I could have the attention of the members. I would like to ask all members to please rise and observe a moment of silence for Philadelphia Highway Patrol Officer Patrick McDonald. He was an 8-year veteran of the Philadelphia

Police Department. He was a constituent of mine in the 169th Legislative District in Northeast Philly. He was a 1996 graduate of Archbishop Ryan High School.

He was taking night and weekend classes. He earned a bachelor's degree in criminal justice from St. Joseph's University. He is the beloved son of Patricia and Larry, a retired captain of the Philadelphia Fire Department.

(Whereupon, the members of the House and all visitors stood in a moment of silence in solemn respect to the memory of Officer Patrick McDonald.)

REMARKS BY MR. McGEEHAN

The SPEAKER. I would like to recognize Representative Michael McGeehan, who is a close friend of the family, for some brief remarks.

Mr. McGEEHAN. Thank you for your indulgence, Mr. Speaker.

I know that your reputation among your constituents and all the members of the House is a champion for police and firefighters, particularly in the city of Philadelphia, and my condolences to you, Pat being a constituent of yours. I did not know Officer McDonald, but I have known his father and mother, Larry and Patsy McDonald, for more than 40 years, and I consider them close friends.

They have had their share, certainly, of personal tragedy, but this latest incident, this terrible, terrible incident, is not just a personal tragedy for them but for the city of Philadelphia. Anytime a police officer is killed, it affects us all because it really does go to the heart of who we are as a society.

I do not think any of us have an answer to this wanton violence that plagues not just Philadelphia but the country. Officer McDonald, in reading much of the news coverage today, is the kind of person that you and I strive to be every day, and I know that the members of this House and the 12 million Pennsylvanians join with you, Mr. Speaker, and the people of Philadelphia and the people of the Commonwealth in keeping Larry and Patsy McDonald and Officer Patrick McDonald and his fellow officer, Richard Bowes, who was also wounded in this incident, in their thoughts and prayers.

And, Mr. Speaker, the attack and assault on a police officer I think goes to the heart of who we are as a society, and it is particularly tragic that this brave, beautiful young man has lost his life in the defense of the values and principles we all believe in.

I just want to extend my personal condolences to my dear friends, Larry and Patsy, and to Pat's sister, Megan, and ask that,

again, as you had suggested, to remember them in their thoughts and prayers today. Thank you.

A Resolution honoring Gold Star Mother Mollie Snyder of Berks County.

Will the House adopt the resolution?

MOLLIE SNYDER INTRODUCED

The SPEAKER. The Chair recognizes Representative Kessler on the resolution.

Mr. KESSLER. Thank you, Mr. Speaker.

Today is a very exciting day. We have today with us Mollie Snyder, who is a Gold Star Mother, who represented

Berks County for 50 years, and I would like to read you a little bit about Mollie.

Today we are here to honor Gold Star Mother Mollie Snyder of Berks County.

- "...A Gold Star Mother from Pennsylvania, Mollie Snyder, has been selected as a model for a relief that is part of the monument honoring Gold Star Mothers from all armed services in all wars in which the United States has been engaged since World War I:...
- "...Mrs. Snyder, of Berks County, is the mother of Pfc. Walter H. Snyder, Jr., deceased, who served in the Korean Conflict and died" in 1950 "from wounds suffered during action;...
- "...Mrs. Snyder served as president of the Berks County Chapter of Gold Star Mothers from the late 1950s until May 2008 and, upon her retirement, was made Honorary President of the chapter at that time;...
- "...Mrs. Snyder, 99" years young, "is honored that sculptor Andrew L. Chernak has chosen Walter and her as models for a bronze relief that will be mounted along the pathway to the centerpiece statue at the proposed Gold Star Mothers Monument in Washington, D.C.;...
- "...The artist, who met Mrs. Snyder in 2004 at a Gold Star Mothers function, selected her for her dignity and her inner strength;...
- "...Not only is she the first Gold Star Mother to be chosen by the artist but the bronze relief of her son and her is the first to be completed;...
- "...The bronze relief of Mollie and her son will be displayed at the Gold Star Mothers banquet on Saturday, September 27, 2008, in Washington, DC as part of the events of the Gold Star Mothers Weekend;...
- "...Gold Star Mothers is a term that arose during World War I that embraces those mothers whose sons or daughters died from injury or illness while serving in...World War I; World War II; the Korean Conflict;...the Middle East, including Operation Desert Storm, Operation Enduring Freedom and Operation Iraqi Freedom;...
- "...American Gold Star Mothers, Inc., is the official national service organization of Gold Star Mothers that was begun in 1928 and continues because of the bond of mutual love, sympathy and support of the many loyal, capable and patriotic mothers who, while sharing their grief and their pride, have channeled their time, efforts and gifts to lessening the pain of others by honoring our deceased servicemen and servicewomen, assisting our veterans, supporting our nation and helping each other to heal;...
- "...In 1936, President Franklin Roosevelt recognized Gold Star Mothers for their strength and inspiration to this country;...
- "...Mrs. Snyder, who volunteers at the local veterans hospital and who rides annually in the Berks County 'Ride for Freedom' motorcycle rally, hopes to go to the unveiling of the bronze relief at the monument, but her greater hope is that the nations of the world learn to live in peace so that there will be no more Gold Star Mothers;...
- "...It is fitting to pay tribute to this amazing mother who nobly represents Gold Star Mothers throughout Pennsylvania and our nation...."

The House of Representatives takes great pride in recognizing Gold Star Mother Mollie Snyder of Berks County. Would you please stand.

GUESTS INTRODUCED

Mr. KESSLER. I would like to introduce two other people, two other people that I consider as fond friends whom I met just a year and a half ago, Bernie Bingham and Diane Simmons, who take Mollie everywhere and have introduced me and are taking her down to DC. Bernie and Diane, would you please stand

Also we have here today Andrew Chernak, who designed the monument, and, Andrew, do you want to come say a few words here?

Mr. CHERNAK. The reason for designing a monument honoring Gold Star Mothers is twofold. Number one, since they were brought into being in 1928— By the way, they are also congressionally chartered and considered by the Defense Department as a veterans service organization. Since that time, they have literally put in millions of hours of volunteer service, their own time, carrying their grief and turning it into a positive force in helping veterans in the hospitals whereas they come back into the community. So they deserve the honor just on the basis of what they have done for this country and their sacrifice of their child.

The other purpose of what we are doing with plaques and the national monument is we hope to get these all across the country to educate people. Wherever I go I ask the question, do you know what a Gold Star Mother is? Sadly, most people do not. I think if this was the 1950s or late forties, most people would know, but it is being forgotten, yet the mothers continue to give service to this country and to their communities. So we are also trying to educate the public with this program of plaques. We hope to see them all across the United States.

All the bronze work for the national monument and these plaques are made in Pennsylvania, in Delaware County and in Lancaster County, and it will stay that way.

Mollie, thank you again. We appreciate everything you have done and the example that you have set.

The Governor, Auditor General and State Treasurer are hereby authorized and directed to borrow from time to time, in addition to any authorization heretofore or hereafter enacted, on the credit of the Commonwealth, subject to the limitations provided in the current capital budget, money not exceeding in the aggregate the sum of \$4,655,654,000 as may be found necessary to carry out the acquisition and construction of the State projects specifically itemized in this act. Section 702. Issue of bonds.

The indebtedness authorized in this act shall be incurred from time to time and shall be evidenced by one or more series of general obligation bonds of the Commonwealth in such aggregate principal amount for each series as the Governor, Auditor General and State Treasurer shall determine, but the latest stated maturity date shall not exceed 30 years from the date of the bond first issued for each series. Section 703. Estimated useful life of projects.

The General Assembly states the estimated useful life of the projects itemized in this act as 30 years. Section 704. Appropriation.

The net proceeds of the sale of the obligations authorized in this act are hereby appropriated from the Capital Facilities Fund to the department in the maximum amount of \$4,655,654,000 to be used by it exclusively to defray the financial costs of the State projects specifically itemized in this capital budget. After reserving or paying the expenses of the sale of the obligation, the State Treasurer shall pay out to the department the moneys as required and certified by it to be legally due and payable.

Section 705. Federal funds.

In addition to those funds appropriated in Chapter 3, all moneys received from the Federal Government for the projects specifically itemized in this act are also hereby appropriated for those projects. Section 706. Allocation of funds.

Whenever as determined by the Department of Transportation that the full estimated financial costs of the projects itemized in this act are not necessary for the proper design, acquisition or construction of such projects, the excess funds no longer required may be allocated by the Department of Transportation to increase the estimated costs of any one or more of the projects specifically itemized in a capital budget.

Amend Resolution, page 3, by inserting between lines 13 and 14 WHEREAS, Recent rising energy costs and slow economic conditions render it crucial that any potential for fraud within the Low-Income Home Energy Assistance Program be eliminated; and

Amend Resolution, page 3, by inserting between lines 20 and 21 RESOLVED, That the Federal Government put in place measures to prevent fraud within the program or direct the states to enact fraud prevention measures that could include establishing verification and/or photo identification systems for those receiving assistance under the Low-Income Home Energy Assistance Program; and be it further

On the question,

Will the House agree to the amendment?

The SPEAKER. The Chair recognizes Representative Cutler on the amendment.

Mr. CUTLER. Thank you, Mr. Speaker.

I would like to rise to offer this amendment because of the report that the Auditor General recently released on LIHEAP (Low-Income Home Energy Assistance Program) fraud. As many of you know, a little over a year ago the Auditor General released a report detailing what he described a system that was ripe for fraud in regards to our LIHEAP heating system here in this Commonwealth. And I recognize the importance of this program and sincerely believe if we truly want to help individuals with their heating costs, we should effectively use the money that we already have in the system.

I have here in my hand that very report, and it is not, if you will, located in just one area. This is a statewide problem. It goes from Philadelphia to Pittsburgh and even includes Lancaster City, which is near me, and I would like to just highlight a few of the points, if I may.

Page 16 indicated a 30-percent loss of records in the city of Philadelphia. Page 18 detailed the fact that no income verification is utilized to determine if individuals are eligible for this program. Pages 15 through 18 found that 429 individuals out of 982 were using Social Security numbers of individuals who had been deceased more than 5 years. Page 16 indicates a misfiling rate of almost 70 percent. Of the 105 records out of the 348 that they were able to find, 23 of them were potential fraud cases, as identified by the Auditor General. That is a 21.9 percent fraud rate.

Page 43 said that there is no monitoring of the external crisis centers that we have in this Commonwealth. There are nine of them that handled these very same claims. Page 43 also documented a serious flaw in the audit process. Audit centers that handle these claims that the constituents bring forward are allowed to select the very records that they get audited. There is no random sampling in this program as it currently stands, and

the Auditor General said that that was a glaring flaw. Page 43 also noted that there are numerous missing files, and page 16, they cited concerns of identity theft and the fact that there was open access to many of these records in these centers.

And finally, there is not a standardization of the process or the forms that these individuals use in collecting the information to release millions and hundreds of millions of dollars in this Commonwealth for this program.

I agree that LIHEAP funding is necessary, and I agree that it is a great program and have individuals in the 100th District that benefit from this program. However, I believe that this need for our constituents will only increase in these troubling economic times. If this need is going to increase and we are going to ask for additional funding, I strongly believe that we should also urge Congress to put in oversight measures and recommend that the States do a better job of managing the money that we have so that we can most effectively serve and help the constituents that we all seek to serve.

So I humbly request your support of this amendment, A09104. I would also like to point out that this amendment is urging precisely what we have already passed in HB 83. It passed this House 197 to 1 on 7/12/07. That was a welfare reform bill that we passed. It is currently sitting in the Senate. Unfortunately, the safeguards that we put in for the welfare programs in HB 83 would not – please hear me – would not currently cover LIHEAP, because LIHEAP falls under DPW (Department of Public Welfare) as well as the DCED (Department of Community and Economic Development) Weatherization Program.

I have introduced two separate bills, HB 2193 and HB 2194, of which I am proud to call many of you cosponsors and supporters of that legislation, and those are the kinds of oversight measures that we need in this Commonwealth for this program. So I humbly request your support for my amendment, and help us to bring this attention up to the public as well as the Federal government that we need more oversight in this program. Thank you.

The SPEAKER. Representative Waters, on the amendment. Mr. WATERS. Thank you, Mr. Speaker.

I spoke with the gentleman that just spoke before me about his amendment that he wanted to offer today, and I do not have any problem at all with any program that is sound and a program that is fraud-free. So I do not have a problem with anything that would act as a deterrent or a way of catching people who are fraudulently making claims.

I only want to add to his list of things which he failed to mention, that why does the gas keep going up and fuel keep going up? To me, that is where the fraud is, and we need to address that problem, too, while we are talking about fraud. He is picking on the small people who are being punished with the increase of fuel oil. We need to do everything we can to increase the poverty level. We need to do everything we can to make sure that the programs that will be designed to help people who keep facing higher and higher fuel costs at a time when unemployment is at an all-time high.

So I do not have a problem with dealing with fraud at any level of government or any agency, but right now, I am more concerned about how we are going to help the people in need in the Commonwealth of Pennsylvania.

Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, further providing for the definition of "all-terrain vehicle"

Amend Bill, page 1, lines 9 through 18; pages 2 through 93, lines 1 through 30, by striking out all of said lines on said pages and inserting

Section 1. The definition of "all-terrain vehicle" or "ATV" in section 7702 of Title 75 of the Pennsylvania Consolidated Statutes is amended to read:

§ 7702. Definitions.

The following words and phrases when used in this chapter shall have, unless the context clearly indicates otherwise, the meanings given to them in this section:

"All-terrain vehicle" or "ATV." A motorized off-highway vehicle which travels on three or more inflatable tires and which has:

- (1) a maximum width of 50 inches and a maximum dry weight of [800] 1,000 pounds; or
- (2) a width which exceeds 50 inches or a dry weight which exceeds [800] 1,000 pounds.

ATV's described in paragraph (1) may be referred to as Class I ATV's, and ATV's described in paragraph (2) may be referred to as Class II ATV's. This term does not include snowmobiles, trail bikes, motorboats, golf carts, aircraft, dune buggies, automobiles, construction machines, trucks or home utility machines; military, fire, emergency and law enforcement vehicles; implements of husbandry; multipurpose agricultural vehicles; vehicles used by the department; or any vehicle that is or is required to be registered under Chapter 13 (relating to registration of vehicles). SUDDEN INFANT DEATH SYNDROME EDUCATION AND PREVENTION PROGRAM

§ 1101. Legislative findings.

The General Assembly hereby finds and declares as follows:

(1) The sudden, unexpected death of a newborn is the third most common cause of death among newborns and is only

- exceeded in the first year of life by congenital malformations and prematurity.
- (2) Most sudden infant deaths occur when a baby is between two and four months old, and 90% of all sudden infant deaths occur before six months of age.
- (3) Most babies that die of sudden infant death syndrome (SIDS) or sudden unexpected death in infants (SUDI) appear to be healthy prior to death.
- (4) Sixty percent of SIDS victims are male and 40% are female.
- (5) While SIDS occurs in all socioeconomic, racial and ethnic groups, African-American and Native-American babies are two to three times more likely to die of SIDS than Caucasian babies.
- (6) In 1994, the American Academy of Pediatrics, in conjunction with other major health organizations in the United States, launched the national "Back to Sleep" campaign, which endorsed and promoted the placement of infants on their backs both for sleeping and napping.
- (7) The incidence of sudden infant death in the United States decreased by more than 50% since the inception of this campaign.
- (8) In 2005, the American Academy of Pediatrics issued a new recommendation to further reduce the risk of SIDS that defined and promoted the use of a safe sleeping environment for infants.
- (9) At this time there is no known way to prevent SIDS or SUDI, but the risk can be minimized. Parents should learn risk factors associated with SIDS and SUDI and share with others information on how to create a safe sleeping environment for an infant to reduce the risk of sudden and unexpected death.

§ 1102. Definitions.

The following words and phrases when used in this chapter shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Birth center." A facility not part of a hospital which provides maternity care to childbearing families not requiring hospitalization. As used in this definition, the term "maternity care" includes prenatal, labor, delivery and postpartum care related to medically uncomplicated pregnancies.

"Commitment statement." A form which may be voluntarily signed by a parent, acknowledging that the parent has received, read and has an understanding of the educational and instructional materials provided on sudden infant death syndrome and sudden unexpected death in infants.

"Department." The Department of Health of the Commonwealth.

"Hospital." A for-profit or nonprofit hospital providing clinically related health services for obstetrical and newborn care, including those operated by the State, local government or an agency. The term shall not include an office used primarily for private or group practice by health care practitioners where no reviewable clinically related health services are offered.

"Infant." A child 30 days of age or older and younger than 24 months of age.

"Midwife." An individual who is licensed as a midwife by the State Board of Medicine.

"Newborn." A child 29 days of age or younger.

"Parent." A natural parent, stepparent, adoptive parent, legal guardian or legal custodian of a child.

<u>"Program." The Sudden Infant Death Syndrome Education and Prevention Program.</u>

"Sudden infant death syndrome" or "SIDS." The sudden, unexpected death of an apparently healthy infant that remains unexplained after the performance of a complete postmortem investigation, including an autopsy, an examination of the scene of death and a review of the medical history.

"Sudden unexpected death in infants" or "SUDI." The sudden, unexpected death of an apparently healthy infant.

§ 1103. Establishment of program.

- Establishment.-The department shall establish a Sudden Infant Death Syndrome Education and Prevention Program to promote awareness and education relating to SIDS and SUDI with the focus on the risk factors of SIDS and SUDI and safe sleeping practices for newborns and infants.
- Public awareness.-The department shall design and implement strategies for raising public awareness concerning SIDS and SUDI, including, but not limited to, the following:
 - (1) Risk factors for sudden infant death, including infant sleep position, exposure to smoke, overheating, inappropriate infant bedding and bed sharing.
- (2) Suggestions for reducing the risk of SIDS and SUDI. § 1104. Materials.
- (a) Educational and instructional materials.-The program shall include the distribution of readily understandable information and educational and instructional materials regarding SIDS and SUDI. The materials shall explain the risk factors associated with SIDS and SUDI and emphasize safe sleeping practices. The materials shall be provided to parents prior to discharge from a hospital or birth center or by a midwife for births that take place in settings other than a hospital or birth center.
- (b) Commitment statement.-The commitment statement may be signed by a parent prior to discharge from a hospital or birth center or after births performed by a midwife in settings other than a hospital or birth center. One copy of the commitment statement shall be given to a parent, and one copy shall remain on file in the hospital or birth center. Copies of commitment statements signed by parents in settings other than a hospital or birth center shall be kept on file by the health care practitioner or midwife performing the birth. The commitment statement shall be set forth in a form to be prescribed by the
- (c) Distribution of materials.-The information and educational and instructional materials described in subsection (a) shall be provided without cost by each hospital, birth center or midwife to a parent of each newborn upon discharge from a hospital or birth center.

§ 1105. Scope of chapter.

The department shall do the following:

- (1) Work to improve the capacity of community-based services available to parents regarding the risk factors involved with SIDS and SUDI and safe sleeping practices for newborns
- (2) Work with other State and local governmental agencies, community and business leaders, community organizations, health care and human service providers and national organizations to coordinate efforts and maximize State and private resources in the areas of education about SIDS and SUDI, including the risk factors and safe sleeping practices.
- (3) Identify and, when appropriate, replicate or use successful SIDS and SUDI programs and procure related materials and services from organizations with appropriate experience and knowledge of SIDS and SUDI.

§ 1106. Regulations.

The department may promulgate regulations necessary to implement the provisions of this chapter.

§ 1301. Definitions.

The following words and phrases when used in this chapter shall have the meanings given to them in this section unless the context clearly indicates otherwise:

"Child." An individual 21 years of age and under.

"Child death review data collection system." A data collection system approved by the National MCH Center for Child Death Review or a similar national organization.

"Department." The Department of Health of the Commonwealth.
"Local public health child death review team." A county or regional team comprised of professionals from organizations and local agencies who review cases of child deaths in accordance with protocols established by the State public health child death review team.

"Person in interest." A person authorized to permit the release of the medical records of a deceased child.

"State public health child death review team." A State team comprised of multidisciplinary professionals and representatives of State agencies who review data submitted by local child death review teams to develop protocols for child death reviews and child death prevention strategies.

§ 1302. Public Health Child Death Review Program.

- (a) Establishment.-The department shall establish the Public Health Child Death Review Program which shall facilitate State and local multiagency, multidisciplinary teams to examine the circumstances surrounding deaths in this Commonwealth for the purpose of promoting safety and reducing child fatalities.
- (b) Powers and duties.-The program shall have the following powers and duties:
 - (1) Assist in the establishment and coordination of local public health child death review teams.
 - (2) Coordinate the collection of child death data including the development and distribution of a form to be used by local public health child death review teams to report information and procedures for sharing the data with State and local agencies as appropriate.
 - (3) Develop protocols to be used in the review of child deaths.
 - (4) Provide training and technical assistance to local public health child death review teams, local agencies and individuals relating to the child deaths.
 - (5) Review reports from local public health child death review teams.
 - (6) Identify best prevention strategies and activities, including an assessment of the following:
 - (i) Effectiveness.
 - (ii) Ease of implementation.
 - (iii) Cost.
 - (iv) Sustainability.
 - (v) Potential community support.
 - (vi) Unintended consequences.
 - (7) Adopt programs, policies, recommendations and strategies based on collected data to prevent child deaths.
 - Review statutes and regulations relating to confidentiality and access to information relating to children from agencies responsible for the health and safety of children propose recommended changes to appropriate Commonwealth agencies and the General Assembly.
 - (9) Provide public information and education regarding the incidence and causes of child injury and death and the reduction of risks to children to agencies, health care professionals, child care professionals and the public.
 - (10) Submit an annual report to the Governor and the General Assembly by September of each year relating to the activities of the State child death review team, a summary of reports received from local child death review teams and recommendations relating to the reduction of risk of child injury or death.

- § 1303. State public health child death review team.
- (a) Composition.—The program shall be advised by a State public health child death review team. The team shall consist of:
 - (1) The following individuals or their designees:
 - (i) The Secretary of Health, who shall serve as chairman.
 - (ii) The Director of the Office of Children, Youth and Families within the Department of Public Welfare.
 - (iii) The Commissioner of the Pennsylvania State Police.
 - (iv) The Attorney General.
 - (v) The Pennsylvania State Fire Commissioner.
 - (vi) The Director of the Bureau of Emergency Medical Services of the Department of Health.
 - (2) The following individuals who shall be appointed by the Secretary of Health:
 - (i) A physician who specializes in pediatric medicine.
 - (ii) A physician who specializes in family medicine.
 - (iii) A representative of local law enforcement.
 - (iv) A medical examiner.
 - (v) A district attorney.
 - (vi) A coroner.
 - (3) Representatives from local public health child death review teams.
 - (4) Any other individual deemed appropriate by the Secretary of Health.
- (b) Initial meeting.—The initial meeting of the State public health child death review team shall be held within 90 days of the effective date of this section.
- § 1304. Local public health child death review teams.
- (a) Establishment.—Each county in the Commonwealth shall establish a local public health child death review team. Two or more counties may establish a local public health child death review team on a regional basis to satisfy the requirements of this section.
- (b) Local public health child death review team.—Local teams shall be comprised of the following:
 - (1) The director of the county child protective services agency or a designee.
 - (2) The district attorney or a designee.
 - (3) A representative of local law enforcement appointed by the county commissioners.
 - (4) A representative of the court of common pleas appointed by the president judge.
 - (5) A physician who specializes in pediatric or family medicine appointed by the county commissioners.
 - (6) The county coroner or medical examiner.
 - (7) A representative of emergency medical services selected jointly by the supervisors of all emergency medical organizations in the county.
 - (8) The director of the local public health agency or a designee.
 - (9) Any other person deemed appropriate by a majority of the local child death review team.
- (c) Chairman.—The members of the local public health child death review team shall elect a chairman annually.
- § 1305. Powers and duties of local public health child death review teams.
- (a) Review.—A local child death review team shall review all deaths of children and may review the following information:
 - (1) Coroner's reports or postmortem examination records.
 - (2) Death certificates and birth certificates.
 - (3) Law enforcement records and interviews with law enforcement officials.

- (4) Medical records from hospitals and other health care providers.
- (5) <u>Information and reports made available by the</u> county child protection services agency.
- (6) Information made available by firefighters or emergency services personnel.
 - (7) Reports and records made available by the court.
 - (8) Reports to animal control.
 - (9) EMS records.
 - (10) Traffic fatality reports.
 - (11) Any other records necessary to conduct the review.
- (b) Data collection.—The local public health child death review team shall utilize the child death review data collection system to report its findings in accordance with protocols established by the State public health child death review team. The name and home address of the deceased child shall not be reported to the child death review data collection system.
- (c) Reports.—A local public health child death review team shall submit biennial reports on deaths reviewed to the State public health child death review team. The report shall include the following:
 - (1) Identification of factors which cause a risk for injury and death, including modifiable risk factors.
 - (2) Recommendations regarding the following:
 - (i) The improvement of health and safety policies in this Commonwealth.
 - (ii) The coordination of services and investigations by child welfare agencies, medical officials, law enforcement and other agencies.
 - (3) Any other information required by the department.
- (d) Recommendations.—A local public health child death review team shall make recommendations to local agencies relating to the procedures and other actions to reduce injury and death of children. § 1306. Access to records.
- (a) Juvenile records.—Notwithstanding any other provision of law, all files and records of the court relating to a child under review in a proceeding under 42 Pa.C.S. Ch. 63 (relating to juvenile matters) shall be open to inspection by a State or local public health child death review team under 42 Pa.C.S. § 6307 (relating to inspection of court files and records).
- (b) Medical records.—Notwithstanding any other provision of law, health care facilities and health care providers shall provide medical records of a child under review without the authorization of a person in interest to the State public health child death review team and to a local public health child death review team for purposes of review under this chapter.
- (c) Other records.—Other records pertaining to the child under review for the purposes of this chapter shall be open to inspection as permitted by law.
- § 1307. Confidentiality.
- (a) Maintenance.—State and local public health child death review teams shall maintain the confidentiality of any identifying information obtained relating to the death of a child, including the name of the child, guardians, family members, caretakers or alleged or suspected perpetrators of abuse, neglect or a criminal act.
- (b) Agreement.—Each member of the State and local public health child death review team and any person appearing before the team shall sign a confidentiality agreement applicable to all proceedings and reviews conducted by the State or local public health child death review team.
- (c) Liability.—An individual or agency that in good faith provides information or records to a State or local public health child death review team shall not be subject to civil or criminal liability as a result of providing the information or record.
- (d) Discovery.—The proceedings, deliberations and records of a State or local public health child death review team are privileged and confidential and shall not be subject to discovery, subpoena or introduction into evidence in any civil or criminal action.

- (e) Meetings.—Meetings of the State or local public health child death review team at which a specific child death is discussed shall be closed to the public and shall not be subject to the provisions of 65 Pa.C.S. Ch. 7 (relating to open meetings).
- (f) Attendance.—Nothing in this chapter shall prevent a State or local public health child death review team from allowing the attendance of a person, including a parent, with information relevant to a review, at a child death review meeting.
- (g) Penalty.—A person who violates the provisions of this section commits a misdemeanor.

§ 1308. Regulations.

The department shall promulgate regulations as necessary to carry out the purposes of this chapter.

Section 2. This act shall take effect in 90 days.

Amendment 9275 strikes out, on page 8, lines 28 through 30. These lines explain that "...this article shall not be subject to the act of August 15, 1961...known as the Pennsylvania Prevailing Wage Act." What we are doing with this amendment is fundamentally making the status quo, and we are just maintaining things as they would normally be with PHFA (Pennsylvania Housing Finance Agency), and I ask for support for this amendment.

The SPEAKER. Representative Boyd.

Mr. BOYD. Thank you, Mr. Speaker.

I was wondering if the maker of the amendment would stand for brief interrogation?

The SPEAKER. Representative Daley indicates he will stand for interrogation. Representative Boyd is in order and may proceed.

Mr. BOYD. Thank you, Mr. Speaker.

Mr. Speaker, in terms of this amendment, trying to establish legislative intent/current practice, projects that are funded currently by PHFA loans and those programs, are they currently subject to prevailing wage, to your knowledge?

Mr. DALEY. There are some that are that are funded through State funding, Davis-Bacon through Federal funding, and there are some that are not.

Mr. BOYD. All right. So the purpose of this amendment is actually to really maintain the status quo under what projects through PHFA receive prevailing wage or have prevailing wage applied to them, and those that do not would not have prevailing wage apply. Is that a correct statement?

Mr. DALEY. That is absolutely correct. What we are doing is maintaining the status quo. Those projects that are funded through Federal funds will still be applicable to Davis-Bacon, those funded through State funds under State current law will be under prevailing wage, and those that do not have that particular

mantle attached to those, other than DCED moneys, will not be under the Prevailing Wage Act.

Mr. BOYD. Thank you, Mr. Speaker. That ends my interrogation.

The SPEAKER. Representative Maher.

Mr. MAHER. Thank you, Mr. Speaker.

I am hoping that the sponsor of the amendment will stand for interrogation?

The SPEAKER. The gentleman, Representative Daley, indicates he will stand for interrogation. Representative Maher is in order and may proceed.

Mr. MAHER. Thank you, Mr. Speaker.

I am a bit confused. The current statute provides that funds in this program are subject or are not subject to the prevailing wage? I thought the current law said that this program was not subject to prevailing wage. Is that correct?

Mr. DALEY. Are you talking about current law, or are you talking about the language of this particular bill?

Mr. MAHER. Well, I am trying to understand your amendment based upon the conversation you just had with another member. Your amendment, as I understand it, removes the stipulation that funds under this program are not subject to prevailing wage. Is that correct?

Mr. DALEY. That is correct. What we are doing, Mr. Speaker, we are removing this paragraph that will maintain, as other bills and other acts under PHFA, where applicable to prevailing wage, they will be applied; where applicable to Davis-Bacon through Federal funds, they will be applied. What this fundamentally does, by removing this paragraph, it maintains the status quo.

Mr. MAHER. Well, I am again confused, Mr. Speaker, because it seems to me that maintaining the status quo would not be removing a provision. If you are maintaining the status quo, you would not need this amendment, it would seem to me.

Mr. DALEY. Mr. Speaker, I do not understand your question.

Mr. MAHER. Well, I guess, and genuinely, I am just plain old confused about what your amendment does. If I understand your amendment, your amendment repeals the existing provision that these funds are not subject to prevailing wage. Is that correct?

Mr. DALEY. Mr. Speaker, you are confused, because quite honestly, what this amendment does is just takes that language out of this bill. It does not change any other law.

Mr. MAHER. My understanding was existing law provided that these funds were not subject to prevailing wage.

Mr. DALEY. Mr. Speaker—

Mr. MAHER. Is that correct, or-

Mr. DALEY. One second, Mr. Speaker.

QUESTION OF PERSONAL PRIVILEGE

The SPEAKER. For what purpose does the gentleman, Representative Smith, rise?

Mr. S. SMITH. Mr. Speaker, I rise on a point of personal privilege.

The SPEAKER. Without objection, the gentleman is recognized under the provision of unanimous consent.

Mr. S. SMITH. Mr. Speaker, I rise today as a member – and I moved purposely from the leader's podium to put a mild emphasis on that point – because there is something that is taking place that I find offensive and I think it affects each and every one of us as members of this House.

Our House rules are generally established to regulate the procedures and the process of this House, but some of them deal with other actions of this House and of the members of this House, and within those rules it allows for a process for either members or people in the general public to file a complaint with the House Ethics Committee and make a complaint.

If you or I, anyone sitting here, were to file a complaint with the House Ethics Committee, by rule, we are prohibited from talking about that in public or to talk about it with anybody else. The person who is the subject of the complaint is, by rule, not allowed to talk about that complaint. The members of the Ethics Committee, by rule, are prohibited from talking about that complaint.

However, Mr. Speaker, if a member of the general public files a complaint, they would be informed of a duty of confidentiality, but there is no law to bind them to that. That is in difference to if someone filed a complaint with the Ethics Commission that oversees all of us in government, not just us as legislators. If someone files a complaint with the Ethics Commission, they are required to sign, under penalties of perjury, number one, that their complaint is accurate to the best of their knowledge, that they are not fabricating or trumping up a charge. They are also bound, once they file a complaint, an ethical complaint with the Ethics Commission, they are bound to confidentiality under law, and if they then went out and talked about that, they would be in violation of the law.

I want to point out that distinct difference between someone filing a complaint relative to the House Ethics Committee and the State Ethics Commission, and why I raise that question, Mr. Speaker, is because just recently, last night, I received a copy of a news release that was sent out in which a third party, a political operative, alleged or filed a complaint against a member of this House to the House Ethics Committee and then proceeded to initiate the political charge of so-and-so is under investigation by the House Ethics Committee.

Now, Mr. Speaker, why I find this insulting and I find it concerning for the integrity of this House is simply this, Mr. Speaker: Anyone could go out and trump up some kind of charge that they want to file against anyone in this room, and if they file it with the Ethics Committee, there is no law that can keep them from making something up and there is no law to keep them from talking about it in the media and there is no law to keep them from putting it into their campaign literature that would say, so-and-so is under investigation by the Ethics Committee, and I find that behavior particularly appalling. I find it almost questioning an ethics in and of itself, Mr. Speaker, because it is abusing the rules of this House that we have established to try to maintain a level of integrity and balance, a uniformity to govern ourselves, and for someone to step outside of that to use these rules to impugn the integrity of an individual is, I think, questionable in itself and that that action is of questionable ethics, plain and simple.

So, Mr. Speaker, I am going to send a memo around to the members with a little more information relative to this, and I appreciate the House's indulgence of me at this moment. My message primarily is that while I found this particular action insulting, what concerns me more, Mr. Speaker, is that if this House is going to function in an honorable and respectable way, then it is up to each one of us as individual members and as we engage in our respective political campaigns to operate in an honorable and respectable manner ourselves. We cannot constantly pass it off to a third party and say, well, I did not have anything to do with that or I did not know about that. We need to stay focused on what we are doing as individuals and live up to that honorable title and live up to that respect that we all purport to afford each other.

Thank you, Mr. Speaker.

STATEMENT BY MAJORITY LEADER

The SPEAKER. Does Representative DeWeese seek recognition?

Mr. DeWEESE. Thank you, Mr. Speaker.

Mr. Smith is categorically correct. I embrace every syllable of his pronouncement. There are no ands, ifs, or buts relative to his declarations.

We are guardians of the sacred flame, so to speak, if we can elicit a metaphor from antiquity. This Assembly, and especially our House chamber, has to maintain a fundamental sense of integrity that cannot be compromised, and the gentleman's references seem to assert that that dynamic may have taken place. It cannot, must not, and will not be countenanced.

The institutional dynamics of this room and the personal friendships and the political relationships when personal relationships seem frayed must be guarded, must be respected, and the preeminent noun that should guide us is "integrity," and this seems to be a breach of integrity.

So let me repeat, as I relinquish the microphone, that the honorable gentleman from Jefferson County, the minority leader, is correct in what he says, and Mr. McCall and the rest of our leadership team embrace not only the letter but the spirit of his remarks. Thank you.

The Chair recognizes the Speaker, Representative O'Brien, on the bill

Mr. D. O'BRIEN. Thank you, Madam Speaker.

At present, widows and widowers of firefighters and other fire department employees in Philadelphia who are receiving pension payments are subject to what is called a remarriage penalty. Should these widows and widowers choose to remarry, they must forfeit any pension payments, service-connected death benefits, and service-connected health-care benefits.

My bill eliminates this remarriage penalty in Philadelphia, just as it has already been eliminated in other municipalities across Pennsylvania. The only other place where this penalty applies to firefighters is Pittsburgh, and that issue was addressed by Representative Geist's amendment, and I thank him for that collaboration.

HB 1737 prohibits Philadelphia from denying certain benefits to surviving spouses of firefighters upon subsequent remarriage. The bill is essentially identical to Act 184 of 2004, which eliminated the remarriage penalty for surviving spouses of Philadelphia police.

For the information of the members, this has been an issue that I have dealt with for a number of years. It was first brought to my attention and I called it the Maureen Faulkner bill, because as you recall, Maureen's husband, Danny Faulkner, was killed in the line of duty. And at that very funeral of Danny Faulkner, another widow approached her and said, I lost my spouse in the line of duty, as you did, and I never thought I would find happiness or a lifelong companion, and then 2 years afterwards someone came into my life. And what happened after that was the most horrific injury upon that loss. That individual then proceeded to rifle that spouse's bank accounts, run up the credit cards, and leave her family and the surviving children destitute. Maureen promised at her husband's wake that she would never remarry until these issues were resolved.

That is why we are doing it for police, that is why we are doing it for firefighters, and there is no member of the uniformed force in Pennsylvania that we should leave uncovered. And I thank Representative Geist for his collaboration, and I ask for an affirmative vote.
