THE SPEAKER (DENNIS M. O'BRIEN) PRESIDING

BILL ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 36**, **PN 41**, entitled:

An Act establishing the State Energy Office and an advisory council; and imposing duties on the State Energy Office.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

(Bill analysis was read.)

The SPEAKER. The question is, shall the bill pass finally?

The Chair recognizes Representative George.

Mr. GEORGE. Thank you, Mr. Speaker.

Mr. Speaker, I stand here knowledgeable that those of you who are my colleagues are as concerned about the matters that seemingly are going on without our attention or that at least we do something about it. When I came down here in '74, we had a State Energy Office, and it was under the Governor's Office, under Executive order. However, unfortunately, under the Ridge administration, the State Energy Office was dissolved.

Now, just last week we had several hundred truckers. I was shown proof that the one trucker had worked all week and burnt \$1700 worth of fuel oil and his take-home pay was \$300, which he had to utilize for not only his own livelihood but the additional expenses of the truck and the repair.

So what I am asking you to do in that this bill would create a statutory mandate for the DEP (Department of Environmental Protection) to continue to promote the goals of energy, energy development and conservation, and most of all, I would be proud to have you all join with me to show the people in this Commonwealth we do hear your cries in the dark. Thank you.

On the question recurring,

Shall the bill pass finally?
