SUPPLEMENTAL CALENDAR A

BILL ON CONCURRENCE IN SENATE AMENDMENTS

The House proceeded to consideration of concurrence in Senate amendments to **HB 1, PN 86,** entitled:

An Act providing for alternative sources of energy; establishing the Alternative Energy Development Program, the Consumer Energy Program, the Home Energy Efficiency Loan Program, the Home Energy Efficiency Loan Fund and the Alternative Energy Production Tax Credit Program; and providing for the powers and duties of the Department of Environmental Protection.

On the question,

Will the House concur in Senate amendments?

The SPEAKER. Representative Hutchinson, on concurrence.

Mr. HUTCHINSON. Thank you, Mr. Speaker.

Mr. Speaker, I rise in opposition to HB 1 for many, many reasons. Number one, I think that this bill is based on a false premise, and that premise is that only by counting on a windfall tax increase, a windfall tax increase on people's electric bills, can we pay to decrease energy costs. Mr. Speaker, we should be cutting that tax, a direct cost that the consumers of Pennsylvania will be paying, and reducing electric bills. That is a smarter way for Pennsylvania to produce energy.

Number two, I believe that the only true way to energy independence in this day and age is not for some super bureaucratic agency located in Harrisburg to float bond issues and then pick winners and losers, doling the money back out, borrowing \$500 million to eventually be repaid at a clip of about \$800 million. I think that is the wrong way to go. I think that the true way to energy independence is to responsibly harvest proven domestic energy resources.

Pennsylvania is blessed with many proven energy resources. The experts say that the coal reserves of Pennsylvania could fuel us for 200-plus years. A huge and exciting new find of natural gas called the Marcellus shale reserve has been proven in Pennsylvania and is now accessible because of new technology and improvements in geology. We should be using those resources to truly move Pennsylvania to energy

independence, not doing what Pennsylvania has continued to do, which is, whenever there is a source of energy, it seems like Pennsylvania piles on new regulations, adds additional requirements to get that energy. New requirements have already been added for Marcellus shale drillers. A couple years ago additional mercury regs were making Pennsylvania coal less competitive. We keep doing those kinds of things, stopping energy production instead of promoting proven energy production.

Mr. Speaker, a small technical problem with this bill that I think deserves to be aired is the fact that not only are we borrowing that \$500 million, part of those funds, which we are borrowing over 30 years, we are borrowing money for 30 years, and some of it is being used, \$40 million, as a matter of fact, is being used for current expenditures in the LIHEAP program (Low-Income Home Energy Assistance Program). Mr. Speaker, LIHEAP may or may not deserve more funding, but we should not borrow for 30 years and then spend that money on one-time help with people's energy bills. That is wrong and maybe even not allowed.

Mr. Speaker, this bill goes a step further than some other legislation we have worked on in the past week as we create a super agency called the Commonwealth Financing Agency. Just in this past week alone, we have poured hundreds of millions of dollars into this super agency that is politically controlled, and somehow they are an expert on every issue. I do not know how they developed an expertise to pick winners and losers in the energy field. Earlier this week we said they were expert enough to give out money for water, sewer, and dams, and flood protection. They must be one super group.

Mr. Speaker, as I said, the \$500 million in debt is a major problem for our children and grandchildren, and it is based upon the premise of collecting new taxes as if we in Pennsylvania want people to pay higher energy bills, because that is the only way that this program will be funded.

And quite frankly, at the end of the day, I think you will find after we implement this bill, go 5 years down the road, 10 years down the road, we still will not be any more independent than we are today. Mark my word. Not only that, our energy costs will still be higher and we will be stuck with a bill to pay back for the borrowing.

I think this is a truly bad bill. It is not the right thing for Pennsylvania, and I ask my colleagues to join me in opposing HB 1.

Thank you, Mr. Speaker.

The SPEAKER. Representative Saylor.

Mr. SAYLOR. Mr. Speaker, I rise today to support HB 1 on concurrence from the Senate.

I understand where some of my colleagues here in the House are very disappointed with this bill, and I, too, am disappointed that we have not looked at the way we fund money in Pennsylvania in the area of borrowing, but I do believe that we do have to take some steps forward, and I believe this bill does make those first initial steps.

I am pleased to see that as the Senate sent this bill to us, that they have incorporated a lot of the things that the House Republican energy task force wanted to see included, free market things like \$92 million for various consumer energy conservation measures, \$25 million for funding for loans and grants to the individuals and small businesses in Pennsylvania to help them build high-performance buildings and energy-conserving technologies to be used in homes. There is

an assistance program as well for this coming winter, \$40 million, that will go to LIHEAP to help people pay their energy bills this fall and winter. There is \$25 million that will go to fund small coal-fired power plants to help them with more pollution reduction and make them more environmentally friendly. Those are things we need to do in Pennsylvania to clean up our environment.

And also, Mr. Speaker, there is \$50 million in tax credits for companies to produce alternative energy in this State; \$40 million for the Ben Franklin Technology, which is an outstanding program for this Commonwealth that has been here for many, many years; and a \$25 million fund for loans and grants for small-scale renewable energy projects, including geothermal and solar projects throughout the Commonwealth of Pennsylvania.

Mr. Speaker, I think this bill today is the beginning. It is not the end of what this State needs to do to become energy independent. It is a beginning. We need to commit ourselves to come back here and continue having a policy in Pennsylvania that moves Pennsylvania to energy independence.

Today I ask for a confirmation vote, and send this bill to the Governor's desk and get Pennsylvania started on the road to energy independence. Thank you.

The SPEAKER. Representative George.

Mr. GEORGE. Thank you, Mr. Speaker.

Mr. Speaker, I will be careful, for I would not want to impugn my cochair. I think the world of him, but I daresay that the reason that this State of Pennsylvania is in dire straits is because there were many that philosophically were in tune as that gentleman. That is why now we have these problems.

The truth is that if we keep on as we have, our citizens will soon see that they have been forgotten. The truth is that I would want to be around here when that rate cap comes off and hear this individual and others talk about what we are, where we are going, and what we are going to do. The fact is that now there is more power coming into Pennsylvania from out of State than there is from in State, and I will get into this more so as we go on, but it is hard for me to go any further without daring to say something that I would not want to say.

You are individuals. You represent as many people as each of us, and I think you know your responsibilities as well as we do, and I know you will find that we had better start doing something. Let us forget that we are 40 years late, but let us not be another year late.

Mr. DePASQUALE. Thank you, Mr. Speaker.

This has been 18 months of hard work, and I just want to thank all the people, all the members that were involved. This, obviously, changed a lot from the beginning introduction of this legislation, and I want to thank everyone for their insight. I want to especially thank the staff both from the House side of it and the Governor's Office that worked so very hard on the details, and I also want to thank the Senate for working with us for this bipartisan bill that we now have today, and I would ask for an affirmative vote.
