I would also like to recognize some important people that are with the band, beginning with Brad Boandl, who is the new director following in his father's footsteps, Bill Boandl, who was the director for 30 years. Also, on the professional staff with the band is Frank Felix, who is the band instructor, and two very important volunteers are with the band today, James Goldman, who is a 20-year volunteer and serves as head chaperone and director of volunteers for this group; and Celia McEnroe, whom I have known a long time and a parent of former band members and is a very longtime volunteer member for this group also.

I would like to call up Catie Szuba, Dillon Tanzos, and Ana Frace, if they could come forward, please. These young folks will be accepting a citation from Representative Grucela and myself. The Blue Eagle Marching Band captured the United States Scholastic Band Association National Championship, fourth division, and Grand National title for the second consecutive year.
