THE HARRISBURG INTERNSHIP SEMESTER PROGRAM INTERNS INTRODUCED

Mr. KILLION. Thank you, Mr. Speaker.

I am very pleased to offer this resolution today that I have cosponsored with my colleague, Steve Barrar. Representative Barrar and I share the Cheyney University campus in our legislative districts along with one of their distinguished alumnus, Representative Thaddeus Kirkland. Before I get to the resolution, however, I would like to recognize the new president, who is just doing an outstanding job at Cheyney University. She is at the rear of the House, Michelle Howard-Vital, along with her husband, Geri.

Mr. Speaker, today we recognize Cheyney University of Pennsylvania on its 172-year tradition of providing access, opportunity, and academic excellence for African-Americans and honoring distinguished alumnus Octavius Valentine Catto by designating today, February 10, 2009, as "Cheyney University and Octavius Valentine Catto Day" in Pennsylvania.

Cheyney University's educators have left a profound and lasting legacy throughout the Commonwealth of Pennsylvania, the nation, and the world.

Octavius Valentine Catto attended the Institute for Colored Youth, Cheyney University's forerunner, from 1854 to 1858, graduating first in his class. He was only 20 years old when he was appointed professor of both English and mathematics at the Institute for Colored Youth in 1859. Catto contributed significantly to the Commonwealth as an educator, orator, and advocate for justice and civil rights before being killed while appealing to the mayor of Philadelphia to send troops on Election Day to protect Black voters who were facing intimidation and violence.

I ask for your affirmative vote in commending and congratulating Cheyney University for its lasting contributions to the Commonwealth, also in recognizing and honoring the contributions of distinguished Cheyney alumnus Octavius Valentine Catto for his significant contributions to civil rights and Black history by declaring February 10, 2009, as "Cheyney University and Octavius Valentine Catto Day" in Pennsylvania.

I would ask for your affirmative vote.

With their win, they have now qualified to participate in the regional championship in Seattle, Washington.

My other guests, the Liberian Community Association of Pennsylvania, is a group whose mission statement is to strengthen its community by working together as a unit to mediate and resolve existing conflicts among community members, while encouraging participation in social activities.

As many of you may know, the Pennsylvania Legislative Black Caucus is getting ready to celebrate Black History Month with an event in the Capitol Rotunda today at noon, and you all are welcome. Black History Month is not only an important occasion for the African-American community and all Americans, but it is also an important historical event for the Liberians because African-American history is intertwined and interwoven by the Liberian historical experience.

The Nation-State of Liberia was founded by three American slaves from the United States in 1847. Liberia's capital city, Monrovia, is named after American President James Monroe. Liberia enjoyed stability for over 130 years until it was plunged into a civil war in 1990, forcing many Liberians to flee to the United States and other countries as refugees and immigrants.

Today, over 23,000 Liberians reside or have resettled in Pennsylvania. This community is making vital contributions to our socioeconomic development. Many Liberians work in social services, health care, community development, and other professional occupations while others own and operate several small and medium businesses. The community also operates two social service delivery agencies: the African Cultural Alliance of North America, located in southwest Philadelphia; the Multicultural Community Family Services, who serves Upper Darby Township in Delaware County.

As Liberians adjust to the mainstream culture of the United States, they have also created structures to preserve their culture and maintain unity among the 16 ethnic groups represented in Pennsylvania. Let us make our visitors feel welcome here today by joining me with a big round of applause.

I want to thank the members for that, and I want the Liberian Mandingo Association of Pennsylvania to know that that was bipartisan support, and it is always good when we have that in this chamber.
