Ms. BROWN. Thank you, Mr. Speaker.

Today I stand here with my colleague, Kenyatta Johnson, and I am honored today to welcome to the House floor Mr. Jerry Mondersire, president of the Pennsylvania Chapter of the NAACP (National Association for the Advancement of Colored People), as well as other special guests – Mamie Parker, Jackie Jenkins, Barbara Tyler, and Dwayne and Edith Jackson and other members of the NAACP. Please join me in giving them a big round of applause.

I would like to also invite my fellow members to stand with me who are members of the NAACP. Would the members who are here who are card-carrying members of the NAACP please stand with me? Thank you.

The National Association for the Advancement of Colored People, the NAACP, is one of the nation's oldest and largest civil rights organizations. It was formed as a result of the mob-incited race riots in Springfield, Illinois, the home of Abraham Lincoln, during the summer of 1908.

Over the decades, the legal advocacy of the NAACP enabled African-Americans to be commissioned as officers in World War I, which resulted in the admission of African-American students to the University of Maryland. They also led to a reversal of the separate-but-equal doctrine that had governed access to public accommodations since the United States Supreme Court's 1896 *Plessy v. Ferguson's* ruling.

They also ended State-sanctioned segregated facilities in interstate travel by train and bus and, under the leadership of Special Counsel Thurgood Marshall, eliminated segregation in public schools with a victory in *Brown* v. *Board of Education*.

Past and present prominent members of the NAACP include Rosa Parks, Dr. Martin Luther King, Jr., Medgar Evers, Roy Wilkins, Benjamin L. Hooks, Representative John Conyers, Representative Alphonso Deal, and Julian Bond – all pioneers in the struggle for civil, political, and economic liberty.

Since its inception in 1909, the mission of the NAACP has been to ensure political, educational, social, and economic equality for all persons and to eliminate racial discrimination and segregation through the democratic process.

Now it is my honor to introduce HR 114 to honor the NAACP and extend an appreciation for a century-long commitment to justice and equal protection under the law for all of the citizens of the United States of America. Please give them a big round of applause. Thank you.
