"WHEREAS, Ms. Blow belongs to the Southwest EPIC Stakeholders and its Safe Corridor program, the 12th Police District Advisory Council, the South West Action Coalition, Project NEAT and Intelligent Sisters Improving Selves..., is an elected member of the board of the Southwest CDC Neighborhood Advisory Committee and has been involved in the planning and revitalization of the Chester Avenue business corridor; and

"WHEREAS, Lois A. Fernandez holds a master's degree in urban planning from Antioch College and worked for the

This type of injury can cause a wide range of functional changes which affect the thinking, language, learning, emotions, behavior, sensation; can cause epilepsy and increase the risk for Alzheimer's disease, which took my mother, and Parkinson's disease, and other brain disorders that have become prevalent with age.

Mr. Speaker, each year 1.4 million Americans sustain traumatic brain injuries, 50,000 Americans perish, 235,000 are hospitalized, and 1.1 million are treated and released from an emergency department for brain injuries. Mr. Speaker, brain injury prevention can be achieved through community education and public awareness.

Therefore, Mr. Speaker, I would ask all my colleagues to join with me today in designating this Saturday, March 21, as "Brain Injury Awareness Day" in Pennsylvania, and I would ask them to vote affirmatively for HR 157. Thank you, Mr. Speaker.

Mr. FAIRCHILD. Thank you, Mr. Speaker.

This amendment, A00371, is the product of a meeting that Chairman Melio and I had with the Department of Health's Deputy Director Huff, the office of EMS (Emergency Medical Services) Director Joe Schmider, Representative Solobay, Representative Causer, Representative Payne, and Representative Gillespie, and the various staffs.

I would like to first commend all the stakeholders throughout the State and the many groups that worked on Chairman Melio's bill. It came down to the point where, thanks to the diligence of Representative Causer and Representative Solobay, there was a small problem that surfaced, and it is really great as a Representative to see people that are in the field, active in these types of issues, really read the bills and say, wait a minute, we have got a little problem here; thus, the stakeholders' meeting yesterday with Chairman Melio.

My amendment simply reflects mostly language in a prior amendment by Representative Causer, and I would like to, if I could take the liberty because this is such an important issue, after Chairman Melio speaks, ask Representative Solobay and Representative Causer to make small remarks on the bill and explain exactly what the amendment does, or make remarks on the amendment.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Bucks County, Representative Melio.

Mr. MELIO. Thank you, Mr. Speaker.

I just wanted to thank Representative Causer, Representative Solobay, Chairman Fairchild for all their hard work on this amendment. It is an agreed-to amendment, and I would hope that everyone agrees to the amendment.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from McKean County, Representative Causer.

Mr. CAUSER. Thank you, Mr. Speaker.

Mr. Speaker, I rise in support of the Fairchild amendment, amendment A00371. The amendment really does make this a much better bill. It is a good EMS bill, strongly supported by the EMS providers in this State.

When we were taking a close look at the bill, we did find some concerns. One in particular that Representative Fairchild pointed out was a concern dealing with emergency vehicle operators, which would have required volunteer firefighters in this State who operate fire equipment, who are also certified as quick response units for responding to emergency medical calls, to register with the Department of Health and have continuing education requirements, and obviously, this would have been a huge mandate for our volunteer firefighters. You know, many of us here in this chamber have the opportunity to work closely with our volunteer emergency medical services agencies and volunteer fire departments, and we hear constantly, please do not put any more requirements on us, please do not put any more mandates on us, because we are having trouble doing what we do right now. You know, we depend on volunteers around this State to provide this vital service, and they take time out of their day, day and night, to provide this service, and oftentimes

we are putting more requirements on them. So when we took a look at this bill, it was putting some additional requirements on them, and the Fairchild amendment will strip that provision out of this bill and really, really assist our volunteer fire departments.

Another provision that is in the bill is a requirement for registration for EMS ambulance drivers in the State and also continuing education requirements. In negotiating through this process and through this amendment, we did agree to limit the amount of continuing education requirements for ambulance drivers. I have a signed letter from the Department of Health saying that it is their intent that there shall be no greater than 3 hours of continuing education requirements over a 3-year period.

I do want to ask the members to support the Fairchild amendment. It really does strengthen this bill and I think deserves our support. I want to thank Chairman Melio and Chairman Fairchild, Representative Solobay, Representatives Payne and Gillespie for all their work on this particular issue. As I said, this makes the EMS bill a much better bill, and I would urge support for the amendment and for the bill.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Washington County, Representative Solobay.

Mr. SOLOBAY. Thank you, Mr. Speaker.

I also would like to stand in support of the Fairchild amendment and commend all the players that got together to make this happen, the process that we used, sitting down and working through identifying the issues and coming up with a solution, as opposed to letting things get personal and letting them get ugly like sometimes things, unfortunately, do.

I would just recommend, Mr. Speaker, when we get into a tough spot on the budget, maybe you should let the firefighter caucus get it settled.

The SPEAKER. On the question, the Chair recognizes the minority whip, Representative Turzai.

Mr. TURZAI. Thank you very much, Mr. Speaker.

I rise in support of the amendment, and I want to just make clear that the individuals who are sponsoring this amendment, these guys have frontline experience both from the real world in their communities and from their knowledge here as legislators. They know the EMTs (emergency medical technicians) and the firefighters that are out there doing the work day in and day out and what the incentives are and how they are affected by legislation.

Given their credibility, given their experience, given their background, I think we should be supporting them 110 percent, and I appreciate the fact that they have taken the time to know what is out there and to craft legislation to match that real-world experience, and I would urge everybody to support this amendment. Thank you.
