The House proceeded to third consideration of **HB 718**, **PN 797**, entitled:

An Act amending the act of July 9, 1990 (P.L.340, No.78), known as the Public Safety Emergency Telephone Act, further providing for the Wireless E-911 Emergency Services Fund.

On the question, Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

(Bill analysis was read.)

The SPEAKER. The question is, shall the bill pass finally?

On that question, the Chair recognizes the gentleman from Bucks County, Representative Melio.

Mr. MELIO. Thank you, Mr. Speaker.

I just want to explain that this legislation extends the sunset provision for the wireless emergency 911 surcharge. This is not a new surcharge. It is not an increase to the surcharge presently in place. It just extends the date to June 30, 2014, and I thank all the members for their support.

Thank you, Mr. Speaker.

The SPEAKER. On that question, the Chair recognizes the gentleman from Butler County, Representative Metcalfe.

Mr. METCALFE. Thank you, Mr. Speaker.

Mr. Speaker, I rise to raise a concern with this legislation in these economic times when thousands and tens of thousands of people are losing their jobs in Pennsylvania with a piece of legislation that is sunsetting on a fee that was assessed on their cell phone bills. I think, Mr. Speaker, that sunsets are there for a reason, so that we can reevaluate as to whether or not something should actually be imposed.

In a sense, we are just enacting once again this dollar fee on everybody's cell phone to continue to take money for this certainly worthy endeavor of emergency services, but I think there is money that can be found in the budget and in other areas to take care of those needs rather than asking the taxpayers to continue to pay this extra charge.

So, Mr. Speaker, I am going to be voting in the negative because I do not think that this is a fee that needs to continue to be assessed on people's cell phone bills. I think that we ought to let this dollar surcharge sunset and let the government find the money in other areas of the budget.

Thank you, Mr. Speaker.

The SPEAKER. The question is, shall the bill pass finally? The Chair recognizes the gentleman from Dauphin County, Representative Payne.

Mr. PAYNE. Thank you, Mr. Speaker.

With all due respect to my colleague, this \$1 charge on a cell phone is critical to maintaining our 911 call stations at every county so that we can locate somebody in an emergency with their cell phone.

I can stand here today and tell you this occurred in my district in a house fire, where a couple was trapped in their house, got on the cell phone, and locked themselves in the bathroom, putting towels at the door, waiting for the fire company to get there. Through the GPS (global positioning system) device and the 911 system, we were able to track that cell phone and we knew we had both people trapped in that burning house.

I encourage my colleagues to support this \$1 charge on a cell phone so we can save lives in the Commonwealth of Pennsylvania. Thank you.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Delaware County, Representative Killion.

Mr. KILLION. Thank you, Mr. Speaker.

I rise also to support HB 718.

As we all know, this fee was introduced many years ago and provided the necessary funding to our counties to fund their 911 centers. But what you need to realize is, just like our cell phones and our computers, you replace them every couple months or maybe once a year; the same thing in our 911 centers. They have to keep up with technology, the newest advances. Now they can track cell phones. This is a public safety issue, even a national security issue. It is not a new fee; it is an extension of the already existing fee.

I think a dollar a month to protect the citizens of Pennsylvania is not asking too much, and it will allow our counties to stay up on the technology, because they are going to have to spend the money anyway. They are going to have to spend the money. They have to keep the 911 centers up and running with the latest technology. If we do not extend this fee, we will cause a rise in property taxes in the 67 counties in Pennsylvania.

Vote against raising property taxes and extend this \$1 fee. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

On the question, the Chair recognizes the gentlelady from Northampton County, Representative Beyer.

Mrs. BEYER. Thank you, Mr. Speaker.

Just a brief interrogation of the maker.

The SPEAKER. Will the gentleman stand for interrogation? The gentleman indicates he will stand for interrogation. The gentlelady may proceed.

Mrs. BEYER. Thank you, Mr. Speaker.

Can you tell me how the money is distributed to the county 911 centers? Is it an annual— Is it accrued, the money that is collected, and then distributed annually? Monthly?

Mr. MELIO. Mr. Speaker, Mr. Solobay is going to answer that question. Tim.

The SPEAKER. The Chair recognizes the gentleman from Washington County, Representative Solobay.

Mr. SOLOBAY. Thank you, Mr. Speaker.

On the question, the funds go into a dedicated account that is controlled through PEMA (Pennsylvania Emergency Management Agency), and as those particular counties are doing upgrades that were described a little earlier through some of the support comments, the money is distributed back to the counties based on their expenditures on the technology to improve their system for things like the GPS and the other related issues.

Mrs. BEYER. Can you tell me how much annually is accrued in this account and then distributed?

Mr. SOLOBAY. I do not have those figures in front of me at this moment, but I do know that as cell phone usage does increase, that fund is at a figure that is meeting the technology needs and the one issue that we are also looking at.

And to answer a previous question about the need to extend the period on this is that the bricks-and-mortar issues that a lot of these 911 centers are also having troubles with, we are hoping to look at some of it. If there are any excess funds, they would also be able to be relayed back to cover, instead of just technology, also help cover the bricks and mortar.

Mrs. BEYER. Thank you, Mr. Speaker. Just a brief comment.

Although ultimately— A brief comment, Mr. Speaker? Just a brief comment on the bill.

The SPEAKER. The gentlelady may proceed.

Mrs. BEYER. Thank you, Mr. Speaker.

I reluctantly, frankly, support this, and let me just tell you why: Not only do I agree with my colleague that when we make a commitment to sunset something, we should fulfill that commitment unless there is a reevaluation as to why we should do it. I served on the Veterans Affairs and Emergency Preparedness, and we all experienced what happened on Valentine's Day 2 years ago when I-81 and I-78 were paralyzed because agencies could not talk to each other. Our 911 system was not effective. We have spent hundreds of millions of dollars on a system that continues to fail the citizens of this State. I think that it is incumbent upon us to take a look at how this money is being spent and whether or not it is being spent appropriately.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the lady.

The Chair recognizes the gentleman from Washington County, Representative Solobay.

Mr. SOLOBAY. Thank you, Mr. Speaker.

The SPEAKER. The gentleman will yield. The gentleman will yield.

Will the House come to order. Members will please take their seats.

The gentleman, Mr. Solobay, is in order and may proceed.

Mr. SOLOBAY. Thank you, Mr. Speaker. On the bill.

I, too, stand and rise for support of HB 718.

As it has been asked, and I think answered several times, the committee did evaluate and look at the 911 surcharge on cell phones and, through the testimony and other information received to us from the telecommunication folks, did find that the surcharge is still a necessity to continue the ongoing upgrade of technology as it does happen to move forward year by year.

So therefore, I do think that this is vital. The sunset provision was reviewed, was looked at. It was determined that it is still a necessity to move forward, and again, I wholeheartedly support the bill.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman from Delaware County, Representative Civera.

Mr. CIVERA. Thank you, Mr. Speaker.

Mr. Speaker, for those who might not remember the reason why the original statute was amended, there was a situation that happened in the city of Philadelphia where a young boy in the northeastern part of the city was beaten and died that evening, and what came out of that was that there was not enough training under the original act when it was passed for 911. We went back and had a bipartisan committee look at this and created more money to the counties so they would be trained and where they could buy upgraded equipment.

If this statute was to be in a situation where it would sunset for the 67 counties, it would be detrimental. So for the new members, this was to upgrade to where we are presently. What we really should be doing with this bill is to increase the dollar amount that goes to the counties, but right at the moment, I would suggest, after being the chairman of that committee and when we did this, that we adopt HB 718 and we do not delay anything or allow this to sunset.

Thank you very much.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman from Union County, Representative Fairchild.

Mr. FAIRCHILD. Thank you, Mr. Speaker.

In response to a couple of the statements that were made today, this legislation has been well vetted amongst committee members, amongst members of your elected officials back in your counties, emergency personnel, and it does not create any new taxes. What it does is just sunsets or allows the existing rate to continue. This is pretty easy. It boils down, if you do not want emergency services in your legislative district or in the counties you represent, just vote "no." Go back and tell your people, I do not want it. It is not good for you. We do not need emergency services. If you do not, if we do not reauthorize the same fee, the same existing fee, you are looking at about a 50- to 60-percent cut back home in your emergency services providers. So if you want to face that music, go ahead. In fact, if you want to introduce legislation to take out your county or your legislation, bring it on. We will talk about it.

This is about saving lives. This is about using the technology that we have today to make our emergency services systems more efficient. And we are not increasing the dollar amount; it is staying the same, so please consider this and vote positive for the Melio HB 718.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Monroe County, Representative Scavello.

Mr. SCAVELLO. Thank you, Mr. Speaker.

I encourage the members to support this piece of legislation.

I just want to clarify one of the questions that was asked earlier. The dollars that go into this fund come from the cell phone, but however, they go back to the county where that cell phone number originates. So every municipality, whatever cell phone users are within those municipalities, those dollars go back to those counties.

In my particular county of Monroe, we are in the process of putting an enhanced 911 system in where we do not have it now - we are one of the few counties that does not - and the collection of that dollar is going to pay for that system. So it is truly important, and I agree with the other members and all that we do support this bill. It saves lives. This bill would save lives.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

On the question recurring,

Shall the bill pass finally?
