Today we gather to honor one of the most successful all-volunteer athletic associations in the Commonwealth. The Allentown Patriots have been providing a high caliber of recreation and sports in the Lehigh Valley for more than 60 years. Beginning in 1940, during a time when the world was riveted with a world war, a fastpitch softball team was formed

by a group called the Patriotic Order of Sons of America. Eight years later this group became the Allentown Patriots Athletic Association through an official city charter. Since then, day after day the Allentown Patriots have sponsored a number of softball teams and hosted thousands of softball games in the Lehigh Valley and, without question, are the heart and soul of the South Allentown community, and because of them and the work that they have done, the beautiful, picturesque Pates Park has been host to three national fastpitch softball tournaments.

From its humble beginnings, the Allentown Patriots have risen to become the mecca of fastpitch in the Lehigh Valley. Pates Park has hosted world-class women's fastpitch with teams such as Team USA, National Pro Fastpitch, and the Greek Olympic Team.

Equally as important is the contribution they have made to the youth in the area, providing them with an outlet for improving their athletic skills and learning the benefits of team competition. At Pates Park, some 450 games have been played in a single season. In its rich history, over 20,000 games have been played at this glorious park.

The SPEAKER. On that question, the Chair recognizes the gentleman, Mr. Schroder.

Mr. SCHRODER. Thank you, Mr. Speaker.

Mr. Speaker, this amendment is a very simple amendment in concept. It changes the name of this council to the Health Care Cost Research Council. Why do I want to make that change? Mr. Speaker, I think that name more accurately reflects the mission and the duties of this council. Right now it is called the Health Care Cost Containment Council, and I daresay that during its entire lifetime of existence, it has not contained one cent of health-care cost.

Now, it does some good research, I will admit that. So I believe that calling it the Health Care Cost Research Council is much more in keeping with its actual duties, much more reflective of what the true intent of this council is, and I believe is much more informative to the public about what the duties and true motivations of this council really are.

So I would ask for this really simple amendment, really a technical amendment, if you look at it. It is just a name change. So let us make this change and let us make sure that the public truly understands that this council cannot contain anything in and of itself. It just performs research. Thank you.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Delaware County, Representative Vitali.

Mr. VITALI. Thank you, Mr. Speaker.

Will the maker of the amendment stand for brief interrogation?

The SPEAKER. The gentleman indicates he will stand for interrogation. The gentleman may proceed.

Mr. VITALI. Thank you, Mr. Speaker.

I certainly understand the logic of what you are doing. I am just wondering, has the Cost Containment Council or any other group weighed in on this amendment?

Mr. SCHRODER. No. The amendment was filed timely and everything, but no communication has been made to me personally by any of those groups as to their position on this amendment. Whether they put something out there for general reading, I am not sure.

Mr. VITALI. Right. I have some concerns whenever you change the established name of anything on a number of grounds, and maybe you can help address them.

Well, maybe I will get to the minor point first. Just the cost of changing the various addresses, letterhead, anything else that might have the existing name, is there any cost associated with that?

Mr. SCHRODER. Can you hold for one second. Mr. VITALI. Okay.

(Conference held.)

Mr. SCHRODER. Mr. Speaker, as an interim answer, I can only conclude that if there is such a cost, it would be so explained in an Appropriations fiscal note, and that is what we are trying to determine.

Mr. VITALI. Oh, you know what? Do not spend too much time with it. I am sure the answer is going to be, it is small; there is some, but it is a small cost.

Now, my other concern here is just any confusion that results in changing names, because you have a certain body of people used to one name and they hear another name, and there is that possibility for confusion. Given there is this possibility for confusion, other than just the name sounding more logical, is there any other reason that you are doing this? I guess I am of the school that if something is not broke, do not fix it. So am I missing something? Is there some other reason other than to make this sound logical that you are doing this?

Mr. SCHRODER. I am not sure, first of all, that there would be much of any meaningful confusion that would result in this simple name change. I think the public deserves to have an accurate reflection of what the duties of this council are, and that is just really why I made the recommendation and offered the amendment.

Mr. VITALI. Okay. Thank you very much. That concludes my interrogation.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Allegheny, Representative DeLuca.

Mr. DeLUCA. Thank you, Mr. Speaker.

Would the gentleman stand for interrogation a little bit?

The SPEAKER. The gentleman indicates he will stand for interrogation. The gentleman may proceed.

Mr. DeLUCA. Thank you.

Now, I have worked with Representative Schroder for a long time, but this amendment here I do not understand. We have a successful council here, HC4, for the last 23 years. It is recognized throughout the country as one of the best. Other places have emulated that. To change that name is going to confuse a lot of individuals for no reason at all, unless you have some type of information where this council is not doing the job it should be doing, and if they are not doing the job they should be doing, it is a little our fault because we do not fund them to the extent they should be funded, because they do a great job on behalf of the citizens of the Commonwealth of Pennsylvania.

Not only that, we have to recognize, if it were not for them, we might not have had the best bill pertaining to hospital infection rates that myself and Senator Erickson worked on.

So I am just trying to understand how this could be better for the citizens of the Commonwealth of Pennsylvania to change their name.

And I guess the other thing I want to know about, I did not realize they did research. Maybe you can explain to me how they also do their research.

Mr. SCHRODER. Well, Mr. Speaker, as chair of the Insurance Committee, you know one of the functions that we often use them for is when, for political reasons, members of the Insurance Committee do not wish to take a stand on, let us say, a mandate issue, so in order to avoid making a tough political vote, we often punt the issue over to the Health Care Cost Containment Council. And why do we do that? So that they can do research on the cost of whatever the proposal is that we did not want to cast a "yes" or "no" vote on at the time in committee.

So I do not know, I must profess, I do not know how they do their research on it, but they do their research. We have relied upon it to occasionally make decisions on those mandate issues, and I believe it is a well-established understanding amongst all parties that research is really a collection of data, which I would include with research in the overall umbrella as that is understood.

So I am not quite sure if I am understanding your question totally, Mr. Speaker, but that would be my response, as I understand your question.

Mr. DeLUCA. Okay, Mr. Speaker. Unfortunately, I have to ask for a negative vote on this amendment. I know it has good intentions like the Representative always has good intentions with legislation, but unfortunately, I have to ask for a "no" vote on this amendment. Thank you very much, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman from Luzerne, the majority leader, Representative Eachus.

Mr. EACHUS. Thank you.
