Legendary coach Vince Lombardi once said, "...any man's finest hour, the greatest fulfillment of all that he holds dear, is the moment when he has worked his heart out in a good cause and lies exhausted on the field of battle – victorious." I know you have now experienced what Coach Lombardi described, but the details of that moment may fade. In years to come, you may forget the date or how much time was on the clock when those winning goals were scored.

Remember, you will only be high school athletes for a short time and then you will travel different roads. Maybe there are great college and professional athletes among you, but I am sure there are also great doctors, businessmen, and educators. Whatever road you travel, please remember to apply the same principles of dedication and teamwork that I am sure you have relied on throughout the season.

So again, congratulations to Latrobe on a job well done, and enjoy the rest of your day in your Capitol.

The SPEAKER. The Chair thanks the gentleman, Representative Reese, and now recognizes the gentleman from Westmoreland, Representative Petrarca.

Mr. PETRARCA. Thank you, Mr. Speaker.

I stood here last year welcoming the Latrobe Ice Cats to the State Capitol in what was their first State championship, and I was very impressed with the season that they had and the performances that they undertook last year. Little did I know that they would be back this year.

It is certainly a fantastic season, and all of us in the Latrobe area are proud of what they did, and I guess we look forward to seeing you here next year for the three-peat.

So with that, I would ask that you join me and my colleagues in giving the Latrobe Ice Cats a warm House welcome here and at the back of the House. Thank you.

The House will come to order.

## SPEAKER MICHAEL POLLEY PRESENTED

The SPEAKER. I have the distinct pleasure of introducing to the hall of the House a very special guest. We have a very special guest with us today, who traveled a very long distance to be with us. He is the Speaker of the House from Tasmania, the Tasmania House of Assembly.

I should tell you in conversing with the Speaker that we have a lot in common, both in Tasmania as it relates to Pennsylvania and both he and I personally. He was elected to the House of Assembly at the age of 22 like I was elected to this General Assembly. Although I was elected in 1982, he was elected in 1972 and has served 37 years in the House of Assembly. As such, he is the longest-serving Speaker of the House or of the Parliament in Tasmania. He was the youngest cabinet minister in Tasmanian history, appointed at the age of 27 years old. This is his second term as Speaker. He first served as Speaker in 1989, left the position, and then returned to Speaker in 1998, and has served ever since. He has served as Minister for Welfare, Land, Mines, National Parks and Wildlife. The similarity between Pennsylvania is uncanny; whereas mining, agriculture, and tourism are their top or primary industries, likewise in Pennsylvania, mining, agriculture, and tourism are the same thing.

The country is governed according to the principles of the Westminster system, a form of parliamentary government based on the model of the United Kingdom. There are three branches of government: the Crown, represented by the Governor of Tasmania, and the two Houses of Parliament, the Tasmanian Legislative Council and the Tasmanian House of Assembly.

It is with great pleasure that I present to you the Speaker of the House of Assembly, Mike Polley. Mike.

Mr. POLLEY. Thank you. Thank you very much for that warm welcome.

Mr. Speaker, the only thing I can advise you to do when you have served 37 years, as I have done in the House – I face my 12th election for a 4-year term in March of next year – when I was first elected in '72, I used the slogan "Tasmania Needs Youth." Now at 59 my slogan is "Tasmania Needs Experience."

And what I do want to say today – and it is particularly an honor for me to be asked to address this chamber of Pennsylvania. Most of you probably would not realize that the Australian Constitution was modeled on the American Constitution, and in fact, there was an American who was one of our founding fathers in 1901. In 1901 we federated the States of Australia into one country to make Australia. His name was King O'Malley, and he came, of course, from Kansas. He was born in Kansas. He stood for the Federal Parliament, would become one of the founding fathers and an architect, of course, of our Constitution, and that is why the Constitution of Australia is so similar to yours, and it stood as well now for the last 108 years.

But the other reason why I am particularly pleased to be addressing you today as a visitor from Australia is to say, on behalf of the Australian nation, a big thank-you not only to the State of Pennsylvania but also to America for its great, close alliance with Australia. Australia has had a close alliance since the Second World War when we turned to the United States of America when we ourselves were under attack, of course, as you were at Pearl Harbor. And by coming together, and particularly with the support and leadership of a great American by the name of Gen. Douglas MacArthur, we were able to protect our nation of Australia and eventually, of course, triumph as far as freedom was concerned and the protection of our way of life because of the American people.

A large number of Pennsylvanian young men and women perished in that war, as they have done since that war, and it so happens that this coming Saturday, when I return to Australia, it is the national Day of Mourning, when we remember all the fallen that defended our democracy since the birth of our nation, into the federation in 1901, and before that when we were an English colony. We will have memorial services throughout our land, and in that, we will commemorate, as we do every year led by those people who represent your country - your Ambassador and your consul generals - across Australia in that memorial day when we will remember those fighting men and women who perished in our defense. That is why, since the Second World War, Australia has become very close to the United States of America regardless of who happens to be occupying the White House. We have had that ongoing, strong relationship, and at this time we are in Afghanistan and Iraq as we were in Vietnam and Korea.

And the other thing I just want to say, in conclusion, is this: every time I meet an American, including here today, people say to me, is there a Tasmanian devil? Well, I can confirm to you, there is a Tasmanian devil. There has always been a Tasmanian devil. It is a very vicious animal. It is roughly about that long and about that high, and it is a scavenger, and it is something that everybody seems to know Tasmania by, which is one of the smallest States of the federation of Australia.

The other thing, in conclusion, I just want to say, may God bless Pennsylvania, may God bless America, and thank you very much.

And we could thank, I guess, Looney Tunes and Bugs Bunny for giving us the story of the Tasmanian devil, but that is how our history with the Tasmanian devil, I think with all of our members, and the knowledge of that scavenger came to be.

Mr. ROEBUCK. Thank you, Mr. Speaker.

I just wanted to make some very brief remarks in reference to this resolution. I want to, in doing this, recognize the very dynamic and energetic leadership of Constantine Papadakis, who served as president of Drexel University from the middle 1990s.

Taki, as he was called, took Drexel from a point of mere collapse and brought it to a high level of excellence. Under his leadership, the enrollment of the university expanded. The university embarked upon major construction projects. He added to the university a new medical school, he added to the university a new law school, and he also expanded the university beyond the Commonwealth by creating a Drexel campus in California.

He was an outgoing, warm individual who made you really feel that he cared about you. He was the kind of person who engaged you, who had the energy and the commitment to put together the necessary resources to do great things, and I think that under his leadership you saw much more of Drexel leadership and presence here in Harrisburg. He was a frequent visitor to the Capitol. He positioned the university in many of the dialogues about education in the Commonwealth.

He was a man of vision. If I might paraphrase the poet who said, some men see things as they are and ask why? Taki dreamed of things that never were and asked, why not?

He will be greatly missed. Certainly, I will miss his friendship and his leadership, and I would ask that this body might commemorate his excellent life by adopting this resolution.

Dr. Papadakis came from out of New York. He was a gentleman that Pennsylvanians will miss. He was a gentleman that mastered the higher education of not only this State but this country.

We should, all of us, take a page out of his book for his dedication, his belief, not only in his fellow man but his family. He will be one person that will be highly missed, and I would hope that we, and I am sure we all will, adopt this resolution. Thank you, Mr. Speaker.
