A Resolution honoring the memory of law enforcement officers who gave their lives in the line of duty in this Commonwealth and recognizing the memorial service in their honor in Soldiers' Grove at the State Capitol Complex on May 4, 2009.

The Chair recognizes the gentleman from Blair County, Representative Stern.

Mr. STERN. Thank you, Mr. Speaker.

Good morning.

This resolution honors the memory of law enforcement officers who gave their lives in the line of duty in this Commonwealth in the preceding year of 2008.

Recent events with the tragic loss of three police officers in Pittsburgh have prompted the Governor and others to call for changes in gun legislation. A recent event in the Capitol recognized the rights of citizens to bear arms.

I respectfully ask my colleagues today to keep those issues for another day when we can debate and discuss the merits of legislation related to guns, when we can debate suitable punishment for those convicted of crimes against police officers or against completely innocent bystanders.

Today, though, is a solemn day, a day of remembrance, a day of reflection on the memory of these brave officers who dressed one morning to go to work and protect their communities but never came home to their loved ones.

From the Officer Down Memorial Page, I would like to read a list of officers.

Sgt. Stephen Liczbinski was shot and killed while responding to a bank robbery call on May 3, 2008. Sergeant Liczbinski had served with the Philadelphia Police Department for 12 years. He is survived by his wife and three children.

Six months later, on November 17, 2008, Sergeant Liczbinski's former patrol partner, Sgt. Timothy Simpson, was killed when his patrol car was struck by a vehicle being operated by an intoxicated driver. Sergeant Simpson had served with the Philadelphia Police Department for 20 years and is survived by his wife and three children. He was assigned to the 24th District.

Police Officer Isabel Nazario was killed when her patrol car was struck by a stolen SUV (sport utility vehicle) on September 5, 2008. Police Officer Nazario had served with the Philadelphia Police Department for 18 years and was assigned to the Narcotics Strike Force and detailed to the 16th Police District in West Philadelphia. She is survived by her daughter, fiancé, mother, and sister.

Sgt. Michael Weigand was killed in a motorcycle accident while escorting a benefit ride involving the Blue Knights Motorcycle Club on September 14, 2008. Sergeant Weigand had served as a part-time sergeant with the Latimore Township Police Department for 6 years. He also served full time with the Eastern Adams Regional Police Department. He is survived by his wife, 4-year-old daughter, and his parents. His father serves as the agency's police chief.

Sgt. Patrick McDonald was shot and killed after pulling over a vehicle on September 23, 2008. The suspect, who was on parole, having been released from prison just 2 weeks prior to the incident, was wanted for assaulting several police officers 2 days prior. At the time he was killed, Sergeant McDonald was about to be promoted to sergeant and was posthumously promoted to the rank of sergeant at his funeral by the police commissioner. Police Officer Patrick McDonald had served with the Philadelphia Police Department for 8 years and was assigned to the highway patrol.

On October 21, 2008, Officer David Tome was struck and killed by the driver of a vehicle while investigating a fatal accident that had occurred earlier in the week. Despite having cones set out to close a lane of traffic, Officer Tome was struck by an SUV and killed instantly. Officer Tome had served with the Northern York County Regional Police Department for 5 1/2 years. He is survived by his wife and two children.

Officer Nathaniel Burnfield was struck and killed by the driver of a dump truck while assisting at the scene of an accident on November 4, 2008. Officer Burnfield had served with the South Strabane Township Police Department for 5 years. He is survived by his parents and two brothers.

And finally, Special Agent Samuel Hicks, assigned to the Pittsburgh FBI Office, was fatally shot on November 19, 2008, while executing a Federal search warrant associated with a drug distribution ring. Special Agent Hicks joined the FBI in March 2007 and is survived by his wife and 2-year-old son.

Thank you, Mr. Speaker, and I would respectfully ask the members to support HR 252 in memory of these brave police officers and their families. Thank you.

A Resolution recognizing the heroism of Philadelphia Police Sergeant Stephen Liczbinski, who, while in the service of the City of Philadelphia, paid the ultimate sacrifice in the line of duty on May 3, 2008, when he was tragically killed while pursuing bank robbers.

On the question,

Will the House adopt the resolution?

The SPEAKER. The Chair recognizes the gentleman from Philadelphia County, Representative Boyle.

Mr. BOYLE. Thank you, Mr. Speaker.

Today I rise to ask for your support in honoring Philadelphia Police Sgt. Stephen Liczbinski, who was killed in the line of duty while pursuing bank robbers on May 3, 2008.

While responding to a bank robbery call, the sergeant was shot several times by a suspect as he exited his patrol car and passed away later at the hospital at the age of 39.

Sergeant Liczbinski served the Philadelphia Police Department faithfully for 12 years, leaving behind his legacy as a cop's cop. His colleagues respected his willingness to go above and beyond his duties to get the job done right. And in an honor befitting a cop's cop, the police department retired the sergeant's police badge No. 468.

As you may recall, this resolution was originally introduced last session by Representative Kenney along with Representative John Taylor, but the session ended before the resolution was brought for a vote.

GUESTS INTRODUCED

Mr. BOYLE. I believe that we owe Sergeant Liczbinski's family and his memory a symbol of our respect, appreciation, and deepest sympathy by honoring him today with this resolution, and we are honored, Mr. Speaker, to have in the hall of the House a few special guests from my district, including two of the family members of Sergeant Liczbinski.

Please welcome his wife, Michele, and their daughter, Amber.

We are also privileged to be joined by a few of Philadelphia's finest: from the F.O.P. (Fraternal Order of Police), Roosevelt Poplar, and Officers Gary Harkins, Tom Hoban, and Brian Leventhal. Thank you.

Mr. Speaker, on this resolution, I respectfully ask for an affirmative vote. Thank you.

I would just like to add that this Sunday, May 3, at the intersection of Almond and Schiller Streets in Port Richmond, neighbors will gather to remember the sacrifice of Sergeant Liczbinski and to thank his family. They will represent the entire Port Richmond community in saying thanks as well as the city of Philadelphia.

There is also another significant point about their gathering that should be brought up here, and that is the outpouring of support that occurred by those neighbors immediately after the shooting of Sergeant Liczbinski. As many as one dozen neighbors immediately came to his aid and tried to support him as best they could, in spite of the fact that the assailants were still in the vicinity and had been brandishing assault weapons.

So they should be remembered as well, and we did have their names— There were a lot of folks that rendered aid that were passing by that we do not have their full names, so I think it is best to just say that those neighbors came to his aid and should be commended.

But more importantly, they all appreciated Sergeant Liczbinski's work in that community. He was not only a soldier for that community but a community-relations type of officer as well. So he had both the ability to listen to neighbors, to service them in hearing their complaints, but also take on the tough missions, which he did that day.

So we thank him and thank the family for being here today.

The SPEAKER. In the balcony the Chair welcomes the St. Charles Borromeo grade school. They are the guests of Representative DiGirolamo. Will the guests please rise. Welcome to the hall of the House.

RESOLUTION

Mr. HORNAMAN called up HR 139, PN 997, entitled:

A Resolution memorializing Congress to conduct a full and complete investigation into all foreign and domestic factors affecting gasoline and diesel fuel prices in the United States.

On the question,

Will the House adopt the resolution?

The SPEAKER. On the question, the Chair recognizes the gentleman from Erie County, Representative Hornaman.

Mr. HORNAMAN. Thank you, Mr. Speaker.

Mr. Speaker, since December of 2007, we have been witness to a high degree of economic turmoil in the banking industry, the mortgage industry, the auto industry, and of course, the oil industry. I am here today to ask your help in addressing one of these – the oil industry.

We have all felt that uneasiness, that feeling that something just is not right when we observe the fluctuations of gasoline prices at our favorite gas station. Well, we are certainly not alone. The man and woman on the street come to me and say, "Hey, oil dropped \$6 a barrel and our gasoline went up 10 cents a gallon." I have also heard, "When oil was \$147 a barrel, we paid \$4.11 for a gallon of gasoline. When oil dropped to \$34 a barrel, we should have been paying less than \$1 a gallon, not \$1.95. Do the math."

It seems to me that the tried-and-true economic laws of supply and demand have left the building and that we are at the mercy of the whims of the movers and shakers of this market, an unseen force that twists reality and arbitrarily sets gasoline prices.

At this moment we find ourselves in a little bit of a lull. Gasoline has dropped way back from that \$4-a-gallon mark, and consumers are sensing some relief. But in reality, there is no relief. We have no idea when the next price spike will come, because even the best economic prognosticators have absolutely no way to predict prices, because these prices show no connection to market forces.

Pennsylvania has been at the forefront of pioneering the movement to clean, renewable alternative energy, and I am very proud to be a part of that energy plan. But we must realize that while this transition is taking place, oil is still our country's lifeblood, and it is a highly strategic commodity.

Furthermore, it is going to be very difficult to recover from this recession if one of the key economic pieces remains so volatile. Government cannot budget; business cannot budget; heck, we cannot budget until there is some stability in the liquid fuels market.

We certainly feel that there is some manipulation going on here, and international experts from such authorities as Japan's Energy Data Center and the University of Texas Center for Energy Economics agree that excessive energy speculation artificially elevates energy prices. So what do we do about it? Previous hearings held by the Congress of the United States investigated the causes of volatile and record-high fuel prices, but after talking about it, they got up from the table and walked away without producing an adequate national strategy to address the factors that control those prices or a plan to control the speculation.

Therefore, in HR 139 I am calling on Congress to go back to the table. Do not wait for the next energy earthquake that is going to send us back to that \$4-a-gallon twilight zone. Investigate the speculation, the manipulation, the pricing disparities, and provide us with a plan, a national energy strategy, that will address those forces that cause fuel prices to move contrary to the normal forces of supply and demand. Bring predictability back to this market.

Mr. Speaker, I ask your assistance today. Let us remind Congress that it needs to help America get back on its feet by formulating a well-thought-out and strong national energy strategy that will eliminate the ugly manipulation of the oil and gasoline market that leaves us all reeling.

Thank you.

The SPEAKER. The Chair thanks the gentleman.

On the question before the House, the Chair recognizes the gentleman from Bucks, Representative Clymer.

Mr. CLYMER. Thank you, Mr. Speaker.

And I could not agree more with the last speaker that oil is indeed our country's lifeblood, and this economic engine will need fossil fuel within the foreseeable future, even though we have alternative energies.

But here is my point: I hope when this study is done, if it is done at the national level, that they will consider that here in the United States we have 16 billion barrels of oil, a known reserve right here in the continental United States, not to mention trillions of cubic feet of gas that can be produced, and yet it sits there as though it has not been discovered.

And, Mr. Speaker, why is this so important? Because in our national strategy, as the speaker just mentioned, in our national strategy we need this oil for a number of reasons – to begin to do the drilling and the discovery and rediscover this oil.

Number one, it will reduce the \$7 billion deficit we have with foreign countries from whom we import oil. We take a risk every day by not taking this oil from our own country but those rogue nations that we import from, who import simply because they want our moneys. And it is a national defense issue, not to mention that the drilling and discovering the oil and the gas that we have here in the United States is an economic stimulus plan as well, putting to work hundreds of workers – union workers, I might add – in doing the drilling for the oil and for the natural gas.

So I can support this amendment very handily. I would mention one thing, though, and that is, the Obama administration says they will not drill and they will not look to discover the oil that is in Alaska or off the Gulf Coast. Now, that makes it a problem in this whole national strategy. But nevertheless, even though those decisions have been made by the present administration, I will support this resolution, because it does seek to resolve a growing issue, and that is national security and oil here in the United States.

Amend Bill, page 1, line 26; page 2, lines 1 and 2, by striking out all of said lines on said pages and inserting

Section 1. Sections 202 and 1104 of the act of May 15, 1933 (P.L.565, No.111), known as the Department of Banking Code, amended or added December 9, 2002 (P.L.1604, No.209), are amended to read:

Section 202. General Scope of Supervision; Exercise of Discretion.–A. In addition to the powers and duties provided for in this act, the department shall exercise any power and fulfill any duty imposed upon it by any other law of this Commonwealth. Except where otherwise specifically provided, the department shall enforce and administer all laws of this Commonwealth which relate to any institution, and shall exercise such general supervision over institutions as will afford the greatest possible safety to depositors, other creditors, and shareholders thereof, ensure the safe and sound conduct of the business of such institutions, and protect the public interest.

B. Whenever under this act, discretion is vested in the department or any board thereof as to whether, or the manner in which, to exercise a power or fulfill a duty, the department shall, after such examination or investigation as it shall deem appropriate under the circumstances, exercise such discretion in such a manner as it shall deem necessary to ensure the safe and sound conduct of the business of any institution subject to its supervision, conserve its assets, maintain public confidence in the business of such institutions and protect the public interest and the interest of depositors, other creditors and shareholders thereof.

C. The department may promulgate such rules and regulations necessary and appropriate to administer this act. In those instances in which the department is granted the power to regulate a matter under this or any other act and that grant of power requires the department to further define its duties under that act, the department shall do so expeditiously and with concern for both the regulated entities and the consumers that the act intends to protect.

D. The department may issue statements of policy and interpretive letters necessary and appropriate to administer this act or any other statute within the department's jurisdiction to administer or enforce.

E. Notwithstanding any other law or provision of this act, the department may require licensees to use and to pay processing fees for using a national electronic licensing system in order to apply for or renew licenses issued pursuant to any statute within the jurisdiction of the department to enforce. Notwithstanding any other law, the department may modify, by publication of a notice in the Pennsylvania Bulletin, license renewal and reporting dates for any licensees subject to this subsection that are inconsistent with the use of a national electronic licensing system. The department is not authorized to require a person or corporation which would otherwise be totally exempt from licensure pursuant to any statute under the department's jurisdiction to submit information to or participate in any national electronic licensing system.
