Molly is vice president of the school's show choir, a member of drama club, and one of eight Pennsylvania representatives to the International Thespian Society State Conference. ARCHBISHOP JOHN CARROLL HIGH SCHOOL BOYS AND GIRLS BASKETBALL TEAMS PRESENTED

The SPEAKER. The Chair recognizes the gentleman from Delaware County, Representative Adolph, for the purpose of a presentation.

Mr. ADOLPH. Thank you, Mr. Speaker.

Mr. Speaker, good afternoon. It gives me great pleasure today to welcome to the hall of the House some outstanding student athletes from Delaware County, the Archbishop John Carroll High School Boys and Girls Basketball Teams.

The teams each captured their respective 2008-2009 PIAA Class AAA State Championship titles this year. I cannot tell you how proud we are of them.

The boys team won its title after beating Greensburg Salem 75-54 in the championship game, resulting in an overall record of 27 wins and 3 losses.

The girls won their championship title following a victory over Lampeter-Strasburg 68-45, for a season-ending record of 30 wins and 1 loss. I know my good friend, Scott Boyd, from Lancaster County is still suffering over that embarrassing loss.

Not only did the teams win their respective championships, but they also made history by becoming only the seventh school in PIAA history to win both the girls and boys State titles in the same season. In addition, they became the first Philadelphia Catholic League squads to win State titles and the first District 12 teams to win Class AAA State titles.

In addition to their achievements on the court, these young men and women have proven themselves to be excellent students who do a great job balancing their athletics, academics, and extracurricular activities. All those in the 165th Legislative District are very proud of them.

Of course, these two teams did not get here by themselves. The boys were led by head coach Paul Romanczuk and the girls by head coach Chuck Creighton. In addition, both teams had the guidance of an outstanding coaching staff. Without these great coaches, Carroll would not have had the great season it enjoyed this past year.

With me at the rostrum today, representing the girls championship team are coach Chuck Creighton, Kerri Shields, Hollie Mershon, and Kaitlin Cole. The boys championship team is coached by Paul Romanczuk, and he is joined with seniors Andre Wilburn and Pat Daly, and the president of Archbishop Carroll, Father Bill Grogan. In the back, if you would stand, boys and girls State champions, Archbishop Carroll boys and girls, along with their athletic director, Fran Murphy. Please give them a round of applause.

CENTRAL DAUPHIN HIGH SCHOOL WRESTLING TEAM PRESENTED

The SPEAKER. The Chair recognizes the gentleman from Dauphin County, Representative Marsico, for the purpose of a presentation.

Representative Eachus, do you want to approach the dais. We have got some wrestlers up here that know your son.

Mr. MARSICO. Thank you, Mr. Speaker.

I would like to welcome the Central Dauphin High School Wrestling Team to the hall of the House. They are joining us today so that we may honor them for their State championship wins in both the 2008-2009 PIAA State Class AAA Team Wrestling Championship and in the team standings of the 2008-2009 PIAA State Class AAA Individual Wrestling Championship.

Mr. Speaker, joining me at the podium are head coach Jeff Sweigard, State champion Tony Dallago, State champion Marshall Peppelman, senior Simon Rice, senior Kenny Stank, and the Peppelman family wrestling adviser, Representative Todd Eachus. Is that correct? How did you get that job anyway?

The Rams finished their stellar season with an overall undefeated record of 17 wins and 0 losses. Ranked third in the

nation, first in the nation in public schools, the team also won the Mid-Penn Commonwealth Team Championship, the Power Ade Tournament Team Championship, the Top Hat Tournament Team Championship, and placed third in Beast of the East.

Like I said, we are here to honor the team, but we also want to honor coach Jeff Sweigard for being named the "National Wrestling Coach of the Year" by the National High School Coaches Association. This indeed is considered one of the country's top honors for scholastic coaches. Coach Sweigard is also a Central Dauphin High School graduate and began coaching at his alma mater 15 years ago.

Under Coach Sweigard's direction, the Central Dauphin Wrestling Team has won an unprecedented five, that is five consecutive PIAA team titles. On top of that, he has produced 58 section champions; 22 district champions, including a District 3 record, 8 this season; 55 PIAA qualifiers; 39 PIAA medalists; and 6 PIAA champions, including 2 behind me that we are honoring here today, State champion junior Marshall Peppelman and also senior Tony Dallago.

At this time I would like to recognize the wrestling team and their coaches and parents in the rear of the hall. Would you please give them applause.

A Resolution expressing condolences upon the death of Police Officer Richard Matthews, a heroic son of Pennsylvania, who died in the line of duty in Wilmington, North Carolina, on February 18, 2009.

On the question,

Will the House adopt the resolution?

The SPEAKER. The Chair recognizes the gentleman from Northampton County, Representative Dally, on the question.

Mr. DALLY. Thank you, Mr. Speaker.

Today, Mr. Speaker, I am urging you to support the passage of HR 213, which honors the life of Police Officer Richard Matthews, who served the Wilmington, North Carolina, police department with great distinction.

Officer Matthews's parents are Dennis and Margaret Matthews of Hanover Township in Northampton County, which is in my legislative district.

Richard wanted to be a policeman from the time he was a student at Liberty High School in Bethlehem. In 2006, after serving with the New York City Police Department for 2 years, Officer Matthews was hired by Wilmington, a city of 82,000 people between the Cape Fear River and the Atlantic Ocean. He was popular with his colleagues, and he received a commendation for carrying a 96-year-old woman to safety from a burning building.

On the morning of February 18, 2009, Officer Matthews died from injuries he sustained in a crash he was involved in when assisting fellow officers who were attempting to apprehend drug suspects. He was the first Wilmington police officer killed in the line of duty in more than 30 years. Officers from numerous law enforcement agencies attended a memorial service in Wilmington for Officer Matthews.

His neighbors from the Lehigh Valley were very saddened to learn of his tragic death but very proud that he was a native son of Pennsylvania.

Mr. Speaker, police departments in Pennsylvania have been struck by tragedy all too often in recent years, witnessed the loss of three police officers in Pittsburgh and one in Philadelphia just this year.

Tonight I ask you to join me in expressing our condolences to the family of Officer Matthews and in supporting this resolution honoring his life.

Mr. J. EVANS. Thank you, Mr. Speaker.

To help encourage the learning of American Sign Language, I have sponsored this resolution to encourage higher education institutions to consider sign language coursework as foreign language credit. High schools in Pennsylvania consider American Sign Language courses to count toward foreign language credits, and it only makes sense to encourage colleges and universities that receive State funding to use the same consideration. Not only will this make it easier for students who are trained in sign language to complete their college educations, but I believe it will encourage others to learn the sophisticated technique and increase communication to the hearing-impaired community.

American Sign Language, the third most communicated language in the United States other than English, is defined in State law as the complete and autonomous human language with its own unique grammar frequently used in the form of communication by the hearing-impaired communities.

One of the most critical skills necessary to thrive in today's global marketplace is that of communications. Whether it is English, a foreign language, or American Sign Language, our students must have the wherewithal and skills to approach their careers through several avenues of communication.

There is a significant and growing need for interpreters and transliterators, and the legislatures of 40 States have formally recognized ASL as a foreign language.

Once passed, HR 91 will be sent to the presidents of higher education institutions that receive State funding, including the State System of Higher Education and State-related schools such as the University of Pittsburgh, Lincoln University, Temple University, and Penn State University.

I urge your positive vote for HR 91. Thank you, Mr. Speaker.
