For those of you who are familiar with the sport of hockey, you know that it was Ed Snider who in 1966 used his home as collateral to create the Philadelphia Flyers.

After the creation of the Flyers, he then used that as the impetus for the creation of the preeminent sports and entertainment organization in the world, and I am speaking of none other than Comcast Spectacor.

Now, while the success of the Flyers and Comcast Spectacor speaks to the entrepreneurial spirit and success of Mr. Snider, I believe that his true vision was established in 2005 when he created the Ed Snider Youth Hockey Foundation.

You know, the city of Philadelphia, like many other States and municipalities across this nation, were faced and are faced with dire constraints as it relates to the budget, and with that in mind, the administration of the city of Philadelphia was strongly considering closing several of the ice hockey rinks in the city of Philadelphia.

Well, thanks to the likes of the Ed Snider Hockey Foundation, the Tarken Recreation Center; the Skatehouse in northeast Philadelphia; one that I feel particularly fond of and that is the Simons Recreation Center, which is in the West Oak Lane community that I was reared in, are all home to the Ed Snider Youth Hockey Foundation and their efforts to support young people.

Now, if we would have the opportunity to Google the foundation, it could be noted that although hockey is just the

hook for this organization, the organization teaches young people in inner cities life skills. It also teaches them to be competitive and also to know the importance of making sure that they strive extremely hard for academic success.

I am proud, Mr. Speaker, to note that during this spring break, the Easter break when many young people were on vacation, I had the opportunity to visit the young people of the Ed Snider Hockey Foundation, and there were about 60 young people in the room and there were 3 things that came to my mind. The first was that this was not only one of the most ethnically diverse groups that I had ever seen before, it was also diverse as it relates to gender.

Ladies, I have to be very honest and tell you that prior to the Ed Snider Foundation coming to the recreation center in my neighborhood, I knew very little about the sport of hockey. In my mind, if it was not basketball, baseball, or track and field, was it really a sport? I am pleased to note that the foundation even has a very specific course that it has planned just for girls, to teach young girls the game of hockey.

#### **GUESTS INTRODUCED**

Miss PARKER. And while I will ask for your affirmative support on this resolution, I want to just recognize for the record some of our guests who have joined us.

Maria Leonetti, who is the finance and development manager. Will you stand up? She is in the rear.

And now I want you to meet the dynamic young people I had the opportunity to interact with during the Easter vacation: Lewis Nelson, Jerame Nelson, Karissa Kendricks, Gabriel Hall-Jackson, and Gillian Jackson. Will you please stand and be recognized? The future of hockey and excellence. Please give these young people a round of applause.

I know we are not all Phillies fans because we come from different parts of the State, but the Commonwealth has been having a great year with the national championship World Series Phillies last year and the Pittsburgh Steelers, and soon to be, I am sure the Penguins are going to pull it out as well.

But as a favor to the memory of a great man, Harry Kalas – and I can tell you, he was a great man, having gotten to know him personally – can we all put our hats on for a visual so the folks back home can see how much we care about Harry Kalas and all the great things he did for not just Philadelphia but the State of Pennsylvania?

Thanks guys, gals. Everybody is going to have hat hair.

The SPEAKER. I just feel sorry for Joe Maddon, whom we invited here and ironically, we have this resolution today.

Mr. KILLION. Mr. Speaker, I rise today to present a resolution honoring the life of Harry Kalas, a resident of the 168th Legislative District for more than 20 years and better known to most of us here as the voice of the Philadelphia Phillies.

A native of Illinois, Harry's passion for baseball led him to a broadcasting career that spanned 44 years. He joined the Philadelphia Phillies organization in 1971, and throughout his 38 years in Philadelphia, he became one of the most recognizable voices in all of baseball.

His strong voice also caught the attention of NFL (National Football League) films, which enlisted Harry to provide their voice-over. Harry was also a regular on "Inside the NFL."

Harry Kalas moved to the Media area of Delaware County about 20 years ago, where he quickly became active in community and charitable events. He attended opening day ceremonies for youth baseball and emceed the annual Veterans Day Parade in Media for 20 years, and that is where I had the great fortune of meeting Harry 15 years ago.

He was always willing to lend his celebrity and wonderful voice to charitable events. He gave freely of his time, and I have to emphasize "freely." He never asked for anything in return. You cannot imagine how exciting it was for those Boy Scouts and Girl Scouts and Little League teams when they got their names announced, as they marched in that parade, by the voice of Harry Kalas, and he did that year in and year out, not just at that event but at many events.

One thing that always impressed me about Harry is that for all his fame and success, he never forgot the people of Delaware County. He was a very affable and gracious man who seemed as comfortable in a crowd as he was in the broadcast booth. He was generous, down-to-earth, and enormously talented.

Harry Kalas lived in Upper Providence Township and spent the better part of his life as a member of the Philadelphia Phillies family. He died last month in Washington, DC, as he was preparing for the Phillies series opener against the Washington Nationals. He was 73.

#### **GUEST INTRODUCED**

Mr. KILLION. Joining us today, to the left of the Speaker, is Harry's good friend and founder of the Media veterans parade, a Vietnam veteran, Mayor Bob McMahon. Could we give Bob a hand.

Today I am presenting HR 310 honoring the life of Harry Kalas and expressing heartfelt condolences to his family on behalf of this entire body. I respectfully ask for your support. Thank you.

The Chair will deviate just a bit just to really say that the Phillies family, as well as the game of baseball, really lost a legend when Harry Kalas passed away, and it is really hard to imagine a team going from such an extraordinary high in winning the World Series to hit such a great low with the loss of Harry Kalas.

I think every one of us in this room is just delighted that he was able to call that 2008 World Series, and I think all of us in this room will also agree that he was truly a broadcaster's broadcaster, and I know he took his microphone with him.

#### JOE MADDON PRESENTED

#### **GUESTS INTRODUCED**

His mom, Beanie, is here today; his sister, Carmine. We have Richie Palermo, a good friend of the family with him; and Rick Vaughn from the Tampa Bay Rays, who is traveling with the coach today. Thank you for coming to the House. And kudos to Chris, the driver today. Chris, thanks for getting them here.

Let me just say a quick word about Mom. Beanie and her family have a great restaurant in Hazleton called the Third Base Dugout restaurant. We all call it The Base in Hazleton. They have got some of the finest hoagies around the region. So, Mom, thanks for your work in feeding the Hazleton area for all those years, you and your family.

Let me just say, Joe has had a storied career. He started out – you know you love baseball when you are willing to go to Idaho Falls in the minor leagues and coach in 1981. He was with the California Angels organization for 31 years. He has worked his way up from, I guess, sweeping the floors in the minor leagues to the top of the American League, Coach of the Year award. He kind of reminds us of the way we work in Hazleton: Hard work starts in small towns like ours.

He has also worked under Mike Scioscia as the bench coach for the Angels and got his shot only a few seasons ago and took the Rays to an extraordinary game that we all watched closely, a series of games; an amazing hitting feat by his club to get there, an offense led by a group of young men who are paid just 29th out of 30 in teams in the entire league. So we will be vying for those guys. It is pretty cool to be able to pull a group of young guys together like that.

It is a great honor to have Coach Maddon with us today. And just a moment to take a little pride in our own hometown: He does not forget where he comes from. He is a great guy; he is one of us, and if we can just one more time give him a round of applause. Joe.

The SPEAKER. We certainly welcome Coach Maddon to the floor of the House. I certainly give the coach a lot of credit for coming to somewhat hostile territory here in Pennsylvania.

But there is no question about it that if you have followed Joe's career, he is a baseball lifer. He was a great catcher, and we all know that catchers are really the quarterbacks of the baseball diamond. And most of the great coaches actually came from the catcher's spot in baseball. Mr. MADDON. First of all, thank you so much for this tremendous honor. When I was told of it several months ago, I definitely wanted to be able to auger out the time to come on up here. The fact that we are playing Baltimore right now made it somewhat easier. I did not realize I was going to be walking into a room of red hats, though. It kind of reminds me of Citizens Park last year during the fall; that was quite an experience.

But I am glad you were able to recognize my mom and my sister, and also R.V. and my old buddy, Richie Palermo. It is really quite an honor to have this bestowed upon me. My family – my wife, Jaye, is out in California right now. My kids are in Arizona, so they could not be here, obviously. But to be able to come back under these circumstances; I think I was here in 1969 with D.A. Harman, ninth grade. Mr. Stanziola, our civics teacher, would always get us to get out and get involved and got us a tour of the Capitol that particular time. I remember it briefly, but not this elegant, opulent room. It is absolutely fantastic.

But again, thank you for having us down here. Thank you for having me here and giving me this opportunity. I will treasure this forever. And if you are ever in our area – we are playing the Orioles tonight; we come back into town one more time this year, or any time on the road – if you are down in the Tampa area, St. Petersburg, make sure you come on in to see us. Mr. MYERS. Thank you, Mr. Speaker.

Mr. Speaker, today I would like to recognize one of the charter schools that is in my district, and the unique thing about it, many of you remember the fight that took place in this House over should there or should there not be charter schools? And often when you hear news from Philadelphia, 6 o'clock in the morning, it is not such a good thing.

Well, today with my colleagues Cherelle Parker, Mark Cohen, Rosita Youngblood, Dwight Evans, because all of us have children that go to this charter school. It is a new charter school. Ninety percent of their graduates go on to higher education. And the great thing about it is that they take kids from the neighborhood, and when I say from the neighborhood, I mean from the "neighborhood." They educate these kids and they give them a focus, a direction, a commitment, a dedication, an awareness, a conscience, a value system, character.

I am proud of these young people. I am proud of them because, number one, they are scholastically superior. Secondly, this charter school has a better grade average than most of the city public schools.

But I have to say, I want to talk about why they are here today. Their basketball team, which I play with – I mean, play on. Of course, you all know I am joking about that, right? They are the winners of the city's AA championship. They are the winners of the PIAA AA State Championship. They are ranked in the 30s in the nation; the first time ever done, not only in the city of Philadelphia but through the charter school circuit.

# **GUESTS INTRODUCED**

Mr. MYERS. I want to give some recognition to some of the people that put this charter school together, because it was not an easy thing, believe me; it was not an easy thing. There was pushback from the unions, pushback from the teachers. Why are you taking kids just out of the neighborhood? Why are you not trying to cherry-pick the students? What are you going to do with these kids with all these class and socioeconomic barriers?

The CEO and founder, Christine Wiggins.

Dr. Samuel Quartey, the board president.

Andre, raise your hand. Raise your hand high. The head coach. You look like a kid. I remember in some of the speeches I heard earlier today, he was talking about in 1969 when he first got started and looked young. I am not talking about me, because in '69 I was in the Navy. But that is the head coach.

Listen to this. The seniors: Parrish Grant, going on to higher education; Sam Prescott, accepted at Marist College; Will Adams, Towson University in Baltimore County; Ivory Wells III, Kutztown University; Kenneth Battle, Kutztown University; Tyree Morgan, my alma mater, Lincoln University; Saledeem Major, Kutztown University. Those are the seniors.

With scholarship money, I was just told. Academic scholarships, not basketball scholarships, academic scholarships.

So I would just like to say this here in closing: For those of you who do not believe it can be done. For those of you who may question, can we do it? For those of you that have hesitation and say that children from inner-city Philadelphia cannot, will not, shall not learn, here is a true example right in front of you. Look behind you. Everybody from Imhotep, stand up. Let us give them a big round of applause.

So in closing, I would just like to say to my colleagues on both sides of the aisle, because this was not really a Republican or a Democratic issue; this was an educational issue, an issue about educating our children, seeing how far we can move them, to what length, width, breadth, height they can achieve.

Again, I want to thank you young people for all that you have done and for all that you are going to do and for all that we are going to remember when you become oldheads like us, that we were there when you were there.

Again, I would like to give them another warm welcome to the House of Representatives, and thank you for your time.

# Mr. KAUFFMAN called up HR 295, PN 1782, entitled:

A Resolution recognizing with sadness the supreme sacrifice of Private First Class Aaron M. Genevie, who died on April 16, 2007, from wounds sustained when his Humvee struck an improvised explosive device while he was courageously serving our nation in Iraq.

On the question, Will the House adopt the resolution?

The SPEAKER. On the question, the Chair recognizes the gentleman from Franklin County, Representative Kauffman.

Mr. KAUFFMAN. Thank you, Mr. Speaker.

Today I am proud to recognize a young man who served his country with bravery and distinction, a young man whose lifelong dream was to serve in the United States Army. Pfc. Aaron Genevie was tragically killed in Baghdad, Iraq, on April 16, 2007, during his service in Operation Iraqi Freedom. He was just 22 years old.

However, it is not his untimely death that makes him worthy of our recognition; it was his extraordinary life. Aaron was an honor roll student, an all-around athlete, a trusted friend, a loving son and brother. Upon graduating from McConnellsburg High School in 2003, Aaron went to work at a local manufacturing company in Chambersburg until he was accepted into the Army in July 2005. That day, the day he enlisted, was the happiest day of his life, according to his mother. He was proud to follow in the footsteps of his two grandfathers who also served in the U.S. Army. Being a soldier was a dream of Aaron's since he was a young child.

He was assigned to Troop B, 1st Squadron, 4th Cavalry Regiment, 4th Infantry Brigade Combat Team, 1st Infantry Division, based in Fort Riley, Kansas. His service in the Army, although short, was distinguished. He was awarded both the Purple Heart and the Bronze Star Medals in recognition for his bravery and dedication to duty. In the Gospel of John, we are taught: "Greater love has no one than this, that he lay down his life for his friends." As I stand here today and honor the life of

Aaron, I am personally thankful that there are still young men and young women who willingly serve their country and will lay down their lives for their friends, family, neighbors, and fellow countrymen.

Aaron was truly an American patriot, believing in America and its mission to protect those who cannot yet protect themselves. We will never forget his personal dedication to this country and we will never forget the ultimate sacrifice that he paid. Aaron was a man of honor and he should always be remembered for the ultimate gift he gave to our country.

Mr. Speaker, we share in the grief of Aaron's family. Aaron's mother, Patty, is here with us today. Please stand to be recognized. Patty, please accept our condolences on the loss of your son, a fine soldier we were proud to have protecting us in Iraq.

Mr. Speaker, I ask that all members join me in supporting HR 295 to remember the life and honor the sacrifice of Pfc. Aaron Genevie.

## STATEMENT BY MR. D. EVANS

Mr. D. EVANS. Mr. Speaker?

The SPEAKER. The Chair recognizes the gentleman from Philadelphia, Representative Evans, chairman of the House Appropriations Committee.

Mr. D. EVANS. Thank you, Mr. Speaker.

Mr. Speaker, the Republican chairman of the Appropriations Committee and I have been working so well together, and I want to continue working together. I want him to be lockstep with me. I want him to share some of the same kind of activity. I really want him because he is leaving us, but I am going to say that I want him to have the excitement of this next month. So what we are going to do is we are going to have some more hearings – I saw Reichley smile when I said that – we are going to have hearings on SB 850 since the Senate just passed that bill. We just got it last week, I think it was. I have indicated to the chairman that what we are going to do is allow people to voice their opinions on SB 850. We did it with the Governor's proposal; we should do the same thing. And I assure you, both sides, no matter whatever their particular position may be, will have the opportunity to testify before the Appropriations Committee regarding SB 850.

Let me just give you a little bit of my thinking for why I think that that should occur. We, both sides, have been meeting with the Senate in the last 2 months. We have been having meetings every Wednesday at 1:30, and the only reason we are not having one tomorrow at 1:30 is because the Senate is not in and I do not know if we will be in, but we have been meeting. The purpose of those meetings has been for everybody to put all the different issues on the table and to go through discussion. The Senate decided, which they have a right, they introduced the budget, I think it was last Friday, and then they voted on it last Wednesday and they sent it over here to the House.

We have introduced the Governor's budget and we introduced the budget on the same day that the Senate Republicans introduced their budget. Now, what I would like to do, using this month of May, for at least the next couple of weeks, is basically to, again, give the public more chance and more input relating to the Senate Republicans' budget because that budget was not around when the Governor introduced, that is the first thing. Secondly, I am also looking at the aspect of what the revenue picture is going to look like for the month of May. I want to look at the revenue picture, what is going to happen with the revenue picture.

So one, look at SB 850, look at what the revenue picture is, and continue to allow members and the public to have the necessary input relating to this particular budget. So I want to give members a sense of the timeframe and then I yield to my colleague, Chairman Civera.

The SPEAKER. The Chair thanks the gentleman.

#### STATEMENT BY MR. CIVERA

The SPEAKER. The Chair recognizes the minority chairman of the House Appropriations Committee, the gentleman from Delaware, Representative Civera.

Mr. CIVERA. Thank you, Mr. Speaker.

Mr. Speaker, I do agree with the chairman as far as saying that we have been working together. We have been meeting since swearing-in day as far as this budget is concerned. The reason why we have been meeting with the four caucuses is Senator Scarnati, Lieutenant Governor, had called this meeting the day of swearing-in to start this momentum running because we are well aware, every one of us in this chamber is well aware of what this economy is, what the state of this budget is, the declining revenues that we face. And now it comes to the point where we are into probably the end of May before we return back here in the beginning of June and we have 30 days to go before we have to pass a budget that is on time.

Now, this is the scenario with this budget: This budget, basically, at this point in time, with the numbers that we have heard so far, is \$2.9 billion down in revenues. This is a situation where the year before and the year before that we were talking about surpluses; now we are talking about deficits. To call SB 850 to the Appropriations Committee for public hearings, I believe, at this point is a mistake. This is why it is a mistake, and let me be very clear on this: SB 850 is the budget bill that the Senate passed. If some of us watched the debate last week or last Wednesday with the Senate, the Senate Democrats – not one amendment was put forward in that debate, not one amendment.

We have met in the four caucuses on a weekly basis. The issue before us today and the issue before us in the beginning of June and the issue before us at the end of June is this: Do we survive in State government or do we just continue to put, day after day, a Band-Aid on a bad wound? This Commonwealth, as long as I remember it, never had this type of a deficit in the 30 years that I have stood on this floor. This is serious, Mr. Speaker. This is not something that is politics. You could say it is politics, but the basic line and the bottom line to this whole thing is we need to turn the lights on tomorrow and run the government.

Now, SB 850 is not a bill that I would wave a red flag and go around saying it is the answer to all answers; it is not. A lot of things that were done to SB 850 we have all argued on this floor and supported over the years – I know I have – but SB 850 tells us whether we are going to be accountable or we are not going to be accountable to what we have to offer. Now, this is the issue. This is the issue, and let us put it right on the table. This is why I said to Dwight that I wanted to speak today on the floor on this because this is what we face. You either face SB 850 boldly or you look at the other angle and that is either you raise the sales tax or you raise the PIT tax (personal income tax), and these are the answers that we need to know.

Public hearings on 850 is people will come before us and tell us how wrong we are if it cuts certain programs. A lot of people will do that. And then there will be people that will come before us and say, we cannot afford to pay any more than what we are paying. If you think this is an easy task at this point in time, this is a time that each and every one of us that was elected to serve in this chamber is to govern. The Governor is to govern. The Governor is to be responsible in an economic way, that is the business climate, and how to run the finances of this Commonwealth.

You want to call SB 850 for public hearings. The press will be there, and our answer to that is which road do we want to go? There is not a happy medium here. There is not a happy mix where you can say, well, I will take a little bit of taxes and I will take a little bit of cuts because the issue comes down to this, Mr. Speaker: The issue comes down to what happens in 2011 and 2012 to this Commonwealth if this economy does not start to pull up? Increasing the tax base and going in that direction could be detrimental to this Commonwealth, could be detrimental to everything that we have stood for.

My point in saying this today is this: I believe that if you want to talk about SB 850, bring it on the floor. Bring it on the floor. Let us debate it. Let us look at it. Let us tell the people of Pennsylvania what this is all about. We have 30 days in the month of June to do this. We could work every single day doing this. That is the people's business. That is the direction that we need to head to. We had Appropriations hearings. We listened to every group of people, and I have to say the truth: The chairman was gracious that way. He brought people in. They spoke to the committee. We asked questions. They asked questions to us. We responded. But bringing SB 850 before the committee is not the right thing to do; bringing SB 850 before the chamber is the right thing to do.

So my good friend, if you want to work together here and we want to shake our hands, let us work together. Every day you and I could have this podium. Every day you and I could have this debate, and so before I leave this great chamber, let us do it the right way.

Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Philadelphia, Representative Evans.

Mr. D. EVANS. When you say do it the right way, what way would be better than to allow people to be involved in the process? Now, we are going to have hearings. I think the way the process works is that voters who elect us get a chance to speak about their money. There was a bill introduced on a Friday, passed out of the Senate Appropriations Committee on a Monday, voted on a Wednesday. Now, the people had a chance when Governor Rendell introduced his budget on February 6. We had 42 hearings, 42 hearings. Now, here is a Senate bill that spends \$25 billion and we are going to say to John and Jane Q. Pennsylvania that you have no chance to say anything at all, that only lobbyists are the ones who have a chance to say something, that average people do not have a chance to say something about a budget?

Now, we have the time, we have the time. I said to you, next week I am going to do the hearings, so what is wrong with giving people of the Commonwealth of Pennsylvania the chance to speak about the priorities of this State? So in my view, Mr. Speaker, you let the people have their chance to speak. We will have our chance, but we should hear from our constituents who— SB 850 just popped out of nowhere, SB 850 just popped out of nowhere, and now we are at a particular point where we are going to give people a chance. So I would think no matter if you are a Democrat, a Republican, a liberal, a conservative, whatever you may be, I would think you would never be against the idea that John and Jane Q. Citizen – who pay the bill for all of us, who pay the bill for all of us – would ever be against the idea that they come, may they agree with me or disagree with me.

So, Mr. Speaker, I know you did not mean to shut the public out. Now, I know you did not mean that. I know that was a mistake. So we are going to give the people a chance next week, give them a chance in that process to speak and tell us what they think about SB 850. I do not think we should ever be against that. We had 42 hearings. I think we are going to continue to get some more discussion. This is not an easy answer. We may not have the answer among ourselves, but maybe somebody who comes to testify before us has some answers. Maybe people who come from Tim Mahoney's district may have the answer, maybe from Bob Freeman's district may have the answer, maybe from Dave Reed's district they may have the answer. Maybe somebody may have the answer in trying to figure this out, and the only way that that can happen is you have to have them a part of the process, Mr. Speaker.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Delaware, Representative Civera.

Mr. CIVERA. Thank you, Mr. Speaker.

Mr. Speaker, let us go back to February. The Governor came before the General Assembly here in the House, presented his budget. The chairman did not introduce that budget until the Senate started the process. Had the chairman introduced the budget, we would have been talking about what the Governor was looking for. Nobody is saying that we do not want the public to speak, but now that you said that to me, I am going to ask you, Mr. Speaker, a question: After we negotiate the budget with the four caucuses, are we going to bring the public in then?

Mr. D. EVANS. I am for that.

Mr. CIVERA. See, what I am saying to you is this: Let us not get into a delay tactic to delay this, because this is a crisis that we have. Bring the bill before the House – 203 of us, we are all going to be here. Your side is going to want to look at it. My side is going to want to look at it. We are going to caucus. Start the process now because come the middle of July when we are into the process and the thing is not, the items are not concluded what is in that budget, the people of Pennsylvania – here they go again. We have not passed a budget on time since Governor Rendell took office. Start it now. Listen to what I am telling you. I would not mislead you. I am not telling you anything—Start it now.

We are in a situation that every one of us that got elected all has a talent that could come here and say, this is what we need. SB 850 is a bold bill. SB 850 has a lot of detrimental situations where cuts were made because we balanced the budget, okay? We balanced the budget. Let us talk about it. Let us talk about the education. Let us talk about agriculture. Put it out there. That is all I am saying, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Philadelphia, Representative Evans.

Mr. D. EVANS. Mr. Speaker, just before we get to talk about it, there is something called having the people talk about it. Now, we are going to have, as long as I am chairman, Mr. Speaker, we are always going to have citizen participation. I have said that before. We did more hearings – I have been chairman for 19 years – we did 42 hearings, 42 on this process. This has been the most open, communicative process that I have ever seen before, 42 hearings. We went to rural Pennsylvania, went to urban Pennsylvania, went to suburban Pennsylvania. We did online town meetings. We did everything you can think of to allow people.

A Senate bill— And let me just correct you for the record. When you make the statement that we only introduced the bill as a result of the Senate Republicans, that was based on the assumption that the Senate Republicans were going to negotiate with us and work this thing out, but since they chose to introduce a bill and to pass a bill, in my view, that left us no other choice, Mr. Speaker. That left us no other choice. The Senate Republicans chose to do what they did and left us no other choice. So when they did what they did, I thought in good faith effort, I thought in good faith since I was at that meeting on January 6 with the Lieutenant Governor; I was at that meeting. I have been at every single meeting that people have conducted. So I thought in good faith, knowing how difficult this was going to be, that we were going to compromise. That is the name of the game. The budget that the Senate Republicans passed is not compromise. That is their view. Thirty Republicans voted for it, 20 Democrats voted against it. That is not the way the process works. Thirty Republicans, 20 Democrats; that is not a compromise. That was the Senate Republicans' view. The Senate Democrats did not have their input.

Now, I am determined to have the people have input, right? And I am determined that you also will participate. I want you to participate. I want the people to participate and I want you to participate, and I am looking for a bipartisan solution because people are not interested in the typical politics. They want us to move this State forward and that means we must work together. So I am only saying to you, Mr. Speaker – and I understand you do what you have to do. I understand that, and I do have the

utmost respect for you. But I have to say this to you: We sincerely have to allow people to have input. We have been taking a lot of criticism. Both sides have taken a lot of criticism because they say the process is not open and it is not transparent.

You are going to tell me a bill passes last week out of the Senate and you are going to bring it to the House floor and you are not even going to allow anybody to say anything about this bill? I mean, I do not understand that. I understand we have the power to do it, but the name of the game is let the people get involved. What, are we scared of that? Are we scared of having people give their opinion about SB 850? What, are we scared to have a discussion? Let the people give their opinion about SB 850 and when they give their opinion, we are all going to have a chance to give our opinion because, on this side, we have been having weekly budget meetings. My folks will tell you, every Tuesday we have weekly budget meetings. Sometimes we even have like a little movie theater setup. On this side, we have been having it weekly. Every Tuesday I have been meeting with members of this caucus and we have been having discussions every Tuesday. I give printouts to them. I lay every single thing out to these members because there are no surprises.

So, Mr. Speaker, I am saying this to you, and I understand what you are trying to say but today is only May 12. Is it May 12? I should know that, right? May 12, 4 days before my birthday. Now, I would love, I would love to have a birthday present and the birthday present I would love is to let the people into the process. Let us open it up. Let us give them a chance. Let them give their thoughts and their feelings and let them into the process. We have a little time, Mr. Speaker. I know you have a little time. Matter of fact, after we finish, you and I can go down to the deli, right? You and I can go down to the deli after we have some good hearings.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Delaware, Representative Civera.

Mr. CIVERA. Thank you, Mr. Speaker.

I am going to be brief. The Governor came before us, presented his budget. Appropriations had a hearing on the Governor's budget – on the Governor's budget, had hearings, had the public in. We listened to the public, what they had to say. We listened to what the different departments had to say. The Secretaries came before us. So if he wants not to delay and he is saying he wants the public, I do not have a problem with that. We are going to answer this. Bring then— If you do not want to bring SB 850, then bring the Governor's budget before us and let us debate it. We had hearings on that.

Now, let me make this clear, and I guess this is how this side of the aisle is at the moment – bipartisan, mix it up, make some type of a deal. There is one part of the deal that will not play this time. The Republican Party on this side of the aisle will not vote to increase a sales tax, a PIT tax, or any other tax.
