Mr. EACHUS. Mr. Speaker, it is my pleasure and distinct honor to present to the House of Representatives and its members Representative-elect Jerry Knowles.

OATH OF OFFICE ADMINISTERED

The SPEAKER. The oath of office will be administered to the Representative-elect by the Honorable Judge John E. Domalakes, judge, Court of Common Pleas of Schuylkill County.

JUDGE DOMALAKES. Jerry, would you put your hand on the Bible and raise your right hand.

REMARKS BY JUDGE DOMALAKES

JUDGE DOMALAKES. Jerry, before you leave— Jerry, I know that your energy, your work ethic, and your frank manner will serve you well in your new position as you do your best for all Pennsylvanians. So we congratulate you on your new position and we know that you will never forget that you are from Tamaqua, Pennsylvania, and Marian High School.

REMARKS BY SPEAKER

The SPEAKER. The gentleman from Schuylkill and Berks Counties may now take his seat.

Well, your first vote, Jerry, will be a vote to be added to the master roll call. I want to personally offer you my most sincere welcome on beginning a wonderful journey here in the House of Representatives. I hope and I know that you do, in fact, understand what an honor and privilege it is to be the voice of the people, for the people of Schuylkill and Berks Counties, and I know that you take that responsibility to heart.

I am delighted, as Judge Domalakes has alluded, that we have another Marian Catholic graduate. The Speaker being a Marian Catholic graduate, a little school like Marian, we are very proud of the fact that you are here, Jerry, and I just want you to know that there are no nuns here to hit you on the side of you know what, because I hear you always got it up at Marian Catholic. That is what I heard.

But I do, in fact, know Jerry for a very long time, and we shared a lot of time together at the University of Notre Dame. We are both subway alumni, and I can relate back to a story where probably I met Jerry for the very first time. We were traveling back from a Notre Dame game on a Sunday morning and the RV that he was riding in broke down somewhere right after the Indiana border and into Ohio. My father and I and our gang from the Panther Valley picked up the gang from Tamaqua. I do not know how we fit them in one vehicle, but we brought everyone home and that was probably the first time I met Jerry and his friends. I was only 14 or 15 years old at the time. So just some great memories; great football, great memories, and great friendship.

I certainly want to thank Father Jim Bechtel, who is a Jim Thorpe native. He is one of my constituents, was at Sts. Peter and Paul Church in Carbon County and certainly served at St. Nick's up in Weatherly. He is now pastor at St. Jerome's in Tamaqua, and I am delighted that he took time out of his schedule to share this very important day with Jerry Knowles and his family.

And certainly, Judge Domalakes for coming in from Schuylkill County Court of Common Pleas. We are talking about high school athletics and sports, and Judge Domalakes was with Immaculate Heart, I guess, before Shenandoah or when Shenandoah Catholic and all those schools closed down. They were telling us how competitive those games were, and they did not usually keep score. It was who broke what arm, who broke what foot, who broke what leg. It was that kind of rough-and-tumble stuff.

GUESTS INTRODUCED

The SPEAKER. I also want to welcome Jerry's family here: his wonderful wife, Lorraine; his son, Shane, and I think Lisa is with Shane; son Patrick and LaBrea and Jerry's grandson, Patrick Jr. If you all will please rise. Welcome to the hall of the House. Jerry has a rather large family. His brothers, Jim, Bill, and Don, are here, if they want to rise. Sisters Anne Marie and Georgeann, will you all please rise. Welcome to the hall of the House. And I think with about 140 friends of the family and well-wishers all here, I would like to recognize Jerry's in-laws, Joe and Florence David. Will they please rise. Welcome to the hall of the House.

I also would like to thank Senator Argall for his 24 years of dedicated service here in the House of Representatives. Dave is a legislative neighbor, as well as Jerry is going to be a legislative neighbor, and one of the things that we have always talked about, it really was not about party, it was about taking care of people. David has been a leader in the House of Representatives from property taxes to the Main Street and Elm Street Programs, but coming from the coal regions, understanding the importance of environmental issues and the impact that they have on the districts that we both represented, he was a leader in getting waste tires out of the dump sites, well over 28 million waste tires. Dave was the prime sponsor of that legislation. I would have to say, Jerry, you have big shoes to fill, but I think there is a good template for you to follow in how to serve the 124th Legislative District by following the lead of Dave Argall. And of course, I think most of our members know that Dave got tired of doing all of that work here in the House of Representatives. Now he has moved on to a place where he can relax and put his feet up on the desk and take it easy over in the Pennsylvania Senate.

On behalf of Jerry Knowles, I can say quite candidly that he is no stranger to public service. He was a Tamaqua Borough Council member. He was a mayor in the borough of Tamaqua. He is a former Schuylkill County commissioner and certainly understands hardball politics in the coal regions and what it takes to get the job done, and Jerry always got the job done. And even with that service, I will tell you, Jerry, that it is very easy to be overwhelmed by the 327-year history of this great institution, the Pennsylvania General Assembly, and its House of Representatives. It is easy to be overwhelmed by this spectacular chamber that we all come to grow and love and work in every single day. It is the most beautiful Capitol Building in the nation, and that includes Washington, DC, as well.

You will be joining us in honoring the past and the rules of civility laid down by men and women like William Penn and Benjamin Franklin, who served in this body. You will be ascending this grand stage, but I know you will never forget the people of Tamaqua, the people of Coaldale, Hamburg, Deer Lake, New Ringgold, Shoemakersville, McAdoo, and the many townships that sent you here to be their voice in Harrisburg.

You are the face of State government for the people who are intimidated by State government, for people who are not sure where to turn and may not know where to turn for help, but to you as their State Representative. It is those regular, working-class folks back home that you are here for today, not the special interest groups, but that one person back home who needs help and does not know where to turn to for that help, the working family man back home that is depending on you to do what is best for them.

You were sent here to make the right decisions, not the easy decisions, and to stand for more than 60,000 men and women in the 124th Legislative District of Schuylkill and Berks Counties. They all depend on you.

And you know what, Jerry, I hate to tell you, but you are joining us in a very, very tough time in the history of this General Assembly, one of the toughest budget years in the history of the legislature. Your very first substantive vote could very well be the State's multibillion-dollar budget, but I know that you are definitely going to hit the ground running. And remember, the last easy day was yesterday.

So on behalf of your 202 colleagues here in the General Assembly, I proudly welcome you to the hall of the House of Representatives. I welcome your ideas. I welcome your energy. I welcome your dedication to the House of Representatives. Congratulations and Godspeed, Jerry.

REMARKS BY MAJORITY LEADER

The SPEAKER. The Chair recognizes the majority leader, Representative Eachus.

Mr. EACHUS. Thank you, Mr. Speaker.

Jerry, you will soon learn that the Speaker usually gets the first word, which limits the last word. So I am honored to be with this body today to welcome another Representative from the Eastern Middle Anthracite Region. I know, having worked in Congress myself as a congressional staff person – and you know all too well, working at a district office for Representative Argall for all those years – that what really matters is helping people. You come to this job with that knowledge, and I can say that that is the key issue.

In the end, we honor you and your family. Your first swearing-in day is the day that your family will never forget. It is an important day for your family history, but as Representative McCall said, the issues that we face here every day and the timing of your arrival are challenging, but these are the issues that we really, I think in our heart of hearts, when we take public office, you are always hopeful that it is going to be easy, but during difficult times, these are the times that men are measured by, and I know you well, I know you personally, and I know that you measure up to the task. The people of Schuylkill County should be proud to have you serve as their Representative, and I welcome you to the hall today. Thank you.

REMARKS BY MINORITY LEADER

The SPEAKER. The Chair recognizes the gentleman from Jefferson County, the minority leader, Representative Smith.

Mr. S. SMITH. Thank you, Mr. Speaker.

To our newest member from the 124th District and his family and friends and supporters that are with him today, I want to welcome you, along with the Speaker, to the hall of the House. I would say, I think, Mr. Speaker, that you covered all the points that need to be addressed in welcoming a new member, and I echo the basic sentiment that you expressed, although I always find it interesting how you guys all have these relationships up there, going to the same schools, this and that. I could say some other things that would only get me in trouble, but I have to check the pedigree of people all the time. Where did they really come from?

In all seriousness, it is a great pleasure and honor on behalf of the House Republican Caucus to welcome Jerry officially to the House of Representatives as a member. So I think as you face the significant challenges along with the rest of the people in this room, with the legislative agenda we have here and the overwhelming sense that you will have just being the front-lines person dealing with the constituents of the 124th District, it is my hope that you will always look back at this as a great day, but know going forward whenever the tough times are facing you, the tough decisions are before you, that you will take that challenge as a point in time when you grow stronger, you persevere, and build on the character that got you here, that you will not ask why, but ask how. How do I manage this? How do I solve this problem?

I just want to tell you Mitchell will be a senior next year with one more year of eligibility, so we look for some great things, and I assure you, I think that will happen with this young man's future. Please join me in congratulating this 119-pound national champion out of the great town of Bellefonte and giving him a House of Representatives round of applause.

In its current form, the bill makes it clear that the Department of State can investigate complaints from both payers and from patients. Clearly, we want the department to have the ability to investigate complaints of serious events that affect patients receiving medical care.

More importantly, Mr. Speaker, the amendment preserves the requirement that the Department of Public Welfare develop a list of adverse events in nursing homes and for which the nursing homes will not be paid. The list will be developed within 1 year from the date of enactment. This list will be the first, and I say this, this list will be the first of its kind in this country. No other State, not even the Centers for Medicare & Medicaid Services, has developed this type of legislation and this list. This means Pennsylvania will be the first in the nation to take on this task, and other States have expressed interest in monitoring what we develop in order to determine how it can be adopted for their States.

Mr. Speaker, I also want to thank the chairman of the Insurance Committee over in the Senate for his support on this legislation, and I ask for an affirmative vote today on HB 84.
