Ms. **MUNDY** offered the following amendment No. **A01599:**

Amend Bill, page 1, line 3, by inserting after "injury"

and for subsequent convictions of certain offenses

Amend Bill, page 1, lines 6 and 7, by striking out all of said lines and inserting

Section 1. Sections 3742 and 6503(a) of Title 75 of the Pennsylvania Consolidated Statutes are amended to read:

Amend Bill, page 3, by inserting between lines 26 and 27

§ 6503. Subsequent convictions of certain offenses.

(a) General offenses.–Every person convicted of a second or subsequent violation of any of the following provisions shall be sentenced to pay a fine of not less than \$200 nor more than \$1,000 or to imprisonment for not more than six months, or both:

Section 1543(a) (relating to driving while operating privilege is suspended or revoked) except as set forth in subsection (a.1).

Section 3367 (relating to racing on highways).

[Section 3733 (relating to fleeing or attempting to elude police officer).]

Section 3734 (relating to driving without lights to avoid identification or arrest).

Section 3748 (relating to false reports). * * *

On the question,

Will the House agree to the amendment?

The SPEAKER. On that question, the Chair recognizes the gentlelady from Luzerne, Representative Mundy.

Ms. MUNDY. Thank you, Mr. Speaker.

This amendment cures an anomaly in the law. I am offering this amendment on behalf of Representative Lentz, who, as we all know, is having a serious illness to deal with in his family today and cannot be here to offer the amendment himself.

Again, this amendment corrects an anomaly in current law having to do with the offense of fleeing or eluding a police officer. Apparently in current law someone committing this offense for the first time can get a prison sentence of up to 2 years, but a subsequent offense results in only a sentence of 6 months. So this corrects that and changes this anomaly in the law, which was completely unintentional in the first place.

So on behalf of Representative Lentz, I would appreciate your support for his amendment. Thank you.

The SPEAKER. The Chair thanks the lady.

The Chair recognizes the gentleman from Lehigh County, Representative Reichley, on the amendment.

Mr. REICHLEY. Thank you, Mr. Speaker.

The gentlelady is correct that this does correct an anomaly that existed within two different provisions. I had introduced a bill on this subject after being contacted by the Lehigh County District Attorney's Office, who had found in sentencing matters just this kind of conflict arose. The District Attorneys Association has subsequently contacted the House Transportation staff for the majority, and I believe Representative Lentz had been designated to introduce a bill, word for word, the same as mine, and the amendments which we had also offered on this legislation are exactly the same word for word.

So I would encourage the members to support the amendment so we can allow judges to correctly sentence offenders who engage in fleeing activity on a second offense.

Mr. SCAVELLO. Yes, Mr. Speaker.

The SPEAKER. The gentleman from Monroe County, Representative Scavello, makes a motion to suspend the rules for the immediate consideration of amendment A01688.

The SPEAKER. On that question, the Chair recognizes the gentleman from Monroe County, Representative Scavello.

Mr. SCAVELLO. Thank you, Mr. Speaker.

I am talking here from personal experience, having seen 24 operations in supermarkets. What this bill is saying— First, I want everyone to understand that in a supermarket there is a tremendous amount of turnover. A supermarket deli is going to have about 15 to 20 certifieds under this bill, certified inspectors, to fill a shift of 24 hours a day, 7 days a week. Even with that, however, Mr. Speaker, there are going to be times when the certified is not going to be there, sick or something, vacation, but mostly sick is what I am really interested in here, and under those circumstances, we are going to be actually telling that supermarket he is going to have to close the deli, that you cannot service a customer.

What this amendment is doing, it is saying that during that time there cannot be any food preparation. You cannot cook a chicken. You are not going to be able to make roast beef, some turkey. You cannot make any salads. There is not going to be any preparation at all, but it will allow that operation. For example, if a customer needed half a pound of cheese or half a pound of ham, the business could still stay open. So I am asking the members to put yourselves in that position. The supermarket business right now, if you make a penny on a dollar, you are ecstatic. So to lose sales – and that is what this will do – it is going to have them put a sign on that deli, "We are closed." You cannot get any ham; you cannot get any salad; you cannot get anything at all. So I am asking the members to allow this amendment in to try to help this bill and help the supermarkets out.

The SPEAKER. On the question of suspension of the rules, the Chair recognizes the majority leader, Representative Eachus.

Mr. EACHUS. Mr. Speaker, in talking to the prime sponsor and the chairman of the committee, this has not been an agreed-to amendment prior to this session. It was not posted in a timely fashion, and I rise to oppose the suspension of the rules.

Thank you, Mr. Speaker.
