A Resolution designating August 9, 2009, as "Coal Miners Day" in Pennsylvania in appreciation, honor and remembrance of the accomplishments and sacrifices of coal miners in this Commonwealth.

The SPEAKER. On that question, the Chair recognizes the gentleman from Lackawanna County, Representative Staback.

Mr. STABACK. Thank you, Mr. Speaker.

Mr. Speaker, I stand today to ask for your support for HR 317, designating August 9, 2009, as "Coal Miners Day" in Pennsylvania. For me and others like me who had family members who worked in the mines, this day will serve as a reminder – a reminder of a life of work that was tough and dangerous, but a job that laid the foundation for the growth of this State; a reminder that a miner's work was very hard, very dangerous, and a threat to their health. My father worked in the mines for a good part of his adult life and came down with a miner's disease called black lung, which eventually took his life.

So to those who worked in the mines and the many who died from the effects of that work, this resolution serves as a proper and fitting tribute. For all of us who knew miners and witnessed the hardships they lived, August 9, 2009, will be a reminder of what we owe to those men and their hard work. In the borough of Olyphant, in the Mid Valley section of Lackawanna County in my district, a special ceremony will be held on that day giving recognition to the coal miners who lived and worked, and some who died, while building up not just northeast Pennsylvania, but Pennsylvania as a whole.

With all that in mind, I ask for an affirmative vote on HR 317. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Greene County, the majority whip, Representative DeWeese.

Mr. DeWEESE. Thank you, Mr. Speaker.

Just a short one minute.

Coal is the essence of my legislative district. In fact, in the hills of Greene, Fayette, and Washington Counties, we mine more underground coal than any section of the nation. Some of the big strip operations out west exceed it. I congratulate my colleague from Lackawanna County, Representative Staback, from the anthracite fields. Many of us from the bituminous fields wanted to join him with an affirmative vote. And remember that from Revolutionary times through the Civil War, through the Gilded Age, through the First and Second World Wars, coal has been one of the bulwarks of our State economy and of our national success. So as we debate the Honorable Mr. Vitali's proposals on energy and we discuss the whole dynamics of the future, it is appropriate, Mr. Speaker, that we pause today and remember the dynamic element that coal has played within our past history, and I ask for an affirmative vote. Thank you.
