I am here today to offer a resolution in honor of a sadly missed, beloved, and fallen soldier, Spc. Chad A. Edmundson.

### **GUESTS INTRODUCED**

Mr. STERN. Also joining us today, paying tribute to him, are his father – I would ask him to stand at this time – Roy Edmundson; his stepmother, Sherry Edmundson; his mother, Karen Cornell; his brother, Alex Edmundson, and sister, Jessica Miller; and grandmother, Donna Edmundson. Thank you.

Spc. Chad A. Edmundson, 20, of Williamsburg, Pennsylvania, died while serving his country in Iraq on the 27th of May 2009.

Specialist Edmundson was part of the Pennsylvania Army National Guard's Company B, 2d Battalion, 112th Infantry Division, 56th Stryker Brigade Combat Team.

Chad was on a foot patrol with the Iraqi Army when an improvised explosive device detonated on Wednesday, May 27. He later died at the 10th Combat Support Hospital in Baghdad.

Chad Edmundson was a 2008 graduate of Williamsburg High School, where between his junior and senior years, he enlisted in the military. He enjoyed baseball, wrestling, golfing, and bowling, and he was an avid fisherman. Specialist Edmundson was a brave and proud soldier who will be greatly missed and who will always be remembered.

Please join me at this moment in a moment of silence, along with his family members present here today, as we honor the memory of this fearless soldier who gave his own life to protect his country.

(A moment of silence was observed.)

Mr. STERN. Today the House of Representatives of Pennsylvania honors the life and expresses condolences upon the death of Spc. Chad A. Edmundson, who paid the supreme sacrifice on May 27, 2009, while serving his country in Iraq.

Mr. HENNESSEY. Thank you, Mr. Speaker.

I rise to ask support for SB 568, which authorizes the transfer of lands which used to form part of the campus of the old Pennhurst State mental hospital in Chester County, East Vincent Township. The lands will be authorized to be transferred to the township.

The land will be permanently restricted for public use as recreation and open space. The bill has a provision which prevents its use for any kind of a gaming facility.

The House improved this bill by amending it back on June 30 in an amendment by Chairman Fairchild, which essentially assures that the Bureau of Military and Veterans Affairs will be able to maintain modular housing, which has been used for some of the veterans being served at the Southeastern Veterans Center and also that part of the lands are being used for a VA (Veterans' Administration) clinic, a medical clinic, on the property. By virtue of that amendment that we put in on June 30, we will assure that those uses, the modular housing and the VA medical clinic, will remain on the property until such time as the Bureau of Military and Veterans Affairs indicates that they have no further need for those uses of the property.

I would like to thank the East Vincent Township board of supervisors and the police and the citizens of East Vincent Township for carrying the expense for perhaps 20-plus years, for overseeing this campus, the Pennhurst State mental hospital, while most of it has been abandoned and out of use.

I have additional remarks that I would like to submit for the record, but I will note that I would appreciate an affirmative vote, and also, Senator Dinniman, who is the prime sponsor of this bill in the Senate, would also appreciate an affirmative vote of the House. Thank you.

The SPEAKER. The Chair thanks the gentleman.

### **REMARKS SUBMITTED FOR THE RECORD**

Mr. HENNESSEY submitted the following remarks for the Legislative Journal:

SB 568 effects a transfer of land from the old Pennhurst State mental hospital to East Vincent Township, wherein the land is located. It is the second step of a two-step transaction, the first of which was completed in February 2008, when an adjacent tract of land was conveyed to a private developer for \$2 million.

The conveyance of this approximate 95 acres of land from the Commonwealth to East Vincent Township, as authorized by SB 568, is part of that prior transaction in which Pennhurst Acquisition purchased the lower campus and adjacent tract for \$2 million. Pennhurst Acquisition agreed to pay \$2 million with the understanding that East Vincent Township would receive said 95 acres for the purpose of open space.

The land in question is heavily restricted for use as public open space and recreational lands to serve the surrounding community. The land contains an old cemetery where former patients of Pennhurst were buried, and East Vincent Township has agreed to perpetually maintain the cemetery as well as the other lands here in the transfer.

Of primary concern is the retention of the use of lands in tract B of this transfer for modular homes for veterans of our Armed Forces and for the operation of the Veterans' Administration medical clinic, and those uses shall continue on the property until the Bureau of Military and Veterans Affairs affirmatively states that the lands in tract B are no longer necessary to complete its mission at Southeastern Veterans Center on behalf of our veterans.
