An Act amending the act of March 10, 1949 (P.L.30, No.14), known as the Public School Code of 1949, in duties and powers of boards of school directors, establishing parent involvement programs and policies in school districts; in school finances, providing for workers' compensation, and further providing for annual budget and for limitation on certain unreserved fund balances; in grounds and buildings, further providing for referendum or public hearing required prior to construction or lease; providing for certification of teachers by the National Board for Professional Teaching Standards; in certification of teachers, further providing for certificates qualifying persons to teach and for kinds of State certificates; providing for residency certificates, and further providing for disqualifications; in pupils and attendance, providing for use of seclusion; further providing for compulsory school attendance and for exceptions to compulsory attendance; providing for interview reports for withdrawing and illegally absent students; further providing for cost of tuition and maintenance of certain exceptional children in approved institutions and in the four charter schools for education of the deaf and blind; and providing for emergency permits at approved private schools and chartered schools for the deaf and blind; in school health services, further providing for possession and use of asthma inhalers and epinephrine and auto-injectors; in high schools, further providing for academic degrees; in charter schools, further providing for funding for charter schools and for annual reports and assessments; in education empowerment act, further providing for education empowerment districts and for mandate waiver program; in educational improvement tax credit, further providing for definitions, for tax credit and for limitations; in transfers of credits between institutions of higher education, further providing for duties of public institutions of higher education, for transfer and articulation oversight committee and for participation by independent institutions of higher education or Staterelated institutions; in funding for public libraries, providing for state aid for 2009-2010; in reimbursement by Commonwealth and between school districts, further providing for definitions, for basic education funding for student achievement and for accountability to Commonwealth taxpayers, and for payments to intermediate units; and providing for special education funding for student achievement and instruction of eligible students in regular classrooms and for special education accountability to Commonwealth taxpayers.

I think it is wrong and unfortunate that State employees have been used as a hostage once again by this administration to try to force a tax-increase vote and spending that is not within our means.

With respect to HB 1416 as amended, I would rise on behalf of myself and indicate that I think we should concur, and these are the reasons why: HB 1416 as amended has no new taxes, and middle-class families and small businesses are tightening their belts across the State and they have made it readily clear to all of us, do not take more money out of my pocket; we want to have that money in our homes to save for our kids' college, to buy a new appliance, or maybe to take a weekend vacation; you need to get your spending in order in Harrisburg. Second, it

represents reduced spending. And third, in this year of years when we are facing a \$3.2 billion deficit for '08-'09 and another \$3.2 billion or greater in '09-'10, it makes it clear that we cannot continue our ways by increasing spending, by increasing borrowing and increasing debt service, or raising taxes, as has been the legacy of the first 6 years of this Governor's administration.

It also indicates that there is no discretionary spending, and when you have deficits to the tune of over \$3 billion, you need to eliminate discretionary spending and begin to prioritize where you are putting the hard-earned tax dollars.

Would I like to be voting for the Civera amendment again? You bet. It reduced spending, made sure there were no new taxes, and it prioritized spending by focusing on hospitals, education, and law enforcement.

We all know that this is going to a conference committee. We understand that, and the message, I think, that has to be delivered to the Governor and perhaps to the majority Appropriations chair is this: The old days are over. These bodies are not going to vote for a tax increase, and I believe that is true of members on both sides of the aisle. I myself and I think most of the Republican members will not put up a tax-increase vote when people are struggling in this recessionary time.

And secondly, we must recognize that in prioritizing spending, giving a certain dollar amount that we have, the focus must be on hospitals, education, law enforcement, and not on, quote, unquote, "legislative priorities," which the majority Appropriations chairman always talks about. I have been in these meetings, and I must tell you I have not heard any language or talk about focusing on hospitals, education, and law enforcement. It is always about the legislative priorities, or the walking-around money. That is not the right approach.

As we get to a conference committee, we need to make sure there are no new taxes, we have controlled spending, that we prioritize like the Civera amendment did, and that we come to the conclusion in this year of years, we continue to reform government by reforming the budget and recognize that there is not going to be room for discretionary spending or walking-around money this time.

I am hoping that any conference committee also is going to have sunshine, lots of sunshine, open for everybody to hear what the discussion is in terms of our priority in spending, and I call upon the Governor and the majority Appropriations chairman to guarantee each of us House members that there is going to be sunshine throughout that conference committee discussion.

With that, I would say I am going to concur, and I think there are good reasons to concur, but I recognize that we have some days ahead of us in getting this done.

With all due respect, Mr. Speaker, I ask for a vote on concurrence. Thank you very, very much.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman from Greene County, the majority whip, Representative DeWeese.

Mr. DeWEESE. Thank you, Mr. Speaker.

Just a 2- or 3-minute response to my honorable colleague from Allegheny County.

We have been in many of the same meetings in Chairman Evans's office and in Senator Pileggi's office. We have also been privileged to go line by line with His Excellency in the annex to the Governor's home, and I would politely recollect to

my honorable colleague from Pittsburgh that we did talk about hospitals, that we did talk about education, that we did talk about economic development and parks and agriculture.

It was in the New York Times a couple of days ago, and the metaphor is somewhat strained here, but there was an article about Stanley McChrystal, the four-star general who is in charge of our troops in Afghanistan, and the essence of the article was that the end game in Afghanistan is dynamic and unpredictable. Well, Mr. Speaker, the process that we are involved in today is dynamic and unpredictable, but one thing is for certain, if we are to advance this dialogue, this has to go to a conference committee, and we will urge our membership to forward it to that conference committee.

But the honorable gentleman who preceded me at the microphone is, I think, in error when he says that we met again and again and again and we did not talk about matters of great substance. In fact, for the first time ever in my somewhat extended career, we went line by line by line by line with the Governor.

What will happen in the conference committee is, again, dynamic and unpredictable, but I think it is the mission of our General Assembly's chamber here today to send it on to a conference committee.

Thank you very much, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Philadelphia County, Representative Thomas.

Mr. THOMAS. Thank you, Mr. Speaker.

Mr. Speaker, I am not going to take all of the time allotted, but I think it is important to make sure that the record is straight on two things: One, I am not prepared to retreat on the commitment that we have made to children in our public school system.

Two, I am not prepared to retreat on the commitments that we have made to families and communities over the last 6, 7 years. I recognize that the economic situation has changed, but then all that means is we have to redesign our priorities, and I have decided to choose people over politics, I have decided to choose families over special interests, and I have decided to have the patience of Job if it is necessary to get it right.

I am here 20 days after the 30th, and I do not mind staying another 180 days if it is necessary to get it right. The important thing is to get it right. The amended version of HB 1416 is not right. Vote to nonconcur.

The SPEAKER. The Chair recognizes the gentleman from Butler County, Representative Metcalfe.

Mr. METCALFE. Thank you, Mr. Speaker.

Mr. Speaker, I rise in support of HB 1416 as amended by the Senate.

Mr. Speaker, I think it is very telling that today we have received e-mails from both the PSEA (Pennsylvania State Education Association), the State's largest teachers union, and the AFL-CIO asking for a nonconcurrence vote, Mr. Speaker. Mr. Speaker, these are the organizations that feed pretty mightily out of the public trough and are sad that the public trough is not being slopped as full as they are used to.

Mr. Speaker, in order to put taxpayers first to ensure that there are no tax increases this year, I believe that we have to concur with HB 1416, put it on the Governor's desk. Let us call the Governor's bluff to be the last man standing for his personal income tax increase. I know there are some Democratic leaders

that are still pushing for that personally here in the House, but I believe the Senate seems pretty strong both in their leadership in the Senate Republican side and the Senate Democratic side, that they are not going to concur with a PIT increase to sustain the level of spending that the majority Appropriations chairman here in the House keeps pushing for.

Mr. Speaker, I think it is important for taxpayers across this Commonwealth to understand that these are really shameless, despicable tactics of holding State workers hostage, of forcing them to work without pay, of holding college students hostage, attempting to put forward a no-tax-increase budget just by playing a shell game as HB 1416 did in its original form.

Mr. Speaker, there are many deficiencies with the original HB 1416 that were corrected with the Senate amendment. It certainly does not cut spending as I would cut it, because I would have cut a lot more with the revenues that we are expecting, but it went far enough to ensure that we do not have a tax increase this year, Mr. Speaker, and I believe that it is time for taxpayers to be put first in this budget process, as many of us have been calling for since the beginning of the year.

There was ample opportunity, Mr. Speaker, as there were dozens of us that joined in a letter to the majority leader and majority Appropriations chairman earlier this year and asked for the use of our committee process to focus on the budget. We did not have to be waiting until July 21 to finally get to a vote that might force a conference committee, Mr. Speaker. That could have been done in May or June even, but as always, the majority, working in concert with the Governor, attempting to hold taxpayers hostage, the State workers, college students, are once again up to the same old tactics, Mr. Speaker.

Many of my colleagues on both sides of the aisle have come in under the banner of reform, under the banner of transparency, and if this does go to a conference committee, as I understand the new transparency that is supposed to take place, I would hope that members on both sides are very diligent to make sure that their appointees are abiding by what is called for.

Mr. Speaker, I would ask for a vote to concur with HB 1416 in order that we might finally put taxpayers first.

Thank you, Mr. Speaker.

BILLS ON THIRD CONSIDERATION

The House proceeded to third consideration of **HB 1859**, **PN 2445**, entitled:

An Act amending Title 34 (Game) of the Pennsylvania Consolidated Statutes, in preliminary provisions, further providing for definitions; in enforcement, further providing for the offense of assaulting an officer, for jurisdiction and penalties, for revocation, suspension or denial of license, permit or registration and for determination of second or subsequent convictions; in game or wildlife protection, further providing for endangered or threatened species; in hunting and furtaking, further providing for killing game or wildlife by mistake, for unlawful taking or possession of game or wildlife, for unlawful use of lights while hunting, for buying and selling game, for trespass on private property while hunting, for unlawful killing or taking of big game and for additional penalty for poaching; and, in hunting and furtaking licenses, further providing for unlawful acts concerning licenses.

On the question,

Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

(Bill analysis was read.)

The SPEAKER. The question is, shall the bill pass finally?

The House will come to order. Members will please take their seats, members around the majority leader's desk.

On the question of final passage of HB 1859, the Chair recognizes the gentleman from Lackawanna County, Representative Staback.

Mr. STABACK. Thank you, Mr. Speaker.

Mr. Speaker, the primary purpose of HB 1859 has always been to create fines and penalties for poaching big game animals that will act not only as a punishment but also as a deterrent, a deterrent to an unethical and illegal activity.

The measure was written in response to the increasing number of poaching violations including growth in the black-market sale of game animal parts or in multiple kills of game animals, labeled as "thrill kills" – killing, killing simply for the sake of killing. The penalties for these and other poaching offenses, now over 20 years old, are too lenient in the view of prosecutors, law enforcement officers, and organizations within the outdoor community.

HB 1859 treats poaching as it is treated in other States with strong hunting traditions like ours here in Pennsylvania, with stiff penalties, serious grading of offenses, something the Game Code seriously lacks today.

The SPEAKER. Will the gentleman yield. Will the gentleman yield.

The House will come to order. Members will please take their seats. The gentleman has a right to be heard.

Mr. STABACK. Thank you, Mr. Speaker.

The SPEAKER. Will the gentleman yield.

The gentleman, Mr. Staback, is in order and may continue.

Mr. STABACK. Thank you.

My bill will increase fines, including terms of imprisonment, periods of license revocation, and increases offenses for the most egregious violations of the State's game laws.

Mr. Speaker, this legislation has the support of much of the hunting community. In fact, in my experience, hunters are usually the most vocal when it comes to penalizing those people who would poach Pennsylvania wildlife, especially our big game population.

The tough penalties have earned the strong support of many outdoor organizations, including the National Rifle Association, Quality Deer Management people, the Federation of Sportsmen's Clubs, the National Wild Turkey Federation, Pheasants Forever, the United Bowhunters of Pennsylvania, the PA Ruffed Grouse Society, the PA Forest Coalition, the PA Crossbow Association, the PA Deer Association, the PA Nature Conservancy, the Humane Society of the United States, and the Governor's Council for Hunting, Fishing & Conservation.

Mr. Speaker, all of these groups agree that HB 1859 takes the needed steps to toughen up our game laws, game laws that are simply not working to combat the serious wildlife crime of poaching.

With that being said, I hope that each individual considering poaching a game animal, whether for the 1st time or the 100th time, stops and reconsiders his actions due to the price that will be paid if he is caught.

Mr. Speaker, on that note, I ask for an affirmative vote on HB 1859. Thank you.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Armstrong County, Representative Pyle.

Mr. PYLE. Thank you, Mr. Speaker.

Mr. Speaker, I have been involved in this process since this bill was first breached as HB 97, and over the course of a few months – I would like to pay my respects to Chairman Staback – he has been a diplomat and a statesman, incorporating all perspectives yet still crafting a very, very strong bill that will protect our sportsmen from the onus of poaching. It will protect our livelihoods and our hobbies and our way of life in the west much more so, much better than it currently does.

Mr. Speaker, this bill is the product of many, many hours of corroboration and collaboration, and I am proud to lend my support.

As Chairman Staback identified, this has the support of a number of sporting groups, from the PA Federation of Sportsmen, the National Rifle Association, just to name a few. Mr. Speaker, I urge a positive vote on HB 1859 and hope all of my colleagues would do the same. Thank you.

The SPEAKER. The Chair recognizes the gentleman from Northampton County, Representative Dally.

Mr. DALLY. Thank you, Mr. Speaker.

I also rise in support of HB 1859.

I think there is no question that we all agree with the intent of this bill, that a sufficient deterrent and adequate penalties need to be created to deal with poaching here in Pennsylvania, and I would like to thank Chairman Staback for his dedication to tackling this important issue.

This, indeed, has been a long process, and we have worked hard on both sides of the aisle to try and address the concerns and accommodate the wishes of House members, sportsmen's groups, and the sporting community in general, and we appreciate your flexibility and attention toward finding common ground on the provisions of this legislation.

The result of that hard work and compromise is that we now have before us legislation that I believe is tough but fair and is a major improvement over what the Game Code currently provides, and it sufficiently addresses the concerns expressed by various stakeholders.

This bill now addresses the grading of penalties and application of fines in a manner that is more consistent with similar provisions in the Crimes Code, obviously creates the necessary deterrent, and provides the tools necessary to help the Game Commission better deal with poaching and other game-related crimes in our Commonwealth.

For these reasons, Mr. Speaker, I fully support this bill along with our valued outdoor sporting organizations and respectfully ask that my fellow members support this measure as well.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman from Northumberland County, Representative Phillips.

Welcome back to the floor of the House, Merle. Good to see you.

Mr. PHILLIPS. Thank you, Mr. Speaker.

The SPEAKER. Hope you are doing well.

Mr. PHILLIPS. It is good to be back.

Thank you very much.

I rise to support HB 1859. I want to congratulate Chairman Staback for all the effort that he put in with his committee, working with a lot of different groups trying to come up with some legislation that is so sorely needed with this poaching and jacklighting that is taking place over a lot of our large game and with a lot of our game, and we finally came up with a bill, through his effort, that will correct some of the problems that we are having in this State with these illegal activities taking place.

I know that he has worked with all these groups. These groups have been mentioned and the support is there, and I do not know of any other bill that will do more to curb this activity that should not be taking place today.

And again, I ask for your support of HB 1859.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman from Allegheny County, the minority whip, Representative Turzai.

Mr. TURZAI. Thank you very much, Mr. Speaker.

It is clear that a great deal of compromise and a lot of hard work has gone into this bill on both sides of the aisle, HB 1859, which essentially amended HB 97 to take in the concerns that

were raised here on the House floor when that bill was up for a vote

I would certainly like to thank Chairman Staback for his patience and flexibility in addressing our concerns as well as those of all House members and our valued sporting groups across the Commonwealth and ask that my colleagues join me in supporting this important piece of legislation.

We are especially pleased that the bill as changed, in keeping with similar provisions in the Crimes Code, contains no mandatory minimum fines for misdemeanors or felonies within the Game Code and takes a more reasonable approach toward increasing the grading of penalties, while still providing a major deterrent to help reduce poaching in our State. As it should, the bill still provides for very tough penalties on the most egregious violators but is more reasonable overall.

Thank you very, very much, Mr. Speaker, and I urge a "yes" vote. Thank you.
