BILL ON SECOND CONSIDERATION

The House proceeded to second consideration of SB 47, PN 32, entitled:

An Act amending the act of June 13, 1967 (P.L.31, No.21), known as the Public Welfare Code, further providing for establishment of county boards and expenses.

On the question,

The gentleman, Mr. Kauffman, amendment A03917? The Chair thanks the gentleman.

On the question recurring,

Will the House agree to the bill on second consideration?

Mr. **EACHUS** offered the following amendment No. **A03905:**

Amend Bill, page 1, line 3, by inserting after "Commonwealth,"" in general powers and duties of the Department of Public Welfare, providing for determining whether applicants are veterans; and, in public assistance,

Amend Bill, page 1, line 4, by inserting after "expenses"

and for lifetime limit; further defining "exempt hospital" and "general acute care hospital"; further providing for authorization, for administration, for no hold harmless, for tax exemption and for cessation

Amend Bill, page 1, lines 7 and 8, by striking out all of said lines and inserting

Section 1. The act of June 13, 1967 (P.L.31, No.21), known as the Public Welfare Code, is amended by adding a section to read:

Section 215. Determining Whether Applicants are Veterans.–(a) The department shall make a good faith effort to determine whether an applicant for cash, medical or energy assistance is a veteran. While in the process of making its determination, the department shall dispense benefits to the applicant, if otherwise eligible.

(b) As a condition of eligibility to receive cash, medical or energy assistance, unless there is good cause not to do so, an applicant who is a veteran shall be required to contact a veteran service officer accredited and recognized by the United States Department of Veterans Affairs, the Department of Military and Veterans Affairs or the county director of veterans affairs in which the applicant resides in order to determine the applicant's eligibility for veteran's benefits or to file a veteran claims packet. The department shall develop a standard form to be used by a veteran service officer to verify the applicant's eligibility for veteran's benefits.

(c) An applicant who is a veteran shall provide proof of compliance with this section and the department shall, to the greatest extent possible, require the applicant to provide information on the final determination of eligibility for veteran's benefits and the type of benefits the veteran is entitled to receive.

(d) As used in this section, the following words and phrases shall have the following meanings:

<u>"Assistance" means money, services and payment for medical</u> coverage or energy assistance for needy persons who are residents of this Commonwealth, are in need of assistance and meet all conditions of eligibility.

"Veteran claims packet" means an application requesting a determination or entitlement or evidencing a belief in entitlement to a benefit as provided for in 38 CFR (relating to pensions, bonuses, and veterans' relief) or 51 Pa.C.S. (relating to military affairs).

Section 2. Section 415 of the act is amended to read:

Amend Bill, page 2, by inserting between lines 7 and 8

Section 3. Section 441.4 of the act, added July 7, 2005 (P.L.177, No.42), is amended to read:

Section 441.4. [Lifetime Limit] Reasonable Limits on Allowable Income Deductions for Medical Expenses When Determining Payment Toward the Cost of Long-Term Care Services.-(a) [Necessary medical or remedial care expenses recognized under Federal or State law but not paid for by the medical assistance program are allowable income deductions when determining a recipient's payment toward the cost of long-term care services. An allowable income deduction for unpaid medical expenses incurred prior to the authorization of medical assistance eligibility and those medical expenses incurred for long-term care services after medical assistance is authorized shall be subject to a lifetime maximum of ten thousand dollars (\$10,000) unless application of the limit would result in undue hardship.] When determining a recipient's payment toward the cost of long-term care services, longterm care medical expenses incurred six months or more prior to application for medical assistance shall be disallowed as a deduction, and medical and remedial expenses that were incurred as a result of a transfer of assets penalty shall be limited to zero unless application of these limits would result in undue hardship.

(b) As used in this section, the term "undue hardship" shall mean that either:

(1) denial of medical assistance would deprive the individual of medical care and endanger the individual's health or life; or

(2) the individual or a financially dependent family member would be deprived of food, shelter or the necessities of life.

Section 4. The definitions of "exempt hospital" and "general acute care hospital" in section 801-E of the act, added July 4, 2008 (P.L.557, No.44), are amended and the section is amended by adding a definition to read:

Section 801-E. Definitions.

The following words and phrases when used in this article shall have the meanings given to them in this section unless the context clearly indicates otherwise:

["Exempt hospital." A hospital that the Secretary of Public Welfare has determined meets one of the following:

(1) Is excluded under 42 CFR 412.23(a), (b), (d) and (f) (relating to excluded hospitals: classifications) as of March 20, 2008, from reimbursement of certain Federal funds under the prospective payment system described by 42 CFR Pt. 412 (relating to prospective payment systems for inpatient hospital services).

(2) Is a Federal veterans' affairs hospital.

(3) Is part of an institution with State-related status as that term is defined in 22 Pa. Code § 31.2 (relating to definitions) and provides over 100,000 days of care to medical assistance patients annually.

(4) Provides care, including inpatient hospital services, to all patients free of charge.]

"General acute care hospital." A hospital other than [an exempt hospital.] <u>a hospital that the Secretary of Public Welfare has determined meets one of the following:</u>

(1) Is excluded under 42 CFR 412.23(a), (b), (d), (e) and (f) (relating to excluded hospitals: Classifications) as of March 20, 2008, from reimbursement of certain Federal funds under the prospective payment system described by 42 CFR 412 (relating to prospective payment systems for inpatient hospital services).

(2) Is a Federal veterans' affairs hospital.

(3) Is a high volume Medicaid hospital.

(4) Provides care, including inpatient hospital services, to all patients free of charge.

"High volume Medicaid hospital." A hospital that the Secretary of Public Welfare has determined meets all of the following:

(1) Is a nonprofit hospital subsidiary of a State-related institution as that term is defined in 62 Pa.C.S. § 103 (relating to definitions); and

(2) Provides more than 90,000 days of care to medical assistance patients annually. * * *

Section 5. Sections 802-E, 804-E, 805-E, 807-E and 808-E of the act, added July 4, 2008 (P.L.557, No.44), are amended to read: Section 802-E. Authorization.

(a) General rule.-In order to generate additional revenues for the purpose of assuring that medical assistance recipients have access to hospital services and that all citizens have access to emergency department services, and subject to the conditions and requirements specified under this article, a municipality may, by ordinance, [impose] do the following:

(1) Impose a monetary assessment on the net operating revenue reduced by all revenues received from Medicare of each general acute care hospital located in the municipality [subject to the conditions and requirements specified under this article].

(2) Beginning on or after July 1, 2009, and subject to the advance written approval by the secretary, impose a monetary assessment on the net operating revenues reduced by all revenues received from Medicare of each high volume Medicaid hospital located in the municipality.

(b) Administrative provisions.-The [ordinance] ordinances adopted pursuant to subsection (a) may include appropriate administrative provisions including, without limitation, provisions for the collection of interest and penalties.

(c) Maximum assessment.-In each year in which the assessment is implemented, the assessment shall be subject to the maximum aggregate amount that may be assessed under 42 CFR 433.68(f)(3)(i) (relating to permissible health care-related taxes) or any other maximum established under Federal law.

Section 804-E. Administration.

(a) Remittance.-Upon collection of the funds generated by the assessment authorized under this article, the municipality shall remit a portion of the funds to the Commonwealth for the purposes set forth under section 802-E, except that the municipality may retain funds in an amount necessary to reimburse it for its reasonable costs in the administration and collection of the assessment and to fund a portion of its costs of operating public health clinics as set forth in an agreement to be entered into between the municipality and the Commonwealth acting through the secretary.

(b) Establishment.-There is established a restricted account in the General Fund for the receipt and deposit of funds under subsection (a). Funds in the account are hereby appropriated to the department for purposes of making supplemental or increased medical assistance payments for emergency department services to general acute care hospitals within the municipality and to maintain or increase other medical assistance payments to hospitals within the municipality, as specified in the Commonwealth's approved Title XIX State Plan. Section 805-E. No hold harmless.

No general acute care hospital or high volume Medicaid hospital shall be directly guaranteed a repayment of its assessment in derogation of 42 CFR 433.68(f) (relating to permissible health care-related taxes), except that, in each fiscal year in which an assessment is implemented, the department shall use a portion of the funds received under section 804-E(a) for the purposes outlined under section 804-E(b) to the extent permissible under Federal and State law or regulation and without creating an indirect guarantee to hold harmless, as those terms are used under 42 CFR 433.68(f)(i). The secretary shall submit any State Medicaid plan amendments to the United States Department of Health and Human Services that are necessary to make the payments authorized under section 804-E(b).

Section 807-E. Tax exemption.

Notwithstanding any exemptions granted by any other Federal, State or local tax or other law, including section 204(a)(3) of the act of May 22, 1933 (P.L.853, No.155), known as The General County Assessment Law, no general acute care hospital or high volume Medicaid hospital in the municipality shall be exempt from the assessment.

Section 808-E. [Cessation] Time period.

(a) Cessation .- The assessment authorized under this article shall cease June 30, 2013.

(b) Assessment.-A municipality shall have the power to enact the assessment authorized in section 802-E(a)(2) either prior to or during its fiscal year ending June 30, 2010.

Section 2. The act is amended by adding a section to read:

Section 1417. Fraud Reporting to Inspector General.-(a) If an employe of a county assistance office who has reason to believe a recipient or applicant of public assistance is committing fraud or providing false information in order to receive public assistance benefits, including, but not limited to, medical assistance, cash assistance and food stamps, the county assistance office employe shall make a fraud report directly to the Office of Inspector General.

(b) The county assistance employe shall not be subject to any sanctions for making a fraud report.

Amend Bill, page 2, line 8, by striking out "2" and inserting 3

I offer this amendment with the sole purpose of being able to allow for employees to have the option of when they see something is wrong in State government, to have that opportunity to report it.

Simply, this amendment allows for an employee of the Department of Public Welfare when they see some possible fraud, something that they are very well aware of what is right and what is wrong, to be allowed to report that to the Office of Inspector General. Having that opportunity is something they have not had in the past. They have done it under other administrations, at other times. It is policy setting. This would allow for those employees to have that ability without fear of retribution.

Mr. Speaker, our veterans have given generously of themselves so that our country and the freedoms we enjoy can endure. Now our country has an obligation to these brave men and women.

Although there are Federal medical benefits available to our veterans, too often our brave veterans fall through the cracks and do not receive them. Mr. Speaker, by requiring the Department of Public Welfare to ascertain whether or not applicants for its programs and services are veterans, HB 254 will help ensure that veterans in Pennsylvania receive the benefits to which they are entitled.

Mr. Speaker, if an applicant for medical benefits, cash assistance, or energy assistance is determined to be a veteran, the applicant should be directed to an accredited veteran service officer, the State Department of Military and Veterans Affairs, or the county director of veterans affairs where they can file an appropriate VA claim.

Mr. Speaker, this process will ensure that our veterans in Pennsylvania are availing themselves of the benefits available to them through the VA and it will also free up critical Medicaid dollars that can be used to assist other families in Pennsylvania in need.

Mr. Speaker, this legislation makes sense, is patriotic, and I strongly urge my colleagues to join me in supporting it.

Thank you, Mr. Speaker.

The majority having voted in the affirmative, the question was determined in the affirmative and the resolution was adopted.

CALENDAR CONTINUED

BILL ON THIRD CONSIDERATION

The House proceeded to third consideration of HB 1418, PN 2532, entitled:

An Act providing for the capital budget for the fiscal year 2009-2010; itemizing transportation assistance projects to be constructed or acquired or assisted by the Department of General Services or the Department of Transportation, together with their estimated financial costs; authorizing the incurring of debt without the approval of the electors for the purpose of financing the projects to be constructed, acquired or assisted by the Department of General Services or the Department of Transportation; stating the estimated useful life of the projects; and making appropriations.

On the question, Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

(Bill analysis was read.)

The SPEAKER. The question is, shall the bill pass finally?

There are two late-filed amendments by the gentleman from Perry County, Representative Keller, that would require a suspension of the rules. The gentleman is withdrawing the amendments. The Chair thanks the gentleman.

On the question recurring, Shall the bill pass finally?

The SPEAKER. On that question, the Chair recognizes the gentleman from Allegheny County, Representative Turzai.

Mr. TURZAI. Thank you very much, Mr. Speaker.

I just want to point out that this is the capital budget bill, which essentially allows for the issuance of bonds or the additional borrowing, much of it under previously voted-upon legislation.

For those, like me, that have been arguing that under this particular administration we have been borrowing too much, we have borrowed \$6 billion, which our kids and grandkids have to pay back to the tune of \$10 billion, all of that \$6 billion being spent essentially within the Rendell administration during the same time while we have increased regular spending \$10 billion. I have found and many of my colleagues have found that problematic. That borrowing amount that I referenced does not include the \$12 billion I-80 tolling scheme, which is contingent upon moneys being borrowed with toll revenues from the turnpike.

In particular, I felt that the Redevelopment Capital Assistance Program, RCAP, which stood about \$1.6 billion in borrowing at the end of the Ridge-Schweiker administration, we have three times increased that credit card by \$500 million, \$650 million, and \$800 million, more than doubling the amount of the Redevelopment Capital Assistance project. It is true that this issuance of bonds is beyond RCAP. It covers a wide variety of capital budget areas.

The SPEAKER. Will the gentleman yield.

The gentleman, Representative Turzai, is recognized.

Mr. TURZAI. Thank you very much, Mr. Speaker.

Boy, who would have thought that a discussion of debt would engender such excitement.

Anyhow, thank you very, very much, Mr. Speaker.

Mr. Speaker, just for those of us that have over the past years just raised the issue of concern with too much borrowing, to vote in favor of this bill would be inconsistent with that position in opposition to some of the borrowing authorizations that have previously been put up for a vote.

I just wanted to say that Moody's Investors Service and Standard & Poor's recently downgraded Pennsylvania's bond rating outlook, and essentially this capital budget would provide for the issuance. I can see that it is based on previous legislation for \$1.68 billion in additional borrowing over the next year and will ultimately cost about \$2.7 billion in principal, interest, and fees to be paid back over 20 years. Mr. Speaker, that money will be paid by present and future tax dollars. I just want to make that clear on the record.

I rise in opposition to HB 1418. I think it is consistent with the stand that myself and others have taken with respect to previous borrowing proposals that have gone before this General Assembly, and I will vote "no." Thank you very much.

The SPEAKER. The Chair thanks the gentleman and recognizes the majority leader, the gentleman from Luzerne County, Representative Eachus.

Mr. EACHUS. Thank you, Mr. Speaker.

Mr. Speaker, I just wanted to make sure that I made a clarifying statement. The gentleman referred to Standard & Poor's, Moody's, and Fitch's analysis, which I read, which focused on a negative rating for Pennsylvania. The reason why they rated us negatively is because we did not have a budget, and they were concerned that we were going to use one-time fixes and not put enough recurring revenue into this budget, which would guarantee our ratings so that money for our municipalities and our counties and the things that we have to do here are at a fair rate.

Our friends in New Jersey did what our Republican friends in the House and Senate have proposed, which is to use one-time fixes, and guess what happened to their rating? Bam, the taxpayers of those States now pay a higher rate for the money they are lent. It is a simple issue. This has nothing to do with the amount of investment that a Commonwealth makes as it relates to debt as long as it is responsible. It has to do with building a responsible budget model, and that is what we are working on doing, and I just wanted to make sure that this issue and the reports that I read from those three entities were clearly clarified.

The SPEAKER. The Chair thanks the gentleman.

LEAVE OF ABSENCE CANCELED

The SPEAKER. The Chair also notes the presence of the gentleman from Perry County, Representative Keller, on the House floor. His name will be added to the master roll.

CONSIDERATION OF HB 1418 CONTINUED

The SPEAKER. The Chair recognizes the gentleman from Adams County, Representative Tallman, on the question.

Mr. TALLMAN. Thank you, Mr. Speaker.

We know today in our great nation that the vast majority, and I believe it is 58 percent, are very concerned about the indebtedness of our nation and the direction that the current administration in Washington, DC, is taking. Our State is following the same exact path as the administration is in Washington, DC, and under our current Governor, the indebtedness of this State has increased by several magnitudes of 10. Therefore, it is incumbent upon us as representatives of the people of this great Commonwealth to protect their standing as a State, not take us towards the edge of bankruptcy by incurring even more indebtedness. That is plain and simple.

Vote for the bill, vote for debt. If you vote against the bill, at least keep us equal to where we currently stand, which is too much already.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Butler County, Representative Metcalfe.

Mr. METCALFE. Thank you, Mr. Speaker.

Mr. Speaker, as the former gentleman that was making a few comments had mentioned, people across the nation and across our State are concerned about government spending. Last night we saw a billion-dollar-plus tax increase voted on by the Democratic Caucus. Today we are watching another vote that is going to incur or spend more of the people's money through further indebtedness.

I find it very interesting one of the lines in this legislation provides \$15 million for furniture and other equipment. Mr. Speaker, I think there may be some additional chairs somewhere in storage or tables and desks that could be moved around inside the various departments to avoid that extra \$15 million. I know it is a small amount when you look at I think it is \$1.6 billion that the bill entails. But just that one line, \$15 million for furniture, I am sure our constituents, the 13 million or so, 12.78 million across the State would enjoy having \$15 million to spend on furniture and equipment but not something that I think we should be voting in support of today.

And I would agree with a couple of the previous speakers that this should be opposed. People are fed up with irresponsible government, and this is a continuation of it, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Allegheny County, Representative Kotik.

Mr. KOTIK. Thank you, Mr. Speaker.

I am really intrigued by this debate this morning because I think we ought to amend this bill to make it known that everybody that does not want to raise the capital assistance do not put any requests in. It seems like we want to have our cake and eat it, too. We want to vote "no" on this RCAP assistance, and I am not a big fan of debt either, but if you are going to do that, do not put any requests in. Do not put billions and billions of dollars of requests in your district. Let us be consistent on this issue. Let us do the right thing. If you are worried about debt, do not go running over there and asking for all kind of money.

Thank you, Mr. Speaker.

The SPEAKER. The Chair recognizes the gentleman from Allegheny County, Representative Markosek.

Mr. MARKOSEK. Thank you, Mr. Speaker.

Mr. Speaker, just very briefly. If anyone here is not anxious to have any debt for transportation projects in their districts, wait until next year, because you will get a chance to put up other fundraising types of issues next year if you do not want to borrow anything for transportation, because we have major, major vast transportation infrastructure problems staring us right in the face that we are going to have to deal with probably after the first of the year.

So I would suggest that if you do not want to do any borrowing, be ready to vote for other fundraising-type issues to raise money for our very needed and necessary transportation system. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

On the question recurring,

Shall the bill pass finally?

The SPEAKER. Agreeable to the provisions of the Constitution, the yeas and nays will now be taken.
