marked the recognition of the recipient of this highest symbol of unselfish loyalty and sacrifice. Today we honored a young man from Knox, Pennsylvania, who at the age of 19 gave his life to protect the lives of fellow soldiers in his battalion.

Spc. Ross A. McGinnis served in Iraq. He threw his body on a live grenade to protect his comrades, and while he never lived to know what he did was heroic, we hope to correct that in some small way through today's ceremony and by dedicating a place in Soldiers' and Sailors' Grove to the ultimate sacrifice and uncommon courage exhibited by Specialist McGinnis.

Today we salute his bravery and fearless devotion to duty and we honor his service, we honor his patriotism, and we honor his sacrifice.

The SPEAKER. On that question, the Chair recognizes the gentlelady from Clarion County, Representative Oberlander.

Ms. OBERLANDER. Thank you, Mr. Speaker.

Mr. Speaker, I humbly stand before you today to offer this resolution honoring the service and sacrifice of a brave young soldier. He is from my legislative district, and he is Army Spc. Ross Andrew McGinnis.

Ross Andrew McGinnis was born on Flag Day 1987. His parents, Tom and Romayne, who are with us on the floor, named him Ross in honor of Betsy Ross, the seamstress of the first American flag.

Growing up in the small-town community of Knox, Clarion County, Ross knew at an early age, as early as kindergarten, that when he grew up he wanted to be an Army man. Even then it seems Ross was destined to be a soldier, a patriot, and an American hero. When Ross turned 17, he signed up for the early enlistment program in the United States Army. He left Clarion County for basic training a week after receiving his high school diploma. When his basic training was completed, Army Spc. Ross McGinnis, the youngest soldier in his unit, was sent

to fight in Iraq. Divine providence called for Ross soon after to fulfill his destiny and become part of his country's enduring roll call of fallen military heroes.

On December 4, 2006, while serving in Baghdad, 19 1/2-year-old Ross McGinnis was manning the machine gun atop a Humvee with four other soldiers stationed below in the belly of the vehicle. They were the last truck in a convoy. An enemy insurgent tossed a grenade from a rooftop into the vehicle. The Army's official account of what happened next states, and I quote:

"An average man would have leapt out of the gunner's cupola to safety.

"However, Army Specialist Ross McGinnis decided to stay with his crew.

"Without hesitation, and with complete disregard for his own life, he threw his back over the grenade to pin it between his body and the truck's radio mount.

"It detonated seconds later piercing Army Specialist Ross McGinnis' body armor and killing him instantly.

"He turned himself into a human shield and sacrificed his own life to save the lives of his four crew members," end of quote.

For his bravery, courage, and selfless sacrifice, Army Specialist McGinnis was awarded the Purple Heart and the Silver Star. His captain, who describes Ross as one of the bravest men he ever knew, immediately nominated him for the Medal of Honor, America's highest award for combat valor. Since that time, this small-town American hero from Knox, Clarion County, remains one of only six U.S. servicemen to receive the Medal of Honor for fighting in the war against terrorism in Iraq and Afghanistan.

Mr. Speaker, it is for all of these reasons that I ask for your unanimous support of this resolution honoring the life and sacrifice of Army Spc. Ross McGinnis. Thank you.

A Resolution declaring the month of November 2009 as "Pancreatic Cancer Awareness Month" in Pennsylvania.

On the question,

Will the House adopt the resolution?

The SPEAKER. On that question, the Chair recognizes the gentleman from Lackawanna County, Representative Murphy.

Mr. MURPHY. Thank you, Mr. Speaker.

This resolution was introduced to bring awareness about pancreatic cancer. Sadly, it is estimated that over 37,000 Americans will suffer from this insidious disease and over 34,000 will lose their battle with this disease.

This is one of the deadliest types of cancer and the fourth leading cause of cancer deaths in the United States. It is estimated approximately 1,920 deaths will occur in Pennsylvania alone. There is no cure for pancreatic cancer, and there have been no significant improvements in early detection, treatment methods, or survival rates in the past 25 years.

Additionally, Mr. Speaker, the Pancreatic Cancer Action Network is the first and only national patient advocacy organization that serves the pancreatic cancer community in Pennsylvania and nationwide by focusing its efforts on public policy.

Mr. Speaker, the good health and well-being of the residents of the Commonwealth are enhanced as a direct result of increased awareness about pancreatic cancer and research into early detection, causes, and effective treatments.

This disease touches many and it knows no bounds. Many will have known someone affected or diagnosed with this form of cancer.

On the question,

Will the House adopt the resolution?

The SPEAKER. On that question, the Chair recognizes the gentleman from Montgomery County, Representative Murt.

Mr. MURT. Thank you, Mr. Speaker.

Mr. Speaker, this resolution is very relevant and very appropriate, especially in light of the fact that we recognized some fallen heroes and some young men who died in service to our nation earlier today in this session.

Mr. Speaker, today I rise to urge my colleagues to support HR 520, which would designate the week of November 8 through 14, 2009, as "Post-Traumatic Stress Disorder Awareness Week" in the Commonwealth of Pennsylvania.

Mr. Speaker, posttraumatic stress disorder is an emotional and psychological reaction to a traumatic experience such as being in combat.

Mr. Speaker, may I have order in the House, please?

The SPEAKER. The gentleman is entitled to be heard. The House will come to order.

Mr. MURT. Thank you, Mr. Speaker.

Mr. Speaker, while traumatic events such as a violent crime can result in posttraumatic stress disorder, those military personnel who have experienced combat are especially at risk. The symptoms and severity of posttraumatic stress disorder vary. Sometimes symptoms include reliving the trauma through nightmares. Symptoms also include irritability, sensitivity to being touched or to loud noises, an aloofness from family and friends, and the desire to simply be left alone. Jumpiness, insomnia, or physical symptoms such as headaches or nausea are also included, Mr. Speaker. Sadly, some individuals suffering from posttraumatic stress turn to drugs and alcohol to deal with their pain.

Fortunately, Mr. Speaker, much progress has been made as it relates to treating posttraumatic stress disorder. Thankfully, society is also much kinder and understanding of individuals who are suffering in this manner than it was years ago. Caring and compassionate mental health professionals do an outstanding job in helping patients with posttraumatic stress disorder recover and get back on track with their jobs, their families, and their lives.

Mr. Speaker, survivors of posttraumatic stress disorder, including our combat veterans, can and do recover all the time. Perhaps their lives will never be exactly the same as they were before they were sent into combat, but survivors can become healthy again and live full, productive, and happy lives.

We should all do all we can to increase awareness of posttraumatic stress disorder and to encourage family members or friends who might be suffering from posttraumatic stress to seek the care of a mental health professional.

With that in mind, Mr. Speaker, I ask my colleagues to join me in supporting this resolution.

(1.1) possesses a tobacco product; or

- (2) knowingly falsely represents himself to be at least 18 years of age to a person for the purpose of purchasing or receiving a tobacco product.
- (b) Penalty.-
- (1) Except as set forth in paragraph (2), a person that violates subsection (a) shall be sentenced as follows:
 - (i) for a first offense, to pay a fine of not less than \$100 nor more than \$250;
 - (ii) for a second offense, to pay a fine of not less than \$250 nor more than \$500; or
 - (iii) for a third or subsequent offense, to pay a fine of not less than \$500 nor more than \$1,000.
- (2) A retailer that violates subsection (a) shall be sentenced as follows:
 - (i) for a first offense, to pay a fine of not less than \$100 nor more than \$500;
 - (ii) for a second offense, to pay a fine of not less than \$500 nor more than \$1,000;
 - (iii) for a third offense, to pay a fine of not less than \$1,000 nor more than \$3,000; or
 - (iv) for a fourth or subsequent offense, to pay a fine of not less than \$3,000 nor more than \$5,000.
- (3) A minor who violates subsection (a.1)(1) or (2) shall be sentenced to any or all of the following:
 - (i) not more than 75 hours of community service:
 - (ii) complete a tobacco use prevention and cessation program approved by the Department of Health:
 - (iii) a fine not to exceed \$200; or
 - (iv) a 30-day suspension of motor vehicle operating privileges.

(4) A minor who violates subsection (a.1)(1.1) shall:

- (i) for a first offense, be issued a written warning by a police officer who shall file a copy of the warning with the appropriate issuing authority;
- (ii) for a second offense, be sentenced to not more than 75 hours of community service;
- (iii) for a third offense, be sentenced to complete a tobacco use prevention and cessation program approved by the Department of Health; or
- (iv) for a fourth or subsequent offense, be sentenced to pay a fine of not more than \$100.

. . .

(f) Exceptions.-

* * *

- (3) It is not a violation of subsection (a.1)(1) or (1.1) for a minor to purchase [or], attempt to purchase or possess a tobacco product if all of the following apply:
 - (i) The minor is at least 14 years of age.
 - (ii) The minor is an employee, volunteer or an intern with:
 - (A) a State or local law enforcement agency;
 - (B) the Department of Health or a primary contractor pursuant to Chapter 7 of the act of June 26, 2001 (P.L.755, No.77), known as the Tobacco Settlement Act;
 - (C) a single county authority created pursuant to the act of April 14, 1972 (P.L.221, No.63), known as the Pennsylvania Drug and Alcohol Abuse Control Act;
 - (D) a county or municipal health department; or
 - (E) a retailer.
 - (iii) The minor is acting within the scope of assigned duties as part of an authorized investigation, compliance check under subsection (g) or retailer-

organized self-compliance check.

(iv) A minor shall not use or consume a tobacco product.

In the event there is no place of cold storage in the same municipality, the board may approve a place of cold storage in the nearest municipality.
- (2) No importing distributor shall maintain any place for the storage of malt or brewed beverages except in the franchise territory in which the licensed premises is located and unless the same has been approved by the board. The board shall issue no more than two storage facility licenses to an importing distributor. The importing distributor shall designate to the board one storage location where they may make retail sales. The other storage location shall be designated solely as a storage facility, from which only sales to other licensees are permitted.

* * *

(h) As used in this section, the term "franchise territory" shall mean the geographically contiguous area in which an importing distributor has been given rights for the sale or resale of malt or brewed beverages.
