Mr. Speaker, I rise today to honor the life of someone whom the Northeast Times called the most important civic leader in the history of northeast Philadelphia, Mary Jane Hazell.

Since joining the Somerton Civic Association in 1966, Mary Jane forged a reputation as a well-known activist and respected community leader by dedicating herself to improving the quality of life for residents of our community.

Mary Jane worked passionately on practically every relevant proposal and project that affected northeast Philadelphia and the larger city. She was president of the Somerton Civic Association for decades, vice president of the United Northeast Neighbors, a member of the Philadelphia Police Department Advisory Committee for the 7th District, and Civic Association zoning chairperson for two decades before that.

No issue was too big or small. Whether it was the ongoing plans of the Woodhaven Road extension, the redevelopment of the old Byberry State Hospital site, working with the police on improving community relations, working with Philadelphia mayors from Rizzo through Nutter, or in the annual Memorial Day Parade, Mary Jane was there for Somerton and for northeast Philadelphia.

As an active mother and eventual grandmother, Mary Jane cared deeply about our local schools and served as president of the home and school associations of elementary, middle, and high schools.

Mary Jane Hazell was a true public servant. She understood and firmly believed that strong neighborhoods were the root of strong cities, States, and a unified nation. All told, Mary Jane's efforts have kept northeast Philadelphia safe, healthy, and a desirable place to live and work. It is no surprise that 2 years ago when the Philadelphia Eagles were doing, as part of their 75th anniversary, a competition to name the 75 most important living Philadelphians, Mary Jane Hazell was on that list.

So, Mr. Speaker, I respectfully request that we recognize Mary Jane Hazell's life and contributions to her community with a moment of silence.

A Resolution honoring the life and expressing profound sorrow upon the passing of Pennsylvania State Trooper Joshua D. Miller, who lost his life in the line of duty on June 7, 2009, while protecting the citizens of this Commonwealth.

On the question, Will the House adopt the resolution?

The SPEAKER. On the resolution, the Chair recognizes the gentleman from Lackawanna County, Representative Wansacz. Mr. WANSACZ. Thank you, Mr. Speaker.

Pennsylvania State Trooper Joshua D. Miller was born on June 12, 1974, in Pittston and graduated from Pittston Area High School in 1992, where his teachers described him as not only forthright, intelligent and kind, but also very spirited.

Trooper Miller, who enlisted in the United States Marine Corps in 1993, was a true embodiment of "Semper Fi," according to fellow Marine and friend, Rochester, New York Police Officer Brian Phillips.

Upon separation from active duty, having been honorably discharged after attaining the rank of corporal, Trooper Miller worked at the Monroe County Prison while attending Lackawanna Junior College to pursue his goal of becoming a law enforcement officer.

In 1999 Trooper Miller completed his training and joined the Tunkhannock Police Department, where he served until 2002. After years of hard work, Trooper Miller realized his dream of becoming a Pennsylvania State trooper in 2002 and was stationed in Bethlehem. Following his transfer to Troop N, Trooper Miller was selected as a member of an elite unit within the Pennsylvania State Police that conducted an aggressive patrol in Monroe County and was stationed in Swiftwater.

In 2005 Trooper Miller married the love of his life, the former Angela Bowman, with whom he enjoyed hunting and spending quality time with his family. Trooper Miller was the proud and beloved father of three young daughters - Justine, Breana, and Joselyn.

On June 7, 2009, at approximately 7:45 p.m., Trooper Miller, accompanied by fellow Pennsylvania State Trooper Robert Lombardo, responded to a call regarding a man who had violated a protection-from-abuse order and had kidnapped his young son at gunpoint.

A 40-minute, high-speed chase ensued, starting in Nazareth and ending in Coolbaugh Township, where Troopers Miller and Lombardo pinned the car holding the kidnapper and the child into a guardrail. Following procedure, Troopers Miller and Lombardo rushed the driver of the car hoping to remove him from the vehicle and save the child when the driver fired shots at them at point-blank range, killing Trooper Miller and injuring Trooper Lombardo. Because of the brave actions of Troopers Miller and Lombardo, the child was safely removed from the car by two other officers. According to Lt. Col. Lenny Bandy, Lieutenant of Operations for the Pennsylvania State Police, Trooper Miller was truly "a hero who laid down his life instead of swerving from duty.'

Trooper Miller, beloved husband of Angela; adoring father of Justine, Breana, and Joselyn; son of Peggy Hurysh and the late Walter Miller; brother to Jeremy, Daniel, Joel, and Jacob Miller and Season Hurysh, was serving the people of this great Commonwealth with the utmost honor, integrity, and bravery at the time of his tragic passing.

Upon the occasion of his funeral, held in Charlie Trippi Stadium at Pittston Area High School to accommodate the 400 Pennsylvania State troopers who attended, accompanied by their brethren, troopers from 48 States, coming from as far away as Alaska, fellow Pennsylvania State trooper and friend Nicholas Cortes described Trooper Miller as "an angel at my side who would never leave a brother behind."

Family, friends, and all who knew Trooper Miller deeply mourn the extinguishing of the star of his barracks and remember his unconquerable spirit, courage, love, and devotion.

The House of Representatives honors the life and extends the most sincere and heartfelt condolences for the supreme sacrifice of Pennsylvania State Trooper Joshua Miller.

I kindly ask that you join me in celebrating the life of fallen Pennsylvania State Trooper Joshua Miller and offering his family our heartfelt condolences.

(2) The President of the United States, through Executive Order, or the Congress, through legislation, declares that the mandatory divestment of the type provided for under this act concerning China interferes with the conduct of United States foreign policy.

The SPEAKER. On the amendment, the Chair recognizes the gentleman from Lehigh County, Representative Reichley.

Mr. REICHLEY. Mr. Speaker, could you just give me one second. I want to check which amendment this is. Thank you.

Thank you, Mr. Speaker, for your indulgence.

Mr. Speaker, this is an important piece of legislation that the gentleman from Montgomery County has brought before us, and I think it is long overdue to recognize the concerns that a number of members not only of the General Assembly but of Pennsylvania have with regard to the ongoing activities in Sudan and Iran.

Mr. Speaker, may I have just a little bit of attention; sorry.

The SPEAKER. The gentleman has a right to be heard. The House will come to order.

The gentleman, Mr. Reichley, is recognized.

Mr. REICHLEY. Thank you, Mr. Speaker.

Now, despite my support for the underlying legislation, I did file this amendment, along with two other amendments, addressing what I regard are just as tantamount a threat to the moral integrity of this country and more so to our economic security as the concerns over Sudan and Iran, that being with regard to Communist China and also North Korea.

The papers are filled— And it is ironic that the President is in China today engaged in discussions with the President of China regarding our economic security and climate change legislation at the world level, but I think it is important for us to recognize that every day in our country we are subjected to what I regard as a more even insidious level of terrorism than we hear about from al-Qaeda and from other terrorist organizations, and that is the economic warfare being perpetrated upon our country by China.

Just this past month or so, the Chinese had a tariff placed upon tires being imported to the United States from China because they require American tire manufacturers to send every new tire they make for the next 5 years into this country to be sold at a discounted rate below what American tires are being produced and sold at. And that is one small example, whether you look at steel or whether it is other agricultural products. We have had numerous news stories about the tainted nature of items that come from China, whether it is dog food, children's toys, or whatever it might be, and we also have a fair number of examples of Internet theft and cyber attacks coming from China in which even U.S. Congressmen have their computers hacked by people from China in order to obtain national security information.

So I think this is something which needs to be brought to the attention of the people of Pennsylvania and to the general public throughout the country of the threat that has been going on with our country.

#### AMENDMENT WITHDRAWN

Mr. REICHLEY. But out of respect for the gentleman from Montgomery, the concerns about the activities in the Sudan and what is taking place in Iran, I will be withdrawing this amendment, along with my other two amendments, but will request the members to join with me in a bipartisan way to, at the very least, perhaps do an informational hearing through the Intergovernmental Affairs Committee or some other forum so we can take a look at what the impact is on Pennsylvania's workers who have been displaced by cheaper products being made in China, by the impact on our consumers who are threatened with products from China, but more so the degree in which we have entangled ourselves and perhaps our own economic ruin.

Lenin said that the capitalists are going to sell you the rope with which they will hang themselves, and I think we have sort of engaged in that same very dubious situation with regard to so many corporations now being reliant upon the Chinese government's willingness to allow them to establish production facilities closer to natural resources, all to the detriment to our country.

Mr. MURPHY. Thank you, Mr. Speaker.

This legislation was crafted because there is a gap in our State adoption law and regulations in terms of the disposition of case records when an adoption agency closes.

Right now there is no legal mandate to ensure a proper chain of custody for these records, which ensures the integrity of these documents. I feel this is necessary for two equally important reasons. Number one, there are a lot of people here in this Commonwealth of Pennsylvania who are adopted and need to be able to access their adoption records, many who, because of medical concerns for themselves and for their children, may need to access these records for health concerns, and there are also many adoptees who may want to eventually reunite with their birth parents.

This issue was first brought to light last session with former Representative Lisa Bennington of Allegheny County when she identified this gap in the law and introduced HB 1453. A work group was convened consisting of administrators of adoption branches in several county courts, as well as legislative staff from DPW (Department of Public Welfare), and a representative of a private adoption agency. The recommendations of that group are incorporated into HB 1907.

I also want to thank Representative Chelsa Wagner of Allegheny County, who has worked with me and former Representative Bennington to make sure this issue is addressed this session and who is also a cosponsor of this legislation.

I would appreciate an affirmative vote from my colleagues on this bill. Thank you very much, Mr. Speaker.

#### **BILL ON THIRD CONSIDERATION**

The House proceeded to third consideration of **HB 1876**, **PN 2916**, entitled:

An Act amending Title 45 (Legal Notices) of the Pennsylvania Consolidated Statutes, further providing for level of advertising rates and for establishment and change of advertising rates; and providing for additional publication on Internet websites.

On the question, Will the House agree to the bill on third consideration? Bill was agreed to.

The SPEAKER. This bill has been considered on three different days and agreed to and is now on final passage.

(Bill analysis was read.)

## NOVEMBER 17

The SPEAKER. The question is, shall the bill pass finally?

On that question, the Chair recognizes the gentleman from Allegheny County, Representative Maher.

Mr. MAHER. Thank you, Mr. Speaker.

We learned yesterday that this bill in its current form would be historic. For the first time in the history of Pennsylvania and so far as anyone can identify, the first time in the history of our nation, a legislative body is going to dictate to the free press how they have to structure their rates. It seems to me to be such a fundamental imposition on the First Amendment right to the free press, that that alone would be enough to reject this out of hand.

And I understand that the Pennsylvania Newspaper Association, for whatever reason, says that they have struck this bargain. Well, just because the members of that organization are prepared to cast aside the First Amendment, I do not think that means that we need to as well, and I will not.

Now, maybe the reason they were prepared to strike that bargain is because of the unfunded mandate that is included in this bill. When you get to page 6, you will discover that legal notices will now need to be posted on the Internet – so far, so good – but they must be posted on an Internet Web site owned by a newspaper and they will have to pay for it. So this bill creates a monopoly obligation on our State and local governments to publish on the Internet on sites owned by newspapers. Now, I am not sure what is so magical about an Internet Web site and whether it is owned by the newspaper or owned by someone else. If Internet posting makes sense, and I think it does, it seems to me it is none of our business who owns that Web site except for to ensure that it is open and available to the public at large.

I also notice that the requirement that these notices be on the Internet on a Web site owned by a newspaper does not require that that Web site be available to the public. If the newspaper wanted to put up a wall or charge admission, the individuals who would be looking on the Internet for that public notice will not find it. What a sad day for Pennsylvania when casting aside the fundamental element of our Federal Bill of Rights and a deal to create a monopoly on Internet publications of legal notices with daily newspapers.

And to the extent that some may say this is supposed to save government money, I predict at the end it is going to turn out that posting these notices on the Internet with these monopoly obligations will far outweigh any savings from the abandonment of the First Amendment free press.

The SPEAKER. The Chair recognizes the gentleman from Erie County, Representative Evans.

Mr. J. EVANS. Thank you, Mr. Speaker.

May I interrogate the maker of the bill?

The SPEAKER. The gentleman, Representative Hornaman, indicates he will stand for interrogation. The gentleman, Mr. Evans, is in order and may proceed.

Mr. J. EVANS. Thank you, Mr. Speaker.

Mr. Speaker, I was wondering if the maker of the bill could give us information regarding the rate structure of these papers and, indeed, how much money will be saved if this bill is passed into law?

Mr. HORNAMAN. Mr. Speaker, I cannot give you specifics on rate structure, but we are talking about a 25-percent savings across the board. Mr. J. EVANS. As determined by whom, Mr. Speaker?

Mr. HORNAMAN. The legislation, Mr. Speaker.

Mr. J. EVANS. Mr. Speaker, how will this bill be enforced?

Mr. HORNAMAN. Mr. Speaker, the newspapers will be subject to an annual audit at the discretion of the Auditor General of the Commonwealth.

Mr. J. EVANS. And at that time the rate structure will be disseminated to the Auditor General's Office. I am just curious on how this is going to be enforced at the local level so that these local governments, who are now being forced to advertise in major newspapers around the State with legal notices, are going to find out how much indeed they are saving. How will they do that?

Mr. HORNAMAN. Mr. Speaker, the local governments already advertise in newspapers of general circulation. They are not being forced to do that. They already do that and—

Mr. J. EVANS. Mr. Speaker, I believe they are being forced to do that under current law, unless I am mistaken.

Mr. HORNAMAN. Under current law, but not under this legislation.

Mr. J. EVANS. Under your legislation, they would not be forced to advertise in the major newspapers?

Mr. HORNAMAN. They are already doing that, Mr. Speaker.

Mr. J. EVANS. But you are saying your legislation is somehow changing that, and it absolutely is not.

Okay. Maybe we can move on.

For the subscriber or the person that buys a paper at the newsstand, will they also be receiving a discount if they are wishing to look at legal notices in the newspaper?

Mr. HORNAMAN. No, Mr. Speaker.

Mr. J. EVANS. Okay. So in order to get the public information on legal notices, individuals will have to pay a price for that newspaper and really have to buy it every day, because there is no timetable set for which days of the week legal notices are printed in the newspapers, is there?

Mr. HORNAMAN. They will purchase a newspaper as they do now.

Mr. J. EVANS. Okay. Thank you very much, Mr. Speaker. On the bill?

The SPEAKER. The gentleman is in order and may proceed. Mr. J. EVANS. As we discussed yesterday, I think, as Representative Maher indicated in his comments, this is something that is unenforceable. I do not understand, if the rates are not being given out in a public way, I am still waiting to see what the rates are, and that information is not being disclosed to us who are legislators. So we do not know what the rate was yesterday, we do not know what it was last month, we do not know what it was last year, and we are talking about discounting a rate that is a mystery.

#### MOTION TO TABLE

Mr. J. EVANS. So for those reasons I think that this is not a properly drafted bill and would make a motion, Mr. Speaker, to table this piece of legislation.

The SPEAKER. The gentleman from Erie County, Representative Evans, makes a motion that HB 1876 be placed on the tabled bill calendar.

Less than the majority having voted in the affirmative, the question was determined in the negative and the motion was not agreed to.

On the question recurring, Shall the bill pass finally?

The SPEAKER. On that question, the Chair recognizes the gentleman from Philadelphia County, Representative Cohen.

Mr. COHEN. Mr. Speaker, I wish to commend the gentleman from Erie for introducing this bill. This bill is a sensible resolution to a difficult problem. We have heard complaints, as has the newspaper industry, from local governments all over the State. Mr. Hornaman has helped craft a very, very sensible compromise which the newspapers support.

I strongly urge us to vote for this bill. Let us solve a problem for local governments. Let us solve a problem for the media. Let us pass this bill.

The SPEAKER. On the question, the Chair recognizes the gentlelady from Philadelphia County, Representative Manderino.

Ms. MANDERINO. Thank you, Mr. Speaker.

I, too, rise to support HB 1876 on final passage.

The gentleman from Erie has done a yeoman's job in bringing a very complex issue with a lot of controversy around to a solution of compromise, and I think it is well served for our local governments, our newspapers, but most particularly, the citizens of Pennsylvania.

I do want to share some information that I recall from when we had hearings on this bill in committee, because it is different than something that has been said during the debate both yesterday and today. My recollection from our hearing is that, contrary to what may have been said prior, all of the States in the United States or almost all of them do have newspaper advertising acts which address, regulate, and in some States even establish specific rates that newspapers may charge for publishing of legal notices. In Ohio, for example, the law actually contains in the statute a table of line and column, space and inches, how much can be charged by font size, et cetera. It has different prices for smaller newspapers versus larger circulation newspapers, and larger circulation newspapers even have to go to the General Assembly if they want a rate increase.

So we are not setting any kind of new or untested precedent by, for the first time in our law, having a little bit of rate structure around the legal advertising notices, and it only makes sense since government is the one that says you must put these legal advertisements in the paper for the purpose of letting the citizens know. It is a logical extension from there for government to make sure those rates are reasonable.

I think the gentleman has done a very good job with his legislation, and I commend him and urge us all to vote "yes."

The SPEAKER. On the question, the Chair recognizes the gentleman from Cumberland County, Representative Gabig.

Mr. GABIG. Thank you, Mr. Speaker.

Would the maker of the bill please stand for brief interrogation?

The SPEAKER. The gentleman, Representative Hornaman, indicates he will stand for interrogation. The gentleman, Representative Gabig, is in order and may proceed.

Mr. GABIG. Thank you, Mr. Speaker.

This is a question regarding the local governments – the counties, the boroughs, the townships and cities. Have they taken a position on final passage that you are aware of?

Mr. HORNAMAN. Initially, the townships, the boroughs, and so on supported a different form of relief on legal advertising. Since this form of the bill passed on second consideration, I have had no feedback from them concerning final passage of the bill. However, any relief that we can give the boroughs, the townships, the municipalities, the governmental units, I am certain, will be highly welcomed.

Mr. GABIG. Thank you. That concludes my interrogation.

On the bill, Mr. Speaker?

The SPEAKER. The gentleman is in order and may proceed. Mr. GABIG. Thank you, Mr. Speaker.

I have just been informed by our Judiciary staff which handled this bill that the local government is opposed to this bill in its current form. They supported the Creighton amendment, which actually, I think, was very similar to the gentleman's original bill. I think he should have stuck to his guns maybe on that, but the local government, I have been informed, is not in support of final passage of this, and I am not exactly sure why, because I have not had a chance to talk to them since yesterday, but I do know that there are some problems with the amendment that was constructed. And I am not saying— It is well intended, as I said. The gentleman, I think, had a bill very similar to Representative Creighton's amendment when he started.

But we heard today – and I looked on our computers here on the desk – that under section 1(c) the Auditor General, the Pennsylvania Auditor General will be able to go in and audit now all of the private newspapers throughout the Commonwealth at his discretion, his or her discretion – not audit a Commonwealth or not audit the local governments, but audit the private newspapers. Go in there right now. We do not know what they charge. Those are proprietary. They compete in a marketplace. They do not go around telling their competitors here is what we charge. They deal with their customers and they reach contracts, and that is privy information between the parties. So that is why the gentleman, the maker of the bill, was unable to answer the gentleman from Erie, Mr. Evans's question about what are the rates July 1, 2009, which are referenced in his bill. These rates are going to be reduced from July 1, 2009, by 25 percent, but we do not know what those rates are. Nobody knows what those rates are. Those are proprietary, they are not known to us, and that is why the gentleman could not answer it. He was not trying to be evasive or not answer. He does not know. He does not have a legal right to know. None of us do.

So to say we are going to try to reduce it 25 percent, because the argument from the local government is these newspapers have been gouging them, as all monopolies do, they are taking advantage of their monopoly and they are charging too much. And there has been a lot of pressure from both sides of the aisle since I have been here. I was elected in 2000 and took office in 2001. This idea of trying to control these legal fees has been around in a lot of different forms – the Internet, the community papers. We have got to do something about the rising costs, but that is the problem. We are now giving the Auditor General carte blanche to walk through newspapers. That is unheard of.

So I understand that this was cobbled together, and I am not even sure how I voted on it in Judiciary, but I knew there were going to be steps to continue to work with the local governments to come to a consensus. And the disappointment I have here is what I am hearing from our side, and you could look on your e-mails. Did you get anything from your local governments saying they support this? You know they have people that come up here and tell us whether they support it or not. They work full-time for the Boroughs Association, the League of Cities, the County Commissioners Association. They come up and tell you when they support something. They give an e-mail, and I have not seen anything.

So that is why I think we are moving in the right direction. I think this is a good attempt, but I just do not think this is the final product, and I am not going to be able to support it today.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman from Berks County, Representative Caltagirone.

Mr. CALTAGIRONE. Thank you, Mr. Speaker.

A gentle reminder to the gentleman, just check the record. He was a "yes" vote in voting the bill out of committee. That is number one.

Number two, since 1789 this House – we did not have a Senate at the time, by the way – this House regulated and mandated publication on legal notices. We did it, this body.

In negotiations with the Newspaper Association, as I alluded to yesterday, they agreed to this. They are willing to cooperate. They know and they admitted in the hearing, by the way, those of you that were there, that they just happened to be overcharging governmental bodies for the last 200 years; they admitted that, because we are locked into the advertising at all governmental levels. We were going to do the 100 percent or Internet, and then we sat down and discussed what would be reasonable. And they agreed in the amendment that was adopted in committee to the 25-percent reduction at the lowest commercial rate, whatever that would be, because it will vary from community to community. It will be a lot larger in Philadelphia and Allegheny as compared to Erie or Reading, but there will be substantial savings. What I do not fathom is - and I have just been here a few years - how do you look a gift horse in the mouth? Every municipal government, our government, every one that all of us represent will have a savings. This is the first time we have been able to accomplish something like this. That is what this piece of legislation will do.

If there are any questions that anybody has about this, you know I would be more than willing to stand to answer any of the questions that you may have, but we had a hearing on this bill. We sat down with the Newspaper Association. We do not want to put them out of business. There are some in this chamber that would like to run the Internet advertising. That would put them out of business. This was a compromise. They were more than willing to agree to this. And if there are any of the local governments that do not want the savings, well, you know, let them advertise in the small newspapers or the other organs that are available.

This is a good bill. It was compromised. We had the hearing. This is what it is. I would ask for an affirmative vote. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentlelady from Chester County, Representative McIlvaine Smith.

Ms. McILVAINE SMITH. Thank you, Mr. Speaker.

I rise to ask for my colleagues' support of the final passage of HB 1876.

As I said yesterday, I had the original bill, HB 795, which would have caused the Pennsylvania Newspaper Association members, about 1500 newspapers across this Commonwealth, to lose a lot of revenue and possibly, as the PNA said, possibly put them out of business, because I felt that it is time to advertise on the Internet and not be charged. I feel that this is public information and that newspapers should publish this information for free, but they have been getting revenue from this, and it has gotten out of hand.

And to answer the last speaker prior to Representative Caltagirone about how will we know how much people are saving, well, my municipality, West Chester Borough, knows how much they have to pay every time they advertise in the Philadelphia Inquirer and in the daily local news in Chester County. They know for a fact how much it costs them every single time they do it. So they will be able to figure out very easily what 25 percent less is.

And the reason that we are asking the Auditor General to be able to look into it is, if my borough has a complaint, then we need someone to be able to enforce the law, and that is the way to enforce it.

I want to just also close with saying that government, this legislative body, is the body that created the original law that required government entities to advertise in two newspapers of record. We created that, and now what we are trying to do is to give some alleviation to help our local municipalities and our local taxpayers not have to pay so much.

On my bill we could not reach a compromise because I felt very strongly that we should not have to pay for this information twice. Taxpayers pay to have it advertised in the paper, then they pay to buy that paper back to get the information. It should be on the Internet. But this is the only compromise we could get to, and this is a step forward.

So again, I commend Representative Hornaman for coming forward with this compromise, and I think that everyone on this

floor should support it because that will be your vote to help your local municipalities, your local taxpayers save money.

Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentlelady and recognizes the gentleman from Lancaster County, Representative Boyd.

Mr. BOYD. Thank you, Mr. Speaker.

I was wondering if the gentleman would stand for a brief question?

The SPEAKER. The gentleman, Representative Hornaman, indicates he will stand for interrogation. The gentleman, Mr. Boyd, is in order and may proceed.

Mr. BOYD. Thank you.

Mr. Speaker, earlier there was reference made by the gentleman from Allegheny County to the additional requirement in this bill for the newspapers to post the notice also on a newspaper-owned Web site. I read that section, and the question I have for you is, is the newspaper or the parent company permitted to charge an additional fee under your bill for that posting on top of what they charge for the print media advertising?

Mr. HORNAMAN. No, Mr. Speaker.

Mr. BOYD. I appreciate that, particularly for legislative intent, having that on the record.

Can you cite me in the bill where that specifically delineates the fact that they are not allowed to charge a subsequent fee for that Internet advertising?

Mr. HORNAMAN. The advertising charges, Mr. Speaker, are part of the entire package that is offered. So the Internet is not specifically delineated as an additional charge in any way.

Mr. BOYD. So if I understand the answer to my question, Mr. Speaker, it is that this will be an additional requirement that the newspaper, under this act, will be required to do and do it for the fee that is 25 percent lower than what they currently charge for that fee?

Mr. HORNAMAN. That is correct, Mr. Speaker.

Mr. BOYD. Okay. Mr. Speaker, I appreciate the answer, particularly, again, for legislative intent. I guess my concern would be to be certain that the Newspaper Association that is supporting this bill is readily aware that there cannot be any subsequent charges for the Internet advertising. This bill will be heading across the building, and I would recommend that we make absolutely certain that that is clear if there needs to be any addressment in the legislative process. I certainly support in concept what the gentleman is trying to do. I, like many others, would like to see the advertising be on the Internet and not have to pay any fee. I also understand that this is a building that requires compromise at times, but I would appreciate certainly some clarification on that before this bill comes back on final passage.

So with that said, I appreciate the gentleman answering my questions. Thank you, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman and recognizes the gentleman from Northampton County, Representative Freeman.

Mr. FREEMAN. Thank you, Mr. Speaker.

Mr. Speaker, I rise to support HB 1876, and I wish to commend the prime sponsor, Mr. Hornaman, on crafting this measure, as well as Chairman Caltagirone and his staff for helping to guide it through the committee process.

This piece of legislation is a major step forward in reducing the costs to local government, and I think in the course of this debate, we are kind of losing sight of that.

Municipal governments in Pennsylvania are required to publish notice in papers of general circulation in order to inform their citizens, their residents, of various government actions and of various meetings. That is current law; that is existing law. Mr. Hornaman has proposed a measure, the one we have before us today, that will make substantial savings to those local units of government - a 25-percent reduction in the costs they currently face in meeting their obligation of public notice.

In these challenging fiscal times, which all levels of government are facing, this is a significant savings to those units of government, and that means a significant savings to the taxpayers who pay for the operations of those units of government. So this is a measure that will save taxpayers' dollars, and I think in these very challenging fiscal times, we do not want to turn away from a commonsense proposal like this that will save significant money for the taxpayers of Pennsylvania.

I urge a "yes" vote for this very reasonable, well-thought-out measure, and I again commend the gentleman for his legislation.

The SPEAKER. The Chair thanks the gentleman.

Mr. HORNAMAN. Thank you, Mr. Speaker.

The municipalities know very well what they are paying. They know what the rates are. That is coming out of their pocket. It is coming out of the taxpayer's pocket. As the lady from Chester County alluded to, to those who question, what are the rates, what are the rates, ask your municipality.

HB 1876 helps all of our governmental units that publish these legal notices by requiring a 25-percent cut in the rates charged by the newspapers of general circulation, and dissemination of this information is further assisted by the requirement that these legal notices must be posted on an Internet Web site maintained by the newspaper, which many of them already do.

Regardless of what form you felt this bill should take, this bill is the compromise; this bill is the format that can move forward, and the free press that was alluded to supports this bill. This very day, you can help, you can help your municipalities and help your local governments with a positive vote on HB 1876.

## STATEMENT BY MR. KOTIK

The SPEAKER. The Chair recognizes the gentleman from Allegheny County, Representative Kotik, under unanimous consent. Without objection, the gentleman is recognized.

Mr. KOTIK. Thank you, Mr. Speaker.

Mr. Speaker, I rise today to note the passing of a distinguished Pennsylvanian, Dr. Neal V. Musmanno – a local high school principal, a longtime civil servant, and a proud World War II veteran.

Dr. Musmanno, a native of Stowe Township, Allegheny County, within my legislative district, died Friday, November 13, 2009, at the age of 95. He was born in Stowe Township in 1914.

Upon his 1936 graduation from the Pennsylvania State University, he took a job as a teacher at Stowe High School.

He joined the United States Navy during World War II and was a lieutenant commander on the USS Niblack, a naval destroyer that helped to sink a German submarine.

When he was injured and sent to the former Chelsea Naval Hospital in Boston, he befriended his roommate, who later went on to become the President of the United States; namely, President John F. Kennedy.

Nearly two decades later, Mr. Musmanno was invited to attend President Kennedy's inauguration in 1961. Even after becoming President, Kennedy affectionately called his old friend "Mussy."

In 1945, he had the honor to serve as a member of the official party that accompanied President Franklin D. Roosevelt to the Yalta Conference in February of that year for the purpose of discussing Europe's postwar reorganization.

Returning home from the war, he went on for a time to work at the Glenn L. Martin Co., now Lockheed Martin, but soon returned to Stowe Township as its principal.

In the year 1959, Gov. David L. Lawrence appointed him Deputy Secretary of Education. He continued to serve in that capacity through the administrations of five Governors. He left the Department of Education during the administration of Gov. Richard L. Thornburgh, although he continued to consult for the department for years after.

During his two decades of service to the Commonwealth, he worked closely with State schools for the deaf and blind in Scranton and Pittsburgh. He also launched the precursor to the Bureau of Special Education and was instrumental in pushing Pennsylvania to change references in State laws from "handicapped" to read "exceptional." He liked to say that "every child is a candidate for greatness."

A devoted father, Dr. Musmanno took a special leave from the Navy to watch his eldest child start first grade and inspired three of his children to pursue careers in education.

He is survived by his children – Patricia A. Homer of Greenville, Mercer County; Neal V. Musmanno, Jr., of France; Victor H. Musmanno of Germany; James M. Musmanno of Harrisburg; Daniel G. Musmanno of New Orleans; Mark C. Musmanno of Allison Park; and Anne B. Blocksidge of McKees Rocks – 12 grandchildren, and 15 great-grandchildren.

In addition to his wife, he was preceded in death by his uncle, the late Michael Musmanno, Supreme Court Justice here in Pennsylvania.

Mr. Speaker, it is my pleasure to have known Dr. Musmanno. He was a great public servant. He set a high standard for all of us. And upon this recognition of his death, I would like the House to observe a moment of silence on his behalf.
