Ms. BOBACK. Thank you, Mr. Speaker.

In November, the United States Preventive Services Task Force released new recommendations for breast cancer screening that are regressive and detrimental to the health of women. This task force recommended delaying a woman's first mammogram for a decade and suggests that less screening for breast cancer is necessary. Several States, including California and New York, have already begun following these recommendations and have ceased providing mammograms for women under the age of 50 in their State-sponsored breast cancer screening programs for low-income women.

As we speak, Congress is putting the finishing touches on a revolutionary overhaul of our nation's health-care system. As they consider points both fine and broad, it is imperative that we bring to their attention the importance of mammogram screenings for women starting at age 40. Early detection of breast cancer saves lives, and mammograms are the best early detection method available today.

Over the past few weeks, I have spoken to many women who have been touched by breast cancer. Many of them recounted stories of how a mammogram and mammogram screening during their forties found cancer. The early detection of their cancer gave them greater treatment options and greater hope for long-term survival. These brave women shared their experiences with me in anticipation that other women might be spared, if we act now against the task force's suggestions.

That is why I am asking you to join with me in urging Congress to employ the American Cancer Society guidelines for breast cancer screening. These guidelines state that women should start annual mammograms at age 40.

It is easy to use statistics to validate the task force's desire to lower health-care costs, but at what price? The price of even one woman's life is much too high. Women are not statistics. They are our mothers, our sisters, our daughters, our wives, our friends, and they deserve to live without the fear of breast cancer. They must live without the fear that breast cancer will go undetected until it is too late.

Please join me in the fight for women's health. Please vote in support of this resolution.

BILL ON CONCURRENCE REREPORTED FROM COMMITTEE

SB 711, PN 1563

By Rep. EACHUS

An Act amending Title 4 (Amusements) of the Pennsylvania Consolidated Statutes, making extensive revisions to provisions on gaming, in the areas of legislative intent, definitions, the Pennsylvania Gaming Control Board, applicability of other statutes, powers of the board, code of conduct, expenses of regulatory agencies, licensed gaming entity application appeals from board, license or permit application hearing process and public hearings, board minutes and records, regulatory authority, collection of fees and fines, slot machine license fee, number of slot machines, reports of board, diversity goals of board, license or permit prohibition, specific authority to suspend slot machine license, Category 2 slot machine license, Category 3 slot machine license, applications for license or permit, slot machine license application, slot machine license application character requirements, supplier licenses, manufacturer licenses, gaming service provider, occupation permit application, alternative manufacturer licensing standards, alternative supplier licensing standards, additional licenses and permits and approval of agreements, license renewals, change in ownership or control of slot machine licensee, nonportability of slot machine license, appointment of trustee, table games, slot machine licensee deposits, gross terminal revenue deductions, itemized budget reporting, establishment of State Gaming Fund and net slot machine revenue distribution, distributions from Pennsylvania Race Horse Development Fund, Pennsylvania Gaming Economic Development and Tourism Fund, transfers from State Gaming Fund, responsibility and authority of Department of Revenue, wagering on credit, eminent domain authority, compulsive and problem gambling program, drug and alcohol treatment, labor hiring preferences, declaration of exemption from Federal laws prohibiting slot machines, financial and employment interests, additional restrictions, political influence, regulation requiring exclusion of certain persons, prosecutorial and adjudicative functions, investigations and enforcement, conduct of public officials and employees, prohibited acts and penalties, report of suspicious transactions, applicability of Clean Indoor Air Act, liquor licenses at licensed

facilities, interception of oral communications, electronic funds transfer terminals, junkets, gaming schools, appropriations and Commonwealth Financing Authority; and making related repeals.

The House proceeded to consideration of concurrence in Senate amendments to House amendments to **SB 711, PN 1563**, entitled:

An Act amending Title 4 (Amusements) of the Pennsylvania Consolidated Statutes, making extensive revisions to provisions on gaming, in the areas of legislative intent, definitions, the Pennsylvania Gaming Control Board, applicability of other statutes, powers of the board, code of conduct, expenses of regulatory agencies, licensed gaming entity application appeals from board, license or permit application hearing process and public hearings, board minutes and records, regulatory authority, collection of fees and fines, slot machine license fee, number of slot machines, reports of board, diversity goals of board, license or permit prohibition, specific authority to suspend slot machine license, Category 2 slot machine license, Category 3 slot machine license, number of slot machine licenses, applications for license or permit, slot machine license application, slot machine license application character requirements, supplier licenses, manufacturer licenses, gaming service provider, occupation permit application, alternative manufacturer licensing standards, alternative supplier licensing standards, additional licenses and permits and approval of agreements, license renewals, change in ownership or control of slot machine licensee, nonportability of slot machine license, appointment of trustee, table games, slot machine licensee deposits, gross terminal revenue deductions, itemized budget reporting, establishment of State Gaming Fund and net slot machine revenue distribution, distributions from Pennsylvania Race Horse Development Fund, Pennsylvania Gaming Economic Development and Tourism Fund, transfers from State Gaming Fund, responsibility and authority of Department of Revenue, wagering on credit, eminent domain authority, compulsive and problem gambling program, drug and alcohol treatment, labor hiring preferences, declaration of exemption from Federal laws prohibiting slot machines, financial and employment interests, additional restrictions, political influence, regulation requiring exclusion of certain persons, prosecutorial and adjudicative functions, investigations and enforcement, conduct of public officials and employees, prohibited acts and penalties, report of suspicious transactions, applicability of Clean Indoor Air Act, liquor licenses at licensed facilities, interception of oral communications, electronic funds transfer terminals, junkets, gaming schools, appropriations and Commonwealth Financing Authority; and making related repeals.

On the question,
Will the House concur in Senate amendments to House amendments?

The SPEAKER. On that question, the Chair recognizes the gentleman from Bucks County, Representative Clymer.

Mr. CLYMER. Thank you, Mr. Speaker.

Mr. Speaker, is there someone that can stand for brief interrogation?

The SPEAKER. Will the gentleman, Mr. Clymer, yield.

There are a number of amendments that are filed to the bill. The order would be to recognize those members before we recognize you on concurrence. Will the gentleman yield for a moment.

The SPEAKER. The gentleman from Philadelphia County, Representative O'Brien, does he wish to suspend the rules to offer amendment A05293?

Mr. M. O'BRIEN. Thank you, Mr. Speaker.

The SPEAKER. The gentleman from Philadelphia County, Representative Mike O'Brien, makes a motion that the House do suspend its rules for the immediate consideration of amendment A05293.

The SPEAKER. On that question, on the motion to suspend the rules, the Chair recognizes the gentleman from Luzerne County, the majority leader, Representative Eachus.

Mr. EACHUS. Thank you, Mr. Speaker.

Mr. Speaker, can I have order in the chamber, please?

The SPEAKER. The gentleman is correct. The House will come to order. The House will come to order. Members will please take their seats.

On the question of suspension of the rules, the Chair recognizes the gentleman from Luzerne County, Representative Eachus.

Mr. EACHUS. Thank you, Mr. Speaker.

Mr. Speaker, I rise respectfully to oppose the gentleman's amendment from Philadelphia. I have the highest regard for the gentleman. I understand he has a particular concern with this legislation, but I respectfully oppose the motion to suspend.

The SPEAKER. On that question, the Chair recognizes the gentleman from Philadelphia County, Representative O'Brien, Mike O'Brien.

Mr. M. O'BRIEN. Thank you, Mr. Speaker.

Mr. Speaker, this amendment puts back language into the bill that would prohibit an extension of time for licenses to be up and operating. Now, this deals with an awarded license, and if we track this back through the process, it speaks to one license only. It speaks to the Foxwoods license in Philadelphia County and no other. It seems to me that it is reprehensible that the language that is currently in the bill would benefit one licensee who has made minimal attempts to be up and operating in the appointed amount of time.

Now, if we stand here today and if we say we need to get this done, we need to get this done right away, we need to get this done immediately, because we need money, how do we derive revenue by allowing a licensee who has not acted prudently an additional 2 years?

Let us get this done. Let us get revenue flowing. Let us fulfill our budgetary commitments, and I would ask for a "yes."

The SPEAKER. On the question before the House, shall the House suspend the rules for the immediate consideration of amendment A05293?

On that question, those in favor of suspending the rules will vote "aye";— For what purpose does the gentleman from Dauphin County, Representative Payne, rise?

Mr. PAYNE. Thank you, Mr. Speaker.

With all due respect, Mr. Speaker, it is not on the system. We did not get a hard copy in caucus. We have not caucused on this. We do not even know what it is that the gentleman is proposing.

On the question recurring,

Will the House concur in Senate amendments to House amendments?

The SPEAKER. On the question, the Chair recognizes the gentleman from Bucks County, Representative Clymer.

Mr. CLYMER. Thank you, Mr. Speaker.

Where I left off a few minutes ago, if someone could stand for interrogation?

The SPEAKER. The gentleman from Berks County, Representative Santoni, indicates he will stand for interrogation. The gentleman from Bucks, Representative Clymer, is in order and may proceed.

Mr. CLYMER. Thank you very much, Mr. Speaker.

Mr. Speaker, I am going to ask a few questions, and I just need to establish some clarity in SB 711. Certainly, we do not want a repeat of the year 2004 when the bill kept changing language right up to the eleventh hour and what we thought was in the bill was not in the bill, and it was just not a good process. I think the Speaker's Commission on Reform dealt with this very issue to make sure that we all understand exactly what is in the bill when we pass the final vote.

So here is my question, one of my questions: The issue of allowing credit to both the gamblers at the slot machines and at the table games, is that still in the bill?

Mr. SANTONI. Thank you, Mr. Speaker.

The answer to your question is yes. The Senate did allow the ability for people to obtain credit at the casinos.

Mr. CLYMER. Mr. Speaker, one of the issues that we are concerned about is this 30-mile limitation, that no tourist casino can be built within 30 miles of another casino. Has that language been taken out of the bill or is that still in the bill?

Mr. SANTONI. The current version of the bill does not create any additional category 3 licenses.

Mr. CLYMER. Has not created any category 3 licenses, so we still have competition for a second tourist casino license? That second license is still being bid by interested parties. Is that correct?

Mr. SANTONI. Mr. Speaker, under the current bill, the application process will be opened, yes.

Mr. CLYMER. So it is open, but I never got an answer to that 30-mile limitation, so we will have to check that out carefully.

Mr. Speaker, I understand that in this bill you have slot machine competition. I never heard of that. I heard that there is going to be competition for poker games. I assume that is still in the bill, but I am not sure what it is about slot machine competition. Can you shed some light on that issue?

Mr. SANTONI. I am not sure I understand your question, Mr. Speaker. Current law contemplates slot machine tournaments. That is under current law.

Mr. CLYMER. Slot machine tournaments. To your knowledge, have any of these slot machine tournaments been held?

Mr. SANTONI. Mr. Speaker, I am not aware that they have.

Mr. CLYMER. Okay. So we need to check into that, into that issue as well.

Mr. Speaker, one of the issues that we have been debating here is the issue of the 2-percent fee that goes to local municipalities and to counties. Can you explain for all of us exactly what is in this bill as it relates to that 2-percent fee that we thought was going to go for the infrastructure, you know, for roadways and bridges and ambulance and another for police, but now it seems like there are some other caveats involved here as well. An explanation of that 2-percent fee.

Mr. SANTONI. The 2 percent is broken down, Mr. Speaker, as 1 percent to the county and 1 percent to the municipalities in the community where the casinos are located.

Mr. CLYMER. Okay. To be used as they would see fit? They could go to different community projects. Is that correct?

Mr. SANTONI. Mr. Speaker, there is distribution language in the bill that varies by facility.

Mr. CLYMER. All right. Thank you, Mr. Speaker.

Mr. Speaker, one of the issues that we had looked at and received a lot of debate was on local referendums.

The SPEAKER. The gentleman will yield. The House will come to order. The gentlemen are having a difficult time hearing the debate and asking of the questions. The House will come to order.

Mr. CLYMER. Thank you, Mr. Speaker.

The SPEAKER. The gentleman will yield. Members will please take their seats.

The gentleman, Mr. Clymer, may proceed.

Mr. CLYMER. Thank you, Mr. Speaker.

Mr. Speaker, there has been a lot of discussion on local referendums. There have been amendments back and forth, and I am not exactly clear as to whether or not SB 711 on concurrence provides local municipalities, counties such as Philadelphia County, as an example, to have local referendums when it deals to the legalization of slot machines, allowing slot machines – I am sorry – table games into their communities. Is that local referendum provision in there?

Mr. SANTONI. Thank you, Mr. Speaker.

There are no local referendum provisions per se, but in the process of securing a license, there are provisions and the

Pennsylvania Control Board is required to have public impact meetings and hearings and during that process will get input from the community.

Mr. CLYMER. I was hoping that people would have the choice to make a decision.

Going on to the next concern that I have, and this is an issue that has been raised by members on both sides, but in particular on our side of the aisle, and that deals specifically with the authority by the Attorney General or the State Police to be primary in the investigations of casino applications. I just want to make sure where we are on that bill because there were amendments, there was extensive debate on that issue. So can you tell me, is it the BEI, the Bureau of Enforcement and Investigation, that is still primary in doing the investigations, or has that been changed to allow the Attorney General and/or State Police to be primary investigators?

Mr. SANTONI. Mr. Speaker, the Senate made no changes to the House bill that we passed with regards to that issue.

Mr. CLYMER. And finally, Mr. Speaker, another issue that I wanted to bring up, but I did not have the opportunity on an amendment, however, just to be certain that there has been no change, under the current slot machine bill – no, under the current slot machine legislation, law, the casinos are able to provide free alcohol to the consumer. So have there been any changes to modify that provision in the law that would prohibit the use of free alcohol to those who are gaming in the casinos?

Mr. SANTONI. Mr. Speaker, there have been no changes on that issue.

Mr. CLYMER. Mr. Speaker, that concludes my interrogation, and thanks to the gentleman. Thank you.

The SPEAKER. The Chair thanks the gentleman.

The Chair recognizes the gentleman from Allegheny County, Representative Turzai, on the question of concurrence in Senate amendments.

Mr. TURZAI. Thank you very much, Mr. Speaker.

I want to make it clear not only to our colleagues here, but to the public watching that many, if not all, will vote to nonconcur, a technical term used in this legislature, on the Senate version of expanded gambling. But for many of us on our side of the aisle and some from the other side, the nonconcur vote will be for a different reason than some others. Some want expanded gambling with the taint that this particular draft and other drafts have included and are fighting for the spoils, so they will vote nonconcur because they want a better divvying up of the proceeds. Many of us are opposed to the expanded gambling bill because we think that it does not pass the smell test; it does not have appropriate law enforcement reforms; the proceeds do not fully go to property tax relief.

I want to make it clear, if anybody had ever asked if we were going to do an expanded gambling bill that could pass the smell test, what might it look like? Well, in the first instance – and it goes back to the original slots bill of 2004 – all licenses should have been auctioned. If there are any new licenses, these should be auctioned. Second, all proceeds should have gone to what was promised, every cent, property tax relief.

The SPEAKER. The gentleman will yield.

The gentleman will maintain his remarks to concurrence in the amendments inserted by the Senate only.

Mr. TURZAI. Third, and this version does not have it, full and complete oversight from a law enforcement perspective as has been testified before hearings of this House, all law enforcement should be with the Attorney General and the State

Police, not the Gaming Board. They should be public hearings with complete vetting of the licenses, and they should have been auctioned.

The fact of the matter is, this bill as sent over to us by the Senate, and any of the other versions that we have seen, does not pass the smell test and should be nonconcurrent.

I want to read from an editorial from the Philadelphia Inquirer the day before Christmas, the Philadelphia Inquirer, speaking about this bill, "...the political class in Harrisburg still can't control itself.

"Take the pet projects slipped into the latest effort to expand gambling in Pennsylvania..."

The SPEAKER. The gentleman will yield.

The gentleman, Mr. Turzai, the debate and your remarks should be on the amendments inserted by the Senate and nothing else.

Mr. TURZAI. This is about the Senate version of the bill, and the editorial speaks to the Senate version of the bill, and I am arguing why we should be nonconcurring. That is not afield at all. It specifically addresses the Senate version of the bill, and there is no reason for the public not to know about the Senate version of the bill in this body. It is a Democratic body, and it is up to the public to be able to see exactly what is being voted upon, which is what I am speaking to, period.

The SPEAKER. The Speaker is not going to debate you on that issue. The issue is, you passed the rules in this House, Mr. Turzai, and the rules are that you are to speak on concurrence on the amendments inserted by the Senate—

Mr. TURZAI. And I am speaking on the—

The SPEAKER. And I will grant you that—

Mr. TURZAI. Mr. Speaker, I—

The SPEAKER. The gentleman is out of order. The gentleman is out of order. You are allowed to speak on the amendments inserted in the Senate.

The gentleman may proceed.

Mr. TURZAI. The last two paragraphs: "Take the pet projects slipped into the latest effort to expand gambling in Pennsylvania – Gov. Rendell's special baby come full term.

"Under the proposal, select hospitals, libraries, and medical schools with ties to key lawmakers will get dedicated funding from the casinos. Other hospitals, libraries, and schools in need of funding will have to get better connections in Harrisburg."

And the final quote, Mr. Speaker, which does speak to those amendments: "While the institutions may do good work, a specific organization shouldn't be singled out just because it has a sugar daddy in Harrisburg."

I will speak tomorrow on whatever comes out of conference committee or the date that it does come out of conference committee, but the fact of the matter is, we should vote to nonconcur.

Thank you very much, Mr. Speaker.

The SPEAKER. The Chair thanks the gentleman.

CONSIDERATION OF SB 711 CONTINUED

The SPEAKER. On the question before the House, those voting to concur in amendments inserted by the Senate— The Chair recognizes, on the question, the Chair recognizes the gentleman from Butler County, Representative Metcalfe.

Mr. METCALFE. Thank you, Mr. Speaker.

Mr. Speaker, I think it should not go unnoticed that we are here in an unprecedented fashion, the first week of January, to debate the expansion of gambling in Pennsylvania, in particular, the SB 711 as amended by the Senate. But, Mr. Speaker, as amended by the Senate, this bill contains a variety of very specific funding streams that really could be termed to be WAMs (walking-around moneys) in a new fashion.

Mr. Speaker, I would hope that as we nonconcur with this bill that deserves to be nonconcurrent with for many reasons, which I think both sides of the aisle, the majority on both sides, will be nonconcurring for different reasons, but one of the main reasons that this should be nonconcurrent with is because as the Senate amended this bill, it still allowed for, and I am sure improved upon, the number of funding streams that are going to various legislative districts around this State, whether Senatorial districts or House districts.

Mr. Speaker, the public has been calling for an end to business as usual in Harrisburg. This legislation as amended by the Senate is just a continuation of business as usual in Harrisburg. To allow for funding streams that are in a sense going to be permanent WAMs for various legislators should really send a very clear message across the State that the majority of this body, by advancing this in an unprecedented fashion the first week of January, has not heard the electorate.

This legislation is, in a sense, providing bonuses for legislators by making sure that they have political capital in the future through these sorts of WAM funding streams, Mr. Speaker, as amended by the Senate. Mr. Speaker, SB 711 should be nonconcurrent with, but the rumor is in the hall that if you are a mouse in the corner of the cafeteria and had heard those rumors, that there is already a conference committee report of sorts that has been in the works while we have not been in Harrisburg over the holidays, and that many expect to see a rapidly advanced amendment into this legislation in conference committee with all of the behind-closed-doors negotiations that have been going on while people have been enjoying their families and breaking in the new year and not talking about the Senate-amended version of SB 711, because I think the Senate-amended version of SB 711 was the last thing on the minds of most Pennsylvanians. They did not realize that the Speaker would call us in for an unprecedented session the first week of January to advance the expansion of gambling that allows for these permanent funding streams, or these permanent WAMs, Mr. Speaker.

Mr. Speaker, for any legislator in this body that has run on a platform of integrity, they should nonconcur with this legislation, and if it contains the WAM funding streams in the soon to be seen amended version of this out of conference

committee, any legislator with integrity should say "no" to continuing business as usual in Harrisburg through WAMs.

Thank you, Mr. Speaker.

The SPEAKER. On the question, the Chair recognizes the gentleman from Philadelphia County, Representative Thomas.

Mr. THOMAS. Thank you, Mr. Speaker.

Mr. Speaker, I rise to, one, make sure that the record is clear, Representative W. Curtis Thomas does not have any WAMs in SB 711. I wish, given the rise in unemployment, given the mortgage foreclosures, given the health-care crisis facing many of my constituents and facing people all across Pennsylvania, I wish that we could point to a WAM or something in here that would help with that situation, but be as it may. Mr. Speaker, 101 days following our statutory obligation to pass a budget, we passed a budget. When we passed that budget, we said that the Temple Universities, the Lincoln Universities, the Penn States, and the University of Pittsburgh, that they needed additional help, that their financial circumstances and the circumstances of the economy in the Commonwealth of Pennsylvania—

The SPEAKER. The gentleman will yield. The gentleman will yield.

Mr. Thomas, the question before the House is the amendments inserted to SB 711 by the Senate, nothing else. That is what is before the House, to either concur or nonconcur in those amendments that were inserted by the Senate.

Mr. THOMAS. Thank you, Mr. Speaker.

Mr. Speaker, the Senate amendments address funding opportunities for universities who are going to have to raise tuition to a level that prevents a whole bunch of people from being able to gain access to a college education. Mr. Speaker, the other parts of the budget, unfortunately, can be cleaned through the Senate amendments and the Senate's response to the bill that we sent.

I do not like the issue of nonconcurrence and going to a conference committee, but I am hoping, as I said earlier, I think that 2010 is going to be a great year. So I am hoping the Senate amendments deal with the issue of support for neighborhoods with 2 percent of the county share from table games. The Senate amendment states very specifically that impacted neighborhoods and other neighborhoods would benefit from and should benefit from this 2-percent county share. So, Mr. Speaker, when you look at the amendments, the amendments give some, take some, and I guess we are in one of those situations where you have to do like the old folks used to say, you have to shake it up, and if more good than bad comes out, you have to support it; if more bad than good comes out, reject it out of hand.

So, Mr. Speaker, I am hoping that no matter what we do, that at the end of the day, we get the money that Penn, Temple, Lincoln, University of Pittsburgh need to prevent these tuition increase letters from going out. I am hoping that we create jobs. I am hoping that we set aside that 2-percent county share for neighborhoods in a way that is going to improve our neighborhoods, especially those neighborhoods that will be directly impacted by what we do in SB 711.
